THE HOP MARKET

Much Activity at Salem—Higher Prices Expected.

SALEM, Oct. 24.—The hop market is still active and some of the dealers look for higher prices soon. Sales are reported from day to day, and the dealers who are bearing the market, are still getting in and buying some of the lots offered for sale. Last evening three sales were reported in this district. The Gunnison lot of 55 bales, at Silverton, was reported sold to T. A. Livesley & Co., of this city, at 25 cents. The Archie Brown crop of 40 bales of prime hops, at Boia, near here in Polk County, was sold to Catlin & Linn, of Salem, at 24 1/2 cents, and the Dr. Fink crop of 90 bales, at Dallas, was purchased by Kirkpatrick & Williams, for 25 cents. Livesley & Co., of Salem, a week ago offered 25 cents for the Fink hops, but could not secure the crop then.

The Congregationalists.

The annual conference of the Congregational Churches of Oregon adjourned here last night after a most interesting and profitable session. Oregon City was chosen as the place of meeting for next year. Rev. W. C. Kantner, of Salem, was elected a fraternal delegate to the Presbyterian Synod of Oregon, and Rev. Howard N. Smith, to the general association of Washington, which meets at Spokane next week. The Woman's Home Missionary Union held its annual session yesterday. Reports showed great progress. Officers were elected as follows: Honorary vice-president, Mrs. F. M. Warren; president, Mrs. F. Eggert; vice-presidents, Mrs. E. L. House, and Mrs. J. J. Staub; recording secretary, Miss Ada F. Bookings; corresponding secretary, Mrs. D. D. Clark; secretary of literature, Mrs. L. P. Toney; treasurer, Mrs. C. F. Clapp; auditor, Mrs. A. L. Coker; secretary Young People's Society, Mrs. W. D. Palmer; missionary evangelist, Mrs. D. R. Barber; association vice-presidents, Mrs. L. A. Parker, Miss Mary F. Farnham, Mrs. Mae H. Wallace, and Mrs. S. A. Lowell. It was announced in the conference that the triennial meeting of the Pacific Coast Congress of Congregational Churches would meet in Seattle in May, 1903, the following delegates were chosen: Mrs. S. A. Lowell, Rev. W. C. Kantner, Mrs. F. Eggert, and Prof. H. L. Bates.

Suit on a Hop Contract.

George A. La Vie, plaintiff in a suit for the recovery of 10,000 pounds of hops from A. B. Crosby, near Woodburn, has filed his reply to the defendant's answer. He denies the allegations of the defendant, and alleges that he made a contract for the hops at 1 1/2 cents; that he paid \$100 on the contract last spring, and that he has tendered the remainder of the money due, \$100, to the defendant, and he now brings this money into court. The case will attract considerable attention, as it will be a test of the validity of the hop contracts.

Merchants' Carnival.

The ladies of St. Paul's Episcopal Church, of this city, conducted a Merchants' Carnival at the Armory in the city hall, last night, the purpose being to raise funds for the construction of cement sidewalks around their sanctuary. The armory was crowded, and hundreds of people were turned away. An excellent musical program was rendered and refreshments were served, and many well filled booths, containing exhibits of var-

ious kinds, attracted the attention of the crowds. A large number of young ladies were fantastically arranged to advertise various mercantile houses. One of the most interesting and attractive figures was a young lady representing the George E. Waters Cigar store. She wore suspended from her gown, and completely covering it, over 800 cigar ribbons. In various colors, with orange predominating, and scattered over these were about 100 cigars, while a breast pin of pipes, and a head-gear of the same articles finished one of the most unique costumes ever devised. The ladies were unusually successful, and will make ample funds for their plans.

Wedding at Salem.

Tom C. Abrahams, of Cottage Grove, and Miss Iva La Fore, of Turner, were yesterday united in marriage, by City Recorder N. J. Judah, of this city. The groom was formerly assistant engineer of the asylum farm, and is a popular young man. The bride is a daughter of P. La Fore, a farmer residing near Turner. The couple will reside in Cottage Grove.

To Aid the Miners.

The miners' ball to be given in the armory at the city hall tonight, promises to be the social event of the season, and the attendance will probably be the largest ever seen at a similar affair in this city. The ball is given under the auspices of the Central Labor Union, and the proceeds of it will be sent to the anthracite miners in Pennsylvania.

Funeral of Frank Nelson.

The remains of the late Frank E. Nelson, who was killed in the Gold Creek mining district, were buried in the Oak Fellows' cemetery near this city yesterday afternoon, from the undertaking parlors of Coroner A. M. Clough.

YAMHILL PROSPERS

Farmers and Business Men Have Cause to Rejoice.

McMINNVILLE, Oct. 24.—Crops of all kinds are saved in good condition and will net the farmers of Yamhill county a large amount of money. Never in the history of Yamhill County has the weather been so favorable for harvesting crops, nor has there been a year when farmers and business men had greater cause to rejoice.

Nelson Wins the Suit.

The case of J. H. Nelson vs. Yamhill County was tried in the Circuit Court of Marion County Tuesday and a verdict given in favor of Nelson. Mr. Nelson is a former clerk of this county and brought action to recover \$1200 for deputy hire, which the county refused to pay.

McMinnville Notes.

Yamhill Lodge, Degree of Honor, will entertain Carlton Lodge, Degree of Honor. A banquet will be given, and it is expected the occasion will be an enjoyable affair. On Saturday, October 25, the college football team will play the second team of the O. A. C., Corvallis. An effort will be made at the coming city election to do away with saloons. Both sides are actively at work. Concrete walks are being laid by the McMinnville National Bank and the First National Bank around their places of business.

PENDLETON

EPINGER SENTENCED

Judge Ellis Gives Him 18 Months at Salem.

PENDLETON, Oct. 24.—W. Epinger has been sentenced to 18 months in the penitentiary. Epinger will be remembered as the man who came here two weeks ago and registered at Hotel St. George from San Francisco. He claimed to be representing the Western Printing Company, and was soliciting ads to be printed on cards to be posted conspicuously in different places over the country. He found some victims here, from whom he collected money, which he squandered in whisky. He became acquainted with M. S. Monteith, and followed him to his room one night and picked his pocket of a watch. For this he was tried, found guilty and sentenced.

Two Bold Thieves.

A telephone message has been received from Ukiah stating that two valuable horses were stolen from a pasture at White's sawmill. A posse was organized and started out after the thieves, who were followed to Hutter Creek, about 15 miles distant. Here all trace of them was lost and the posse returned to their homes.

Pendleton Notes.

From the miners' benefit sale at the Peoples' Warehouse last Saturday, a total of \$41.25 was sent to the anthracite coal miners. This makes \$94 which has been sent from Pendleton to the strikers' relief fund.

Superintendent J. E. Nowlin is spending most of his spare time visiting the schools in the rural districts, which he reports generally in a satisfactory condition. In speaking of the improvements along the W. & C. R. line, Engineer Cutler said the work was being rushed for the new bridge across the Walla Walla River near Harts. The work on the piers at the Umatilla River bridge has been completed for some time. Clarence Bowlsby is home from Walla Walla where he has been in the Thirtieth Battery, field artillery, in the service of Uncle Sam. He was discharged on account of disability.

GRANTS PASS

THE NEW RAILROAD

Report That Track Laying Will Begin January 1.

GRANTS PASS, Oct. 24.—It is reported on good authority that the laying of track on the new railroad between Grants Pass and Crescent City will begin about the first of January. It is the intention of the company to complete the road at the earliest possible date.

Notes and Personals.

The new dam being built at the Dry Diggings by the Golden Rift Mining Company will soon be completed. There is a great demand for carpenters in Grants Pass. Everett B. Brown and Henry Topek, both of this city, have been adjudged insane and sent to the asylum. The Baptist Church, which was destroyed by fire last summer, is being rebuilt. W. R. Clarke of Grants Pass, manager

of the new Water, Light & Power Company, has gone to Portland. A. L. Adkins of Portland is at Grants Pass on business.

INDEPENDENCE

HOPS MOVING FAST

Large Percentage of Crop Will Go at 25 Cents.

INDEPENDENCE, Oct. 24.—Hops are moving faster than at any time since the crop was harvested. Several batches have been sold at 25 cents per pound, and J. E. Hubbard refused an offer of 25 1/2 cents. There seems to be a general impression that prices will go above 25 cents, yet it is safe to say a great percentage of the crop will go at that figure.

Death of D. J. Whiteaker.

After lingering in an unconscious state for over a week death claimed Jesse Whiteaker yesterday afternoon. Mr. Whiteaker was the victim of a runaway accident, and ever since the accident no hopes were entertained for his recovery.

A Fraternal Visit.

A delegation of Rebekahs, including former State President Paulina Kline, from Corvallis, paid the local Rebekah lodge a visit last evening. Several from Monmouth and Dallas were also in attendance.

EUGENE

SURVEY COMPLETED

The Booth-Kelley Road Across the Cascades.

EUGENE, Oct. 24.—The work of surveying the old military wagon road grant across the Cascades and over into Eastern Oregon, recently acquired by the Booth-Kelley Lumber Company, of this city, has been completed. H. C. Perkins, of Grants Pass, who had the contract for surveying a large part of the land, arrived in Eugene today and will leave for Grants Pass tomorrow.

Death of an Old Pioneer.

James B. McCallister, a pioneer of Lane County, died at his home near Irving last night after a long illness. He was born in Virginia in 1833 and was raised in Indiana, coming to Oregon and Lane County in 1864. He has resided on his farm ever since then. He was a prominent man in political and lodge circles, having represented Lane County in the Legislature one term, and being a member of the I. O. O. F. and A. O. U. W. He leaves nine children—five daughters and four sons.

Timber Owners Form a Pool.

A number of holders of timber land residing in Eugene have formed a pool for the purpose of negotiating for the sale of the land for not less than \$20 per acre. Dr. F. W. Harris, the largest holder in the pool, has been appointed trustee to negotiate the sale. A score or more of men are in the combination and nearly 5000 acres are represented.

Wedding at Eugene.

Frank A. McAllister, a clerk in the First National Bank, and Miss Fannie Young, daughter of Hon. and Mrs. C. W. Young, were married last night at the home of the bride's parents.

OREGON CITY

ADJUDGED INSANE

George Pfister Taken to Salem for Treatment.

OREGON CITY, Oct. 24.—Sheriff Shaver left last evening for Salem, having in charge George Pfister, a man who was adjudged insane yesterday morning. In the course of the examination it was found that he is not as crazy as he might be, but that unless he received medical treatment and good food, he would soon lose his mind. His manner shows that he has brought this condition on himself, through a mean disposition, although he was not too kindly treated by his family. He is 68 years old, and is a German.

Wedding at Oregon City.

Joseph Sears and Effie Knowland were married in this city yesterday afternoon at the home of the bride's parents on lower Seventh street. Both have many acquaintances here as they have been residents of this place for several years. After the ceremony they left on the Albany local for Salem, where they will make their future home.

Oregon City Chosen.

At the closing meeting of the Congregational Church Association, which has been in session at Salem during the last week, it was decided to hold the next annual meeting at Oregon City. Rev. Bollinger, who returned this morning, reports an interesting session. He deserves credit for securing the meeting for this city, as the Congregational ministers from all over the state attended this, their annual convention.

Gus Dimish passed through the city yesterday en route to Hubbard. Miss Vera Hill, formerly of this city, is visiting with friends here. George Quinn, who has been very sick with pneumonia, is convalescent. C. H. Wheeler, of Portland, was in town this morning. He will be remembered as the owner of the Willamette candy store. Mrs. Effie Gay was in Oregon City yesterday afternoon, after having attended the funeral of her grand father, J. W. Root. The funeral of J. W. Root, which was held at the Central Presbyterian church, was a large one, as he left many warm friends who remember him for his good actions. He came to Oregon 32 years ago, hence many pioneers attended the services.

ROSEBURG

THE GREAT CENTRAL

Work Discontinued East of Roseburg for the Winter.

ROSEBURG, Oct. 24.—The officials of the Great Central Railway have directed that all further reconnaissance work toward locating the railway line east of here be discontinued for the winter. A statement to this effect was given out by Chief Engineer Kinney yesterday. The work of locating the line west of Roseburg to Myrtle Point will, however, be steadily prosecuted with the intention of having everything in readiness for the commencement of active construction work when spring opens. Engineering

operations east of here will also then be resumed. The corner stone of the depot and office buildings of the Great Central Railway Company was laid in North Roseburg yesterday noon. The attending ceremonies, simple and brief, were witnessed by a large number of people.

Douglas County Assessment.

The summarized annual statement of the assessment roll of Douglas County for 1902, as equalized by the County Board of Equalization, has just been made public. The gross value of all property is placed at \$6,095,384, of which \$488,700 is exempt from taxation. The statement makes a very creditable showing as compared with the largest assessment ever made in Douglas County (that of 1891) previous to the first election of Mr. Gillette. In that year the individual property owners paid 38 per cent of all taxes in the county and the corporations the remainder. This year the people will pay but 36 per cent and the corporations the remainder.

Circuit Court Adjourns.

The October term of Circuit Court for Douglas County adjourned Wednesday, fixing January 16, 1903, as the date for holding the preliminary session preparatory to beginning the work of the next regular term.

STATE BRIEFS.

The Elks lodge of Baker City is preparing to erect a building 60x100 feet and three stories high. Bids have been called for a suitable site.

The city of La Grande is to have a gravity water system costing \$75,000. Work on a big dam 90 feet wide and 30 feet high will be commenced at once. Embraced within the proposed forest reserve in Baker County are 330 mining claims. There is as many more in Grant County and a large number of claims in Union County not included in this total.

Salem grain dealers report that the farmers are still holding their wheat, and that the sales are not large enough to meet the needs of the mills for the season. Samuel Flock, 27 years of age, a resident of Day's Creek, while hunting with his father-in-law, Mr. Chaney, in the vicinity of Perdue, Thursday morning, was mistaken for a bear by Chaney and fatally shot. Flock lived but a few minutes.

Everything is moving rapidly at the Amalgamated Sugar Company's factory in La Grande. About 9000 tons of beets have been received up to date, of which 7000 tons have been ground up. The percentage of sugar saved is about 18 to 14 per cent—a very high average. The two sawmills that are now being erected in Astoria will be as finely equipped plants as any on the Pacific Coast, and one of them, that of G. W. Hume, will be as large as any in the state. It will have a capacity of 100,000 feet in ten hours.

Chester Jones, of Lorane, had an exciting experience with a highwayman near Junction. He was halted in a lonely road and ordered to throw up his hands. He grappled with his assailant and was shot in the hand, after which the highwayman made his escape in the brush. The Oregon City Weekly Courier-Herald has been purchased from A. W. Cheney, by J. H. Westover, formerly of Williams-town, Ky., the price being \$500. The new proprietor will take possession November 1, and the paper will at once be converted into a straight Democratic organ.

The run of fish in the Columbia River does not appear to have been increased by the recent rains, as anticipated and the catch is still light. The price of 5 1/2 cents per pound for soles and silver-sides, which has been ruling for some time, has been increased to 2 1/4 cents, with a prospect of it going to 2 cents.

ALBANY

UNION DEPOT

Albany Badly in Need of Better Accommodations.

ALBANY, Oct. 24.—There is considerable talk among the business men of Albany about a new depot. Fourteen passenger trains arrive and depart from Albany daily, and the yard limits are many times jammed full of freight cars. At present the depot is across all the main tracks from town. Consequently all passenger trains must stop directly between the depot and the hotel carriages, and the street cars. This necessitates either climbing through the train or going around and it is usually impossible to go around on account of freight cars blocking the way. In summer, travelers get confused about the stations, and there is more or less trouble in the handling of baggage for the branch roads. A union depot would do away with all the evils of the existing conditions and be a great convenience to travelers, and the local traffic as well. Albany people are in hopes that the thing will be accomplished soon.

Albany Bad Boys.

Albany has lately been fitted out with new street signs and house numbers. Some boys who live in the lower end of town have been using some of the street signs as targets for rock throwing contests, much to the disfigurement of the signs. Yesterday three of the naughty lads were arrested and will appear for an accounting tomorrow.

Personal Notes.

J. R. Baltimore, a capitalist, of this city, left last night for Eugene, Har Springs, in the Joaquin Valley, about 60 miles from Oakland, Cal. He will make a short stay for his health. Jim Finch, city editor of the Albany Herald, is a Portland visitor.

TO BUILD HALL

Stock Company Formed at Mt. Tabor for That Purpose.

It has about been decided by a committee of Mt. Tabor Assembly, United Artisans, to build a hall for fraternal organizations. A meeting of the various officers of the assembly was held a few days ago and it was decided to form a stock company with a capital of \$2000 for the erection of the building.

It is likely that property will soon be purchased on West avenue near the City & Suburban Company's station for that purpose.

TO BE TWO STORIES.

The proposed hall will be two stories in height and will be constructed of wood, with a concrete foundation. Work on the erection of the structure will be started this winter. The lodges which formerly held their meetings in "Oriental hall," recently destroyed by fire, are now meeting elsewhere. Mt. Tabor Camp, Woodmen of the World, and Mt. Tabor Assembly, United Artisans, now meet in the Field building on the Base Line Road. The Masons hold their meetings in the new hall on East Burnside street.
