WEATHER FORECAST.

MILLER'S LAST BOLD STAND

Story of His Death Told by Deputy Andy Lee.

HAD NO CHANCE TO ESCAPE

Fired the Fatal Shot That Took His Own Life.

PENDLETON, Or., Oct. 27.—Andy Lee, Deputy Sheriff of Garfield County, Washington, who passed through town Friday evening on his way to La Grande on business connected with the last effort, was one of the officers who surrounded the house where A. C. Miller killed himself near Pomeroy a few days ago.

Mr. Lee was instrumental in running Miller to earth. He was well acquainted with him and when a description of the man who sold the stolen cattle in Pomeroy was given him, he immediately said it was Miller and began a search for him. Three weeks ago he heard of him at Elgin and came through Pendleton on his way to get him, but in the meantime Miller had left Elgin and started across country toward Pomeroy. Mr. Lee then returned through Pendleton intending to go to Pomeroy and there get a saddle horse and cross country into the Grande Ronde River country, to head off the cattle rustler. Miller was too fast for him and the day Lee reached Pomeroy Miller passed over the mountains by Antone and drifted into Lewiston. It was during the fair at Lewiston and an acquaintance of Lee's, while going from Pomeroy to the fair, met Miller and recognized him.

This was late in the afternoon and the man hurried to a phone and called Mr. Lee, told him that Miller was then coming toward Pomeroy. Lee immediately made up his mind that Miller was on his way to the home of his son-in-law, named Nye, being a few miles north of Pomeroy, and he and the Sheriff started out to get the rustler.

They reached Nye's home a little after 9 o'clock in the evening, and were told by Mr. Nye, who did not know that his wife's father was wanted for cattle stealing, that he was up stairs in bed. The Sheriff asked to see him, and Miller was aroused. He got out of bed and dressed himself preparatory to coming down. He could be heard putting on his shoes while the officers waited outside the door. Instead of coming down, however, when he was dressed, he picked up his 32 Smith & Wesson revolver in his left hand, and placing it to his left ear, fired, blowing the top of his head off. The officers then rushed into the room to find him lying across the bed dead.

There was no chance for Miller to escape from the house without the officers getting him. The sheriff was leading from the street, the second story opened on the outside of the house and this was a only exit from the room where Miller was. Knowing this, and knowing that the officers had the door well guarded, he preferred to end his own life rather than surrender to the officers and serve another sentence in the penitentiary.

Miller was 32 years of age and served one term in the Washington state prison for cattle stealing. He was sentenced from Whitman County and had only been out of prison a few months. The crime for which he was being sought when he ended his life was the stealing of nine head of cattle from a pasture on the Snake River, in Garfield County, and driving them to Dayton and selling them to the local butchers. Rather than face another term in the penitentiary, he chose to end his own life.

THEY WANT STONE.

IS A CHRISTIAN SCIENCE CHURCH? "A CORPORATION FOR PROFIT?"

The denial of a charter to a Christian Science Church in Philadelphia on the ground that the institution in question is not wholly a religious one, but in part a business enterprise, is regarded in many quarters as a decidedly unusual ruling. Judge Arnold, of the Common Pleas Court, in Philadelphia, in rendering his decision, declared:

"The charter applied for in this case covers a double purpose—a church and a business. We have power to grant a charter for a church, but we have no authority to grant a charter for a corporation for profit—that is, a business corporation."

Continuing, the judge quoted from Mrs. Eddy's text-book her instructions to Christian Scientists to sell and circulate her publications, failure to do the same being regarded as sufficient cause for expulsion from membership in the church. He said further:

"This shows that the so-called church is an association for profit, organized to enforce the sale of Mrs. Eddy's book by its members, which is a matter of business, and not of religion. As the courts have no power to charter such an association the application for a charter is refused."

"This is the first time," observes the Buffalo News, "that a court has taken cognizance of a point that has been frequently raised by the press and those who have criticized the methods of the Christian Scientists." Judging from the newspaper comment upon the subject, it would appear that the decision of the court is generally held to be unfair.

The Atlanta Journal thinks that the charter should have been granted "as a matter of course," and the Chicago Record-Herald remarks that if Judge Arnold's action was really intended to stay the growth of the Christian Science Church, it is a "futile proceeding." The same paper continues:

"That is not a matter that depends in any wise upon the discretion of the courts. Its sole dependence is upon the faith of individuals. If that becomes stronger and spreads individuals will exercise the right of personal liberty to worship as they please, and help to extend the power and influence of the church. If the faith wanes, the church will decline and judges would be as powerless to prevent the decline as they are now to prevent an expansion."

"The fact that Pennsylvania has a law which vests the power to grant charters in the judges does not alter the essential features of the case in the slightest degree. It serves only to emphasize the lack of common sense in the particular judge who is concerned. For every one will see that he was influenced by a personal animus against the church, and that he took advantage of his authority under the law to gratify this hostile feeling."

"Many people share the feeling with him, but few of them will acknowledge that it is a fit guide for the interpretation of the Pennsylvania law, and when Judge Arnold undertook to discriminate by saying that the application for a charter covered a double purpose—a church and a business run for profit—and when he based his refusal upon that discrimination, he assumed too much. 'For it was hardly his province to act as though he were a censor over sects—to license and to forbid according to his personal notions of religion. That would be a big contract for any man and one that no man can be trusted with.'"

In a supplemental opinion, Judge Arnold explains a greater length the reasons for his decision, declaring that he regards Mrs. Eddy's statements on sickness and death as "palpable fallacies" and as likely to exert an influence "pernicious and injurious to the community. He adds:

"When persons who make a business of practicing the art of healing with or without medicine are not regular and registered physicians, they violate the law which was intended to prevent the practice of medicine by non-qualified persons."

QUIETUDE PREVAILS

Over the Street Railway Franchise Question.

BOTH SIDES ARE CONSIDERING

It Is Now Up to Railway Co. to Submit Counter Proposition.

Perfect peace and tranquility pervades the atmosphere in municipal and street railway circles since the joint meeting which was held in the Mayor's office Friday afternoon. The skeleton of a compromise was outlined in the Journal is being considered by both sides. A majority of a councilman are in favor of the measure, and it is now up to the railway company to say what will be the next move on the franchise checkerboard.

There were no new developments this morning. The mayor was seen, but he had nothing new to offer. He views the situation complacently and believes that a good beginning has been made towards clearing up the atmosphere and that order will be brought out of chaos.

RAILWAY CONSIDERING.
The ordinance was turned over to the railway officials, who are now giving it a careful study. Mr. Fuller, the Superintendent of the Portland Railway Company, when seen said it was yet too early for them to give out anything. They will immediately go over the proposed franchise, and after they have made a thorough study of it will submit a counter proposition, and then the issue between the city and the railway company will have been decided.

As heretofore stated, the bone of contention will be over the matter of compensation the company shall be required to pay the city, the matter of inspecting the company's books and the improvements of the tracks.

LENGTH OF FRANCHISE.

Another matter of contention will be over the length of time the present franchise have to run. The company has a good many franchisees over the streets, some of which have never been used. Some of them have been "dead" for several years, until neither the city nor the company are certain as to the length of time some of them have yet to run. The first one to expire is the Fifth street franchise, which has yet to run for 20 years. The longest one on Union avenue, has yet a life of 30 years. It is on intermediate franchises that there is any dispute. The company claims that the average time of the franchise is 15 years, while the city claims it is only 12 years.

As soon as the railway officials are prepared to submit a proposition to the city the Mayor will call another meeting to consider it.

The city committee will hold another meeting tonight to further consider the Ford street franchise, but as there is a strong sentiment among the councilmen in favor of the blanket franchise it is not likely any action will be taken.

NEW RURAL ROUTE

Polk County Postal Service to Be Greatly Benefitted by Delivery.

INDEPENDENCE, Oct. 27.—A number of petitions are being circulated over the county for the establishment of new rural delivery routes. One of the proposed routes is from Parker to Burns Vista, and there is every reason to believe that this will be established soon, as the section covered by the route is the most thickly populated rural section of the county. Another route takes in the villages of Lewisville, Arlie, Feder, King's Valley, etc. These routes would practically cover Polk County with rural deliveries.

For several days the work of removing obstructions in the river has been going on under governmental supervision. Several large snags were removed. Last winter three river steamers were sunk by running onto submerged snags and it is thought all danger of such disasters will be averted by this preliminary work.

Work on the Independence oil well is progressing daily, it being down now to nearly a depth of 1000 feet. Work has been interrupted many times owing to accidents to the machinery, but work is now progressing night and day.

EUGENE, Oct. 27.—John Lamberg is in the future he more careful about his letter writing. He wanted to get even with his spouse and now he is in trouble. Yesterday he was bound over to appear at the circuit court next week for writing obscene letters to his divorced wife, Louisa Lamberg.

For years they have had trouble and about one year ago she obtained a divorce on the grounds of cruel and inhuman treatment. Lamberg has continually since then annoyed her and lately has been writing obscene letters to her, sending them by their little boy.

Reports come from Florence, on the lower Snake, that the fishermen on that river have gone out on a strike. They have been getting 25 cents each for Chinook salmon and 10 cents for silver-sided. They are entirely satisfied with the price paid for Chinooks, but want 15 cents for silver-sided. The only canner now in operation on the Snake is that of O. W. Hurd, who also owns large stores and shipping interests on the river. Mr. Hurd refuses to accede to the demands of the fishermen and some of the latter have expressed their intention of sailing down their catches and disposing of them in the valley.
