

BAD FOR CRIMPS

Biglin Will Enforce Law in This Port.

CANNOT VISIT SHIPS

Sailor Boarding House Men Give Their Version of the Story.

Harbor Master Biglin states that there is a law on the statute books of this state which he intends to enforce in the future, so far as it applies to the sailor boarding-house proprietors. The substance of the law is that no one shall be permitted to board a vessel lying in port without first receiving an invitation or permission from the captain, first officer or someone who is temporarily in charge. A fine of from \$20 to \$100, or imprisonment in the county jail for not more than 30 days, or both, shall be imposed upon anyone violating this law. Heretofore no particular effort has been made to enforce it, but from this time the harbor master is going to use every available means to see that the statutes are strictly observed.

WERE VICTIMS.
The boarding-house representatives believe that they have been the victims of a plot by the sailors of the Morven, and consider themselves exceedingly fortunate to be alive today. Jack Grant says:

"Evidence which I have in my possession is conclusive proof in my mind that those sailors have been conspiring for several weeks past to murder me. As long as 10 days ago Frank Keam, a watchman on the Dymenese, informed me that the sailors on the Morven were laying for us, and if the opportunity ever presented itself, would do us up. I placed but little credence in the story, but discovered subsequently that it was only too true."

"Why did your people board the vessel?" questioned the reporter.
WERE GUESTS.
"They were invited to do so by this man Jones who said that he wanted us to come and help take his things from the ship, as he wished to leave and was afraid of suffering personal violence if he attempted to do so. Three of us went to the ship, but only one of us boarded. This was Jim White, and as he stayed quite awhile we began to fear that all was not going well with him. The other two then went aboard, and found Jim in the cabin surrounded by the murderous sailors who were shouting:

THE FIGHT.
"We have now got you where we want you, you know where we want you, and intend to make quick work of you."
"The other two boarding-house men then went to his rescue, and the fight began. There is no doubt but that they leveled us aboard for the sole purpose of murdering us. I have thought since that Jones stood in with the rest of the gang, and was simply playing the part given him by his confederates. All of this will come out at the trial in due time, and we have witnesses to prove it."

MORE TROUBLE.

"The Police vs. Chamber of Commerce Building" is the title of a new composition being played between the police officers and the agents, janitors et al. of the Chamber of Commerce Building. It seems that there has been constant warfare between both sides for quite a while because of some dirt that is always to be seen on the Fourth-street side of the building. The police blame the janitors of the building for carelessness in allowing the dirt to remain; the janitors say they have nothing to do with it, that the elevator boys are to blame; the elevator boys lay the blame on the spittoon-washers, and so on, the blame goes down the line to the bootblack. As the police say that they could do nothing with these people they resorted their complaint to Mr. Hartman of Hartman, Thompson & Powers, the agents of the building. The action of Mr. Hartman in the matter has not as yet been made known. The police say that if nothing will be done in the matter in a few days some arrests will be made.

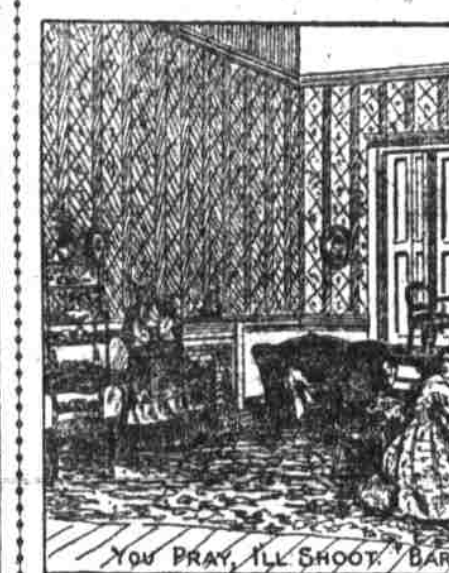
SUPREME COURT GRANTS A STAY

Belding, the Wife Murderer, Will Not Hang on Friday.

The Supreme Court yesterday granted a stay of proceedings in the Belding case to give his attorneys time to prepare their bill of exceptions for a new trial. This will be done within the next 30 or 40 days and the Supreme Court will then review the case. If it finds that the prisoner had a fair and impartial trial in the court below the law will be allowed to take its course, and if not it will be remanded back to the Multnomah Circuit Court for trial. If the court finds adversely to the prisoner his attorneys are prepared to carry the matter to the United States Supreme Court on constitutional grounds, in that the prisoner was not given a proper hearing in the Police Court.

District Attorney Chamberlain is determined that Belding shall pay the full penalty of the law for the crime he committed. If he should escape on the present charge, there are two other indictments under which he can be prosecuted.

BELDING CHEERFUL.
Belding, who from the first, has maintained such an indifference as to his fate, now hopes that he may be spared his life. When told last night by his attorney, D. R. Murphy, the action of the

Supreme Court, he expressed the greatest pleasure and delight.
The preparations which Sheriff Storey has made for the hanging on Friday will be left for the present, as George White, who is now in jail under sentence of death, will probably have the date for his execution set by Judge George in a few days.

SEATTLE MAN INVESTS HERE

Will Establish a Jam and Jelly Factory in Portland.

Portland will have jams, jellies, molasses and syrups galore in a very short time. This depends on one man, and he says "Yes." A. Moran, of the Puget Sound Refining Company arrived from Seattle this morning, was taken in tow by Secretary McLaane of the Manufacturers' Association and the result is a new factory in Portland for the production of the above named articles.
"In an interview with Mr. Moran he said: 'Our firm has long had an eye on the progress of Portland and we had decided long ago to establish such a business in your city, but have not had the time to attend to it. We will establish a mammoth establishment here for the manufacture of molasses, syrups, jams, jellies and other kindred articles. Portland, we believe, is a good point for just such a factory. We will employ many hands, and I think the factory will be a good investment for all interested.'"

SALOON REMONSTRANCE.

C. J. Littlepage has filed a petition in the county court asking to have the saloon license of Richard Latourell, of Latourell Falls, revoked. The county commissioners granted Latourell a license July 31, and Mr. Littlepage now comes into court and avers that the application did not contain the required number of names of the legal voters of the precinct in which the saloon is located.

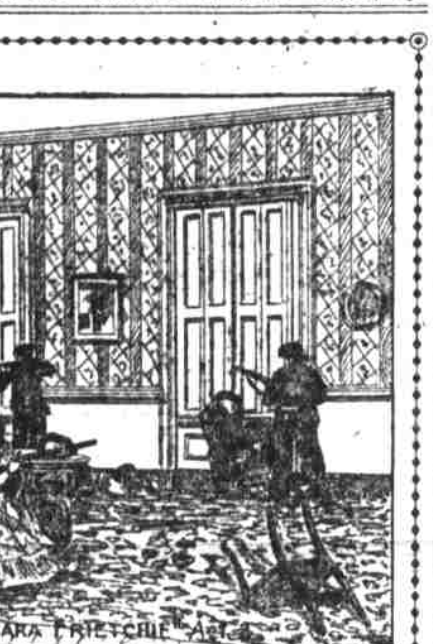
WAS HE WORKED

Did Harris of Lane Pull Booth's Chestnuts

OUT OF THE FLAMES?

"Jack" Matthews and His Status With Mitchell Is Discussed.

If the story of the endorsement of Senator Booth of Lane County for the State Senate Presidency be true, and the Mitchell-Fulton people really propose to put him in that position, then it follows that Mr. Booth's supposed urging of Harris of Lane County for the speakership of the House was a blind. Booth, ap-

parently, was using Harris' name to further his own interests, and while laboring ostensibly for the elevation of the other man, was really all along operating in his own interest.

Another phase of the day's political developments is the assertion that the Mitchell-Fulton people will give the speakership to Eddy of Tillamook, who is said to be a strong Scott man, but who, according to some of the wisecracks, is first, last and all the time a Mitchell follower and ready to do the latter's bidding when the Legislature convenes and he wields the power of the presiding officer of the lower body.

As to Booth and Harris, both are known to be uncompromising Fulton men and determined to do everything in their power to advance the agenda man of the United States Senatorship.

THAT REPORTED QUARREL.
The latest development in the important matter of the relationship between Mitchell and Matthews is that there has never been a quarrel, and that Mr. Mitchell, almost as many words, told his friends that the attitude of the Legislature and he would in all things represent the Senator.

It complicates matters somewhat, inasmuch as Matthews has been presumed to be desirous of giving the Senatorship to Mr. Scott, and this is inconsistent with the reported determination of Mr. Mitchell to support Mr. Fulton for that office.

SHOULD RUSSELL SAGE DIE.

Russell Sage is making every provision to safeguard those with whom he has business relations in the event of his death. There has been much uneasiness among borrowers in Wall street lest complications arise which would tie up a great deal of money if Mr. Sage should die suddenly. As the police say that the heaviest lenders of call money in Wall street, outside of the banks, if he should die suddenly, without making any proper provision for their interests, the borrowers fear that a general selling of his loans might result, which would cause much embarrassment in Wall street. All of this was explained to Mr. Sage during his illness, and after a talk Sunday night with Col. J. Slocum, it was finally decided to add the following clause to all collateral notes outstanding and to all that may hereafter be drawn:

"This note is given by the maker thereof and the collateral surety above referred to in full payment of the loan, which the said Sage by the acceptance of the same agrees to, that in the event of the death of said Sage before the payment of such note, the maker thereof may pay the amount due thereon to such trust company in the city of New York, incorporated under the laws of the State of New York, as shall be named by Charles W. Osborne and J. J. Slocum, in whose physical custody said note and collateral security have been placed by said Sage, and upon such payment said Osborne and Slocum are authorized and directed to deliver said note and collateral security to the maker of this note or his order."
Nearly all the holders of Russell Sage's loans visited his office yesterday to have the new paragraph inserted in their notes.—New York World.

NEW RAILROAD.

W. H. Moody, Albert Bettington and J. P. McInerney have filed articles of incorporation for the Coal Creek Railroad Company, with a capital stock of \$50,000. The proposed road is to start in Clatsop County, through to the northern boundary of the State of Washington. The principal offices of the company are to be in Portland.

This is not detracting from the merits of Mr. Maxwell, who is a very capable man, and is entitled to all the credit for the passage of the irrigation law. We don't wish to detract at all from his merits; he is entitled to all the glory, only he is mistaken when he tries to subordinate the irrigation to any trans-Mississippi Congress or any kind else. Irrigation is paramount and must not be lost sight of in any other movement for a moment."

WESTWARD HO!

CHICAGO, Oct. 28.—The Record-Herald of this morning says: Between 40,000 and 50,000 colonists have gone into the far Western, Northwestern and Southwestern states during the months of September and October. The movement of homeseekers and settlers has never before been so great in the history of Western railroads. During the present week, which is the last of the 33rd rate to the Pacific Coast, the railroads will carry fully 20,000 colonists out of Chicago, St. Paul, St. Louis and other large cities in the Middle West. The Santa Fe alone will carry at least 3,000 during the week, orders having been given for 75 cars thus far.

MORNING vs. EVENING PAPERS

The theory with a great number of advertising men with whom I have corresponded during the past six months seems to be generally that those morning papers that spend mainly on the news stand sales are not so valuable for reaching the public as those papers that are delivered in the morning. It must be remembered that the morning paper is stale by noon. Whether the circulation depends on street sales or paid delivery, it is very doubtful if the morning papers can compete with the evening papers in reaching the mass of women.

Few women indeed will sit down in the morning and look for bargains, when the house news papers are delivered at the homes in this city are brought down town by the men, and read on the cars en route to their offices, and are not brought home again in the evening. Out of some seventy-five gentlemen last month whom I met on the street cars in the morning reading the papers, about sixty per cent had the paper delivered at their residences, and in not a single instance was the paper carried home at night, and ninety per cent of those questioned took their evening paper home, and said that their wives read these papers in the evening, when the day's work was over. It was at this time that they read the advertisements, and if anything appealed to their bargain instincts they would plan a shopping trip for the morning. I believe few ladies, even of the higher class of society, who employ servants, and time to read the morning papers and take advantage of the ads. the same day that they appear. A housekeeper or housewife, high or low, worthy the name, busies herself with her household duties, servants or no servants, in the morning, and has little time for newspaper reading. Other localities may be different; but there is one thing of which I am positive, and that is that in St. Louis the morning papers do not reach the women.
