

GEER IS STRONG

Republican Politicians
Guessing

AS TO HIS CHANCES

To Capture the Toga -- Little
Harmony Among His
Opposition.

Governor Geer's citing of the Mays law and the fact that he received a majority vote last spring for United States Senator are tender subjects for republican politicians just now. The governor appears to have made himself a strong feature in the fight, and to have compelled the political professors of dynamics to include him in their diagrams of the co-relation of forces that are running through the state. There is not very much of harmony to be found among the brethren of that fold. The situation is mixed, badly mixed, with apparently no one in possession of information that can clear the atmosphere. The best politicians in Oregon are frank when they say that only Omnipotence could forecast the future, and it is commonly presumed that the average politician is not on speaking terms with the Almighty. Hence, there is some what of ignorance as to what the coming weeks will bring forth.

THE MAYS LAW.

Governor Geer rests his claim to support upon the fact that the Republican party itself enacted the Mays law. This provided that a candidate for the United States Senate might go upon the state ticket by petition, and that he must be placed there by the secretary of state to be voted for just as other candidates. Mr. Mays, the author of the bill, is a Republican, the Republican party was in strong majority, and therefore it was distinctly a republican measure.

"Governor Geer," say his supporters, "compiled with the Mays law, and went before the people with his candidacy, receiving endorsement at the polls. He stands upon that fact as consistent and conclusive testimony that Mr. Geer was the people's choice for United States Senator."

All of this worries the other fellows, and compels them to reckon with the governor as in the senatorial running.

It might be one of the several men who have been senatorial possibilities in the past, yet at this time he is in the dark and is being kept there by his friends. RESIGNATION IS ACCEPTED

Shaver Will Probably Be Barry's Successor.

The resignation of William H. Barry as secretary of the State Federation of Labor has been accepted. So far as can be ascertained G. E. Shaver, of the "Painters' Union," will be his successor if he wishes to accept the position. It is generally conceded that the members of the executive board have practically decided upon his appointment, although nothing of an authentic nature has yet been given out.

Mr. Shaver is very popular in labor circles, and is well qualified for the position. At the convention held in this city last May, he ran a close race for the position, the successful candidate defeating him by only 10 votes.

Wants Memorial Building in City Park.

MAKE IT PERMANENT

Would Make Use of It for an Art Gallery and a Museum.

"I would like to see the memorial building which is going to be erected in memory of Messrs. Lewis and Clark in connection with the Lewis and Clark Fair, built in the City Park and made a permanent building."

This was Judge George to a Journal reporter yesterday afternoon. Continuing the judge said:

"I would like to see the building made permanent, and built of such material that it would be a lasting monument to the heroism and bravery of those two men. This cannot be done by erecting it on the site of the fair which is leased ground. If erected there it will be built of cheap material and torn down soon as the fair is over and Portland and her people will not receive the permanent benefit they would if the building were erected in the City Park, in such a substantial manner as to last, not only during our lives, but through those of future generations."

PLENTY OF GROUND.

"There is ample room in the City Park for the location of the building. The city has 60 acres adjoining the 40 acres now enclosed as a park on the west and south side of the city. If the city thought best, and indeed, it would be a good idea to do so, as more ground could be devoted to the surroundings. The location in my judgment would be an ideal one for many reasons. First, it affords the interest and beauty of the city, showing the Columbia and Willamette Rivers and our splendid harbor, but of the surrounding country. To make the building a permanent one and locate it here, would give the people of every visitor who came to Portland and the impression they would thus form of the City of Roses would be one of everlasting remembrance."
