SUIT TO RECOVER ATTORNEY'S FEES

Due Account of Litigation in the Skinner Will Contest.

SALEM, Nov. 1.--In the city recorder's court yesterday, the case of W. H. Holmes, plaintiff, vs. T. W. Wann, a Folk County farmer, defendant, was tried before a jury. The action was brought to recover \$150 attorney's fees, alleged to be due from defendant on account of litigation in the Skinner will contest, recently decided by the Supreme Court. The day was consumed in the trial of the case, and late last night the jury brought in a verdict for the defendant. This is the second suit of this character growing out of the litigation over the Skinner will, another one being at issue in the Circuit Court, in which Webster and Frank Holmes are plaintiffs.

SUIT FOR LOT OF HOPS. George A. Layton, a hop dealer, yesterday filed a suit in the Circuit Court here for the recovery of 40 bales of hops from

J. R. Kaser, the Southern Pacific Company and Collidge & McClaine, defendants. The plaintiff alleges he made a contract with Kaser to purchase his hops at 10 1-2 cents a pound; that he had paid the 10 1-2 cents, and defendant Kaser had, according to agreement, hauled the hops to Silverton, when he heard of the recent decision, made by Judge George H. Burnett, regarding hop contracts; that the defendant at once turned the hops over to Collidge & McClaine, the Silverton bankers, who in turn stored them with the I. P. Co., Kaser in the meantime coming to Salem, where he tendered to plaintiff's agent the 10 1-2 cents a pound, which money was refused. The complaint was filed at 9:30 o'clock last night and the papers were served on the railroad company's agent at Salem, William McMillan, the hops being stopped in transit at Woodburn last night.

J. Carmichael yesterday purchased 120 bales of choice hops at 25 cents, for the English market.

THIEF HE KNOWS THIEF. Sheriff E. E. Colbath yesterday received a letter from Col. G. A. Goodlie, of the Seventeenth U. S. Infantry, of Vancouver Barracks, asking for information relating to one C. S. Mansfield, recently arrested in Portland under the name of J. M. Burroughs, with an alias or two, for stealing a team from Woodburn, and who is held in jail here awaiting action by the Circuit Court. Col.

Goodale asks to be kept informed as to the fellow's sentence, as he is an escaped military prisoner and a deserter, and is wanted by the military authorities whenever the civil authorities are through with him. Mansfield, or Burroughs, as he calls himself, is wanted in a number of places, and will be busy for some time to come, atoning for his misdeeds.

HALLOWEEN NIGHT. Halloween was fittingly celebrated in Salem last evening. St. Joseph's Literary Society celebrated the event by a party at St. Joseph's Hall, adjoining the Catholic Church; the Baptist Young People held a similar gathering at the home of one of their members in North Salem; the Woodmen of the World and the Women of Woodcraft spent the evening in their lodge room enjoying a seasonable party, and another gathering was held at the College of Music, Willamette University. Aside from these, small parties went over town, and the usual Halloween pranks were indulged in. Cows were tied to front doors of residences; woodpiles, ladders and other movable articles were overturned or dropped in the mill race at various points; an old threshing machine in the suburbs was placed across the street car track and wagons and buggies were hoisted on the roofs of buildings. In several places, early this morning, sidewalks were found barricaded with fences, that had been mysteriously and noiselessly moved during the night, and the city has a general apprehension of delapidation, as a result of the pranks of the small boys and their bigger brothers and sisters. The citizens generally are thankful that the trial is over and will not return for a whole year.

CIRCUIT COURT AT EUGENE.

EUGENE, Nov. 1.--An adjourned or preliminary term of Circuit Court convened in Eugene yesterday afternoon, the regular November term convening next Monday. A large number of civil cases are disposed of at this adjourned term, thus making the regular term much shorter. The sessions of the Court this month will probably be lengthened considerably, on account of the trial of Bert Heaton for the murder of Benton Tracy, a bartender at Junction City, last May. Considerable interest is taken in the case, as Tracy was a well liked and popular man at Junction, and several other Oregon towns. Heaton's father is here and has employed L. Blyden, one of the most prominent attorneys in Eugene, to defend his son.

The Eugene High School football team defeated the team from the Drain Normal School this afternoon on the Kincaid field with a score of 52 to 0. The Eugene boys made long runs at will, while their opponents were unable to advance the ball at all.

ENDS UP IN A SQUABBLE

Oregon City Printers' Strike Causes Trouble for Arbitrators.

OREGON CITY, Nov. 1.--There is excitement for everybody connected with the printers and printing houses. After a vain attempt to do business yesterday afternoon, the arbitration committee, composed of Charles Albright, J. M. McGlashen, and George F. Hixon broke up in a fine squabble and two members resigned.

When the committee met in the office of U'Ren & Schubel, it was their intention to examine each and every person who wanted to be heard, but they wanted to conduct the examination privately and as they saw fit, according to the papers which were signed by the union men and Mr. Porter. One man, Foreman Dreyfus, of the Enterprise, had been questioned and dismissed when two men from the union went into the room and asked to be allowed to hear the testimony and ask such questions as they

saw fit. The members objected and that was the end of the meeting. After many sharp remarks had passed, Mr. McGlashen resigned, saying that he had come to settle a row, and not be a party in one.

Dr. Carl was asked to serve in the latter's place, but he refused unless he was given a chance to help appoint the third member of the committee. Mr. Horton then withdrew and Jack Moffat was asked to fill the vacancy. These two new members, with Mr. Albright, will meet tomorrow morning and try to complete the work started at the first meeting. The whole row was the result of a misunderstanding.

When daylight came this morning a large "scab" sign was stretched across the front of the Enterprise office, but it was soon taken down by order of one of the union men.

STRIKE IS OVER.

LANSING, Mich., Nov. 1.--The faculty of the Michigan Agricultural college has taken up the striking student question here from the opposite side from former action, and have submitted a proposition for the pupils to return to their work, the faculty agreeing to appoint a new committee to hear their grievances. The scholars are back at their desks and a peaceable solution to have been reached.
