

MERCHANTS WAKING UP

Board of Trade May Get to Work

To Capture a Share of the Big Alaskan Opportunities.

(P. E. Beach of P. E. Beach & Co., President of the Board of Trade.)

Alaska trade is a question of the greatest importance to Portland, much more so than has been generally appreciated, although the merchants of Portland are beginning to realize the magnitude of the business done with Alaska and that a large part of this could be handled from Portland to better advantage than any other Pacific Coast port. The Board of Trade gave the matter considerable attention early in the season and the committee having the matter in charge reported at that time thirty steamers advertised as sailing from different ports, some making two trips a month. Some were tramps and a number small crafts, but the most were of good size and on regular runs with large carrying capacity, both freight and passenger. At first it seemed incredible that so many steamers could secure business, but on estimating the population it was found much larger than generally supposed, as the Northwest Territory also draws supplies from the Alaskan ports, and as the country produced no supplies everything had to be imported. Oregon produces a large part of the food products and is the best market for the buying general supplies. And all that is lacking for Portland to secure the larger part of this trade is favorable steamer connections. There are some indications this line will be established by one of the large transportation companies. If this is not done, or a line provided in some way, it is the intention of the Board of Trade to again take the matter up, as it is generally considered that the best interests of Portland require a regular steamer line to Alaska, and the assurances which we now have from business houses promise that our next attempt will be successful, as the Portland of today stands ready to take hold of the Alaskan steamer line or any other project that the business interests of the city demand and furnish all means necessary to make it a success.

WEATHER FORECAST.

The Cape Flattery storm is moving slowly southward. "Storm northeast" warnings are displayed at all stations in this district. The following maximum wind velocities occurred during the last 24 hours: North Head, 52 miles S.E., and Nehalem Bay, 30 miles E.

EUGENE, Nov. 8.—The jury in the Heaton murder trial returned to the courtroom at 3:30 o'clock yesterday afternoon and gave a verdict of murder in the second degree.

The affair was a splendid success, the evening being passed in exchange of pleasant reminiscences until Romeo Rhodes presented Mr. Mellem with an exempt certificate handsomely framed. The veteran was warmly congratulated on his long and faithful service, which ended the evening's entertainment.

Ethel, the infant daughter of W. H. Young, died during the night of a disease known as marasmus. Funeral arrangements are being made for an evening service, which will be held tomorrow afternoon from the house.

About 20 of the young friends of Beldon Ganong tendered him a surprise party at his home in the city last evening. The evening was quickly passed in playing games and other amusements until refreshments were served. The guests then departed for their homes after warning their host against future surprises.

ROSEBURG, Nov. 8.—W. F. Harvey, a well-known resident of this place, died here yesterday after a brief illness, aged 81 years. His wife, with whom he was wedded over 38 years ago, passed away only last Wednesday, and the shock occasioned by her death, combined with general debility attending old age, was more than he could bear. Mr. Harvey and his family came here from Nebraska about 14 years ago. They leave two sons, Frank and Will A. Harvey, and several grandchildren to mourn their loss.

DEATH OF WELL KNOWN YOUNG MAN

John Savage of Salem Passes Away as a Result of Typhoid.

SALEM, Nov. 8.—John Savage, a young drug clerk of this city, died at the Salem Hospital yesterday from typhoid fever after an illness of but two weeks, aged 19 years. His case was not considered of a dangerous nature until late Thursday night, when peritonitis set in, and he died rapidly. His father, George Savage, is a resident of North Salem, and a pioneer of Marion County. He also leaves two sisters to mourn his demise. He was a member of Protection Lodge No. 2, A. O. U. W., and of Oregon Cedar Camp No. 2, Modern Woodmen of the World. The funeral will be held from the family residence on Sunday, at 10 a. m., under the auspices of the two fraternal societies.

MARION COUNTY TEACHERS.

The Marion County Teachers' Institute completed its three days' session in this city last evening, after one of the most successful gatherings ever held here. The total enrollment of the institute was 220, the teachers coming from every portion of Marion County. The last day's session was made peculiarly interesting by the excellent addresses delivered by Prof. S. Y. Gillan, of Milwaukee, Wis., who held the attention of the teachers to the last by an explanation of his original method in teaching "the young idea how to shoot." The management is very much pleased with the success of the institute.

The County Court today appointed C. W. Younger, of Silverton, Justice of the Peace for the Silverton district, to succeed C. W. Kenney, resigned. The court has spent the past three days auditing bills and examining into road matters.
