WEATHER FORECAST.

A disturbance of great magnitude and decided energy is central this morning over British Columbia and the British Northwest. It has caused general rains in the North Pacific States and southerly gales along the coast and high, gusty winds in the interior.

The following maximum wind velocities occurred during the last 24 hours: North Head, 50 miles; Seattle, 32, southwest; Astoria, Tacoma and Spokane, 30, southwest; Pocatello, 36, southwest; and Winnemucca, 38, southwest. The winds are from Cape Plattery and Eureka and the reports from these stations are missing.

Southwest storm warnings are displayed at the mouth of the Columbia River, Aberdeen, Strait of Juan de Fuca, Bellingham Bay and Puget Sound.

It is much cooler in Northern California, and sharp fronts are reported in the Sacramento Valley. The indications are for occasional rain and high, gusty winds in this district tonight and Tuesday.

THE RIVER.

The river at Salem has risen four feet during the last 24 hours, reaching a stage of 10.8 feet at 8 a. m. today. At Portland the gauge read 7.7 feet this morning, a rise of 1.7 since yesterday. The present rains will cause a further rise of two or three feet.

Tonight and Tuesday, occasional rain; cooler southwest portion tonight; with brisk to high southwest winds, with southwest gale along the coast.

TWO KINDS OF MISSIONARIES

Bishop Rowe of Alaska Speaks of Them.

Insincere Workers Who Forsake the Gospel for Gold Do Harm.

The Rt. Rev. J. T. Rowe, who has for seven years been Bishop of the Episcopal Church in Alaska, is registered with his family at the Portland. Bishop Rowe has been all summer in the vicinity of Nome and is now returning to his headquarters at Sitka.

"It seems strange that I should have to come so far South to get back to another part of Alaska," said Bishop Rowe this morning "but owing to the way the steamships run it is really the quickest way."

SENTIMENT AGAINST MISSIONARIES.

"I know that there is a considerable sentiment among the laity against much of the so-called missionary work done in the North, and this has frequently made it difficult for us to procure young men to carry out the work. This sentiment I think is due very largely to the numerous instances in which missionaries have abandoned the preaching of the gospel as soon as they could find a paying gold mine."

"Knowing this, I have in recent years spoken strongly to intending missionaries on the subject. I have said in substance: The church is not willing to pay your expenses and a salary to send you into the interior of Alaska to hunt for gold or to start into commercial enterprise. If you feel that you desire to engage in these pursuits you must go to Alaska as other men go. The church desires as missionaries only those who feel that they are willing to devote their life to the uplifting of the people among whom they work."

"And," said Bishop Rowe, "I do not think that Episcopal missionaries have attained any fame as discoverers of new gold fields, promoters of reindeer herds or as politicians. The harm done by pseudo-missionaries in Alaska, who have entered these pursuits, is incalculable and reflects on the little band of workers who are sacrificing a lifetime in the wilderness."

CAPITAL WILL BE MOVED.

"Under present conditions, Juneau will be the next capital of Alaska, Sitka, the present seat of government, is too far removed from ordinary lines of travel. But I do believe that the claims of Valdez should be considered. Valdez is the logical gateway to Alaska, and the way to the interior. The harbor is deep, and the point is readily accessible, and should a railroad be built from that city as seems very probable, there can be no legitimate argument on the subject. I am not interested in Valdez," said Bishop Rowe, "I have been many years in Alaska, but no one can tell me with any gold mines. That is not my business."

Portland has displayed too much of the pettishness of a child of late. Go on with the preparations for the Lewis and Clark Exposition and accept with thankfulness the Legislature's appropriation. Instead of threatening on the one side and soft-soaping on the other, act like sensible men, draw out the Legislature, fix upon an estimate of just what sort of a fair it will be, and go to the Legislature like dignified gentlemen. Before making the journey to Salem, let the committee selected for the trip make up its mind whether it will or might ask for \$500,000, it will never get it.—Aurora Borealis.

They Want to Know.

It would be better for Portland if she would spend the time between now and the meeting of the Legislature in regular session next winter in educating the people of the state, by showing the benefits to be derived from the exposition and the need of a large appropriation to carry out the project, than to call a special session and attempt to force a half-million dollar appropriation before the people have been brought to a realization of the magnitude and benefits of the enterprise. There is such a thing as putting out the fire that provides the heat in the incubator with the golden eggs.—Union Republican.

Wants a Small One.

It is certainly possible for a person to be very loyal to Oregon and yet not favor making a very large appropriation for the Lewis and Clark Exposition. Had the last Legislature proceeded along economical lines instead of passing more graft measures than had ever passed before the people of the state would be in more of a humor to permit a large appropriation, but just after having paid the unreasonable fee of \$7,000, about twice what a state tax levy should be, they are not so much in the humor for a \$500,000 appropriation, in fact it is doubtful if a majority of the people of the state would be so much interested in the proposition for more than \$100,000 for the purpose.—Albany Democrat.

TO REPAIR WITH CABLES

City Engineer Says the Willamette Bridge Can Be Repaired.

City Engineer Elliott has prepared an approximate estimate of the cost of repairing the Willamette Heights bridge, and finds it can be done for \$150,000, which will put it in condition for use for several years. The plans are to use four cables for supporting the bridge, thus doing away with the substructure. The cables will cost about \$400, and the necessary amount of timber to be purchased and the labor required would make up the \$150,000.

There is no money in the city treasury to make the repairs, but it is thought the Portland City Railway Company and the Portland City Light and Water Company will contribute the most of it and the city would appropriate the balance.

The bridge was erected by the late John Hale at a cost of \$100,000, and was donated to the city.

SAYS HE BROKE ENGAGEMENT.

Thomas J. R. Nicholson filed an answer in the state circuit court Saturday afternoon to the suit filed against him by Miss Lois Stevens for \$50,000 damages for breach of promise. He enters a general denial and pleads a release from the engagement.

Nicholson answered his answer that in August, 1901, he asked Miss Stevens to be his wife at that time in the future, provided they continued to be pleased with each other. He alleges in his complaint, however, that the engagement was broken off by mutual consent in 1901.

MINOR COURT NEWS.

A damage suit for \$200 was filed in the state circuit court Saturday afternoon by W. H. and Mrs. L. Wilson against M. Cagellito, Consable A. M. Cook, Constable A. B. Roemer and the Delicate Trading Company. The suit is the outgrowth of an attachment of furniture in the City View Hotel on August 16, 1902.

The jury in the case of J. P. Finley, guardian of Leo Patterson, Jr., against the United Assurance Co., returned a verdict for the plaintiff in the sum of \$1,900.

William Bayne has filed a suit in the state circuit court against Lizette Cotterline to recover \$300 on a note.

Ray Debnair filed a mechanic's lien suit in the state circuit court Saturday afternoon against N. M. Davis and L. M. Davis et al. to recover \$261 for grading and filling two lots in Central Albina.

Rose Jost has filed a suit for divorce from her husband, Charles Jost, alleging desertion in July, 1901. Mrs. Jost asks for the custody of the four minor children.

The suit of the Goodale Lumber Company against the Congress Construction Company, which was on trial before a jury in Judge England's court Friday and Saturday, resulted in a verdict for \$70 for the plaintiff.

NEW CLUB ORGANIZED

Its Motto Is "Don't Give Up Your Seat."

WAR AGAINST THE FAIR SEX

Will Not Show Them Courtesies on Street Cars.

A "Don't Give Up Your Seat" Club is the latest organization in Portland, and it gives promise of having a very large membership within the next few days.

Its organizers and adherents have experienced considerable trouble, it seems, in retaining their seats on the street cars while returning to their homes in the evenings. They claim that if they are fortunate in securing decent seats a troupe of good-looking women invariably put in an appearance and look longingly in their direction. The gallant act is the only thing remaining to be done, and before they fully realize what has transpired the weary men are hanging on to their seats while the fair ladies are occupying their seats in sweet contentment. It is said that this sort of thing has gone on long enough, and that an immediate warfare is to be declared against the practice. It is the intention, they say, to proceed in a bold manner, and bring about the reform, and the best way which has suggested itself was to form an organization for mutual protection.

TAKE UP ONE ROAD.

One of the members, in speaking about the new club, says:

"The street cars running up Fifth street are little, wobbly affairs at the best, and if a passenger gets a seat he is not receiving very good accommodations. But when he has to give this up to another patron of the road, just through foolish sentimentality, and be jolted up and down all the way home, it is time to call a halt. Common sense should take the place of idocy. When clerks and other laboring men are returning home from a hard day's work it is exasperating in the extreme to have some woman, who should have been at home an hour before looking after her household duties, come in and almost stare you out of a comfortable position. It seems that a majority of the women who are riding just on purpose to return home on the cars that the various employees usually go on."

HOW IT IS DONE.

"Our plan is simple and will undoubtedly prove very effective. We are having emblems made which all our members will wear. They consist of buttons on which will appear the picture of a blue-pot. This will be suggestive of stolidity, or don't give up your seat. When the sweet young thing comes tripping through the car, or the more experienced matron, casting furtive glances here and there, she will most certainly grab a strap when her eyes fall upon our self-explanatory buttons."

"Of course, our hearts will melt toward a woman carrying an infant, or an elderly lady, but to no others will any concessions or considerations be made whatsoever. We will be as adamant, even if we have to sacrifice golden opportunities of winning charming brides. We have taken a solemn oath to be true and loyal to the cause, let the results be what they may. It may be the means of dooming some of us to a life of honorable bachelorhood, but it cannot be helped. We are in the fight to gain a great principle. The opening battle will be fought on the Fifth street car line, and from there the war is expected to extend to every road in the city. It is men against women, and will require more nerve than was ever exhibited on the blood-stained battlefields made memorable in song and story."

"Yes, we are up against the real thing," he continued, after a reflective pause. "I am getting nervous already. Let us go in and have a drink."

"No, I must go," answered the reporter. "Good-bye, I hope you will not be killed in this skirmish."

BIG RALLY OF GOOD CITIZENS

Resolutions Adopted Denouncing Vice and Upholding Law.

A good citizenship rally was held by the Young People's League of several churches yesterday afternoon in the First Baptist Church. The meeting was largely attended and was addressed by the following: Rev. E. L. House, pastor of the First Baptist Church; Rev. Edgar P. Hill of the First Presbyterian Church, and W. H. Stone, General Secretary of the Young Men's Christian Association.

In his address on "Standing Against the Devil," Rev. House made a strong plea for the closing of all the houses of ill repute, gambling houses and all others in which vice is rampant. He made a vivid contrast between the environments of Ralph Waldo Emerson and Samuel Barrett, the all-round thug. He proved that Emerson could not help being what he was because of his birth and surroundings and Barrett could not help being what he was because his father was a thug and his mother a prostitute, and from early life he was associated with the lowest of mankind.

Rev. Hill followed in a speech in which he scored the law for allowing proven gamblers to go free and roared the so-called Law Enforcement League as being a wolf in sheep's clothing. Mr. Stone then spoke and said that what is necessary is action on every body to do anything with support of the 1,500 members of the Y. M. C. A. to law and good order.

At the conclusion of Mr. Stone's address resolutions were adopted pledging themselves to elect only good men to office, appealing to the people of this city to observe the law, commending the present city administration for its efforts in suppressing vice and thanking the newspapers for their actions against the gambling evil.

TWO YEARS IN PENITENTIARY

George Hammond, the young man convicted in the state circuit court for stealing a pair of pants from the store of the Salem Woolen Mills, was sentenced by Judge George Saturday afternoon to two years in the penitentiary. Hammond was before the judge some four years ago on a similar charge when leniency was shown him on account of his youth, and an appeal from his attorney this time for leniency was unavailing. The court said he should have profited by the first lesson.
