LETTER FROM LOSTINE. "Dear Sir: We have saw notice in our town paper about your work. We live in this dry hill land about the center of Wallowa County. Here is a scope of country 30 or 40, yes, perhaps twice as many square miles of high, dry land,

which is really a richer loam and freer from frost than the lower valley lands, and if irrigated would be more productive. The upper Walla Walla River or Wallowa Lake is high enough and would afford water enough to water much of it again. Many of the ranchers here suffer for water for solves and stock. Will you please have Mr. F. H. Newell visit this section? I speak the views of the farmers here. Let us know what further steps to take."

ANSWER OF MOORE. The answer which Mr. Moore sent is as follows: "Replying to your postal of 18th to Mr. Dovers. If you will send me a map of the country that can be irrigated, showing the government and private lands, the area of storage reservoir, size of dam required, material convenient for building dam, number of miles of canal necessary to reach land, rock work, rainfall, area of country drained, etc., prices which contracts could be let for constructing dams and canals, either by yard or mile, etc. With this information and a good irrigation map, it is probable the government engineers would give it a thorough investigation."

SAULT LAKE, Nov. 25.—Another case of poisoned candy being sent to a person whom it was desired to put out of the way has occurred in California. Unlike the famous Hotkin case, this time it is politics that supplies a motive for the crime. Dr. M. M. Enos is the victim and the poisoned candy was sent him a month ago while he was a candidate for being a physician. Enos' first thought was for an antidote. He mixed a potion and gave it first to the woman. That delay probably cost him his life, as it is admitted he cannot live, while Miss Cooper will recover.

There is absolutely no clue to the perpetrator of the crime. An inspection of the candy brought to light the fact that each piece was plugged and a large quantity of deadly poison inserted in the chocolates among the working. It is generally admitted that some political crank adopted this means of securing Dr. Enos' defeat in the election. He is a strong labor advocate, and has many warm friends among the working classes where he has been very generous of his medical aid.

SALT LAKE ROBBERS.

SAULT LAKE, Nov. 25.—An epidemic of robberies occurred here last night. Six hold-ups were reported from different sections within a few minutes, and one grocery store was robbed by masked men while its proprietor was terrorized at the muzzle of a revolver.

MAY BE MISTAKE.

OAKLAND, Cal., Nov. 25.—T. Lawrence Christensen, a chemist, is now suspected of the responsibility for the poisoning of Dr. Enos. The police believe the candy was not prepared for Enos but was intended for Christensen's sisters, with whom he is at war over their father's estate. How Enos happened to possess it is not yet explained.

EIGHTEEN MONTHS FOR FASS

Judge Sears sentenced George Fass to 18 months in the penitentiary, late yesterday afternoon for stealing an overcoat in the St. Charles Hotel on November 8. Fass pleaded guilty, saying he might as well be hanged when the deed was said to have been committed and could not tell whether he had stole the coat or not.

APPEAL FOR SMITH.

A notice of appeal was filed late yesterday to the Supreme Court in the case of George Smith, the negro sentenced to be hanged December 19. His attorney asks that the testimony in the case be transcribed without cost for the benefit of the prisoner. Smith is without money and in order to get a new trial, an expense of \$150 will entail for a transcript.

WANT CHINESE.

Honolulu Merchants Want Asiatic Labor in Hawaii.

HONOLULU, Nov. 25.—The Merchants' Association has addressed a memorial and sent it to each labor organization in the islands asking aid in a movement to secure the admission of Chinese to this country as "agricultural" laborers to process the sugar industry, which is now at a low tide and is causing great business stagnation. Congress will then be asked to admit the Chinese.

Violated The Terms of His Peace Bond and Is in Jail.

W. H. H. Reed, the Corbett fish wheel operator, who has for the past month been a spectacular figure before the public, was re-arrested last night by Deputy Constable Adams, for hanging around the house of Mrs. Jennie Lawson. In the first place Reed borrowed \$1,000 from Mrs. Lawson to go into the fish business. This he refused to pay when due. The woman threatened to bring action against him, when Reed gave her assurance that if such a course was pursued he would kill her. The woman became frightened and had him arrested for threatening to kill her. Reed was placed under a bond of \$200 pending a hearing. When the case came up for trial before Justice Reed it was found the man had made his escape. About a week ago he showed up and was again arrested. He was released on another bond several days ago, with the understanding that he was to keep away from Mrs. Lawson. Last night he called and threatened the woman, and the arrest followed.

LETTER FROM MR. MITCHELL

The following letter regarding the enlargement of the local postoffice was received by Postmaster Crossman this morning from Senator Mitchell: "WASHINGTON, D. C., Nov. 19, 1902. "My dear Mr. Crossman: "I have had a full conference with the supervising architect in regard to the postoffice building. The objection he makes to your plans is, that if adopted, it would present a building without architectural proportions and would therefore be an eye-sore, especially to all who understand the principles of architecture. "The department, therefore, has determined on plans of their own, which they have already prepared, and which will present a building nearly square in form, and in which, I think, splendid arrangement will be made for all the offices. "It will therefore be necessary, as the department wrote some time since, to secure a building for the postoffice and other offices now in your building. I think it advisable, therefore, to send or at the earliest possible moment any recommendations you may have to make in regard to another building. "The postoffice building will be under contract, but the work will hardly be commenced before early spring. "Yours very sincerely, "JOHN H. MITCHELL."
