

THE BIG HEAVIES PLAY IN SECRET

Tapering Off Practice for Contest.

Multnomah Will Put Up a Grilling Struggle on Thursday Afternoon.

"Mum is the word." Thus say Coach McMillan of the Multnomah team and Coach Dolph of the U. S. team. That is to say, the practice for the big game on Thanksgiving is from now on to be strictly secret. Nobody but the coaches and substitutes will be allowed to see the players go through their final maneuvers. This rule is almost invariably adopted before each important game of the season. Not that either team thinks that the other would act so dishonorably as to spy on the other, if chance offered, but that the enthusiastic supporters of each team let their enthusiasm get the better of their caution and talk too much about what kind of form their teams are in and what sort of plays they expect to rely on to win.

That Multnomah expects to have the fight of the season next Thursday is evident from the diligence with which the boys are practicing. Every night for two hours they go through the stiffest sort of sparring practice, running as hard as if they were battling against U. S. O. instead of an imaginary foe. Real bucking and tackling will be eliminated from the practice from now on, because of the danger of injuring some of the team in the last minutes. The main attention of the coaches is now being turned toward removing the few irregularities which remain in the team work, and toward getting each man in the best possible physical condition to stand the severe strain of the game. What that strain means physically to a player is shown by the fact that in the recent Yale-Princeton game some of the players lost as much as 12 pounds in weight, that amount when it was thought they had every ounce of superfluous flesh reduced and its place supplied by muscle.

EUGENE IN GOOD FORM.
Eugene will undoubtedly come down with them in the pink of condition, ready for the game of their lives. Heretofore, Eugene has always been "hot" some time before the Thanksgiving game, and consequently has been likely to go a little "stale." But this year they have rounded into form slowly, keeping ever in mind the thought that the great test is to come next Thursday, and that they must be "right" on that day and not before.

WILL NOW DO BUSINESS.
ALBANY, Nov. 25.—After weeks of squabbling and misunderstanding, the Albany eleven has accepted the challenge of the Corvallis Farmers for a game of football to be played on December 3, on the local grounds. The idea of the Corvallis players was to contest on some neutral field, but the Albany boys had heretofore played at Corvallis and they figured that it was due them that in the pending game the eleven meet them on their own campus.

PORTLANDS AND SCOTTS.
Tomorrow afternoon the Bishop Scott boys and the Portland Academy will play their last game of the year on Multnomah Field. Both teams have been practicing faithfully and are in the pink of condition.

DANNY MAHER'S GREAT RECORD

LONDON, Nov. 25.—The American jockey, "Danny" Maher, who sailed on the Celtic today for New York, has the record for the highest average of wins in an English season.

"I have been more or less restricted by physical conditions in securing mounts, which I believe would have increased my average," said Maher, "but I am quite satisfied with 106 wins out of 400 mounts. I must say I cannot allow myself to sympathize with the complaints some of my fellow American jockeys have made against English turf methods. As far as I am concerned, I have always found English racing men to be true sportsmen, and I have had no trouble at all in having been with Americans quite as often as with English jockeys."

PEACOCK FEATURES.
"My racing season has been a number of peculiar features. For instance, the fact that I won five of the most important races on Rockland and that I never lost a race with him. This is probably without precedent. I did almost all my racing with Flotsam, on which I beat my old mount, Rockland, in the most sensational finish of the season."

"As these two horses are now the favorites of the Derby in 1933, and I believe they are the best 2-year-olds in England, I hope to bring one of them home first in that race. My wins of the Eclipse stake, value \$50,000, on Cheers, and the Champion stakes, value \$25,000, on Rebels, both at Sandown, helped to make up the sum of \$200,000 which I secured for my employers during the season."

"I propose to remain in the United States until March, when I will return to England to ride for Sir Daniel Cooper, Sir James Miller and Lord Cadogan."

MIDWEIGHT CHAMPIONS DUE

Bunch Being Weeded Out in This Class.

Best Man Will Be Brought to the Fore as the Result of Recent Contests.

Gradually the ranks of the middleweights, or light heavies, are being thinned out, and before long the leader of this class will have been pretty well determined.

Tommy Ryan, when he beat Kid Carter, showed himself a good man and since that time Carter has had his measure taken by Jack Root, and now Root has beaten another man in his class, Marvin Hart, the Louisville fighter, who a short time ago was proposed as an opponent for Kid McCoy. Many admirers of the former Syracuse champion believe that if Ryan would permit Root, Gardner and others of his class to meet him at catch weights, he could defeat them handily, but as Tommy insisted that Carter come to 135 pounds before meeting him there is little hope that the Kansas City boy will ever meet the other men at higher weight. Consequently, casting about for a man to defeat these half middleweights, one turned out full back on Kid McCoy, practically thrice the conqueror of Ryan.

If McCoy is still in the boxing arena he should be up and doing. Some time ago he was mentioned as a ring probability, but nothing came of his proposed match. Now there are rumors to the effect that the Hoosier will not go into training again for battle. Even if he did, much would depend on the outcome of his first appearance in the ring. It will be remembered that after showing a flash of his old-time form in his bout with Carter in Philadelphia, McCoy was banged all over the ring by the Brooklyn man, and finished in bad condition. It may be that the Kid's fighting days are over. The Root-Hart bout at Chicago was a vicious affair, and both men finished badly banged up. Hart gained distinction for his grand exhibition of gameness which, after all, is but a poor chance for a fighter to devote his attention to. Root seemingly can fight scientifically, and can also slug if needed, but even Chicago sports admit he seems to lack the delicate finishing touch of either Ryan or McCoy.

TOMMY REILLY IS IN THE CITY

Victor in Tremble Bout Is Visiting Relatives.

Tommy Reilly, who put Ben Tremble out of business in the eighth round before the Northwest Athletic Club at Seattle last week, is in Portland visiting relatives. His decisive victory over Tremble has elevated Reilly a good many points in the estimation of Northwest followers of fistiana. At no time did Tremble have a look-in at the long end of the purse. Reilly showed up a great deal better than he did when he fought Gibbs. He was cool and confident at all stages and did not take so many chances as of old, to knock his man out. That is, he kept himself well covered up from the possibility of a chance blow.

The Seattle Times, in this connection, says: "Reilly was certainly trained to the hour. He looked perfection, physically, when he crawled through the ropes. When the fight was over, save for a very slight swelling under his right eye, there was not a mark on his body to show that he had been engaged in a flat encounter. He was very strong throughout the battle and made the best impression of his class."

"Reilly, while apt to be a little mean in the ring at times, undoubtedly has a future before him. It all depends upon himself just to what heights he will soar. If he becomes a contender, there is no reason why he shouldn't be fighting top-notchers before many months. He wants to stay clear of the rich and rosy path, that's all."

A battle between Neil and Reilly ought to be a great drawing card. Frank Kelly has received a telegram from San Francisco suggesting a meeting between the boys in that city. Should Reilly defeat Neil, who recently gained the decision over Young Peter Jackson, it would attract the attention of the sporting world to him. In Neil he would have the hardest fight of his life and might not win. A creditable showing, however, would be a great boost to him."

BOXING BOUTS FOR PORTLAND

Dal Lampman Trying to Form a Circuit.

Sparring Matches to Be Held Here and at Seattle and Tacoma.

Dal Lampman, manager of the Olympic Club of Seattle, is in the city, and hopes to be able to secure police permits for a series of prize sparring contests which he intends to hold here this winter. Lampman has a scheme along the fighting line, that is certainly unique and original. He hopes to pull off a series of fights in Seattle, Tacoma and Portland. He believes, should he be able to secure those three cities, he will be able to offer inducements to Eastern talent that will do the game a great deal of good here.

On the night of next month he will hold his first show in Tacoma. Young Gibbs and Jim Williams furnishing the card, and also next month he expects to meet Mysterious Billy Smith against some good man in Portland. One of Lampman's men, Kid Fredrick, is now in Butte, Mont., where he has practically concluded arrangements for a fight with Jack Clifford of that city. After this go with Clifford, he will go direct to San Francisco, where he has a frame up with Kufe Turner, who will match him with some good lightweight in that city.

Since the dropping out of Jimmy Morrison of Seattle from the management of the Northwestern Athletic Club, Lampman has taken upon the original plan of Mr. Neill and Reilly, namely, December 15, and upon that night Young George Gibbs will be given the opportunity to relieve his lost laurels. His opponent will be Chicago Jack Daly, who is well known in the annals of the ring. Daly will leave Chicago for Seattle probably by the middle of next week and will put on the finishing touches to his training in Jerry Sweeney's gymnasium.

In the meantime, however, Gibbs will be sent against Jimmy Williams of Los Angeles, the bout to take place in Tacoma. According to Phil Snowden, Williams has a great record and should have an even break with the colored boy. If by any chance Williams should submit to a fight with Gibbs he will be pitted against Daly.

Lampman says if he can he will match Reilly and Neill to fight at some point in the Northwest in January. Arrangements are being made for a match between Kid Blood and Herrera.

HERRERA AFTER MATCH.

Biddy Bishop has written Mr. Lampman for a match for Herrera. He says: "I want to match my boy, Herrera, with some good man in the ring. He is a good man at the weight, or, in fact, weeks to train he will agree to do 125 at 3 o'clock. Now I feel that the best man at that weight in the business is a man named Billy Williams. He is a man that will stand up and wallop with him. He is very aggressive and will please the Northern sports. I also have Maxey Haugh, the Brooklyn featherweight, who is a real fighter. He will meet Harry Foley. Both are good men. Burns will meet either Tremble, Reilly or Neill after his fight here. I have almost completed arrangements for Herrera to meet Ben Jordan in the city of Los Angeles. I may have my own club in 'Prisco. Oh, yes, Dave Sullivan would be a good card with Herrera."

TEAMS FOR BIG BICYCLE RACE

Preparation for Great Six Day Wheel Contest.

Interest in the coming New York six-day race is bound to center around McFarland and Maxa this season as being the team most likely to win the contest. This was the winning team in the Boston six-day race of last winter, and is the only team from the three races of last year which remains intact for the big contest. For some reason or other, the teams in these six-day races do not come together a second time, and the interest and speculation in the races are much heightened in this way.

Elkes, the partner of McFarland in 1930, when he put down the big race, is teaming with Bald for this year's contest. Inasmuch as "Eddie" Bald has been winning steadily in Europe, the team becomes a factor in the struggle. Wilson, the partner of Maxa in the second place last winter in New York, is not figured upon as a starter at all. Walworth is not to go, and his mate in first place last year, McEachern, is dead. Munroe, who was third with New York, is not to start. Newkirk is mated with Jacobson, and New Haven unpaired rider, Babcock will not start, and Turville, his mate in the fourth place, is reported to be mated with Butler, who, with McLean, gained fifth place last year in America for the winter. King has no mate yet, and Sam-Johnson, his partner in the sixth position, is coming East with John Chapman to compete as a team. Of the foreign teams many will be charged to the ground, as such as Fred, Charles, and George Gascoyne, and Bruni and Wattill will come together from France.

There will be several other teams from Europe. In all, about 20 teams will start in the contest, and these will be of far better quality than any former entry list. Europe sends its best, and America will pit its best men against the men from across the water.

COAST TO COAST AUTO HIGHWAY

Scheme for Building of Such a Road.

Bill to Be Introduced in Congress for a Large Appropriation.

NEW YORK, Nov. 25.—Extending across the entire country, starting in Boston and concluding at San Francisco, there should be a national highway, according to the American Automobile Association, which decided at the session of its board of directors to bring every influence in its power to secure the passage of a measure that will make possible the building of the great road. Gen. Nicholas A. Miles was the father of this suggestion, and the automobilists are determined to transform the once designated Utopian idea into an actuality.

Present at the meeting were President W. G. Scarritt, in the chair, Albert H. Shattuck, Automobile Club of America; W. J. Stewart, Automobile Club of New Jersey; F. G. Webb, Long Island Automobile Club; and Secretary S. M. Butler. The Cleveland Automobile Club was added to the membership list, and applications were received from the San Francisco Automobile Club and the North Jersey Automobile Club.

Early in the coming session of Congress the National Highway bill will be introduced, and the attention and support of automobilists throughout the country will be sought in the determined agitation to secure the long-dreamed-of highway from ocean to ocean. The route desired crosses Massachusetts and New York, follows Lake Erie's shore to Detroit, then continues to Chicago, and the overland route to the Pacific Slope goes through Salt Lake City.

Licensing of automobile operators was referred to the legislative committee of the National Highway bill, and the plan of action will embrace state laws. Possibly the first measure of this character will be introduced at Albany, and this statute would serve as a pattern to be duplicated in other states, with one license sufficient for an operator.

The constitution of the American Association needing some revision, it was voted to hold a national meeting for the purpose December 9. One change will be in the assessment of clubs, which now pay to the national body \$3 for every member. This will be reduced to \$1 per member, as the treasury is overrunning with surplus funds.

PLAYED BALL TIED BY CHAIN

Deserters Indulge in a Most Remarkable Game.

PHILADELPHIA, Nov. 25.—Perhaps the most remarkable game of baseball on record took place at the navy yard yesterday, when two teams of shackled prisoners played five innings, one team winning by the score of 10 to 0.

The players were handcuffed in pairs and instead of one man pitching or catching there were two for each position on the diamond.

The number of prisoners now in the "brig" on board the receiving ship Minneapolis, awaiting sentence for various misdemeanors, principally desertion, is unusually large and every day they are taken from their narrow quarters and marched in pairs to the athletic field, where two teams were organized and the game begun.

In every detail was the usual game followed, only when the pair of batters hit the ball both started on a run for first base. Sometimes one in the couple ran faster than the other, and there were numerous falls when one man, forgetting his condition, would attempt to slide without communicating his intention to his manacled partner. The position of shortstop on one team was particularly well filled by a pair of young colored men, who, by working harmoniously with four legs and four arms, covered considerable territory.

The fielders when not making one-hand catches, put up their manacled hands, the right of one player and the left of another, while the third man in the free right arm generally did the throwing.

There were no long hits, but some remarkable catches were made and errors were numerous although the playing improved as the men became used to those who were generally despised as "bums" and "lows" by the other prisoners.

Later another squad spent an hour in restoring their drooping spirits and getting their kinks out of their bodies by kicking a football about. As in the baseball game, each man was handcuffed to another.

PAPER CHASE ON THURSDAY

Portland Hunt Club Will Canter Over the Fields.

On Thanksgiving morning the Portland Hunt Club will give its semi-annual paper chase for the Kerr cup. The riders will assemble at Park and Burnside streets at 9:30 a. m., and at 10 o'clock a start will be made from some point on the East Side. The conditions are that none but the members of the club can participate, and that no race horses are to be hired for the occasion. It is expected that a score or more of riders, both men and women, will take part in the chase. The exact route has not been decided upon and will not be made known until the morning of the ride.

JIMMY BRITT AND FRANK ERNE

Great Boxers Prepared for the Fray.

Exciting Mill to Be Held Tomorrow—Condition of the Men.

SAN FRANCISCO, Nov. 25.—James Britt, late of the Olympic Club, but more recently known as an aspirant for the lightweight pugilistic championship of the world, is hard at work conditioning himself for his contest with Frank Erne, which is to take place before the Yosemite Athletic Club tomorrow.

Britt can see no possibility of any result but that of victory for himself. "I never felt better in my life," he says, "and with my hands all right am prepared for the battle of my career."

With his splendid appearance, bears physical witness to the truth of his statement. Clear of skin, bright of eye and every movement denoting the keenest perception, he is certainly not lacking in physical condition.

With faith in his ability to win, Britt has already formed plans for further advancement in the pugilistic world. He would not object to meeting "Young" Corbett, the conqueror of Terry McGovern, at 135 pounds, ring-side. That he is longer more rightly to this lighter class of boxers Britt is more than convinced as a result of his present training. Already he is down to 131 1/2 pounds, which is just exactly one and a half pounds more than he weighed some time last week. How to take on weight instead of throwing it off is the problem that confronts him for his contest with such a heavy man as Erne. To the casual observer Britt is a small man, but he is a more powerful man than he looks. The supple muscles that encase his sloping shoulders and circle his arched back betray every evidence of indefatigable power. Britt states that he will continue training on the road and in the gymnasium at Croft's until the evening of the contest, when he will enter the ring attended by Charley Reno, Tim McGrath and S. Kelly. Eddie Smith will act as referee.

AFTER THE BATTLE.

Both fighters are making preparations for the time after the battle. Erne's present intention is to go home for Christmas. He is the only child, and his father and mother will be waiting for him on the little steamer away from the Mohawk Valley. After the holidays, unless unexpected matches crop up, he will probably go to Europe. Jimmy Britt is thinking about the matches he can make, for he is sure to be confident of the light of tomorrow will result in his favor. He thought that the Buffalo lad may bring him down never seems to suggest itself to him. "Like Napoleon, where he is concerned, things could not be possible in other words than as he would have them."

ERNE TOO FAT.

Credible and exclusive information from Frank Erne's training quarters, at the Bellows Falls, N. Y., camp, conveys the information that the Buffalo boy is very big and is having hard work to get down anywhere near the stipulated weight, 135 pounds, ring-side. This information is all the more interesting from the fact that whereas the match was looked upon as a gift, practically, for Erne, if these reports are true, then he has been outgeneraled and the Californian has the best of the bargain.

Erne, reputed to be in pugilism as well as elsewhere, when Erne trained down to 125 pounds to meet McGovern he did not believe he was hurting himself, but the bout very plainly proved that he could not make do himself. He lost the battle when the test came, and he found himself as weak as a child. If appearances count for anything Erne is going to have a hard time to make the weight and be strong. He may train down to 135 pounds, but to keep the limit it will be necessary for him to work on the day of contest, and he will try to do enough work to come enough to permit of his eating on the final day. All these little things are going to have a direct issue on the battle.

It has been proven by the past Erne cannot go against a strong, rugged fellow after he has gone through such hardships to make weight. It is possible, however, that Erne will make a desperate battle and it is only fair to assume that Britt is as good as the Brooklynite.

The whole matter, resolves itself, therefore, into that one question of endurance. If Erne is as big and as credible witnesses say, and is compelled to abstain from eating the final day to make weight, depending on gaining strength after he enters the ring from bed and other concoctions, then the verdict in his favor is not worth a cent on the dollar.

Britt will have the advantageous advice of Young Mitchell, and if the above conditions are substantiated, the Californian will make a desperate battle and allow Erne a chance to show his cleverness. The odds will be with success by McGovern, and unless Erne can make this weight readily, then the verdict is very apt to go to J. Edward Britt.

PHILADELPHIA, Nov. 25.—In a six-round draw last night between Charley McKeever and Charles Haghey, neither man was injured. The contest was a fast one.

AUSTRALIAN AND GARDNER.

NEW YORK, Nov. 25.—Bill Dougherty, the Australian, will fight George Gardner at the San Francisco Athletic Club. The fighter is now on route from Australia, and this go will be his first fight in the United States. He is expected here in two weeks.

His manager, Sam Fitzpatrick, received an offer yesterday by wire from Ed Humm, president of the San Francisco Athletic Club, to hang up a purse of \$5,000 for the men.

"I accepted the offer at once," said Fitzpatrick last night, "and the fight will be pulled off as soon as my man is in after his voyage. After that, of course, we want a crack at the big ones."

He should have little trouble in defeating Britt as Erne is one of the cleverest men in the ring today, and if he wins he will make Herford keep his word.

McGOVERN AS AN ACTOR.

Like Sullivan, Fitzsimmons, Corbett and other famous fighters, "Terrible" Terry McGovern is going on the stage as a heavy impersonator. Terry has learned the dialect and gestures of the Ghetto. He will not caricature the Jews but will merely live the life of a peddler on the stage.

McFADDEN AND LONG.

SAN FRANCISCO, Nov. 25.—"Kid" McFadden and Louis Long will box 15 rounds before the West Oakland Athletic Club tonight. The contest will draw a large contingent from this side. McFadden has many friends in town who back him heavily. The "Kid" still feels sore over being beat at the hands of Eddie Hanlon. He is expected to be in the Mohawk Valley. After his bout with Long the "redtop" will depart for England to take on Ben Jordan and other English boxers. The "Kid" working out nicely and will enter the ring in good shape. He complains that he was out of condition when he fought Hanlon, and thinks if they were to meet again he would be the victor.

Long has been training with Frank Erne at the Bellows Athletic Club. He is in good shape and has been put into many new points by the champion. Long has been fighting before the Oakland clubs many years, and has the reputation of being a fast and aggressive boxer.

CARTER WILL BE BUSY.

Joe Macias, manager of Kid Carter, intends to keep his man busy this winter. He has arranged a number of matches with men in the middle and lightweight classes. Macias in a letter from Philadelphia says: "Things are going along nicely here. I intend to pull off a number of good shows at my club, the Penn Art, and Kid Carter will be the star of them. Young Corbett and Billy Maynard are to meet on November 26. Peter Maher and Kid Carter will be the stars on December 3. I do not see where I am going to get any better. Carter will win in all probability meet for another six-round go on December 8 at the Locomotive Club in Chicago. I have been advised to put in a bid for the McGovern-Corbett match, which will make a proposition. Of course, no decisions are rendered in Philadelphia, but I am sure the men would draw a big house. I hope things will open up in Louisville shortly, as I would like to put Carter against Hart again. I intended to bring Jesse Shippen here, but for the time being I am unable to do anything for him."
