THE MARKET SHOWS STRENGTH

Quotations Slide Up an Eighth.

Package Coffees Advance—Fresh Eggs Scarce at 33 Cents a Dozen.

Business was quiet in the local whole-sale markets today, receipts in nearly all lines being short.

ADVANCE ON LARD.
According to the Hammond Packing Company, quotations on Eastern brands of lard were advanced 1-8 cent this morning on account of the strengthening of the market in the packing centers.

PACKAGE COFFEE ADVANCE.
As is usual at this period of the year, quotations on the various grades of package coffees were advanced this morning. This change is brought about by the closing of Lake navigation and the consequent advance in the freight rates when shipped by rail. The various brands are quoted as follows: Lion, \$10.75; Arbuckle, \$11.25; Cordova, \$11.25. The advance today will amount to about 12 cents a hundred pounds.

WHEAT AND FLOUR FIRM.
Although no changes have appeared in the quotations on grain or flour today, that market is quite steady at current quotations and it is likely that further advances will take effect in the near future.

HOPS AND POTATOES UNCHANGED.
The hop and potato markets remain at the same quotations as were reported in Saturday's Journal. Hops are showing some additional strength, but very few sales are reported.

LAWYERS TRY QUEER CASES

The Baltimore Attorney Is Very Interested in Damage Suits.

"Ambulance-chasing" lawyers and their side partners, the "runners," are becoming more numerous every day in Baltimore. Frequently now dim hints at their methods are made in court. Vexatious damage suits are being promoted in Baltimore to an extent never known before.

All of the Baltimore law courts are behind with their work. This is due largely to the pernicious activity of the damage suit lawyer. At least one-half of the suits that go to the trial dockets of the law courts are damage suits for alleged injuries to person or property. It is probable that an investigation would show that four-fifths of the docketed suits which ultimately call for trial are of this sort. The majority of such suits are worked up by "ambulance-chasing" lawyers and "runners," and have very slight foundation.

Yet this pressure of frivolous litigation will very soon make necessary an additional judge, with bailiffs, clerks, deputy sheriffs, jurors and all the paraphernalia of a court. It costs about \$50 a day to conduct a court with a jury, and the public will soon have the pleasure of paying that additional amount to aid "ambulance-chasing" lawyers in "plugging" corporations and individuals. That is about what it amounts to. At the same time, legitimate litigation will have been crowded out.

On the other hand, these lawyers actually make it more difficult for the really injured person to win his case. Reckless damages, claiming from \$500 to \$50,000 damages for injuries that are merely nominal, have made the courts so overburdened that a certain extent, the courts and jurors look askance at all damage suits. Like all courts, all damage suits look alike to the corporation. They are "plugged" so often that the only safe way is to fight every case to a finish, and this is what is done.

But when an injured person places his claim in the hands of a damage suit lawyer, the corporation prepares to fight. The claimant who secures a lawyer is at once looked upon as a "runner" and is not taken seriously. Although that may be the best claim in the world, the corporation fights to a finish, because it has reason to suspect the lawyer of using questionable means.

Then, too, if a verdict is received by the claimant, he gets little in the end. There is the lawyer's part, which always goes to the lawyer in full measure. He looks out for himself, and the claimant gets a slice, so the "runner" is in the pocket of \$250 or \$300, the usual size, the claimant is lucky if he gets \$50. It is possible that he might have got considerably more from the company directly, without bringing in the lawyer. If the claimant has put himself in the power of a clever and not over-scrupulous man versed in the law, and does not know what must be his fate, he is in a bad way. The public would be surprised the expense of vexatious litigation.

Lawyers of standing do not necessary work in present social organization, and it is important at times to bring damage suits for the purpose of guarding personal property and keeping powerful corporations within bounds in dealing with the public. But anybody who is really injured will go to a lawyer and place his case in the lawyer's hands. It is not necessary for the lawyer to have solicitors out hunting for the injured or the wronged. If all suits were begun in a regular and proper manner there would be no prejudice against the damage suit, as there is now, and the honest claimant would have some show of success in vexatious litigation.

This "promoted" law business is conducive to subordination of justice, and is a blot on the courts whose officers these "ambulance-chasing" lawyers are. The honest members of the bar, the judges, the jury, and the public, should take up the matter. Maintenance, barratry and chicanery are still punishable. They should at least be ground for disbarment. The public at large and even damage suit litigants should know, too, that the "ambulance-chasing" lawyers and their side partners, the "runners," are Baltimore news.
