



CAN FIGHT IN OLD KENTUCKY

So Says the Chairman of the Board of Public Safety.

LOUISVILLE, Dec. 2.—Fighting will hereafter be permitted in Kentucky under certain restrictions. Chairman Brennan of the Board of Public Safety has announced that under the decision of Judge Toney, sparring contests will hereafter be permitted. The board insists, however, that the agreements between the contestants must be submitted, and the board would lay down the rules under which the matches are to be conducted. Robert Gray of the Athletic Club says he still has hopes of securing the Corbett-McGovern fight for Louisville, and negotiations are now pending between him and the Baltimore Club to have them release the fighters from their contract.

HAUGH AND EDDIE HANLON.

KID IS READY FOR A FIGHT

Is in a Class by Himself and Can Get No Match.

NEW YORK, Dec. 2.—Although Kid McCoy announced his re-entrance into the prize ring several months ago, he has not succeeded in getting on a match. He was matched to fight Marvin Hart at the International Athletic Club, Fort Erie, but Manager Herman, at the last moment, decided to call the match off. McCoy is a training, nevertheless, in the hope that something may turn up. McCoy's trouble in securing matches seems to be that he is in a class by himself as regards weight. He weighs 165 pounds, at the lowest, he is too heavy for a middleweight and not heavy enough to make a formidable opponent for the leading heavyweights.

Tommy Ryan and Jack O'Brien are about the only fighters within hailing distance of McCoy's weight who, on form, would be able to give the Hoosier an argument. O'Brien, it is said, would have a lot of trouble making the middleweight of 165 pounds and at even weights he is hardly as good as McCoy.

UP TO TOM RYAN.
With O'Brien eliminated, it seems to be up to Middleweight Champion Tommy Ryan to give McCoy a battle. The men have met three times, but none of the bouts was decisive. McCoy won the first in 15 rounds. The second bout was in Ryan's favor when the police stopped it in the fifth round. The third was a six-round bout, in which the decision went to McCoy, although a majority of the spectators were of the opinion that a draw would have been the proper decision.

Ryan is willing to fight McCoy at 158 pounds, but the Kid says that it is impossible for him to make that weight. He has made a counter proposition, in which he agrees to make 164 pounds at the ringside, and Ryan is seriously thinking of warring the few pounds difference in weight. Ryan at McCoy's age, without question, the cleverest of the class, and if a bout can be arranged it should prove to be one of the greatest battles in the history of the ring.

Trainer Expects to See Lord Derby

While attending the Trotting Horse Breeders' Association meet at Lexington, Ky., a few days ago, Ed Geers, the veteran driver, gave it as his opinion that Lord Derby was the coming two-minute trotter, at least in 1904, if not in 1903. He reasons that any horse capable of going the last quarter of a mile in 30 seconds is bound to have a chance to see the day when he can put every quarter at the same notch. Then the two-minute mark is at last reached. Geers says that the fact that Lord Derby goes his last quarter the fastest indicates that the great horse's powers are not fully developed, and believes that he has only to reach maturity age to be as fast away from the post as he is at the finish, and when that day comes he will have the long-sought-for two-minute trotter, and that without the aid of Cruseus, 2:30 1-4.

"I have driven many fast trotters and pacers," said Geers, "and whenever I come across a horse that goes his last quarter faster than the others I mark him down as an ultimately unbeatable crack. That is the reason I like Lord Derby best of all the prospective two-minute material on the turf today, and I look for him to be the champion trotter before his career on the turf ends."

The result is that 'Dug' is happy and gained nine pounds on his trip. The peace declared at Chicago, by the terms of which the American Association enters the National Association of Minor Leagues, means all everything to baseball, not only through the East, but in the Pacific Northwest. By the terms of the compact, the American Association on its own application becomes a member of the National Association in good standing, and the latter organization which has been anxious to do anything in its power to aid in the settlement of all differences. That meeting blocked the imminent combination of the American Association, the new Southern League and the California League—a combination which would have worked irreparable harm to the national game and would have crippled us in the Northwest greatly. It makes reasonable salaries possible from this time on. As it now stands, players will have difficulty in securing a position if they jump their contracts. California is now the only Mecca for the contract jumper and a four-team league cannot exist in the territory of the class in the country. The question of players was settled by permitting the contracts made prior to October 29 of this year to stand, except in the case of players taken from the Western League by the American Association since the close of the season and vice versa. All players signed by the American prior to October 29 belonging to other minor leagues, will be returned."

The locomotive sank deep into the mud, and after a firm foundation can be built around it the wrecking crew will lift the massive machine by means of a derrick and a dandy engine. Officials of the railroad company say that as far as can be found, the engine is not badly injured by its fall.

THEY KILLED ENTIRE FLOCK

Adventure of Duck Hunters on the Columbia Slough.

John Klippel, G. H. Knott, C. Strinell and A. Parrott of this city are indignant over the unportsmanlike action of a number of Portland hunters. By the latter's stupidity and general awkwardness the former are bewailing the loss of a flock of fine imported ducks.

The first named gentlemen have secured a lease to the Bybee place on the Columbia Slough, near Cedar Park, for hunting purposes. During the latter part of last week they took down there a dozen call black ducks, a rare species, which were procured at no little expense, to be used as decoys. The birds were picketed in the slough, and a short time afterwards a number of hunters from Portland, said to be employed in the general freight office of the O. R. & N. Company, happened by and espied the picketed game. They crept within about 10 yards of the doomed aquatic beauties and at a given signal opened fire. Two of the ducks were killed by the first volley, and as the remainder did not fly, they approached still closer to get a pot shot. At the second fire two more of the hapless victims were maimed for life, and a hand to hand encounter ensued until the last bird had perished.

WERE DISCOVERED.
About this time the watchman, employed to look after the grounds, appeared on the scene and began to expostulate. When fully acquainted with the extent of the depredations which they had committed the hunters took a flight and soon vanished in the brush.

Mr. Klippel heard from one of them this morning, however, through the mail. He signed his name Jones and admitted he was guilty of a stupendous error. He stated that he was willing to compensate the owner of the ducks, and enclosed the sum of \$1 with which to do so.
