

CAPITALISTS SEND AGENTS

Cotton Mill to Be Established at Oregon City.

Funeral of Mrs. McIntyre--A New Organization--Personal and General News Notes.

(Journal Special Service.)

OREGON CITY, Jan. 15.—Now that the southern portion of Main street is about to be improved by the erection of the new freight house and theatre by the O. W. P. & R. Co., and the construction of the new road-way over the bluff by the city and county, it is learned that already outside capital has been interested to the extent of sending representatives to this city for the purpose of looking over the upper end of the town. Several days since agents of Eastern mill owners were in the city examining into the advisability of securing the property at the northwest corner of Third and Main streets for the purpose of establishing a cotton mill. What cotton mill owners have in mind is not known, but should the property be secured, it will include the old "Barnum" saloon property and the old brick flouring mill. The object of the company would be to engage in the manufacture and sale of cotton goods giving employment to a large number of workmen. There is no such mill in this vicinity and very few of them on the coast, hence if this new industry is established in this city, it would give Oregon City another step toward the front in the line of prominent manufacturing cities of the Western states.

FUNERAL OF MRS. F. E. MCINTYRE.
The funeral of Mrs. Francis E. McIntyre who died in this city on Tuesday, was held this afternoon from the Episcopal Church, Rev. E. K. Hammond officiating. From the church the remains were taken in a special car to Sellwood, where they were cremated. The deceased was 35 years of age, and is survived by her husband, Truman McIntyre and her two daughters, Mrs. D. N. King, of Tacoma, and Miss Jennie McIntyre, of this city.

ORDER OF REST.
A new organization to be known as the Order of Rest has been formed in this city with Thomas Randall, ex-county recorder, as president and Sherman Burford, secretary and treasurer. The charter members are Bert Greenman, William Logans, and Frank Newton. The new lodge has been in existence only a short time, but has received numerous applications for membership, but these have been rejected, subject to the result of a hearing that will be held today. One of the members, Greenman, is charged with having broken one of the principal rules of the order, so will be given a hearing today.

MINOR MATTERS.
J. W. Campbell has returned from Salem, but will go to the capital again tonight.

The board of School Directors held a special meeting last evening and named Monday, January 13, as the date for the holding of a meeting of the taxpayers to levy the school tax for the next year. The new book containing the record of the Second Oregon Volunteers, which has been printed by the state, will be ready for distribution tomorrow. Officers and non-commissioned officers will be given a copy of the volume free of charge.

BRIDGES WASHED OUT.

PENDLETON, Jan. 15.—Nearly all the smaller bridges on Wild Horse and Cold Stream, in Umatilla county, went out during the recent freshet, which has resulted in considerable loss to the demand for bridge timber and plank. Among other incidents of the flood the bridge at Holderman went out clean, which was entirely unexpected, as it was a solid built structure. From the bottom of the piers to the topmost timber.

RAILWAY EMPLOYEES.

The open meeting of the Bridge and Structural Iron Workers Saturday night will probably be largely attended. The members of the Brotherhood of Railway Employees, imposed men working in every capacity on a railroad, are invited to attend. tingham of Multnomah, is designed to correct the defects of the present system of assessment and taxation. It provides for the creation of a Board of Commissioners to investigate the subject and to formulate a new code on taxation. They are to be appointed by the Governor and shall be allowed a clerk and assistant clerk.

OF INTEREST TO PORTLAND.
Fisher's House bill to provide the City of Portland with a fireboat is designed especially for the protection of the shipping and of the warehouses and wholesale houses along the river. The bill authorizes the levy of a special tax of 1-12 mills for the current year, in order to defray the cost.

House Bill No. 40, introduced by Cobb of Multnomah, authorizes the City of Portland to issue bonds to the amount of \$500,000 for the purpose of constructing a new bridge over the river at Morrison street, the work to be under the direction of a Bridge Commission.

PORT OF PORTLAND.
Sanderson Reed, of Multnomah, has introduced a bill to provide for the funding of the present indebtedness of the Port of Portland Commission, amounting to about \$200,000. This commission was authorized by the last Legislature to expend \$200,000 for the construction of a drydock. The present bill provides for the issuance of bonds to that amount, bearing interest at 5 per cent., one-tenth of the issue to be retired each year for the next ten years. It is understood that the bonds falling due during the next few years will be taken care of by the people of Portland.

SHALL NOT WORK ON SUNDAY.
Gault of Washington has a bill making it a misdemeanor to carry on the business of a photographer on Sunday. The bill recites that it is for the relief of overworked employees in this line of work.

A FRIEND TO LABOR.
Gov. Chamberlain, in his inaugural message, has declared in no uncertain tones his friendship for the working classes. His utterances upon the subject of labor and capital were received with close attention both by the legislators and by the throng that filled the lobby and the side aisles. When he alluded to the "cool, determined and manly course of John Mitchell," there was a burst of hearty applause from the crowd of listeners in the rear of the chamber. The Governor's attitude inspires just and full consideration of all bills affecting the condition of labor which are sent to him for approval.

Bills May Be Illegal.
SALISBURY, Jan. 15.—There is a serious question in the minds of many attorneys in the Legislature as to the validity of the great majority of the measures thus far introduced. The doubt arises on account of the language employed in the bills, and the cause of the uncertainty as to whether the initiative and referendum amendment to the Constitution is effective without legislation.

The enacting clause of nine tenths of the bills thus far presented reads either: "Be it enacted by the people," or "Be it enacted by the Legislative Assembly" of the State of Oregon. If the referendum is already in full force and effect without any legislation providing for the machinery by which the popular approval or disapproval shall be expressed, the latter form of enacting clause is inadequate. If not in effect, the same objection applies to the form first quoted.

A few of the Legislators, foreseeing this danger, have adopted the plan of enacting both expressions in the enacting clause of their bills, as follows: "Be it enacted by the Legislative Assembly of the State of Oregon," and also, "Be it enacted by the people of the State of Oregon."

This form is believed to obviate all danger but it has not been used in more than 10 per cent of the bills presented. In the House 37 bills have already been presented, and in the Senate 51, so that the matter is one of most serious moment. Still another danger that threatens is the possibility that the referendum amendment may be declared unconstitutional. Many attorneys believe that it is and that the Supreme Court will so hold. Such a decision would, of course, invalidate all bills purporting to be enacted "by the people" only. The fact that so large a proportion of the bills presented are defective will mean a very serious loss of time by the Legislature at the outset of its labors. Fortunately the Lewis and Clark bill is one of those drawn with the double enacting clause, so that its validity cannot be questioned.

NUGENT IS LET GO.

The case of John Nugent, charged by Karl Wintercon with larceny by bailies in Justice Reid's court, was dismissed yesterday. Wintercon charged Nugent with selling a saloon and fixtures for \$500, when the fixtures really belonged to the Sellwood Brewery.

KAFURIA PLEASED.

S. E. Kafuria, arrested on advice from Sheriff Taylor, of Salt Lake City, yesterday, was released today. The charge was embezzlement, but the Salt Lake City people wired today to let him go.

CONGRESSMAN TONGUE'S BODY

Every Effort Is Being Made to Rush It Home.

The Southern Pacific general offices in this city are humming with the bustle of arrangements for the rapid transportation of the remains of Congressman Tongue to the former home of the deceased, at Hillsboro.

There will be hardly a moment's delay in Portland. The special in which the body is being brought back to its friends and to the state it represented when imbued with the spirit of life, will be detached from the Oregon Short Line train at the Union Depot and connected with the Southern Pacific passenger if all plans carry.

If there is a hitch, through failure of the O. R. & N. train to reach Portland on time, the Southern has made provision for a special train to bear the funeral party and the corpse to their destination.

There will most certainly be no hitch here," said General Agent Conman, of the Southern Pacific, to a reporter for The Journal this morning. "The Southern Pacific will do all in its power to take the remains of the honored dead to Hillsboro on time and if the special car reaches Portland we now figure, this will be done. If the O. R. & N. is late we will have a special engine waiting at the depot to take the funeral car upon its way."

Additional accommodations will be provided in any event for those who desire to accompany the body to Hillsboro and pay their last respects to the dead. It is expected by the company that several hundred from Portland will desire to attend the last services at the grave.

IN MEMORY OF MR. TONGUE.
It is generally conceded by city officials that some special token of respect ought to be paid by prominent citizens and citizens of Portland to the memory of the late Congressman Thomas H. Tongue, whose remains will pass through Portland Saturday, to Hillsboro.

Mayor Williams stated today that no definite move had been made by the city officials to that end. He said he believed it eminently fitting and proper that some token of respect should be shown the deceased Congressman. He conferred this morning with General Bebe in the matter. The Mayor said the city should attend Mr. Tongue's funeral, and it is probable that others will also go from here, even though they do not do so in an official capacity.

TILLMAN SHOT EDITOR TODAY

CHARLESTON, S. C., Jan. 15.—Lieut. Gov. James Tillman this morning followed out the traditions of his family and shot down Editor Gonzales, of the Columbia State, a newspaper published at the capital of South Carolina. Tillman's bullet entered the stomach of the newspaper man, inflicting a fatal wound. The two men had quarreled over a criticism of Tillman published in the paper. This morning Tillman, now serving in the United States Senate, for his red-hot address of yesterday, and the shooting followed. Lieut. Gov. Tillman gained notoriety a year ago when he insulted President Roosevelt on the occasion of the sword presentation at the Charleston Exposition.

More Bills Introduced.

SALISBURY, Jan. 15.—In the Senate, McGinn introduced a bill prohibiting child labor. Miller introduced a bill to redistrict the state into senatorial and legislative districts, and one to authorize the annual meeting of County Superintendents of Schools. This afternoon the Senate adjourned until Monday.

The House Adjourns.

SALISBURY, Jan. 15.—The House was in session until noon, and then adjourned until 3 o'clock Monday. Among the bills introduced was one by Jones of Multnomah providing that all demands upon that county must receive the approval of the County Auditor before payment. The measure was introduced at the request of the Taxpayers' League. Orton of Multnomah introduced a bill regulating child labor.

ELECTRICAL WORKERS.

The Electrical Workers' Union donated \$5 to its strike meeting last evening to the electricians of Seattle, who have been on a strike for the past six weeks. It is just one branch of the Puget Sound electrical workers who have been out. They are known as the light men, and in Seattle a strike by the company men are said to have violated signed agreements. Several new members were initiated into the union last night, and a number of applications were received. The new constitution and by-laws were read for the third and last time.

GAY SADDENED BY HOLD UP

J. W. Gay was held up last night at 9 o'clock on Couch street, and relieved of some \$5. He reported the loss to the police and Detective Weiner tried to find the man, but owing to a poor description was unable to find him.

HOLD UP ARTIST GETS EIGHT YEARS

Pitiful Scene in Circuit Court--Chic Houghton Gets Stern Rebuke.

It is seldom indeed that the Circuit Court habitues witness a more touching scene than was enacted this morning while the four judges were together on the bench in Judge Fraser's court, and the room was filled with attorneys and spectators. It was the occasion of passing sentence upon "Chic" Houghton, a young man, 20 years of age, convicted of holding up Elmer Balch. He was tried by a jury before Judge Fraser. He was sentenced to eight years in the penitentiary, and his attorney appealed to the Supreme Court on a writ of probable cause.

"Chic" was brought into court this morning by Detective Joseph Day. He was accompanied by his aged parents, who, through all of the evil doings of their son, have never forsaken him, but have stood by him with the devotion known only to a father and mother. It was a most trying moment to them, but they braved bravely, seated by their arthritic and youthful son. The father, blind, and the mother so aged she could scarcely walk into the room, took a seat close to the boy and placed her hand on his shoulder, where it rested until the court pronounced his sentence, when she drew it away and buried her face in both hands, and wept bitterly.

DRAMATIC SCENE.

It was a most dramatic scene. Chief Deputy District Attorney Spencer arose and stated that he had no further words to speak relative to the case.

Judge Fraser then faced the prisoner, who stood between his parents, and said: "You are so young, Houghton, that if this was your first offense the leniency would be inclined to exercise great leniency toward you. But it appears that this is not the first time that you have been in trouble; that for many years you have continued in your evil ways, persisting against the will of your poor old parents, in living with vile women, associating with the worst element of the city and committing a number of serious crimes yourself."

"That you have been in serious trouble before was brought out by your own attorneys, at the trial. And that you were let go each time, previously because of your father and mother, who are so highly respected and beloved, was also made clear. If you will not heed the entreaties of your poor, blind father, and your gray-haired mother, and turn from your evil ways, the court does not believe that you would reform if given leniency at this time."

"I think also that a good sentence upon you will have a beneficial effect not only on you, but also on other young men who are following in paths similar to yours. You have been a continual burden to your parents, causing them untold agony and expense; and although this blow almost kills them, nevertheless the court believes that it is his duty to sentence you to as long a term in the penitentiary as is possible under the law. I sentence you to serve a term of eight years in the penitentiary, and to pay the costs of this trial."

PARENTS WEEP PITIFULLY.

When the Judge finished his address, the prisoner sat down. His mother on one side and his father on the other, were crying pitifully, but the son, when he observed their lamentations, did not shed a single sign of distress or heart ache.

Attorney Hume made his appeal to the Supreme Court, which was strenuously objected to by Mr. Spencer for the state. Judge Fraser granted the writ of probable cause and fixed the bail of the young man at \$25,000.

He could not furnish the amount, and was separated from his sorrowing parents at the entrance to the county jail. The parting was a sad one, and the affectionate kiss which the parents gave their son as he was led to prison, seemed to demonstrate their utter belief in his guilt.

WILSON PLAYS TRUMP CARD

OLYMPIA, Jan. 15.—"We are not going to elect any Senator this time!" This statement, made by one of John L. Wilson's followers this afternoon, betrays the sentiment of the anti-Ankeny element in the Washington Legislature, and the extent to which they are prepared to go in order to defeat the man against whom they have allied themselves. Wilson, who allied himself with Preston long enough to blast the hopes of that senatorial aspirant, has secured signatures to an agreement which will prevent a caucus. Preston is in a tight place, and Ankeny, while he has the majority, cannot win unless Wilson is forced from his present position. It is the hope of Wilson to repeat the deadlock of 1892.

SOCIAL QUESTION

WASHINGTON, D. C., Jan. 15.—Washington society is all torn up over the question of whether, under our democratic form of government, an invitation to the White House is to be regarded as an honor, or as a mere social informality over the telephone, from the daughter of the President.

An impromptu girls' party, given by Alice Roosevelt, started the commotion. Miss Roosevelt, learning that President and Mrs. Roosevelt were going to the theatre, decided to invite a number of her old school friends to the White House. She used the phone to extend the invitations, and among those who were asked in this manner was Carolyn Postlethwaite, the daughter of Mrs. William M. Postlethwaite. Mrs. Postlethwaite took the message, and accepted in her daughter's name. She was then informed that her daughter was to be hostess at a dinner that evening in honor of her brilliant debut into society.

During the afternoon Miss Roosevelt in some way heard of the dinner and went to the Postlethwaite residence and told Miss Postlethwaite that she would not think of interference in the dinner program, and among those who were themselves that Miss Postlethwaite should remain with her own guests. The mother took a different view of the situation and maintained that it would be a most unpardonable breach of etiquette should her daughter disobey "a summons from the White House." Mrs. Postlethwaite presided at her daughter's dinner, and the young woman went to the White House. Now Washington society people who are loath to regard an invitation from the White House, no matter how informal, as a command, are waiting to see if the president's wife will permit an organization of the etiquette governing White House invitations.

THE PRISONERS TABOO A CELL

Superstition at the County Jail Develops Consternation.

In Corridor No. 2 of the county jail is a cell which may be tabooed by all prisoners, because there is supposed to attach to it something mysterious which strikes death to its victims. Recent events have struck terror to the prisoners confined in the jail, lest they may be removed from their cells and placed in the dreaded cell.

John Lewis, who died last night at the County Hospital, was confined in the cell, and before he had been there long he fell ill, a prey to dreaded quick consumption. After a lingering illness of a few weeks he died.

NOW ANOTHER ILL.

This morning D. F. Post, another prisoner who has been occupying the cell, was taken from the jail and transferred to the County Hospital. He was stricken with some serious disease, which has not yet been made known by the physician. It was stated this morning that the chances are against his recovery. In the light of all of these facts, there is consternation among the inmates of the county jail. Each one fears that he may be placed in the cell which they think contains something that produces disease.

Lewis, who died last night, was being held to trial in the Circuit Court for robbery of a dwelling, and Post, who is ill now, was in for larceny.

MADE HIM WANT TO PLAY BALL

James A. Clock Pleased With the Weather in Oregon.

"The people of Oregon do not understand what a weather snap they are having. I hear them today complaining of the cold, while in reality it is as near summer as it ever gets for some people." Having just returned from a 15-day business trip to Chicago and across the bleak and cheerless plains of North Dakota, James A. Clock, general agent for the Wisconsin Central in this city, made the above statement this morning.

"There is nothing to it," he went on, "and the more I see of it the better it makes me feel. I saw the thermometer 38 degrees below zero while I was gone, and when I got back here this morning and felt the warm sunshine of old Oregon, I was glad to get back to my home and go out and play for some people." "The people of the East are coming to understand this condition, too, and they are today hailing the Pacific Northwest as the only country in the world. Look out for them, they are coming West by the train load after February 15."

MARINE NOTES.

The Herzogin Cecelle began loading this morning at the Irving dock, and the Martha Roux is working at the Montgomery No. 2. The Jean Bar will finish loading at the elevator today. "The British ship Scottish Minaret" will arrive in port this afternoon with a general cargo from Antwerp. It is consigned to G. W. McNear. The Columbia arrived at Astoria this morning from San Francisco, and will reach port this evening.

YOUNG HEARTS.

INDIANAPOLIS, Ind., Jan. 15.—A remarkable story has developed, in the course of a marriage license to Victor Andrews and Josephine Andrews, the bridegroom-elect being 73 years old and the bride four years his junior. They were husband and wife in a years gone by, and were devoted one to the other. Prior to 1838 Mr. Andrews went to Europe on a business trip, and while there he was prostrated with illness and lay for months in a hospital in a delirious condition, unable to send word to his wife and family in this city.

When finally he recovered sufficiently to write his letters went astray. Meanwhile his wife undertook an inquiry which failed to disclose his whereabouts and she reached the conclusion that he had met with an accident and was dead. Eventually, she ran short of ready money, and as the property was in her name it was necessary for her to have her husband's consent to secure a mortgage thereon, or else pay a bribe, and finally she concluded to apply for a divorce, and was granted a decree of separation.

Recently Mr. Andrews returned to this city, restored in health, and he speedily located his wife, although the law said they were no longer united. Their love survived, however, and they began proceedings to set aside the divorce, and to find that this would be long delayed. It was then suggested that remarriage would be the easiest solution, and so Mr. Andrews applied for another license, and Rev. William H. Vowler officiated at the ceremony which again made them man and wife.

SOLE SURVIVOR.

ROME, N. Y., Jan. 15.—In the little hamlet of Dunn Brook, 18 miles from here, lives Hiram Cronk, the sole surviving veteran, and pensioner of the War of 1812. He was born in Franklin, Herkimer county, 103 years ago next April, and comes from one of the old Dutch families that settled in New York State.

Hiram, with his father and brothers, John and Jephtha, enlisted in the second war against the British, and served at Sacketts Harbor. The man is now being cared for by a daughter, on the old homestead. He sleeps all the day long and walks the floor nights. Aside from the weakness of old age, he is in good health. He has chewed from 5 to 10 cents worth of tobacco daily, and he also drinks wine and milk, of which he drinks nearly half a gallon.

Hiram was present when Governor De Witt Clinton came to inspect the building of his "big ditch," and tells with glee how a mischievous boy placed a loose plank across the canal, on which the Governor stepped, and received a dunking in the muddy water. In politics Hiram is a staunch Democrat. "My first vote was cast for Andy Jackson and my last for Grover Cleveland," he said.

In church affiliations the old man is a Methodist. He is also the last surviving veteran of the Fort Stevens Chapter, Sons of the American Revolution. On the occasion of the last annual assembly of the Union Veterans' Union, in Chicago, that body sent Hiram a congratulatory telegram.

ECLIPSES DUE THIS YEAR

In 1903 there will be four eclipses, two each of the sun and moon, but none of them will amount to much, from a spectacular point of view, in this region. The only one of the four visible here at all will be a partial eclipse of the moon on April 12. There will be a total eclipse of the sun, always a scientifically interesting event, on September 26, but it will be visible only in the far southern hemisphere, including the southern part of Australia. Easter Sunday will occur on April 12, which is a little later than the average date of that great religious festival. Decoration Day and Fourth of July, which always come just five weeks apart, will this year come on Saturday. Christmas will come on Thursday, and go out, of course, on the same day of the week as is always the case, except in leap years, there being just 52 weeks and one day in the ordinary year. Leap years, by the way, have been few and far between of late years, but if nothing goes wrong with the motions of the solar system, one will come in 1904.
