

THEY ARE ALL FOR THE FAIR

Idaho Will Make an Appropriation of \$75,000—California and Utah to Consider Subject Next Week.

Idaho, California and Utah are on the right track. They are all for the Lewis and Clark Fair. Communications have been received from Special Commissioners Knapp and McIsaac, in which it is stated that California and Idaho will make appropriations for the 1935 Fair. From Utah comes the news that the Utah commissioners to the Lewis and Clark Fair have made a recommendation to their Legislature that an appropriation of \$100,000 be made for Portland's big Exposition.

Special Commissioner Knapp makes his report from Sacramento under date of January 13. He is now in Denver working in behalf of the Fair in the Colorado Legislature. His suggestion that some one be at Sacramento next week will be complied with by the Lewis and Clark Fair board of directors. The probability is that Alfred Holman, of this city, will be the one who will represent the directorate in California next week. Mr. Knapp's report is as follows:

KNAPP'S REPORT.
I am pleased to report that in conference with Governor George C. Pardee, Senator R. T. Devlin and Representative E. B. Dunlap, the latter two respectively chairmen of the committees on finance and ways and means, I found that they were most agreeable indeed to the proposition of including in the St. Louis World's Fair bill that of the Lewis and Clark Centennial; but as the committees have not been appointed as yet, it was suggested that we have a representative on hand the fore part of next week to appear before the committee, as will be asked also of the St. Louis people.

MCISAAC'S REPORT.
The report of Special Commissioner C. H. McIsaac to the Lewis and Clark Fair board of directors shows that he is making a success of his work in behalf of the Fair. Summing up the situation in Idaho, Mr. McIsaac states that he believes the matter is now in good hands and success certain. He states that O. L. Miller, of Baker City, one of the directors of the Fair, accompanied him to Boise, and the two insisted on an appropriation of \$75,000. Senator B. F. Wallace will look after the interests of the appropriation bill in the Senate and Francis Jenkins, of Moscow, chairman of the ways and means committee of the House, will introduce the bill in that body. The Fair company is very fortunate in securing the support of these two gentlemen for the Oregon Exposition, as they are powers in the political arena of Idaho. Mr. McIsaac concludes his report by stating that the chances for an appropriation of \$75,000 by Idaho is very good. In fact, A. C. Moore, Democratic leader in the House, is in favor of an appropriation of between \$75,000 and \$100,000, and will use his best endeavors with friends and associates to secure the passage of the appropriation bill. Another prominent man in Idaho who is rendering Mr. McIsaac much assistance is Judge J. H. Richards, one of Idaho's commissioners to the Lewis and Clark Fair. The women of Idaho are also working hard in favor of the Fair. Among the most prominent in this movement are Mrs. Green, who was commissioner to the Lewis and Clark Fair, but resigned, and who is now one of Idaho's commissioners to the St. Louis World's Fair, and Mrs. Hutton, who is wielding her influence in Northern Idaho.

Mr. McIsaac left yesterday for Salt Lake City, Utah, where he will confer with Utah's commissioners to the Lewis and Clark Fair regarding their recommendation to their Legislature.

UTAH'S APPROPRIATION.

Utah will probably appropriate \$100,000 for the Lewis and Clark Fair. This is deduced from the fact that the Utah commissioners for the 1935 Fair in their report to the Utah Legislature recommended that that amount be appropriated for the Fair. The commissioners of Utah are Hoyt Sherman, L. W. Shurtliff and H. B. Clawson. They were appointed on March 14, 1931, and during the time intervening to date have visited Portland and the site for the Fair, and are thoroughly satisfied that it will benefit Utah to make the appropriation.

APPROPRIATION TOO SMALL.
There is a sentiment among those who have expressed themselves on the subject that Utah's appropriation is proportionately too small to the good it will derive from the Lewis and Clark Fair.

Special Commissioner McIsaac will be wired today to attempt to remedy the hasty action of Utah's commissioners in making their recommendation before his (McIsaac's) arrival, and that he endeavors to have the Utah Legislature raise the amount of the proposed appropriation to \$100,000. It is understood that the Lewis and Clark Fair directors will endeavor to have the State of Washington appropriate more than its commissioners to the Fair have recommended. Its commissioners have recommended that an appropriation of \$100,000 be made for the Fair, while this amount is considered entirely too small. In the opinion of those who are versed in the effect which Expositions have on the country in its vicinity, an appropriation of \$250,000 is not considered too big an amount for Washington to appropriate for the Fair.

OREGON IN FAVOR.
J. M. Church, of La Grande, one of Eastern Oregon's representatives, on the directorate of the Fair, is in the city today. Speaking with a Journal representative, he stated:

"The opposition which the Lewis and Clark Fair had in some districts in Oregon is rapidly being cleared away. In view of the fact that outside states are in favor of it. Neither are we in doubt but that the \$500,000 appropriation bill will be passed by the Legislature. There may be some opposition to it, but not much. There is one thing, though, and that is, that the representatives from Eastern Oregon in the Legislature do not say much, but when it comes to voting, you bet they will all vote the right way, because Eastern Oregon is in favor of the Fair, body and soul. If people walk back in Arkansas are in favor of the Fair and will help it, why there is no reason why people right here in Oregon should not be in favor of it."

COURSE IN LEGISLATURE.
Some of the lobbyists who have returned from Salem, and who have been watching the progress of the Lewis and Clark Fair appropriation bill, state that the bill would have passed the House in rush order, had not Dan Malarkey, spokesman for the bill, made the motion providing for it to be referred to a committee, the members of which shall be selected from all parts of Oregon. It is argued that if the bill had been put before the House, it would have been passed without opposition, and referred to the Senate. As the Senate is a much smaller body, there would not have been much debate on it, and its fate would have been known much sooner.

NEW YORK, Jan. 17.—A score or more of bald-headed men walked into the cafe of Mayor Emil Groth of Union Hill, N. J., yesterday. When Groth inquired their business, one of them displayed a newspaper advertisement, which read as follows:

WANTED—1,000 bald-headed men to call at 1 Bergenline avenue, Union Hill, to receive a New Year's gift.

Groth instantly scented the advertisement as a joke of Chief of Police Rannenberg. The chief's poll is as bald as an agate door-knob, and he threatened to square matters with the Mayor when the latter gave him a comb for a New Year's present.

The Mayor refused to be stumped, however, and bidding the bald-headed men be seated, dispatched a message to a nearby department store for a box of combs. He presented to each a comb.

NO BLOOMERS IN OKLAHOMA

Governor Prohibits Bifurcated Garb on Girls.

GUTHRIE, Okla., Jan. 17.—Gov. Thomas B. Ferguson of Oklahoma has set down his foot officially on the use of bloomers by girls who attend the territorial institutions. During the past month one of the schools narrowly escaped a scandal, it is said, through a game of basketball played by the young women of the school in bloomers.

By virtue of his office, Gov. Ferguson is at the head of all the territorial educational institutions and regarding the bloomer incident he said today:

"The bloomers must go. While I am in a position to do so I will see that our institutions do not countenance such apparel. I believe in the young women and girls getting as much good as there is in physical culture and athletics, but it is going too far when the young women of the territorial schools get out in an apparel such as is worn by the 'Boston Bloomers Baseball Club,' an aggregation of women that have traveled extensively over the territory during the past season."

GIRLS ARE NOT TO BLAME.
"It is not right that the school girls should be the subject of ridicule. The girls are not to blame. It is the school and the parents who countenance such things that are at fault. It is an injustice to the young girls. I will put a stop to it. Indeed, I have notified the heads of the schools that there is to be no more basketball playing by Oklahoma's daughters in bloomers."

When asked if there were any further reforms of a similar nature he was contemplating in the schools of the territory he said: "Yes, there is one other matter which has been called to my attention. It is the practice of many of our school presidents and members of the faculties of smoking in hotel lobbies and in smoking cars on the trains."

SHOULD GIVE UP SMOKING.
"Smoking is a matter of personal desire and right and I would question no one's right to the pleasure of the weed. However, it does not seem to me that the heads of our schools and the occupants of the chairs of colleges can afford to set any such example."

"The teacher is taken as a model in every sense of the word by the students under him, principally because he is their leader. For this reason he should strive to set the best example possible and deny himself trifling pleasures if necessary."

HARD FATE OF A PEACEMAKER

Body of Hero Goes to the Dissecting Table.

ATLANTA, Ga., Jan. 16.—The body of James P. Ewing, who was shot to death on an outdoor Southern passenger train two weeks ago, by Fred L. Stephenson, has been sent to the Georgia Eclectic Medical College for dissection.

Killed in what seems to have been an effort to save the lives of others, and in an attempt to calm a drunken man who, crazed by the drink he had taken, was flourishing a revolver, it seems the irony of fate that Ewing's body should lie for two weeks in an undertaking establishment, unidentified and unclaimed, and then, under the city ordinance, be turned over to medical students for dissection.

Ewing was killed by Stephenson just after a Southern train left the union passenger station about two weeks ago. Stephenson was yesterday indicted for the murder of Ewing at about the time his victim's body was being taken to the dissecting room.

Ewing was a citizen of Ewing, and immediately after his death the body was taken to an undertaking establishment. Efforts to find any one to claim the remains failed and now they have been given to the college for dissection.

DIAGNOSIS BY PHONE.

NEW YORK, Jan. 17.—A. Halsey street resident of Newark was awakened at midnight recently by his wife, who said their infant son had the croup, and he must go for the doctor. There was a telephone in the house, and the husband suggested calling the physician by this means. The doctor said:

"Are you sure the child has the croup? I have been up most of the last three nights, am very tired, and do not want to go out if it is not necessary. Bring the child to the telephone and I will examine him."

The parents did so and after a moment the baby whimpered and coughed, quick as a wink the physician shouted, "That's croup, sure enough!"

He came and prescribed for the baby.
