WEATHER FORECAST.
A storm of considerable magnitude moved rapidly across British Columbia during the last 24 hours and is now centered over Manitoba. It caused general rains in Western Oregon and Western Washington and light snow in the Eastern portions of these states and in Idaho. It has caused high winds and gales along the Coast, the following maximum velocities being reported: North Head, 50 miles; southeast; Tootah Island, 55 miles; south.

COMMISSION IS
SEPARATE MATTER

Not a "Rider" on Levi Ankeny.

So Says Palouse Country Politician Who Is Here on Way to Olympia.

Residents of the State of Washington who make their homes on the west side of the mountains may cry as long as they please that the political fate of Levi Ankeny is coupled with that of the railroad commission bill. But on this matter G. M. Smith, a resident of the Palouse wheat section, has opinions of his own.
Mr. Smith arrived in Portland this morning and will remain in this city until 11 o'clock tonight, when he continues his journey toward Olympia, the Washington capital, where the struggle for United States Senator is now going on. Smith has no vote, but says he will get "in on the fun of the thing." He is well known in the Washington wheat belt and is a strong supporter of the candidacy of Mr. Ankeny.

"That Ankeny may be elected Senator and the commission bill pass, is not only possible, but probable," said Mr. Smith to a reporter for The Journal. "There are thousands on the East Side who favor Ankeny, while they also favor a railroad commission bill. They do not know why they want the bill. It is in the air; that is all."

EAST WANTS ANKENY.
"Do they know why they want Ankeny for Senator?" was asked, and to this Mr. Smith replied:

"You bet they do. Levi Ankeny is a man who owns property in the same country that East-Siders do, and they want him because they know with him in the Senate the East Side will get a fair deal. Then Ankeny has never made any sudden flops in policy. He has been the same all the way through."

Asked regarding Harold Preston and his chances, Mr. Smith said:

"Harold Preston is a poor Seattle attorney, while Ankeny is a business man of acknowledged means and ability. There is no comparison."

In response to a query he said that he felt sure Mr. Ankeny would win, as John L. Wilson had weakened Preston, taking from the latter a large percentage of the support he had at the beginning of the battle, while Ankeny had lost nothing at all.

Mr. Smith is an attorney of Tekoa, and has been prominently connected with Eastern Washington politics for several years. He is at the Hotel Perkins.

FUTURE OF JUNEAU.

"The business future of Juneau, Alaska, is promising and I believe it will continue steadily to progress until it becomes a city of importance, not only in the North, but throughout all the world."

Dr. Damomette, who has been for seven years attending the needs of the sick and afflicted in Alaska, gave the above opinion to a reporter for The Journal. Dr. Damomette left last evening for Seattle, and will take ship for the North, returning to his place of business after having spent several months in the United States. He is a great sufferer from asthma, and came South to obtain relief.

"There is a large country tributary to Juneau," he said, "and a country that is capable of much development. We may be slow in getting what we expect, but it will come in time, and those who are in on the ground floor will be the ones who profit most."

TWO DIVORCE SUITS.

Maud Ackers has instituted divorce proceedings against her husband, Charles W. Ackers. She alleges desertion as the cause of her action. The couple were married in this state in 1922, and in 1921 the husband deserted her. No cause was assigned, and she wants a divorce.

William McIndies has decided that if his wife will not live with him he might as well get a divorce. Therefore he has filed his complaint in the Circuit Court. He states that he was married to Elizabeth McIndies in Portland January 3, 1894, and that she deserted him in 1899 without any cause.

JUDGE BELLINGER
RETURNED TODAY

Enjoyed His Stay Among Hospitable San Franciscans.

Hon. Charles B. Bellinger, Judge of the United States District and Circuit Courts, returned this morning to Portland, after an absence of six weeks in San Francisco. He held court in that city during the absence of Judge Morrow, sitting as a Circuit Judge. Judge Morrow was called to Washington in connection with his duties as a Judge in the United States Circuit Court of Appeals, and also as one of the trustees of the Carnegie Library, recently dedicated at the National Capital.

In speaking of Judge Morrow's court in the City of the Golden Gate, Judge Bellinger says that the amount of business that comes before his court there is exceedingly heavy and that he certainly should have assistance in the hearing of so many cases.

"The people of San Francisco," said his honor, "certainly have this to their credit—they are the most cheerful, optimistic and hospitable class of persons I have ever been my pleasure to meet. I think that they surpass the world in these particulars."

WAS MUCH AMUSED.
"I was not a little amused," continued the Judge, "to read statements in the San Francisco newspapers to the effect that that city was experiencing what they call 'unusually cold weather.' Compared, I suppose, to their ordinary winter weather, the temperature was lower than they are accustomed to, but it did not seem very 'intense' to me. It is claimed that the winter there is the coldest since 1885."

"One day at the Merchants' Club a man who had come in from San Mateo told with great emphasis the astounding fact, in proof of the dreadful (?) cold, that he had actually noticed a thin film of ice that morning. This would amuse persons who have seen genuine winter weather."

Judge Bellinger has already begun to hold court, both as a trial Judge in District and Circuit Court cases. Judge Gilbert, who looked after judicial matters during Judge Bellinger's absence, and who has been in Portland for two months, will return Thursday to San Francisco to sit as a member of the United States Circuit Court of Appeals.

WHAT'S ABOUT
THE BIG FAIR

Omaha Woman Speaks Good of Portland.

I was talking with Mrs. Albert Curtis of Omaha, who spent part of last week in Portland. She was telling how, in her anxiety to see the city Mr. Curtis had so often described, she hardly allowed him to get their grips safely at the hotel before they took the car for Wilmette Heights. She was quite surprised to hear she had been looking out over the site selected for the Exposition. To be honest, she had a very hazy idea as to where the Fair was coming off. After four days at one of the leading hotels, too! She has visited all the Expositions of note since the Chicago Fair. The women of Omaha, she said, had an important part in the success of their venture. There were one or two of them on every committee that had to do with laying out the grounds or beautifying things generally. The Women's Building she thought rather a failure. Really gifted women prefer to exhibit with the men. Aside from the old curios collected, the articles, she thought, had little value. It was amusing to hear Mrs. Curtis' opinion of Seattle. Between its hills and parks she was decidedly glad to get back to Portland.

By the way, she thinks Seattle stores are not to be compared with our own. Even Omaha's are not so fine.

NOT ADVERTISED
Denver Has Scarcely
Heard of It.

Portland Needs Hotels to Handle
Guests—Those Here Are
Now Overcrowded.

In Denver, St. Paul and Sioux City little, if anything, has been heard of the Lewis and Clark Exposition, and Middle Western people to say nothing of those in the East, are not planning to come to the Portland Fair, because they know nothing of it.

While he declares the above to be absolutely true, Martin Murray, a commercial traveler for a firm in Louisville, Ky., deplorable conditions as he found them during a recent tour in the Middle States, Mr. Murray transacts much business in the Pacific Northwest, and takes a deep interest in the success of the Lewis and Clark Fair.

ADVERTISING NEEDED.

"It needs advertising," he said. "Good, live men, provided with proper literature, could do a great deal of good."

Mr. Murray makes his home in Denver, Col., and was surprised when informed that the National Live Stock Association would be held in Portland in 1934. "I had thought Denver would take the prize," he said, "but I guess it was written that the big gathering should come to the Northwest. Stockmen are taking a great deal of interest in this section of the country just at the present time, and the coming of thousands of them to Portland to attend the 1934 meeting will mean a great deal for this city. The railroad rate reductions to this city for the 1935 Fair should be announced at an early date, according to the opinion of Mr. Murray."

NEED EARLY RATES.

"If the reduced rates were announced now," he said, "they would, in themselves, be an advertisement for the Exposition. They would permit of plans being formulated now for coming to this coast to visit the Fair, and the sooner people begin to plan the more certain they are to make the trip."

"Get out literature descriptive of the Fair and the country that Fair is to represent, and send it East in the hands of good, live agents, who will work night and day for the success of the Exposition. That is the way to make it an assured fact. There are thousands who will want to come West just as soon as they hear of the Fair. Just now the Pacific Northwest is the best advertised and most talked-of section of God's kingdom. If you can just couple the Portland Fair with the Northwest and advertise it in the same way, offering inducements and making arrangements and preparations, you will have a wonderful triumph."

Anybody who shook his head and looked worried for Portland as he said: "But they have not advertised it as yet, and you never hear of the Lewis and Clark Fair in Denver."

HOTELS NEEDED.

With the National Live Stock Association convention for 1934 at the Lewis and Clark Centennial Fair both in prospect, there is a general feeling among travelers and those who are compelled to patronize hotels, that it behooves the City of Portland to inaugurate a movement for better hostelry. At the present time there are three first-class hotels in this city—the Portland, Perkins and the Imperial. On common lines, as this city is working at the present time, these houses are well used. There would be no room for the thousands of guests who are certain to make Portland their temporary stopping place during the two prominent events above mentioned, unless additional accommodations be provided. There has just been complaint against Portland hotels other than the three already referred to. Travelers have gone from here to other cities and "roasted" the service offered them, and scarcely an Eastern man comes to this city who does not complain that what he deems to be done to care for those who are expected to attend the stock meeting and the Fair.

ORATORIO OF "THE GALILEAN"

One of the largest congregations that ever came together assembled at the First Congregational Church last night to listen to the production of "The Galilean," by the choir. This is an oratorio that all lovers of music cannot fail to appreciate. There was not a single note or hitch anywhere. The soloists were Mrs. Rose Bloch-Bauer, soprano; Mrs. Max M. Shillock, alto; Lauren Pease, tenor, and W. A. Montgomery, bass. Dr. H. S. Lewis gave the invocation, and Mr. H. S. Lewis gave the reading parts of the oratorio.

Contrary to the announcement of a morning paper that "Dr. House" preached a most excellent sermon, that gentleman merely read a selection from the Scriptures, which served as an introduction to the oratorio.

COFFEE GOES FREE.

Melrose Coffey, alias Frank Carter, was discharged from custody last Saturday afternoon upon recommendation of Chief Deputy District Attorney Spenser. It was argued that it was hardly possible to convict him on the evidence at hand, and Judge George acted upon the recommendation of the district attorney.

Coffey was charged with complicity in the theft of a \$75 diamond stud from S. R. Hanawalt on the night of November 22. Harry Thomas was convicted of the charge and has been sentenced to five years in the penitentiary. Coffey had one trial, the jury standing six to six.

QUARANTINE LIFTED

For some time past the Boys' and Girls' Aid Society has been in quarantine on account of seven cases of scarlet fever. The ban has now been lifted and visitors are again allowed to visit the institution. During the quarantine it has been impossible, of course, to place any of the inmates in homes. There are now 40 children awaiting adoption.
