WEATHER FORECAST.

HOD BUTTER.

COFFEY BUTTER

Schulmich Makes Startling Allegation.

Says Lobbyists at Salem Would Nullify the Pure Food Law.

"If they can do anything underhanded to accomplish their purpose, they will do it," was the startling announcement of William Schulmich, president of the Oregon Dairyman's Association, to the Journal. Mr. Schulmich was speaking of the creamery men who are lobbying at Salem for the purpose of changing the latter part of section 2 of the present state pure food law.

"Yes, sir," continued Mr. Schulmich, "there are two persons at Salem at the present time who are trying to nullify one of the best portions of our present pure food law. I refer to Mr. Townsend of this city and Mr. Goodrich of Salem. The latter part of section 2 of the Oregon pure food law reads:

"It shall be unlawful for any person to offer or expose for sale any tub or packed butter remolded into prints or rolls or squares, unless the same is plainly marked 'tub butter,' and it shall be unlawful for any person who offers or exposes for sale remolded or remolded butter to mark or brand said butter with the stamp of any creamery or with the words 'Creamery butter.'"

"This is the part that these people are trying to change. They want to have the law fixed so that they can put tub butter in papers and mark it creamery butter, when it is not. In this way the public will be fooled. To gain their point these men will do all kinds of underhanded tricks."

Will Talk Their Game.

Being asked whether his association will do anything to stop the proposed change in the law, Mr. Schulmich answered:

"At the last convention Messrs. Judd and Eddy and I went to Salem to look into the matter of three to look out for the dairy interests at the session of the State Legislature. Judd and Eddy are there and I will try to arrange my affairs so as to be at Salem again, to defend the purpose of these two people. I merely came to the Journal for the purpose of reaching the people and pointing out to them the danger that is threatening."

DIVORCE ACTIVITY.

Oriana Cotes has filed an action for a divorce from her husband, John C. Cotes, in the Circuit Court. She alleges cruel treatment, and in addition that on December 10, 1902, her husband brought an express wagon and while he held her in bed, the two men took the stove and furniture, and carted it away in the wagon. Mrs. Cotes asks the Court to allow her \$10 per week while the suit is pending; \$100 for costs of the suit, and \$200 per month alimony after the divorce is granted—if it is granted.

Elizabeth Killow wants a divorce from William Killow, and in support of her action alleges cruel treatment. She says that on the glorious Fourth, in San Francisco, Cal., her husband grew exuberant and threw a bucket of water over her, not to cool her ardor, but because he was angry with her, and wanted to get revenge. There are two children, and she thinks the Court should compel the father to contribute \$10 per month to their support.

TOTAL TAX LEVY 11 MILLS.

In addition to the report of the proceedings of the City Council at its meeting yesterday afternoon, not already published by the Journal, the recommendations of the Committee on Ways and Means for a total levy of 9 1/4 mills was passed upon in the affirmative by the eight members present. The weakest levy—a special levy authorized by the act—was also affirmatively acted upon. This makes an additional levy of 1 1/4 mills, bringing the total levy up to 11 mills. The ordinance providing for the payment in installments of the assessments for street and sewer improvements, under the act of 1893, was unanimously adopted.

OREGON IN OLD TENNESSEE

The Chamber of Commerce has received a letter from J. J. Reason of Galatin, Tenn., stating that he has secured valuable literature concerning Oregon through his section of the country.
