

HORRIBLE STATE OF CITY JAIL

Filth and Disease There Stalk Rampant.

Sick Prisoners Quiver Under the Moans of Dope Fiends and Idiots.

He was very sick and his face was covered with blood. At intervals his whole body was shaken with sobs. The officer who brought him in watched him quietly while the Captain telephoned all over the city for a physician. Every now and then the night jailer took a sponge and wiped the injured man's face.

An hour later this man, well dressed, bleeding and sick, was put into a cold cell reeking with filth and unutterably foul with a foulness beyond expression. Portland's city jail has a cell, much in use, of which this is an exact description:

It is cement floored and cement walled.

It is possibly 12 feet square.

The floor slopes into a hollowed out center which acts as the receptacle for all filth of every description.

There is no window.

The only furniture is a low wooden bench against the inside wall.

The stench within this cell, even under the most favorable circumstances, is unendurable by a civilized man.

Every grand jury has protested against such a city jail.

Every Chief of Police has strenuously advocated immediate and radical changes.

The report of every grand jury has resulted in nothing.

"Lack of Funds."

Chief Hunt's scheme of renovation was rejected this week for "lack of funds."

Portland has no money to prevent the spread of disease in a filthy jail.

Two men have died in the jail within the past two weeks under circumstances that would have resulted in trouble for the city, had the men had friends interested in getting damages.

There is no provision made for keeping boys criminals elsewhere than with the hardened men in the main cell.

There is no place to keep the injured and sick temporarily.

There is no heat other than that from coal stoves.

There are no bathing facilities except for special cases.

A State of Horror.

Almost any night the visitor may hear the screaming and groaning of some dope fiend in the main cell and before many minutes of having to listen to this he will realize what the prisoners must endure.

And half a dozen officers must spend half their time about this place of infection. And Portland will not spend a cent to better the condition of her jail. There is no money in the treasury to save lives, no money to reform criminals, no money to secure the health of the peace officers, no money to save her from the shame of the rottenest prison on the continent.

This is officially stated.

In the meantime the injured writhe in filth, in the dying pass away in a reeking cell that must render death a longer relief, the criminal huddles within his damp clothes and hates a social order that condemns him to an existence such as would be considered fit for no animal.

It is officially decided that there is no remedy.

ing in the matter of the city jail. All three of these gentlemen deplore the frightful condition of affairs that exists and are unanimous that there should be radical changes. Mayor Williams said:

"It must be admitted that there is no site equal to the present one. The majority of crimes come from the North End, and the Police Station and city jail should be near that quarter. The present site is valuable property, and it is possible that the city might dispose of it if deemed advisable for a sum sufficient to buy a site more cheaply. The probabilities are that as a temporary shift we may be compelled to renovate the city jail, which all are agreed is necessary. There is no lack of sentiment, but there is a lack of money and we have no authority to increase the indebtedness of the city. It is shameful that the place should have been allowed to get into such a condition."

Sig. Sichel's Views.

"In the first place," said Mr. Sichel, "a city of this size should provide decent quarters for its prisoners. We shouldn't allow a horse used in the City Sprinkling Department to occupy quarters where its health would be endangered, and it is certain that a human being is entitled to fully as much consideration. I am certain that the present city government desires an economical administration of affairs. Certain improvements must be provided for. Grand juries have repeatedly reported on the horrible conditions prevailing in the city jail. I consider that for the present the city jail can be put into fair condition for a few thousand dollars, and that it may be made to answer all requirements for some years to come."

"If funds were available, I should favor the erection of a new jail building, but as there are no funds available, the sentiment of the Executive Board is to conduct the affairs of the city with good judgment, just as those of a firm are carried on, but we should not go to the extent of being penurious."

Gen. Beebe's Views.

"Great good will result," said Gen. Beebe, "in The Journal's putting forward the true conditions that exist at the city jail. Chief Hunt's report very accurately shows the deplorable and filthy conditions in that place, and there is no question but that they call for a remedy, and that right speedily. The demands of a growing city have long since outgrown the present inadequate quarters, and there should be more room for sanitary ones provided. As matters now stand, being without money or authority to increase the city indebtedness, I suppose that we shall be compelled to cleanse, overhaul and purify the old jail into some semblance to that of a human habitation, but I would favor, as soon as the matter can be provided for, an entirely new jail fitted up with modern requirements in the way of sanitation and good health."
