

ISSUES ORDER AGAINST CRIMPS

Cannot Interfere With
the Riversdale.

Captain Porter Is Not to Remain
to Give Testimony at
the Trial.

Restraining orders issued by Judge Ballinger of the United States District Court were served yesterday at Astoria on Paddy Lynch and John Kenney, the sailor boarding house men at that place, prohibiting them from interfering with Captain Porter, the British ship Riversdale, his vessel, or her crew. In the same order the Portland sailor boarding house men were also mentioned.

Porter Leaves.
The Riversdale is to sail at once, it not being deemed necessary for Captain Porter to remain here to testify in the case which will come up in the District Court shortly against those who were arrested for alleged complicity in the brutal assault made upon three sailors while they were aboard the vessel. After the attack it will be remembered that ropes were cut and an effort made to set the ship adrift. James White, Harry White and "Mysterious" Billy Smith, who run the Albino sailor boarding house, were charged with having something to do with the outrage, and soon after the occurrence were placed under arrest. They are now out on bonds.

Trial Not Set.
No date has yet been set for the trial. British Consul Laidlaw says that he is determined as ever to do whatever he can to put a stop to crimping in this port. The case will be pushed with vigor, he says, and he hopes for a speedy conviction of the guilty parties.

Many shipping people do not like the new crimping law, which was recently enacted. They state that it legalizes the business, and will have a tendency to make a trust of the local sailor boarding house.

made between Bourne and Fulton. Either would prefer to see the other win, rather than have the prize carried off by some representative of the Mitchell-Scott combination. Fulton, on the other hand, would infinitely prefer Bourne to any one else from Multnomah County.

Dark Horse May Win.
It must not be forgotten, however, that the struggle is rich in possibilities for the proverbial dark horse, and as has happened before, victory may ultimately rest with some man hitherto practically unmentioned. Multnomah County has several men who may be injected into the fight, and among them is Theodore B. Wilcox, who is now at the capital. It is said that if Bourne is elected, and with the backing that Bourne could give him, he would be a candidate of substantial strength. With all other Multnomah candidates out of the way, he might reasonably expect strong support from his own county.

Geer's Friends Hopeful.
The friends of ex-Governor Geer look forward to the crisis of the struggle with hopes increased by the results of this week. They have made a gallant fight for the candidate of their choice, and still cherish the belief that the wishes of the people cannot be ignored when a Senator is finally chosen. The support received this week from Multnomah was given with the two-fold object of preventing a break in his ranks, which might elect Fulton, and of cementing an alliance which might bring the Geer forces eventually to the assistance of Scott. There is always the possibility that as a last desperate resource by which to defeat the plans of Jonathan Bourne, Scott might throw all his influence to the ex-Governor, whose following would then embrace the majority of the Multnomah delegation.

Democrats For Wood.
Every Republican candidate looks longingly toward the 17 Democratic votes, but the indications are that they will be cast solidly for C. E. Wood until the last roll call has closed. Claims have been made that a few of the Democratic members are disposed to vote for Geer, if by so doing they can elect him, but such expectations are not likely to be realized.

Never Saw Jail.

"Well, I guess not—Mayor Williams has never been inside of the city jail, and knows nothing about the situation. Say, I'll bet the men who are in jail now don't know what a turkey looks like. It's like a hobo who was brought out the other day."

"He was standing at the railing, waiting to get his pack. A man came in and laid a \$10 gold piece on the counter. It was for bail."

"Let me see that, will you, old man?" asked the prisoner.

"Certainly," replied the owner. "The hobo scrutinized the coin critically, then threw it down, with a look of surprise on his face."

"What's the matter?" asked the owner.

"Why, it's been so long since I saw one, I thought the government had called them all in."

Same With Turkey.

"It's the same way with the city prisoners and turkey," continued the officer. "If a turkey should strut through the jail, they'd think they were asleep, and dreaming of their boyhood."

"A prisoner may be a prisoner, and still not be a dog," spoke up another old officer. "And this city jail is not fit to keep a dog in. No person who cared a rap for a dog, would keep him in such a place."

Thus the conversation went on, and various views were expressed as to the Mayor's utterances about the city jail, and the contemplated new improvements.

One man said: "When the Mayor criticizes the installation of an operating table, and a private room for the prisoner, when he criticizes private rooms for the Chief and the detectives, he simply shows that he does not understand the first principle of police work."

MANY BILLS IN THE FINAL GRIST

Work of the Legislature and Action
of the Executive.

(Journal Special Service.)

SALEM, Feb. 20.—Although a bill to compel attendance of pupils at school was rejected by the Senate, another measure intended to provide funds for the education of children was passed. Although this bill came up from the House, it was championed in the Senate by Pierce, of Umatilla, and it was owing to the strong and able arguments he presented in its favor that so many votes were registered in its behalf. Under the workings of this bill there will not be a child of suitable school age in the state of Oregon but will each year have \$5 devoted to its education. It is made compulsory on the part of the County Courts or County Commissioners to each year levy a tax for school purposes that will yield at least \$5 for each pupil in that county. This, it is planned, will raise every school district in the state to at least three months of school in every year. In the past this has been impossible in many instances.

Some Important Measures.

SALEM, Feb. 20.—House Bill 14, creating the office of State Labor Commissioner, needs only the Governor's approval to become a law. The amendments made in the Senate were concurred in yesterday by the House. Although the bill has undergone material changes in its progress through the Legislature, it still retains its essential features, and there is no doubt that it will be signed by the Governor. The most of the alterations made in it were made by the Republican majority for party reasons, and were vigorously opposed by the Democrats in both houses.

Another important measure which passed the House yesterday was Senate Bill 202, giving the Justices of the Supreme Court an increase of \$1,000 per annum in salary.

There was no opposition in the House to the Senate bill giving the State Land Agent a deputy, at a salary of \$300 per year. The need of an assistant in the office of the land agent is a matter of common knowledge. The task of comparing and correcting the records in the office is an arduous one, and cannot be performed by the Land Agent alone.

Right Fishing.

SALEM, Feb. 20.—Night fishing for trout is prohibited in the State of Oregon under the provisions of House Bill No. 335, which has passed both houses. This measure was strongly indorsed by the committee on game and recommended by those interested in the preservation of game fish.

That Land Commission.

SALEM, Feb. 20.—The claims of the State Land office investigating committee for expenses and clerk hire have been

State Printer Wins.

SALEM, Feb. 20.—House Bill 270 had many vicissitudes in the Senate, but has finally become a law. This measure provides for the purchase of paper needed in the state printing office by the State Printer direct, and not by him through the Secretary of State, as under the old law. When the bill came in from the House, it was favorably recommended, but several Senators took the floor against it and the vote began to show strongly against it. To save waste of time the Senate moved post-ponement and the motion carried. Two hours later the Senators began to awaken to the fact that this was a good bill, as it prevented red-tape delays, and brought about the purchase of paper by the man who is to use it and who is a competent judge of what he wants. It was then remembered that the motion had been simply to postpone, and not to "indefinitely postpone," so the bill was taken up on motion and this time it passed with ease.

Dairy Commissioner.

SALEM, Feb. 20.—The office of Dairy and Food Commissioner is made elective, to begin with the election in June, 1904, the term of incumbency is fixed at four years and the duties of this office are prescribed in House Bill No. 158. This bill was prepared by the committee on food and dairy products, the best points being taken from several other measures placed at the disposal of that committee.

Under the provisions of this bill as finally passed, the commissioner receives a salary of \$1,800 per year and traveling and office expenses of not to exceed \$1,200. Legal expenses may be incurred either in or out of the state, so long as the business on which the officer is embarked be in connection with his regular duties. Provision is made for a deputy at a salary of \$1,200 per year, this deputy to be a competent chemist.

A second deputy, to be a graduate of a reputable dairy school and to be known as "dairy deputy," is also provided for at a salary of \$100 per month. Seven hundred and fifty dollars is appropriated for laboratory fittings. The commissioner is also empowered to appoint other deputies, but these he must recompense himself.

In addition to this, the bill defines adulterated foods and prescribes a penalty for their sale, unless clearly marked "adulterated."

The present commissioner fulfils his term.

State Mining Bureau Bill Passes
the House After Going
Through Senate.

SALEM, Feb. 20.—An interesting incident of today's session in the Senate was the presence of Hon. F. X. Matthieu, who entered the House arm in arm with President Brownell, and was greeted with hearty applause. He was escorted to the Speaker's desk and President Brownell announced the distinguished visitor as "one of the last surviving members of the first provisional government of Oregon. In his time have occurred some of the most memorable events in American history, and it was his vote that decided whether Oregon should belong to England or to the United States."

Now Mining Bureau.

Senate Bill 237, creating a State Mining Bureau, was passed by the House this morning, after a spirited debate. For a time defeat of the bill seemed inevitable, but Wheelodon, Robbins, Davey, Malarkey and others rallied to its support, and it was passed by a vote of 49 to 17. This creates a mining bureau, to be located at Portland, and to consist of three members from Eastern Oregon, three from Southern Oregon and one from Portland, all appointed by the Governor. An appropriation of \$20,000 is made to defray expenses for two years.

The House concurred today in the Senate amendment to House Bill No. 27, fixing the rate of interest on the Port of Portland bonds at 4 per cent.

**HOUSE ACCEPTS

Party Vote Decides the Philippines' Coinage.
