

IS UNION AVENUE FRANCHISE VOID?

Residents Will Soon Bring Test.

Claim That Portland Railway Co. Falls to Live Up to Its Agreement.

Whether the franchise which the Portland Railway Company has held on Union avenue between East Burnside and East Washington streets has been forfeited by reason of the non-use of that portion of the company's line, is causing a great deal of discussion by the residents along Union avenue.

The company has not run any cars on that thoroughfare for several years, but it still claims the right to do so whenever it chooses to avail itself of the privilege.

When the roadway on the avenue was renewed about a year ago, that portion of the roadway upon which the company formerly had its track was conveyed by the railway company.

It is itself, they claim, proof that the franchise has not yet been declared void.

Residents along Union avenue are investigating the merits of the case, and it is quite likely that steps will be taken at no distant date to compel the company to run its cars on its own franchise.
