HOMER BIRD TO DIE TOMORROW

President Refuses to Pardon Him.

Beautiful Wife Whom He Deserved Worked With Ideal Devotion to Save Him.

(Journal Special Service.)
WASHINGTON, D. C., March 4.—President Roosevelt, having declined to interfere, the execution of Homer Bird, the Alaska murderer whose case has attracted widespread attention, will take place tomorrow in far-off Alaska.
The case of Bird reads like a novel. Six years ago he was a well-to-do business man in New Orleans. He had a beautiful and talented wife, several children and a happy home. Then he met the other woman, Naomi Strong, for whom he neglected his wife and children.
In 1897 he organized an expedition to Alaska, taking the woman with him, and also three men—Hurlin, Patterson and Sheffer. When the party had reached a point near the Slaughter House, on the Yukon, Bird was seized with jealousy on account of the attentions of the other men to the Strong woman. He deliberately shot and killed Hurlin and Patterson, and inflicted a fatal wound on Patterson, from which the latter died several weeks afterward.
Sheffer and the woman managed to escape and reported the facts. Bird was arrested, and at the trial the Strong woman testified against the man she had aided in his crime, and largely on her testimony, Bird was convicted of murder and sentenced to be hanged. Then his wife, who had been basely deserted, took up her efforts to save his life. She came to Washington and appealed to all the authorities here who could do anything for her husband. An appeal was pending in the courts, however, and President McKinley would not act until the appeal had been disposed of. The Supreme Court granted Bird a new trial. He was again put on trial and was once more convicted. Again there was an appeal on a writ of error, and a third

trial was granted by the courts. On this trial Bird was for the third time convicted of murder, and as a result his execution takes place tomorrow in the jail at Sitka where he has been confined for nearly five years.
The devotion and self-sacrifice of Mrs. Bird have been most extraordinary. She attended her husband upon all three of his trials, came to Washington to see President McKinley when the first respite was granted and has expended all the money which she could raise for his defense and appeals. During her recent visits here she has been received by President Roosevelt, Attorney-General Knox and others with the greatest consideration, but the convincing evidence of Bird's guilt and the atrocity of the crime made it out of the question for any further clemency to be exercised.

POLICE MATTERS DISCUSSED

Nothing startling came before the Executive Board and Police Commission this morning. Chief of Police Hunt presented his January and February reports, which showed that 330 arrests had been made in January and 448 last month. The payroll was approved; also bills amounting to \$44,556. Last month's bills were \$62,755. The expense of paying the board of witnesses in the recent sailor kidnapping case will be presented to the county.
"I do not think the city should pay the expenses of witnesses to be used in courts other than our own," said Mayor Williams.
The cost of police telephones was discussed. It is the opinion of the committee that the police company had better not raise the price of the police phones.
"They should charge us nothing," remarked Gen. Beebe.
Mr. Sichel thinks that the police headquarters and city jail should be heated by a furnace. "A furnace would not take much more fuel than one stove," he said.
The Mayor appointed Gen. Beebe and Mr. Sichel as the Executive Board members of the joint committee to inquire into the condition of the city jail. The Chief stated that the new patrol wagon would be here soon.

FIRE COMMITTEE TODAY

The Fire Committee of the Executive Council will report on the monthly bills of the Fire Department this afternoon. The fireboat will also be referred to, and the purchasing of a water tower for the department will also be discussed.

MAIDEN TRIP.

The steam schooner Aurelia arrived last evening from San Francisco for a cargo of lumber. She will load at the Portland Mill. This is the Aurelia's maiden trip. The vessel was recently built at Coquille River, and is owned by Russell & Rogers of San Francisco.

PIONEER LAID IN THE GRAVE

Other News Notes From the City of Salem.

SALEM, March 5.—The remains of the late Eugene Breyman were laid to rest in the Odd Fellows' Cemetery yesterday afternoon, a large concourse of friends following the casket bearing all that was mortal of the pioneer merchant to the grave. Salem Lodge, No. 4, A. F. & A. M., conducted the services, the deceased having been an honored member of the lodge for over a third of a century.
The Greater Salem Commercial Club last night signed contracts with E. J. Arnold, who will conduct the carnival here, the week beginning June 29, and ending July 4, next.
J. J. Chamberlain of Wallace, Idaho, who has been appointed manager of the local office of the Western Union Telegraph Company, has arrived and took charge today.
M. L. Chamberlain, chief clerk of the State Land Board, is lying ill at his home in this city, suffering from an affection of the heart.

Deaths at Salem.

SALEM, March 5.—Patrick Egan, an aged and highly respected citizen and pioneer of Marion County, died at the home of his son, Hon. W. H. Egan, eight miles north of Salem, at 2:10 p. m. He was 90 years 11 months and 19 days old. The funeral will be held from the Catholic Church at St. Louis, on Friday, at 10:30 a. m.
Deceased was a native of County Longford, Ireland, where he was born March 17, 1812. When 6 years old he came with his parents to the United States, and in 1832 came to Oregon, settling in Benton County. Six years later he removed to Marion County, and located on French Prairie, where he lived until his demise.
He leaves three sons and one daughter.

Mrs. Aiken's Death.

Mrs. Jennie Aiken, widow of the late John Aiken, died in this city yesterday morning, after a lingering illness, aged 65 years. The funeral was held this afternoon from the home of deceased, Rev. T. H. Henderson, of South Bend, Wash., conducting the funeral services at the home, and Salem Rehearsal Lodge, No. 1, I. O. O. F., of which deceased was a prominent member, officiating at the grave.

WEDDED AT SALEM.

SALEM, March 5.—Miss Myra Raymond, youngest daughter of Deputy Postmaster F. H. Raymond of this city, was yesterday united in marriage to Mr. M. L. Spangler of San Francisco, at the Raymond home, Rev. P. S. Knight officiating. A large circle of the most prominent society people of this city witnessed the ceremony and showered congratulations on the happy couple. The groom is a native of Corvallis, but now resides in San Francisco, where he fills the position of electrical engineer for the American Barbed Wire Company. The couple left last evening for Portland, whence they go today for their new home in San Francisco.

BIG TOBACCO CARGO TO ASIA

Indravelli to Carry 67 Carloads.

Two Trains of the "Divine Weed" Are Shipped Through the Port of Portland.

Two train loads of tobacco, the first shipment of this kind ever sent out of the Port of Portland, will leave the Columbia River on Saturday by the O. R. & N. Company's steamer Indravelli, bound for Japan and the Orient. In addition to this shipment of tobacco the Indravelli will carry her ordinary cargo of beer, flour and staples for Oriental consumption.
The tobacco shipment, the first of many, is made by the American Tobacco Company. Sixty-seven cars of tobacco traveled clear across the American continent, and were unloaded at the Portland docks and their contents transferred to the hold of the liner. The tobacco was grown in Virginia and North Carolina, and is being shipped for the most part in its natural form.
By far the larger portion of this shipment is consigned to dealers in Japan, and will there be manufactured into cigarettes for which the Orient is famous. "Hero" cigarettes, advertised by flaming letters on every hillside in Japan, are filled with American tobacco, and there are also manufactured at Hong Kong, China, several varieties of alleged American cigarettes which are placed on the Philippine and Australian markets as having come from the United States.
Six carloads of beer will also be shipped toward the Far East on the Indravelli, but this is only following out lines laid down long ago. Pacific Coast beer, as well as that made in Milwaukee and elsewhere, is shipped through the Port of Portland to the Philippines, to Japan and to China, and is found on sale in every "foreign quarter" in either of the three countries, as well as in Singapore.

Two Train Loads.

"This is the first tobacco shipment of consequence that has been handled by our company," said Freight Agent Ransom, who, under General Freight Agent E. B. Miller, is in charge of the trans-Pacific freight business for the O. R. & N. Co. "It will not be the last. Sixty-seven cars of tobacco is an immense amount. Over the roads between Portland and the country where this tobacco was raised a locomotive cannot pull, as a regular thing, more than 33 or 34 loaded cars. It will, therefore, be seen that two full train loads of the weed are being stored in the hold of the Indravelli, and will cross the Pacific."
In addition to the tobacco and beer there will be a large consignment of

flour and staple articles. We ship flour regularly, but never before has a shipment of tobacco been routed through this port.

ILLICIT WHISKY SEIZED TODAY

Through persistent and most clever work, Detectives Kerrigan and Snow of the Police Department effected the capture of a man this morning who gave his name as John Hussler. He was found on a scow on the river bank, near the old power house. A quantity of illicit whisky and the paraphernalia for making the same was seized by Kerrigan and Snow. It is probable that late this afternoon a charge of illicitly distilling whisky will be placed against Hussler.
Detectives Kerrigan and Snow have known for some time that there was an illicit distillery in operation in Portland, but where, they have been unable to tell until this morning. The two detectives have spent much time in their search, and but for their persistency the capture would never have been made. They have spent days and nights scouring the North End for the distillery. They went through almost every apartment and basement in the district. So systematic was the search that their efforts were crowned with success this morning.
It is understood that the revenue officers were aware of the presence of a distillery in the city, but were unable to locate it.

NANCE O'NEIL INSIST ON CHANGE

With the arrival of the Nance O'Neill Company in this city today there began an alteration that has extended up to the time of the going to press of The Journal this afternoon. Miss O'Neill was advertised by the management of the Marquam Theatre, at which she is to appear, as opening her local engagement with "The Jewess." This, it is claimed, she positively refused to do, alleging that since the beginning of her tour she has opened all stands with "Magda," and that she would play that tonight or nothing at all. "The Jewess" she is willing to present tomorrow evening. Requiring the lateness of the hour to announce a change of bill, the Marquam management strove to secure the carrying out of the program as advertised. At 3 o'clock it was announced that "Magda" would be presented tonight.

ENGINEERS MEET AT HOUSTON

HOUSTON, Texas, March 5.—Members of the Brotherhood of Locomotive Engineers are here from all the Southern and Western States in attendance on the big union meeting which will be in session during the next two days. The list of visitors is headed by Grand Chief P. M. Arthur of Cleveland, and a number of the other officers and members of the national executive committee are present. The business sessions, the first of which was called to order in the Auditorium this afternoon, will be interspersed with various features of entertainment provided by the local members of the organization.

MARINE NOTES.

Otto Skibbe, the young sailor who shot and slightly wounded Paddy Lynch, the sailor boarding house man at Astoria a short time ago, was found guilty in the Circuit Court at that place yesterday on a charge of assault with a dangerous weapon.
The British ship Riversdale went to sea yesterday with a short crew. Captain Porter secured eight men from San Francisco, the steam schooner Robert Dollar arriving with them yesterday. Upon their arrival the men refused to be transferred to the Riversdale and were forced to do so at the point of a revolver.
The steamer Elmore, which recently sank in the Yamhill River, arrived in Portland last evening in tow of the Ruth and was taken to the O. R. & N. boneyard for repairs.
The extensive repairs being made to the steamer Regulator at the Portland shipyard will soon be completed.
The British ship Hutton Hall cleared yesterday for Melbourne with 117,190 bushels of wheat, valued at \$93,709. It was shipped by Eppinger & Co.

POLICE SEARCH FOR CRUTCHLEY

Chief of Police Hunt, acting on new information in the case of George Crutchley, who has been missing for more than a month, has ordered a thorough search of the city to be made by his officers. He is determined to unravel the deep mystery, and has placed the matter in the hands of Captain of Detectives Simons.
Last night the three police patrols were furnished with the information published in The Journal, and received instructions to make special efforts to find a trace of the missing Crutchley. The police are inclined to the belief that he has been murdered and his body hidden in some out-of-the-way place.
Up to the hour of going to press there were no new developments in the case.

A CHANGE OF BILL.

Owing to non-arrival of the costumes for "The Jewess," in which Nance O'Neill was to appear at the Marquam Grand Theatre tonight, "Magda" will be the play. Seats may be exchanged for one of the other performances or money will be refunded at the box office.
