HIS PARDON WAS MERITED

Humphrey Rather Sinned Against Than Sinning.

SALEM, March 14.—The pardon granted by Governor Chamberlain yesterday to A. M. Humphrey, convicted in Marion County in 1902 of larceny by bailor of wheat stored with him, was the result of an active campaign waged by the convicted man's wife, who circulated petitions throughout the state. A dispatch in yesterday's Journal stated the fact of the pardon having been granted. The petition on which the Governor took action is signed by 446 of the leading citizens of the state.

The facts stated are to the effect that Humphrey, who comes from a highly respectable family in Marion County, is not one of the criminal class, has never before been accused of a crime, and has always sustained a high reputation. He has been in the employ of a Portland firm which uses only men of character and high standing. Humphrey had accepted wheat on storage, while acting as a warehouseman. Some of the wheat was shipped away by him, and when the owners called for their wheat, there was none there, nor was the money for it forthcoming. This shortage was due in part to the shrinkage of grain stored in the warehouse, and his employees and not himself took in the wheat in question.

Hon. George H. Burnett, the trial judge, in giving a statement of the case, commiserated with the defendant, and recommended a pardon. In his letter to the Governor he gives a statement of the case as shown at the trial, and in conclusion says:

"On behalf of the defendant also appear the facts of his previous good character and respectable family. These coupled with the anxious importunity of a faithful and affectionate wife who, with her children, must in their innocence be made to suffer for the sins of their father, and the many respects that the defendant himself, appeal strongly to any one of a generous nature, especially when the wrongs of those injured by the defendant's acts are not now so much in evidence."

MAIL DELIVERY IS BADLY WANTED
East Twenty-Eighth Street District Protests.

Postmaster Bancroft has begun his investigations into the conditions in the East Twenty-eighth street district relating to the free delivery of mail.

The question of extending the free mail delivery to the district was brought up in the local Board of Trade, with the result that a committee was appointed to interview the postmaster in regard to the matter. The committee reported that they had seen the postmaster and that he would look into the matter at once.

The East Twenty-eighth street district is now largely covered with stately residences where a few years ago there were nothing but large vacant lots. Parts of the district are now served with mail delivery and sometimes two mail deliveries a day. Other parts are not served with mail delivery and are compelled to get their mail addressed to the postoffice at Central, several miles off, or to walk to the West Side of the river.

A Resident Makes Complaint.
"I think it is an outrage," said a prominent member of the local Board of Trade today, "that our section of the city should not be given free mail delivery. The government is extending its rural mail routes over the entire country while here in such a large city as Portland some of the residents are compelled to go to the central office for their letters."

"It has been contended that the reason the East Twenty-eighth street district has not yet been given free delivery is on account of the lack of proper side walks and streets. This is not the truth, for the walks and streets in our section of the city are in as good a condition as they are in localities where the residents have been given free delivery for many years."

SANTA FE MAY BUILD IN HERE

Has Secured Right-of-Way in California.

(Journal Special Service.)
SAN FRANCISCO, March 14.—An announcement made today by general officers of the Santa Fe Railroad tend to confirm the opinion that it is the intention of that company to build northward into Portland and the Pacific Northwest. Already right of way privileges have been secured into the most remote districts of Northern California, and from that section it is but a step over the line into Oregon.

A Santa Fe official says: "You may say that certain persons acting in the interest of the Santa Fe, have acquired the El River & Eureka Road, the Pacific Lumber Company's railroad, and the California-Northwestern; that surveys are now in the field making surveys for the extension of these properties southward, and that eventually there will be direct rail communication between Eureka and this city."

It is known that negotiations looking to control of the capital stock of the California-Northwestern were undertaken by the Santa Fe some months ago, but the result or present status of negotiations is a matter on which the parties in interest have nothing to say.

A northern extension to Crescent City is mentioned as a possibility in the future, and the road is likely to go still farther.

ENLISTING FOR UNCLE SAM'S NAVY
Next Week Men and Boys May Have the Opportunity.

The naval recruiting office will open in the United States courtroom Monday afternoon at 1 o'clock. During next week it is expected that at least 50 men and boys will be enlisted in Portland.

F. Josephson, chief master-at-arms, arrived in the city yesterday, and has been busy today making all necessary arrangements for the examinations. The examination board will arrive in Portland tonight and will be ready for service Monday.

Boys of 17 and 18 years of age, and men ranging from 18 to 25, will be enlisted without respect to their having trades. Men over 25 will be required to show artizan's papers. Such boys enlisted at 17 and 18 years of age will be sent to the training ship at San Francisco, where they will be put through a seven months' course of training. When the course is complete a foreign cruise of a year's duration will be required, and on return home a further year will be given the young sailors in order that they may visit their homes before being assigned to regular duty. It is now possible for a boy to gain the rank of petty officer during his first enlistment. A petty officer has the advantage of attending the gunners' school at Washington, D. C., and may then take an examination for warrant officer and from that rank to a commissioned officer in the service.

Men over 25 years of age must have a trade and their wages average from \$30 to \$60 per month, according to line of service, such as yeomen, carpenters, machinists and the like. Such persons enlisted between 18 and 25 years of age will be immediately and prepared for actual service.

During the tour of the enlistment board an average enlistment of 40 men per week has been obtained.

MORMONS TAKING PLURAL WIVES
SALT LAKE CITY, March 14.—The grand jury has been called to investigate the rumors regarding the taking of plural wives by several business men and politicians since the manifesto of 1890. A meeting will be held in the city hall tomorrow next Sunday at which the local officials who are responsible for the call will be arraigned by Samuel Russell Young against whom charges have been made. Interesting developments are expected.

HARRY TALKED TO LABOR MEN

Oregon City Tolders Turned Out in Force—Other Items.

(Journal Special Service.)
OREGON CITY, March 14.—A successful and highly interesting meeting of members of the labor unions of this city was addressed by President G. Y. Harry, of the American Federation of Labor, at the Willamette Hotel last evening. The wage earners turned out in force, and hall being filled with the enthusiastic listeners. As a result of the gathering a Federated Trades Council will be established in this city at some date in the near future. Besides Mr. Harry, Mr. Harry Rodgers, President James, of the Cigar Makers' Union, and Manager Thomas, of the Labor Press, were present, each speaking to the crowd before the evening's entertainment ended. The Labor Press Quartet of Portland furnished excellent music that was appreciated by the audience, as was shown by the encores.

President Harry expressed his satisfaction for the progress made by labor unions of this city during the last year. And well he might. In Oregon City there are over 1,000 union wage earners. During the past year and a half the wages of these men and women had been increased by over \$30,000. This amount being added to the yearly sum received by the laboring people before the year was uncompleted. There has been some difference of opinion among the union members concerning recent events of which no mention need be made. It was explained that such differences can lead to weakness only, and it is the will of the laboring people of this town to avoid such troubles, as was demonstrated at last evening's meeting.

When the organization of the local council of the American Federation of Labor, known as the Federated Trades Council, will have been completed in the near future all trouble between the different unions will have passed. As it is now, every union in this city must fight its own battles. With the new council established, however, the unions will be closely bound together and what affects one will affect them all in a general way. If two unions have a misunderstanding their troubles are taken to the Federated Trades Council and adjusted. This council is composed of a committee of members from each union in the city. The prospects of the unions of this city are indeed very bright for the future.

Old-Timer Dead.
Mrs. Harry Fry, for 30 years a resident of this state, died at her home on the hill last evening. She was 75 years of age, death being caused by pneumonia. She is survived by three grown sons and two daughters, all but one of the latter being of age. Funeral services will be held tomorrow afternoon at 2 o'clock at the residence to be interred in Mountain View Cemetery.

M'INNIVILLE NOTES.

The election of the postoffice was a matter of the county ticket. At the election the majority of their ticket was defeated. BAKER CITY MAN IN PHILIPPINES

(Journal Special Service.)
BAKER CITY, March 14.—W. H. Fairchild, formerly of this city and rated one of the best outfielders in the Eastern League, is now in the Philippines, where he is stationed as corporal in a company, Twenty-Eighth Infantry, telling of his capture by the Moros and of being a prisoner among them for nine days. He refers to his captivity modestly.

The following is an abstract from the communication which was written to a former employer, Will H. Ellis, of the Ellis Transfer & Forwarding Company: "When we first reached the islands and were stationed on Luzon and doing guard duty, which consisted in the most part of changing latrines, I was contented, but now we are 700 miles south of Manila upon an island called Mindanao, among a people called Moros, the most cruel of the Philippine tribes. We are building a wagon road from Iligan to Lake Lano, a large lake, 100 miles from the coast. The work is hard and the danger is great. I had a small encounter with the Moros and was a prisoner for nine days before being found by my comrades and I don't want any more. I was treated much more like a dog than a human being and am lucky to be alive. Of course some are apt to say, 'I expect to live to see God's country about Christmas. It is 119 here in the shade.'"

Fairchild was familiarly known among his friends and ball fans as "Missouri" and was a clever player in addition to being a popular hero. He played a portion of the season of 1901 with the home team and later was employed by Mr. Ellis. The letter was written New Year's Day.

DISPLACES HAND LABOR IN GLASS
New Machine Will Greatly Reduce Cost of Production.

(Journal Special Service.)
PITTSBURGH, Pa., March 14.—The action of the American Window Glass Company in shutting down all of its plants today for an indefinite period is attracting much attention in glass manufacturing circles.

The company's action is taken irrespective of what the other companies may do. The American Window Glass Company has arranged to put a large force of men at work next week equipping all of its plants with the new glass-blowing machines.

It is said that all the factories of the country will be equipped with the new machines, which will do the work of the skilled labor by machine and remove from the glass factory the highest priced skilled labor known in the country. It will give the company glass production at a cost of less than one-third of the cost under the hand labor. It is believed the move prearranges a general cut in glass prices.

The action of the company in closing its plants and installing its machines is said to be its answer to the independent, who have refused to come to any agreement concerning a uniform closing of plants this spring.

CHAMBERLAIN RETURNS.
LONDON, March 14.—Secretary Chamberlain this afternoon arrived from South Africa. He was met by a distinguished party of friends, including General Lord Roberts, Premier Balfour and members of the cabinet. Chamberlain was heartily cheered by the crowds in the streets.
