Funeral of Henry W. Corbett Arranged.

Valuable Estate is Estimated at \$3,000,000--Heirs to the Property.

All that remains earthly of Henry W. Corbett will be laid at rest tomorrow afternoon.

Industry, integrity, charity, can well be written on Henry W. Corbett's grave.

Funeral Arrangements. Arrangements for the funeral of the late Mr. Corbett have been completed.

Employees from the First National Bank will bear the casket containing the remains of Mr. Corbett to and from the hearse and the honorary pallbearers will be the following:

C. A. Dolph, who for years has been close to Mr. Corbett in business, charitable and social matters, said: "The fortune left by the dead does not represent his estate, for a great share of his earnings and income was given over to charity."

Valued at \$3,000,000. Various estimates of the value of the estate left are given by persons who were in close touch with Mr. Corbett's business affairs.

The dead man held numerous interests in many of Portland's best business propositions. He was a director in the Oregon Railway & Navigation Company.

Mr. Corbett's real estate investments were numerous and the list comprises some of the most valuable property in the city.

Principal Heirs. The five principal heirs to the vast estate are Mrs. Corbett, the widow; Mrs. Helen Ladd Corbett (widow of Henry J. Corbett, the eldest son of the deceased); and his three grandsons--Henry Ladd Corbett, aged 22; Elliott Corbett, aged 18; and Hamilton Corbett, aged 15.

Other connections of Henry W. Corbett are W. E. Robertson of Portland; a nephew; Miss Henrietta E. Felling; Mary E. Felling and Mrs. H. C. Cabell, who are daughters of Mrs. Henry Felling, who was a sister of Henry W. Corbett.

NOTE, DOFFERS, CATCH WINNER IN PRIMARIES

Heavy Vote Pooled Throughout the County and Workers Were Active.

SALEM, April 1--The Republican primaries in this county yesterday held to elect delegates to the Marion County convention resulted in a victory for Claud Gatch. Mr. Gatch and Hon. Frank Davey contested for the control of the convention, both gentlemen being candidates for the Congressional nomination, and as both men stand high in the Republican party and have a wide following throughout the county, there was great interest manifested in the contest.

In the Salem precincts closed primaries were held, and the polls were kept open from 12 o'clock noon to 7 p. m.

Mr. Gatch will have about 200 of the 250 delegates to the county convention, and as he and Mr. Davey had agreed beforehand that whoever secured control should have a solid delegation from this county to the Congressional convention, that program will doubtless be carried out.

Mr. Davey, when seen last night after the returns were in, was quite cheerful and stated to The Journal representative: "I am a loyal supporter of Mr. Gatch. The Marion County delegation of 250 members to the Congressional convention will therefore be a solid Gatch delegation, and it is hoped by the Republicans of this county that, with delegates from other counties secured by Mr. Gatch, that gentleman may capture the nomination for Congressman."

John Gately and Peter Burns, alias Peter O'Donovan, thought to be firebugs, are lodged in the city jail. Gately was arrested shortly after 10 o'clock this morning at Tenth and Flanders by Patrolman Slover, and Burns was arrested last night at Eleventh and Flanders by Patrolman Endicott. Both prisoners are undoubtedly insane.

There is much circumstantial evidence against Burns. He is known to have purchased small quantities of coal oil at Ryan's grocery store of late, and when arrested last night he had a jug of oil with him. He was standing by a pile of lumber when caught. He had been rooming in the basement of the residence of Jacob Bohmer, 72 Tenth street. He had been performing odd jobs in payment for his room. In this room, which was in a most filthy condition, were found numerous bottles, in which coal oil had been stored at some time.

The clue that led to the arrest of Burns was given Patrolman Endicott by A. E. Clark, living at 402 1/2 Glisan street. He knew that Burns was daft, and when he saw him buy the coal oil in Ryan's store last night, connected him with the many recent fires. He followed Burns down the street, and when he found Patrolman Endicott he informed him of what was taking place. Endicott then participated in the work of placing Burns under arrest by the pile of lumber, which was recently set on fire.

Both Men Insane. Burns, when searched at the police station, was found to have two candles, a lot of matches, some crumpled paper in his coat pockets. It is evident that he, as well as Gately, is insane. He makes rambling statements, from which the officers are unable to extract the slightest intelligible fact.
