

LOVED AND LOST HIS IRISH LASSIE

An Affair of Youth Responsible for Condition.

Burns, Firebug Suspect, Has Been Daft Since Cast Off by Sweetheart—Not Right Party.

Peter Burns, in jail because he bought coal oil, and the police discovered it, is insane because the girl he madly loved in Dublin, Ireland, cast him off for another. It was many years ago, but this morning Burns cried pitifully about it, saying he still loved the girl. He would not tell her name.

The dominating thought in Burns' mind is his love for the Irish lassie. He told the officers about his past life. He was born in Dublin, grew up to manhood there, but came to America when his sweetheart married another.

Writes a Letter.
Chief Hunt gave Burns a sheet of letter paper, a pen and ink and asked him to write a letter. This was done in order that his handwriting might be compared with a letter received through the mail yesterday by Chief Hunt. Burns took a long time to write his letter. It did not look at all like the writing in the letter and Chief Hunt decided that the letter he got yesterday was an April fool.

Burns would not tell anything coherent or tangible about his love affairs, except to say that he loved a girl in Dublin, who did not care for him, but married another.

After talking nearly an hour with Chief Hunt, Burns went back to his cell. Burns makes no complaint about his incarceration, but seems to think it is all right. He laughs in a maniacal manner all the time.

Not the Firing.
Chief of Police Hunt and Captain of Detectives Simmons agree that Burns is not the man who is responsible for the many incendiary fires and the numerous incendiary attempts that have occurred of late.

"We have nothing to prove Burns guilty," said Chief Hunt, "except circumstantial evidence. He may have used some fire, but it is probable that he used the coal oil he purchased in his oil stove in his room. He says that is the only fuel he burns, and probably that is where he used all of the oil he bought."

John Kately, who was arrested yesterday morning on suspicion of being a fire bug, was released last night. He was found to be insane, and harmless. The police are just as much at sea as to the fire bug as they were yesterday. The solution of the case is as far off as it was when the Victoria Dock was burned to the water's edge five weeks ago.

Does Not Like Hypnotism.
The report that Mrs. Tilden knew the fire bug was received by me Tuesday morning, as published that evening in the Journal," said Capt. J. Simmons. "It was telephoned to the station by Mrs. Dr. Flora Brown, a practicing physician of 648 East Belmont street. I think it is a case unworthy of investigation, because it deals with hypnotism."

PARALYZED MAN IN CITY JAIL

Lay in Cell All Day, Never Showing Any Sign of Life.

An unknown man who boarded the Northern Pacific train at a small station beyond Kalama was brought to the police station this morning in the patrol wagon. The conductor of the train could do nothing with the man, so turned him over to the police. The stranger seems to be paralyzed and cannot speak or move a muscle.

Capt. Parker was in command of the police station when the man was brought in, and attempted to ascertain something from him. It was a vain effort, however, as the man could not utter a word. City Physician Zan was summoned, and pronounced the man paralyzed from intoxicating liquor. He did nothing to relieve the sufferer, but left the station saying the man would be all right later.

All day the man lay in his cell, neither moving or speaking. Several times he was approached by officers who tried to elicit from him something that would lead to his identity. But he appeared as one dead.

WHO WILL BURY THIS STRAY DOG?

Question as to the Ownership of a Dead Canine.

It was all about a dog and a dead dog at that.

Some benevolent person having the welfare of the city at heart and wishing also to conceal his identity so that the city's gratitude could not reach him, sent an anonymous communication to the Police Board, stating that a brown, shaggy and homeless dog had on one day last week crawled under his house, beneath the very family hearthstone and there inconveniently died.

The letter further states that rather than be annoyed with the idea and other suggestions that the dog was under the house, he applied for relief to the poundmaster, and was told by that gentleman that it was the poundmaster's duty to capture live dogs and that dead dogs were beyond his jurisdiction. The police were then appealed to, but they could not see how the simple guardians of the peace could loan themselves to the undertaking department of the city.

The matter was taken up and discussed fully by the commission and the following plan of action was agreed upon.

That the man should himself take the dog from under his house.

That under no consideration would the dead dog be allowed to creep into the city's records.

That the poundmaster need not assume the air of a Beau Brummel when requested to move a dead dog.

SUES FOR \$10,000.

A suit was filed in the United States Circuit Court yesterday by Alfred A. Bronkey, a boy 12 years of age, through his father, P. E. Bronkey, against the Southern Pacific Company, to recover \$10,000 for injuries alleged to have been received by the boy on June 24, 1902. The complaint shows that young Bronkey had attended commencement exercises at Mount Angel College and, owing to the crowd at the station when the exercises were over, he was compelled to return to Woodburn in a box car. While standing near the open door of the car the train gave a sudden lurch, throwing the boy out of the car, where he was run over by the train and crippled for life.

BEYOND A GRAVE IS REST

Last Sad Rites Over the Body of Henry W. Corbett.

Fully Three Thousand Persons View the Remains.

Long before the hour set for the public obsequies to be held over the body of the late Henry W. Corbett, the First Presbyterian Church, at Twelfth and Alder streets, was thronged with mourning relatives, friends and admirers of the illustrious citizen whom the Divine Master called from their midst Tuesday morning.

Never before has greater honor been paid to the dead than that which touched the last bow of the philosopher lying before the altar in God's house of worship this afternoon. A thousand silent prayers went out from those assembled. The offerings of supplication hovered the bier and then went on to Heaven.

"Blessed are They That Mourn, for They Shall be Comforted."

A few minutes after 1 o'clock this afternoon the employees of the First National Bank congregated at the late residence of Henry W. Corbett, and with bowed heads carried the casket from the chamber of death and laid it in the hearse waiting in the street below. Thence to the First Presbyterian Church was the vehicle driven, followed by carriages containing the near relatives and friends of the dead. A silent, mournful procession which compelled men along the streets that it traced to remove their hats and remain with uncovered heads until it had passed.

Arriving at the church the same pallbearers carried the casket to a position immediately before the altar. Floral offerings were placed about the bier. The covering of the coffin was removed and before the final funeral ceremonies were begun 2,000 people had passed before it, each one remaining long enough to gaze on what remained earthly of the people's friend.

Occupying the front seats and to the right of the altar were the immediate members of the family. To the left were seated the active pallbearers. Near the relatives of the dead man the honorary pallbearers were gathered. Further down the center aisle were committees of the Chamber of Commerce, Lewis and Clark Exposition, State Circuit Court Judges, Mayor Williams and members of the city administration, members of the Board of Trade, members of the Multnomah County Fair Association, representatives of civic organizations, members of the Oregon Pioneer Association, and hundreds of others who had come to pay their last respects.

Raised His Voice in Prayer.
Promptly at 2:15 o'clock Dr. Edgar P. Hill came into the pulpit and raised his voice in prayer. The vast congregation arose to its feet and every head was bowed. The choir chanted a "Te Deum." Dr. Hill, coming to the front of the altar, began one of the most simple, yet appealing funeral discourses ever delivered in Portland. He recounted briefly the good deeds of the dead, while God had spared him on earth. He praised his character which had been so suitable with charitable instincts, and finally thanked the Creator for not having sooner called him home.

At the conclusion of the ceremonies the casket was borne to the waiting hearse, and accompanied only by relatives and the nearest friends of the bereaved family, it was taken to River-view Cemetery, where private services were held.

Many messages of condolence have been received by the widow of the dead since Tuesday. Among others were telegrams from Senator Levi Ankeny of Washington, C. H. Harriman of the Southern Pacific system, Governor Mont. B. of Washington, and ex-Governor Z. F. Moody.

Memorial Resolutions.
Resolutions have been adopted by the Manufacturers' Association in memory of Henry W. Corbett and a copy forwarded to the widow. They are the following:

Resolved, That the Manufacturers' Association receives with deep sensibility the announcement of the death of Hon. H. W. Corbett, and tenders to the family and relatives of the deceased the assurance of its sympathy in their bereavement.

Resolved, That the Manufacturers' Association appreciates deeply the loss which has been sustained by the City of Portland and State of Oregon in the death of a man so well known and so highly respected and honored by all that words of eulogy are superfluous.

Resolved, That the Manufacturers' Association directs that a copy of these resolutions be forwarded to the family of our deceased friend and be spread on the minutes of this meeting.

Resolved, That we extend to his bereaved widow and family our sincere and heartfelt sympathy in this their time of trouble, and sincerely trust that the good work done by our late lamented fellow citizen will serve to ameliorate the sorrow which his bereaved family is called upon to bear; and be it further Resolved, That a copy of these resolutions be forwarded to the family of our deceased friend and be spread on the minutes of this meeting.

The following resolutions of sympathy

for the Board of Directors of the Lewis and Clark Fair on account of the death of Mr. Corbett were adopted yesterday at a meeting of the Lewis and Clark Women's Club of McMinnville.

Resolved, That we deplore the death of the Hon. H. W. Corbett, president of our Exposition, whose wise counsel has given to the people of this state confidence in this enterprise; be it also Resolved, That we tender our sincere sympathy to the Board of Directors of the Lewis and Clark Fair for the loss of the guiding hand of their president. Yet we have the fullest confidence that the work he has planned will be executed with honor to the founder and credit to his adopted city and state.

Resolutions in memory of Mr. Corbett have been ordered prepared by the committee of the Lewis and Clark Exposition and will be embodied and one copy transmitted to Mr. Corbett. Also has the Chamber of Commerce ordered that a memorial set of resolutions be framed and made a record of the institution.

Police on Duty.
Captain Moore was in command of the police at the funeral. He had four officers on duty.

Among the beautiful floral offerings were the following: From the Associated Banks represented by the Clearing House, a large wreath of roses, japonicas and lilies of the valley; from the Security Savings & Trust Company, a wreath of roses, sheath of grain and palms; from the London, Paris and American Bank of San Francisco, a wreath of roses and hyacinths; from the Portland Hotel, a beautiful vase of roses, calla lilies, a sheaf of grain and palms; from the Pacific University, a bank of calla lilies and Oregon grapes; from the Willamette Iron & Steel Works, a column of white flowers and carnations; and several individual offerings were also displayed around the altar.

PRAISE COMES FROM ASTORIA

(Journal Special Service.)
ASTORIA, April 2.—The late H. W. Corbett was one of Astoria's most persistent commercial enemies, but his death caused profound sorrow here, where the famous Portlander's sterling worth was appreciated. He was the guest of the city on several occasions and had many loyal friends here.

In the office of County Clerk Clinton is a small sum of money that is part of the great Corbett estate. The sum is about \$50 and it has long been subject to the order of the dead millionaire. The little story of the matter is interesting and shows the financier's great love for the city in whose upbuilding he played so prominent a part.

After a quarter of a century of failure, Astoria finally interested A. E. Hammond in her railroad proposition, committees of citizens were appointed to look after the various matters connected with the enterprise. One of this committee was given charge of right-of-way. Steps of considerable magnitude made their concessions until Mr. Corbett was encountered. With other capitalists, he owned a piece of choice property near the foot of Ninth street. The committee called on Mr. Corbett at Portland to ask for the right-of-way, but met with emphatic refusal.

What Would You Do?
"Never will I come to it!" exclaimed Mr. Corbett. "What would you do, gentlemen? Would you tear down these magnificent buildings that we have erected here? It would be a crime to build a railroad to Astoria!" Unable to convince Mr. Corbett that Astoria's interests were identical with Portland's, the committee returned home and regretfully instituted condemnation proceedings in the courts. The committee's petition was granted and Mr. Corbett was allowed \$50 damages. The committee at once paid over the amount, which was placed in the care of the county clerk. Mr. Corbett was notified that the money awaited his order, but he ignored the notice and refused to accept the court's award. The money still is in the clerk's hands, and it is just possible that he heirs may collect it.

WORK ON PUZZLE OF LONG STANDING

Interstate Commerce Commission to Dissect Santa Fe.

SAN FRANCISCO, April 2.—The old question of whether the Santa Fe and the Southern Pacific railroad companies are parties to an agreement by which freight rates are divided between the roads regardless of the wishes of shippers, is to be taken up again by the Interstate Commerce Commission on the occasion of the visit of that body to the Coast next week. Orange shippers claim they have no benefit of competition, and that a pooling arrangement exists contrary to law.

BRUTAL ASSAULT ON GIRL

Cook at National Hotel Strikes a Defenseless Woman.

Knocks Her Down With Heavy Plate, Inflicting Serious Injury.

Brutal and unwarranted in the extreme was the attack made last night by Leonard Ball upon Miss Pearl Lovely.

The first is a big, husky fellow and the other a frail and delicate woman. The assault occurred at the National Hotel, and from the best evidence obtainable was entirely unprovoked. Ball is a cook, and in a moment of unprovoked anger, smashed several plates over Miss Lovely's head, inflicting injuries that are both serious and painful. Miss Lovely is a waitress at the National.

Patrolman Nash was called, and placed Ball under arrest, charging him with assault with a deadly weapon. The case came up for hearing this morning in the Municipal Court, but was continued over until tomorrow morning.

The trouble last night is said to be the outgrowth of Ball's dislike for the manner in which Miss Lovely gave orders. He is said, desired her to do as he told her, and when informed by her that she knew her business and would do as she pleased, he grew violently angry, and more than once has threatened to do her bodily harm.

Miss Lovely entered the kitchen, and, as usual, gave her orders. Without a word, Ball is alleged to have picked up a number of heavy restaurant plates, and began hurling them at the waitress. The first one he threw struck her with such violence that it was broken into several pieces. Ball had time to throw several more plates before he was restrained.

With the first blow, Miss Lovely fell to the floor. She had been rendered unconscious by the force of the impact, the plate striking her directly on the top of her head. Blood streamed from the wounds, and it was fully an hour before the injured waitress was able to walk to her room. She has been confined there ever since.

Ball would have been severely handled had not the attention of the men present been directed toward alleviating the sufferings of Miss Lovely. Every one connected with the hotel places the entire blame upon him, each saying that Miss Lovely has acted within her rights at all times, and that Ball has for some time past been very ungentlemanly in his conduct.

Great excitement reigned when the crash of the dishes was heard by the patrons of the restaurant. Thinking that murder was being done, dozens of people rushed in, wild to witness the scene. Ball was discharged after the affair last night.
