

CAREY MAY GO TO ARGENTINA

Oregon Delegation Recommends Him.

May Succeed Ex-Governor Lord in Mission to Southern Republic.

(Journal Special Service.)
WASHINGTON, D. C., April 2.—Judge Charles H. Carey of Portland, Or., has been recommended by Senator John H. Mitchell, Senator Charles W. Fulton and Congressman J. N. Williamson as the successor of ex-Governor W. P. Lord, who is now serving as United States Minister to the Argentine Republic.

The recommendation has been filed with Secretary of State John Hay, who is now making a tour of the West Indies. The absence of Secretary Hay may account in part for the Argentine Ministry remaining in statu quo so far as action on the Oregon delegation's recommendation is concerned.

The recommendation was made by the Oregon delegation with no difficulty in arriving at a decision. At least, that is the view of the men here who are at all versed on the subject. Judge Carey is a distinguished citizen of Oregon who has taken a very prominent part in the conduct of political affairs in that state. He has been a life-long friend of Senator Mitchell and his selections may logically be presumed to have been largely resultant from the senior Oregon Senator's desire, though it is not to be inferred from this that the other members of the delegation were lacking in cordiality in concurring.

Appointed by McKinley.
Ex-Governor Lord was appointed Minister to Argentina by the late President McKinley. He was formerly Governor of Oregon, the immediate predecessor of T. T. Geer, and was on the bench of the Supreme Court of that state prior to his selection as Governor.

The reason why the Oregon delegation has recommended a successor is not known, beyond an intimation that Mr. Lord is not desirous of remaining longer at this present post, and the delegation, earning... at such was the case, took the matter under consideration and determined whom they would recommend as Mr. Lord's successor.

It is impossible at this time to predict what action will be taken. The post of Minister to Argentina is regarded as quite important, especially at this time, when the relations of the United States with South American republics are becoming constantly more vital and in view of the recent revival of Monroe Doctrine agitation.

So far as known, no dissatisfaction has been felt with the service of Mr. Lord, and on the contrary his term has passed with unusual credit to the incumbent.

That there will be other applications and recommendations from delegations from other states goes without the saying.

Desirable Place.

The Argentine Ministry is looked upon as a very desirable billet. Only one drawback may be cited—the salary is scarcely sufficient to permit the Minister to maintain the social establishment that seems to be demanded by the people there from the representative of a foreign government.

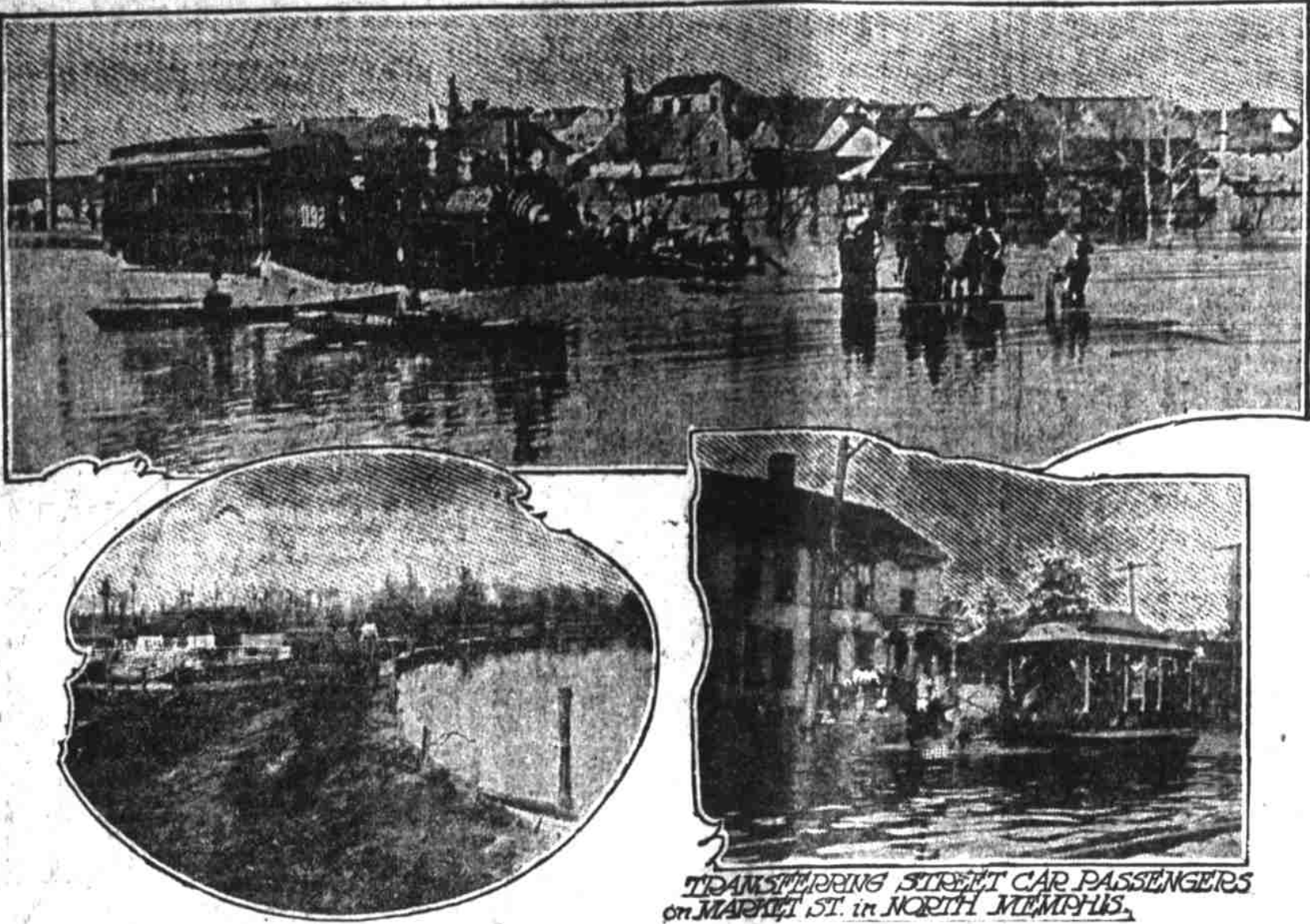

EXPERTS CHARGE COUNTY CLERKS

Shortage of \$3,554.45 Found.

Bondsmen Will Probably Be Sued and Other Measures Taken If Necessary.

The County Commissioners have not decided what action to take in the alleged shortages of three former County Clerks, as reported by Expert George Black and his assistant, George Bartlett.

Several months ago the County Commissioners called for an examination of the books of the County Clerk's office covering the terms of H. C. Smith, Hanley H. Holmes and Lot Q. Sweetman. It was found that a shortage of \$27, said to be against H. C. Smith, while he was incumbent from 1894 to 1895, a shortage of \$2,959.49 was discovered in Hanley H. Holmes' books during the time he was County Clerk from July 7, 1898 until November, 1901. At his death Lot Q. Sweetman succeeded to the office and held the position until July 1, 1902, and during his term a shortage of \$368.95 was found.

According to the report of the experts the shortages occurred more particularly in transactions in reference to delinquent taxes. Gross errors in this respect have been discovered during the terms of Holmes and his successor, Sweetman, also in Sweetman's term and discrepancies found in the collection of marriage license fees, articles of incorporation fees, etc. In one or two instances the report shows that the most reprehensible methods were used in covering up discrepancies, erasures of a "bungling" nature have been made by some person or persons for whose actions the County Clerk's holding office at the times are unaccountable.

More Publicity Needed.
One matter of particular significance pointed out is the loose method which has obtained in cancelling delinquent taxes, and a strong recommendation is made by the experts that close attention be given the subject by the County Commissioners. The report finally embodies a recommendation that publicity be given to many matters of record that are at present kept hidden.

County Commissioner Showers was at the Court House bright and early this morning and held several conversations with persons who asked him concerning the nature of the report, and what procedure would be undertaken to prosecute the county's claim against the bonds of the delinquent County Clerks mentioned in Mr. Black's report.

To the Journal reporter Mr. Showers said: "It was not until yesterday afternoon that I knew of the character of the report that the experts made. I at that time received a copy of it and immediately began to think. At present I can only say that I see no reason why the shortage money cannot be collected from the bondsmen of the Clerks so charged."

"Will criminal proceedings be instituted?" was asked.
"I am not able to say what will be done," replied the Commissioner, but so far as the taxpayers of Multnomah County are concerned, nothing will be lost, nor will guilty persons go unpunished, but to find the guilty is the question."

"The county has been put to a large expense already, has it not, by hiring two experts?" was asked.
"Yes, good salaries have been paid Mr. Black and Mr. Bartlett for several months."

Bondsmen Can Be Held.
Judge Webster, when asked whether a bondsman could be liberated from responsibility after the bondholder had filed his report and left his office, replied: "I recall no law which releases a bondsman

at any time, be it ever so long after the bondholder has been discovered short in his accounts." Judge Webster concluded by saying that he had not been consulted by the County Commissioners, and did not know what would ultimately be done in the matter.

The case is a peculiar one and more or less a surprise, according to several old employees about the county offices at the Court House. Some, however, say that so long as three years ago a sort of unhealthy condition was suspected, and it was almost decided at that time to have an expert examination of County Clerk Holmes' books made. It is said with truth that Mr. Holmes was ill nearly the entire last year he held office, and his death delayed an investigation which was about to be inaugurated.

During Mr. Holmes' sickness the office was conducted by Lot Q. Sweetman, who succeeded Holmes at the latter's death, November 6, 1901.

In conversation with the present County Clerk Fields this morning it was ascertained that for nearly four months experts Black and Bartlett have been engaged on the county books. Mr. Black receives a salary of \$225 per month and Mr. Bartlett \$100 per month.

"Were these men engaged to expert the County Clerk's books and no others, Mr. Fields?"
"No; the new County Commissioners, I understand, decided to bring every detail of the county's business up to date, and the report on the three County Clerks is one of the results."

The Recommendations.
"How about the recommendation that the Commissioners should hereafter look carefully into matters of tax delinquencies, Mr. Fields?"
"It is a good one," was the reply, "but they will find things mighty straight nowadays."

At the Sheriff's office the same feeling of security was evident. It is said that great care is being exercised in regard to tax collections and the cancellation of delinquencies.

Ex-County Clerk H. C. Smith, who is charged with a shortage of \$27, said to be against him, said: "I am not at all sorry that the small amount must have been due to an error, which I must have had difficulty in clearing up and explaining. His bondsmen for his term were James Stott and Abe Tichnor."

Hanley H. Holmes had for bondsmen for his first term C. B. Bartel, E. P. Sweetland, ex-Mayor H. S. Rowe and Joseph Paquet. For his last term the American Bonding & Trust Company of Baltimore was his surety. Lot Q. Sweetman retained the same Baltimore concern on his bond.

Lot Q. Sweetman and Mrs. Hanley H. Holmes, widow of the late County Clerk, appeared before Judge Webster at noon today and petitioned the court to delay action in regard to the alleged shortage, until they had had time to carefully go over the books of the County Clerk's office and check up for the purpose of determining the exact amount of any shortage that might exist.

Mr. Sweetman, in speaking of the matter to the Journal reporter this afternoon, said: "If a shortage is shown, the money will be remitted to the County Commissioners. I do not believe that criminality can be charged against any clerk employed in the office during Mr. Holmes' or my incumbency. Errors may have caused shortages, for which the County Clerk is accountable. Judge Webster will not proceed in the matter, I am very sure, until we can definitely ascertain our position in the premises."

Asheamed of Her Hair.
An aged lady, known as Miss Owens, died suddenly this morning about 11:30 o'clock at 422 North Greene street. Captain Fullum has ordered her body to be removed to the Morgue, as she does not seem to have any friends or relatives.

The deceased was said to be 55, but looks to be much older. She has occupied a room at the above address for the past five years. She never went out for any length of time, or received any mail. When the police searched the room this morning they found a lot of antique articles and a small amount of money.

A peculiarity about the deceased was that she always was extremely unwilling to show her hair. She wore a bonnet indoors and out, and when the bonnet was removed, wrapped her head in a towel. The towel was removed after she was dead, and her hair was found to be snowy white. A bundle of letters, none of recent date, were also found by the police, and will be examined this afternoon, in the hope of getting a clue to her identity.—Baltimore News.

Queer Things About Slag.

Esperanto.

Volapuk is dead, but a simpler international language, Esperanto, is flourishing, with a growing literature and a score of periodicals as its organs, and a society for its study in London has just been founded. The creator of Esperanto is a Polish doctor, who from boyhood thought it a pity that the people around him, who were of different nationalities, should not know each other because they spoke different tongues. It is so simple that a man can learn enough of it in eight hours to read, with the help of a dictionary of 800 words, an Esperanto book; while educated men in many countries find it so capable of expressing the most delicate shades of meaning that they are spending days and nights in perfecting it. Esperanto is, in fact, a vocal international shorthand. Its two peculiarities are its invariable terminations—O for nouns, A for adjectives, E for adverbs, and its system of word-building, by means of which from one root word, such as "sano," meaning health, fifty other words can be constructed.

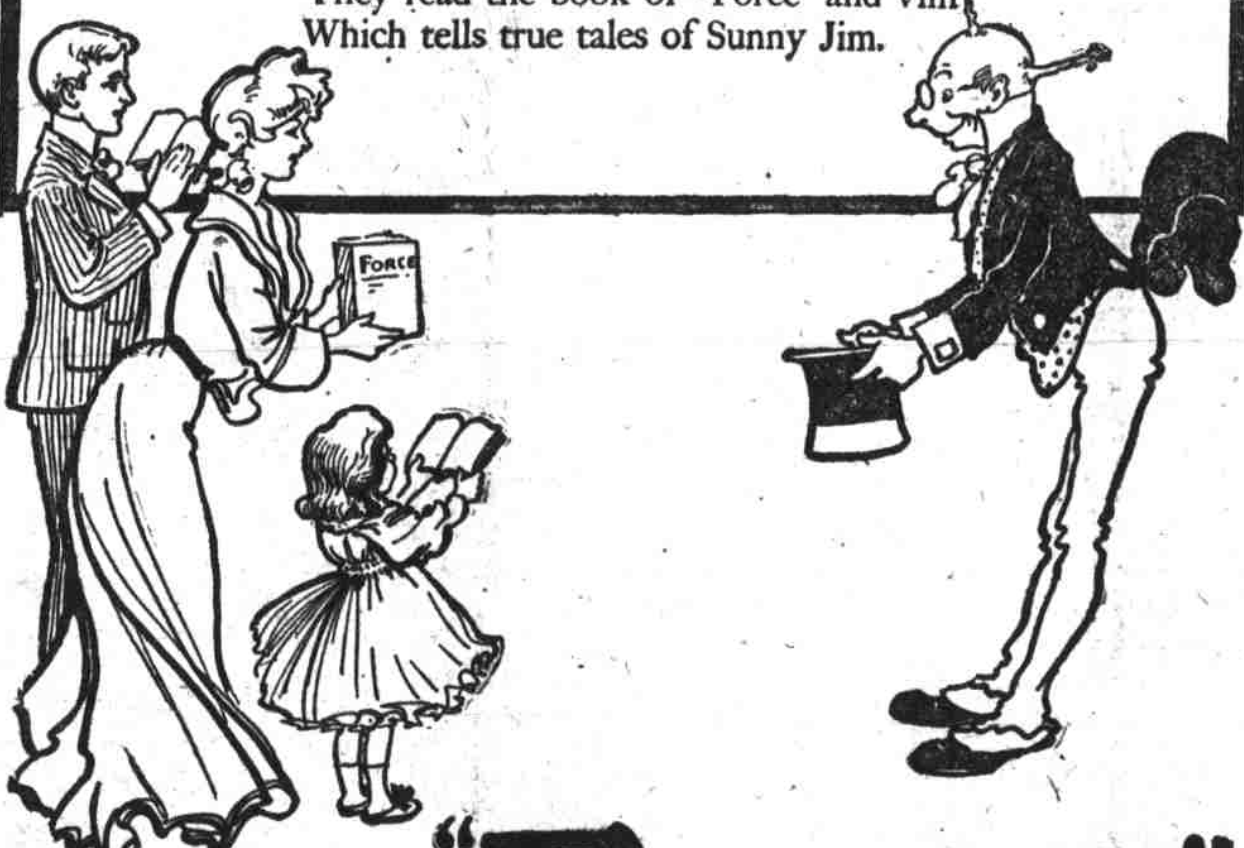
