

NEW INDUSTRIES FOR EAST SIDE

Standard Box Factory at Work on New Site.

Sawmill Will Be One of the Largest on Pacific Coast—East Side Mill's Yard.

The Standard Box Factory Company has begun the driving of piles for its new sawmill and factory at the foot of East Ankeny street. The building will be 42x192 feet in dimensions and will be equipped with the latest machinery.

The following other buildings will also be erected by the company on the land leased from the river to East First street and from East Pine to East Ankeny streets: Boiler house, 36x42 feet; engine house, 24x20 feet; two dry kilns, 48x25 feet each and a planer shed 36x129 feet. It is also the intention of the company to build a box factory during the present year, and the present factory at the foot of East Washington street will be moved to the new site.

The entire plant when completed will cost nearly \$150,000 and will be one of the largest institutions of the kind on the coast. The saw mill will have a capacity of about 100,000 feet of lumber a day, the entire product to be used in the manufacture of boxes.

Sawdust Mill Will Move.
A number of saws are located on the land upon which the new factories are to be built and the owners have been given orders to move without delay. It is not the intention of the company to work any special hardship on these people, so they will be given until the June rise in the river before they are forced to vacate. The company is also extending East Water street to East Ash street, a distance of two blocks, and work on that project is being pushed by the contractor. A pile driver has been in operation for several days and as the material is already on hand it will not take very long to complete the work.

The East Side Mill Company, which has a plant at the foot of Spokane avenue, Sellwood, will soon begin the work of constructing a lumber yard adjoining the box factory site. The land for that purpose was purchased about six months ago and it is the intention of the company to commence operations as soon as the mill at Sellwood is completed. The lumber from the Sellwood mill will be brought to the yard by flat cars on the new line which the Oregon Water Power & Railway Company is constructing. A franchise for the branch down East Water street has already been secured. The Sellwood mill will employ about 75 men when in full operation.

WEATHER FORECAST.

The storm yesterday over the British possessions north of Montana has been reinforced by a second disturbance, and the two combined now form a well defined storm area, the center of which is apparently off the British Columbia coast. Southwest storm warnings were continued at all stations this morning. Heavy rains have been general in the North Pacific States during the last 24 hours, except in Southwestern Oregon and Southeastern Idaho. High winds also occurred along the coast and in the Sound country, the following maximum velocities being reported: Tatoosh Island, 62 miles, southwest; North Head, 44, south; Seattle, 34, southeast; Tacoma, 30, southeast; and Portland, 34, southwest.

The indications are for occasional rain in this district Wednesday. It will be slightly warmer tonight in Northeastern Washington and extreme Northern Idaho.

NEW UNIFORMS FOR THE POLICE

Chief Hunt and Others to Appear in Gay Attire.

The Portland Police Department, from the patrol drivers and jailers up to the Chief, will be attired in a military, when the Civil Service Commission finishes its work and a permanent force has been selected. Every man, detective excepted, will be in uniform, and in fancy ones at that.

Chief of Police Hunt has made known his intentions, and the officers know that they will have to order new outfits when it is ascertained what will be permanent members of the force.

At present the patrolmen are in semi uniform of a decided mixed character. Some wear a coat of one cut and some another. A few wear ordinary black trousers, while others wear blue.

Chief in Uniform.

Chief Hunt will have a splendid uniform which he will wear when on police duty. He is a thorough believer in uniforms and stated this morning that as soon as the force is organized for permanent work he will appear in a new dress.

It will be remembered that when he was chief of the department before Chief Hunt was so attired.

The Police Commissioners favor the military idea, too, and the officers will undoubtedly live strenuous lives when the department is completely at present no one knows who will compose the force, as the dreaded Civil Service rules are yet to be met. NEW MINSTRELS AT THE MARQUAM

Al. G. Field Has Old Time Shows Faded.

Gives an Up-to-Date Performance to a Big and Appreciative Audience.

Many persons pass up a minstrel show with the trite remark: "What's the use going? They're like circuses—you see one, you see them all."

So popular became this idea that comedians in comic opera and funny men in other walks of life added to their stock in trade. No less a personage than Seabrook couldn't resist the temptation to knock and went about for a season singing how Johnson's girl was tired in endmen's jokes and had made up her colored mind to cut out black-face entertainments and wait "Till Mr. Shakespeare came to town."

People who still harbor the thought that there's nothing new in minstrelsy want to begin all over again. They should take a fresh "hunch" and try even. This suggestion is intended for all those playhouse patrons who believe they are losers by having paid their good dollars this year to hear the same moss-grown gags, same old songs, and be tortured by the musical notes of tired, in about the same manner that happened last year and a half dozen years before.

Last night Al. G. Field's minstrel troupe appeared at the Marquam. Do you require unique situations before becoming satisfied? Well, you got them. Will excellent staging of new songs help you out in your effort to find enjoyment? It was heard last night, and no one can with honesty say that Rose Prosser, James Cavanaugh, J. E. Blumkin, or Matt Keefe have not beautiful and well-trained voices. And how about the picture scenery? Have you become acquainted with anything better than the "panorama from the roof garden?" There was the Brooklyn bridge, with statue of liberty further down New York Bay, and the kaleidoscope of colored lights adding beauty to it all.

And then the finale of this scene, when the Tempest was rendered by the chorus of male voices. The scheme of sublimity was ably carried out. With a darkened house the singers could be heard and their dim figures seen upon the stage as they rendered the splendid descriptive song. Behind them and about them lightning flashed and the storm raged, until in a climax of awe the voices grew distant, as the tempest abated in its violence. Was this new? Keefe entertainers, has scarcely so pleasing a voice as Mr. Prosser, and when in minstrel overture work has a more delightful feature shown itself than the Yodel songs of James Cavanaugh? He was recalled last night and responded to the encore with J. K. Emmett's "Swanee Song" song. Not many in the audience ever heard Fritz Emmet, but those who have were carried back to the old days 15 and 20 years ago. It was a pretty touch, the warbling of that song and last night the people couldn't get enough of it.

One of the most remarkable specialties was that of "The Musical Barber of Seville." As a rule musical comedies have nothing new about them. Last night it was different. The execution of excellent music on unheard of contrivances added great value to the entertainment.

Mr. Field is made up of clever persons. There are Harry Shunk, Billy Murray, Tommy Hyde, Billy Cawley, Tommy Donnelly, Doc Quigley, Tommy O'Dell and Sam Goldman. "Bill Bailey, Won't You Please Come Home," and "Under the Bamboo Tree" were catchy comedy songs by Billy Murray. "The Jonah Man," by Harry Shunk, was excellent work. "Kiss Yourself Good-b
