P. H. D'Arcy of Salem stopped in Portland for a day, en route home from attending the Jefferson Day banquet at Boise, Idaho. At the Imperial Hotel he talked politics and told of the Boise function, at which he and Sam White spoke, representing Oregon. In addition to Governor George E. Chamberlain.

Governor Chamberlain's Reception. "The Jefferson Day affair was quite brilliant," said Mr. D'Arcy. "It was attended by Governor Morrison of Idaho and other state officials, who are Republicans, and by Boise City officials. The address of our Governor was enthusiastically received and was pronounced an able analysis of the character of Jefferson and a discriminating estimation of his place in American history. The Boise people made our visit exceedingly pleasant."

As to the Campaign. "You ask me about the status of the Congressional campaign. You may quote me as saying that A. E. Reames' chances for success on June 1 are flattering. He is a clean, able young man, has behind him a united, enthusiastic party, and will grow in strength every day as the campaign progresses."

Chairman White Expected. Chairman Sam White of the Democratic State Central Committee is expected on any train, and will at once organize for the Congressional campaign. He is closing up the business of the court term, which he attended as District Attorney at Baker City, and will sail his ship to the campaign after reaching here Friday or tomorrow.

SCIENTISTS OF POLITICAL ART

Philosophers and Statesmen Meet at Philadelphia.

(Journal Special Service.) PHILADELPHIA, Pa., April 17.—The seventh annual meeting of the American Academy of Political and Social Science was begun in this city this afternoon. Many distinguished men from all over the country are in attendance, and the sessions promise to be more than usually interesting. The general topic for discussion is "The United States and Latin America." This is divided into two heads, "The Trade Relations With Latin America" and "The Policy of the United States in Conflicts Between Europe and Latin America."

There were four formal addresses today by W. W. Rockhill, Director of the International Bureau of American Republics; Hon. John B. Moore, former Acting Secretary of State; Hon. William L. Buchanan, formerly United States Minister to Argentina; and Prescott Williams of Philadelphia. The first three speakers discussed international arbitration on the American continent, and Mr. Williams took as the subject of his address, "Ethnic Composition as a Factor in Latin American Republics."

At tonight's session Prof. L. S. Rowe, president of the Academy, will review the work of the organization, and will be followed by Hon. E. B. Loomis, First Assistant Secretary of State, who will deliver the annual address. The session of the Academy will be continued and concluded tomorrow with an interesting program.

TO ADD SIXTY ACRES TO PARK WOULD TEAR OUT BOTTOM OF RIVER

Plan Made for Enlarged O. R. & N. To Ballast Mountain Division. City Resort.

Water Board Will Be Asked To Relinquish Ground Needed --- To Receive the President.

At a special meeting of the Park Board, held in Mayor Williams' office this morning, City Auditor Devin was instructed to prepare a resolution requesting the Water Board to relinquish its claim to the 60 acres of land adjoining the City Park on the south, which an unused reservoir is situated.

The object of the resolution is to increase the acreage of the park, which is now insufficient to accommodate the collection of curiosities for the various departments. The number of acres at present is only 40, and the addition would give a total of 100 acres. Some of the animal cages will be removed to the annexed property and a thorough system will be laid. By the annexation, the city will have about 350 acres of park property. Macleay Park numbers 170 acres; Governor's Park, 6; Columbia, 51; Holland, 4, and there are several small parks, not including Park Row and the plaza blocks.

The question of the size of a platform for the reception of President Roosevelt caused a lengthy discussion. The Lewis and Clark Fair committee was of the opinion that there should be accommodations for 1,000 guests. The Mayor and the members of the board thought that there would be no need of room for more than 50 persons. There will be three concerts a week in the park block opposite the Park School in the southern part of the city, and in the block opposite the Custom House, in the north.

There will be concerts in the City Park on Sunday afternoons, and arrangements will be made for concerts in the plaza blocks and on the East Side. The committee to arrange for dining the President was appointed by the Mayor. It consists of H. W. Scott, W. D. Wheelwright and W. D. Fenton. A committee on music was appointed, consisting of General Owen Summers, Paul Wessinger and George Taylor, Jr.

POLICE PREVENTED POSSIBLE MURDER

Man Accused of Robbery Beaten Nearly to Death.

The timely arrival of the police served to prevent a murder in the Popular Saloon, corner First and Washington streets, this morning shortly after 10 o'clock. John J. McGuire thought H. B. Thurmond had robbed him of \$20, and attacked him with a club. McGuire pulled a revolver to defend himself, but McGuire wrestled it from him, and before he could be stopped, beat Thurmond frightfully about the head. No robbery had been committed. It was all a mistake.

Even after arriving at the police station McGuire cursed Thurmond violently, declaring in emphatic terms that he had robbed him and still had the money in his possession. A thorough search revealed nothing but a \$50 certificate of deposit on a local bank. McGuire was next searched, and his money—two \$10 pieces—was found on him.

Admits He's Wrong. "Oh, yes, I remember now," said McGuire. "I was not robbed at all. I know it now." "This is a pretty late hour to make such a discovery," said Capt. Gritzmacher, who was in charge of the station. "You've almost killed the man, and you are in serious trouble." McGuire was then locked in a cell, and as soon as Thurmond regained consciousness, a charge of assault with a dangerous weapon was placed against McGuire, Thurmond being the complainant.

Thurmond was badly beaten in the affair. He is of rather slight build, while McGuire is a powerful man, and delivered terrible blows upon his victim's head. Dr. Slocum, Assistant City Physician, called at the station and dressed Thurmond's wounds.

McGuire was beating Thurmond over the head when Officers Price and Vaughn arrived at the saloon. Excitement was intense and the officers thought a murder was being committed. Price sprang forward and grasped the revolver as McGuire was bringing it down with terrible force toward Thurmond's head. McGuire turned and cursed the officers and then lunged toward them. He grappled with Price, trying to wrench the revolver from his possession. He begged that he be given him until he could kill Thurmond, whom he claimed had robbed him.

McGuire claims he has just arrived in the city from the East, and Thurmond stated that he is but recently from Eastern Oregon.

POLICE PROBING THE MYSTERY (Journal Special Service.) NEW YORK, April 17.—The order to give the police time for the investigation of the alleged Mafia prisoners and counterfeiters has gone over until tomorrow.

The police are close mouthed, but it is said information was furnished from papers seized when Moretti, the alleged Mafia leader, was arrested that will lead to other arrests today.

The victim's identity is still unknown. The police have wired the New Orleans police to investigate, and it is believed the man was lured from there.

Dredge To Be Built on Grand Ronde To Reach Sunken Gravel Beds.

The O. R. & N. Company contemplates tearing out the bottom of the Grand Ronde River and using it to ballast 100 miles of railroad grade between Huron and Pleasant Valley, in Eastern Oregon. For this purpose a dredge will be built and set to work in the Grand Ronde River near the town of Union and the tracks of the O. R. & N. will be built to a point where the gravel raised from the river bed can readily be loaded on cars and transported to points where it is used. Engineers who have viewed the scene of intended operations claim enough gravel can be taken from a few miles of river bed to ballast the track clear through to Huntington.

Although all plans have not as yet been completed it is intended to begin work shortly and all of the track will be improved before the 1903 wheat crop is ready for shipment.

Much Work to Be Done. Carrying forward this work will require the employment of several hundred men and a number of construction trains will be in commission during at least two months. No work has as yet been done.

The stub road to reach the river will be built from the Elgin branch, only a few miles of track being necessary. The dredge is designed to work on the river bed, tearing up the compact gravel and piling it on the shore. It will greatly deepen the channel of the Grand Ronde River and will render the surrounding country less likely to overflow.

The track to be ballasted is the most mountainous section of the O. R. & N. Its improvement has long been contemplated, but it was for years deemed impossible to find gravel suitable to the work. The scheme of tearing up the bed of the river has been adopted as a way out of the difficulty.

HOW DID HE GET THE MEN

Crown of India's Captain Makes Strange Statement.

Did Captain Sauter, master of the British bark Crown of India, secure a crew in Portland or is he running a gigantic game of bluff, and is he a swindler? This question is being asked today along the waterfront.

Certain it is that the Crown of India, from which at least a dozen men deserted shortly after her arrival in this port, despite the fact that her three highest officers stood guard with shotguns to keep the men on board, left down stream this morning in tow of the Oklaheima. She was bound for the bar and expected to sail either tomorrow or Sunday. To a reporter for The Journal Captain Sauter announced that he and a crew of members of which would stay with him at least until the coast of Africa was reached.

But local shipping men declare that Captain Sauter did not secure a single sailor in the Port of Portland. They think the British captain either intended to pause at Astoria long enough to take on a complement of river boatmen or loggers, or that a crew has been picked up by agents in British Columbian ports, and will come here by rail, meeting the Crown of India at the mouth of the river.

It is claimed that when here on a former voyage, 15 months ago, Captain Sauter made the statement that if the sailor boarding house masters of this city did not come to his terms he would ship a crew in a manner that would surprise the natives. Many are wondering if he has carried out his threat and incidentally the natives are awaiting to be surprised.

Several sea-going ships have secured crews from San Francisco during the past few weeks, the sailors having been sent up to Astoria on small coasting vessels. It is thought by some that the men needed on the Crown of India will be shipped up from the Golden Gate.

STOLE HORSE AND CARRIAGE

A bold thief, whose nerve has never been excelled in the city, stole H. P. Peterson's valuable bay horse and a handsome carriage from the corner of Seventh and Washington streets at 2 o'clock this afternoon. The police were notified shortly after the daring theft, and officers were sent out from headquarters in every direction to head off the thief. The horse and carriage are valued at \$900.

It is thought that the most probable direction the robber would take is the road to Vancouver, Wash. Fred Olson, clerk of the Municipal Court, saw the man driving the Peterson outfit toward Vancouver on the Burnside bridge shortly after 2 o'clock. Officer A. G. Vaughn, who knows the rig, was dispatched to Vancouver.

ROOSEVELT SAYS HE CANNOT DO AS UNIONS ASK

THE COMBINE CANNOT ACT

(Journal Special Service.) ST. PAUL, April 17.—There were other sensational developments in the famous merger suit today when Judge Sanborn refused to allow the Northern Securities Company to furnish a supersedeas bond and to modify the decree to permit the company to pay dividends on May 1. The District Attorney says he had definite instructions from United States Attorney-General Knox to oppose such a move, and the court held that it would not be legal. This would seem to completely bind the hands of the company until such time as the Supreme Court renders its decision.

BRITISH WARSHIPS FOR LAKES. (Journal Special Service.) OTTAWA, Ont., April 17.—It is announced that Raymond Prefontaine, Minister of Marine and Fisheries, has before him a scheme which involves the appearance of three third-class cruisers in Canadian waters, one off the Atlantic Coast, the second at Toronto and the third on the British Columbia Coast. The appearance of war vessels in our upper lakes would be open to objection under the Rush-Bagot treaty, but against a training ship the United States could make no complaint.
