

MILITARY COMPANY WITH LONG HISTORY

The Cleveland Grays Have Served 66 Years in Peace and in War.

They Are in Portland Today on Tour of the West—Independent Command.

With a record of 66 years of continuous service, with a past history in which are written the incidents and important battles of three wars, but as tourists and sightseers, not as soldiers, the celebrated Cleveland Grays are in Portland.

After a journey of more than 2,500 miles, many honors and few adventures, they arrived at the Union Depot in this city at 8 o'clock this morning, 25 minutes behind their scheduled time. Their trip has been without greater delay than this.

The Grays are traveling in a style that might be envied by railroad kings or other monarchs. They have a special palace train, consisting of two sleeping cars, a diner, an observation car and two baggage coaches, carry their own food and report having enjoyed themselves to the full. When they complete their journey it will require \$20,000 to foot the bill.

Portland is the turning point in the career of the Cleveland Grays on their tour of the West. After spending a day and night here they will start east over the Oregon Short Line early tomorrow. The return journey will be by way of Salt Lake City, Colorado Springs and Denver, the Grays going northward from the latter place. They started on their wanderings May 2, choosing the Southern route to the Coast and stopping off at all points of interest.

No Parade Here. No company will attend the stay of the Cleveland Grays in Portland. Tourists they came, as tourists they will remain, and when they choose to go their departure will be taken as private citizens and not as soldiers and heroes of much service and many wars.

"We are only traveling for pleasure," said Captain E. P. Shupe, commanding officer of the Grays. "We did not expect a reception and are not prepared to respond to it if one were tendered. We are simply looking over the West, and have been vastly pleased with what we saw."

The Grays are approximately 100 strong, boasting that they represent the best families and most influential business firms of Cleveland, Ohio. Captain E. P. Shupe is in command, the subaltern officers being First Lieutenant H. W. Storr and Second Lieutenant A. W. Neal. The entire equipment of the company is carried in one of the baggage coaches, full dress uniforms, sharp muskets, high branched shakos, knapsacks, tents and all the other paraphernalia usually supposed to be a portion of the kit of the ideal soldier being in provision. Two stands of hand-colored notes are also carried with the train.

Not in "Show Clothes." Fatigue uniform alone will be worn by the Grays during their stay in Portland. Fitting close and cut after the fashion of the officers' clothes of the regular army, these gray suits are most becoming. The trimming is in black and the caps are natty and topped with gold braid. "Service medals" are worn by nearly every member of the command, it being necessary for an enlistment of five years to be completed before eligibility to a medal is attained. Medals of bronze are pinned to the left breast of the blouses of those who have spent a decade or longer in the ranks of the Grays, a full 10 years entitles the soldier to a gold medal, and when 15 years have been passed in the organization a gold medal with a diamond bar is given.

Although "soldier boys" in action and in hospital—there is none more free and open-hearted than the soldier on campaign—the Grays are for the most part men. Many of them have the gray frosts of time upon their hair, and there is hardly a juvenile in the entire force. They disclaim connection with any national guard, laugh when asked if they are a portion of the state troops and glory in the fact that they are self-supporting men and have endured for more than half a century.

War and Politics. Not alone in the field of deadly battle have the campaigns of the Cleveland Grays been fought. They have used the ballot as their weapon, and have taken part in more than one political

PUBLIC OPINION IS RAPIDLY BECOMING SET AGAINST HERMANN FOR CONGRESS

(Continued from Page One.)

record he has made scrutinized by every person.

Simply Said It's a Lie. Mr. Hermann said: "I have been trying to conduct a gentleman's campaign. And I shall do so to the end."

And yet he did not do what most gentlemen do, when brought into question, set that complete exoneration is secured, and that well grounded suspicion in the minds of reasonable persons is removed.

The effect of Mr. Hermann's address here was to leave his supporters without material for a competent defense, beyond the mere statement from him that "It's a lie." He went no further than to enter a plea in the court of public opinion. "Not guilty." He did not adduce testimony. He permitted the case to go by default, and, as in all courts, so in this court of public opinion, in this present instance, Mr. Hermann appears to have been convicted by a verdict already returned by the people generally, and that will be registered upon June 1, if indications are not deceiving.

Here is the Law.

The Land Office was established by an act approved April 25, 1812, of which Section 10 is:

"Sec. 10. And be it further enacted, That no person appointed to an office instituted by this act, or employed in any such office, shall directly or indirectly be concerned in the purchase of any right, title or interest in any public land, either in his own right, or in trust for any other person, or in the name or right of any other person in trust for himself, nor shall take or receive any fee or emolument for negotiating or transacting the business of the office. Any person offending in the premises shall be prohibited from this act shall forfeit and pay \$100; and upon conviction, shall be removed from office."

Law of Reorganization.

The General Land Office was reorganized by an act approved July 4, 1838, in which is this provision:

"Sec. 14. And be it further enacted, That all and everyone of the officers whose salaries are hereinbefore provided for, are hereby prohibited from directly or indirectly purchasing or in any way becoming interested in the purchase of any of the public land; and, in case of a violation of this section by such officer, and on proof thereof being made to the President of the United States, such officer, so offending, shall be forthwith removed from office."

Any officer of a land office has abundant opportunity to use his official information to advance his own financial fortunes, and the provisions herein cited are of course laid down for the prevention of such conduct. That such statutes were enacted at the inception of the Land Department of the government, and in language such as to plainly indicate that they applied to all connected with the department, indicates that the acquisition of lands as Mr. Hermann did while receiver was known to be illegal, and that the taking of such lands deprived settlers and citizens from opportunity to secure them.

SPEAKERS WHO DO NOT THINK

EUGENE, May 15.—Some excellent campaign material is being furnished by some of Mr. Hermann's friends, particularly by Col. E. Hofer of Salem, who spoke here Monday night. Col. Hofer, speaking in Mr. Hermann's presence and endorsed by him later, said:

"Since Binger Hermann left Congress, Oregon has suffered a loss in federal appropriations. Look at the federal bill of last year. Oregon got \$300,000, while Washington got \$3,000,000 to \$4,000,000."

Last spring, Col. Hofer was arguing differently. His conclusion was that date, he therefore is being untruthful. He is now conceding the situation of what he regards as correct political philosophy, his views then and now being:

SALEM, Or., May 15.—Binger Hermann has come and gone, and the bitter taste in the mouths of the goodly portion of the Republic of Marion County has not abated a particle; in fact, they are less satisfied with the Republican nominee for Congress, since his speech here Wednesday evening, charged against him was an evasion pure and simple.

Yesterday the Republicans gathered on the street corners in little groups and discussed the Hermann rally, and every one of opposing the party's candidate, the candidate. The result of the candidate's visit here is increased opposition to the choice of the Eugene convention, and several prominent Republicans who thus far have not been suspected of disaffection from the party's candidate are now quietly at work against his candidacy and promise to help roll up a majority against Hermann in this, the strongest Republican county in the district.

The disaffection in "Old Marion" appears to be fully as strong now as it was when Furness was the Republican candidate for Governor in 1902, and men well informed on political affairs are now quietly at work against his candidacy and promise to help roll up a majority against Hermann in this, the strongest Republican county in the district.

No Party Feeling. Republicans are not opposing Hermann because they want a Republican in Congress, but they express themselves ready to sacrifice their party principles in this, an off year, in order to rid the party of an incubus that was thought to be effecting the party's defeat in 1902.

Thomas H. Tongue defeated Hermann in the now famous Albany convention. Since Hermann has again "bobbed" up they are disgusted, and are determined to "keep" him again, and this time "keep" him by electing him to Congress next year; a man with a clean record and with ability, who will be an honor to the state and a credit to the strength to the Republican party.

Want a Clean Man.

It is for this reason that the Republicans opposing Hermann welcome the opportunity to vote for a clean and able young Democrat whose candidacy is widely endorsed by Republicans here and in adjoining counties.

WOODBURN GIVES REAMES GREETING

(Journal Special Service.)

WOODBURN, Or., May 15.—Hon. A. E. Reames, Democratic nominee for Congress, visited this place yesterday and was very hospitably received by the citizens. He was met by a large number of new acquaintances and a most favorable impression.

In the afternoon Mr. Reames addressed a well-attended meeting in the opera house, notwithstanding this is a rainy season with the farmers of this vicinity. The speaker was introduced by Mayor Grant Corby, Democratic precinct committeeman, and closely listened to by many anti-Hermann Republicans in the audience.

Mr. Reames dwelt principally upon the tariff and his leading opponent. He advocated taking off of tariff on all articles manufactured by trusts that were sold cheaper than at home, and on the trust question addressed the same views as were entertained by the late Congressman Tongue, his father-in-law.

While he touched upon the "push" policy, he did not dwell upon it, in which Hermann was chosen, and expressed the opinion that all Republicans would not submit to be gagged. Mr. Reames treated the Republican candidate very much in a friendly manner. An effective statement by him was that he was in a strong Republican district, and if his issue proved unsatisfactory the Republicans could easily get rid of him. His remarks were frequently punctuated by applause from some of the Republicans present heartily joined.

That he made votes is beyond doubt. After the address nearly every one in the house, of which there were several ladies, went forward and shook hands with the distinguished guest.

Woodburn, which gave Tongue a good majority, will, from present indications, give Reames a big vote. This is a general feeling here among the Republicans that the only way to retire Hermann is to defeat him in June, even if it does place a Democratic Representative in Congress for one year.

The people feel that the interests of the state would be safe in Reames' hands, and that, with such a man of honor, possessing no principles that are really inimicable to the Republican party, no more fitting opportunity would be found to block the schemes of a few senseless Republicans pursuing the rule or ruin policy.

SMALLPOX CASES NOT ATTENDED

Local Doctors Allege Clackamas Officers Are Negligent.

According to the Portland health officers Pleasant Valley people, when they get the smallpox, seem to feel lonely unless they can spread the contagion to their neighbors. For some weeks smallpox of a severe type has been prevalent near the county line of Clackamas and Multnomah counties and in Clackamas more than 30 people have already suffered from the disease.

The Multnomah health officers allege that though the officers of Clackamas County have repeatedly been notified of the serious condition that exists in their borders, they have refused to take definite action and by their negligence have aided the people in spreading the disease. Cases are reported where people went from the side of an afflicted relative to a dance; where sweethearts mutually exposed each other knowingly and then went out to give the disease to their friends. The entire region is more or less closely related and being as it were in one big family but little effort to quarantine has been made and it is charged that diseased persons have not even been fumigated.

In Multnomah County there are some 10 cases, or have been recently, but these have been isolated and fumigated and there is said to be little danger of the disease spreading from any of these camps. The real danger, the health officers believe, comes from the farmers of Clackamas, who frequently come to Portland when already in the early stages of the disease, or when recovering from it, and bring with them the most dangerous examples of negligence is that where a cream separator was found running in a house where the majority of the family were down with the smallpox; this cream was being regularly shipped to Portland, and half a city according to the health officers, could have been exposed to disease through this one means.

YOUNG SOLDIERS ARE INSPECTED

The Militiamen Before Regular Army Men Last Night.

With their knapsacks strapped to their shoulders, their canteens filled with water, their tin cups clanking and jangling, their Springfield rifles across their backs and their belts crammed with copper cartridges, volunteers of the Oregon National Guard stood muster and inspection last night. The men were in perfect field and campaign equipment.

They marched and counter-marched, back-stopped and went through the manual of arms with a precision that proclaimed constant drill and great adaptability. Colonel Jackson, United States Army, retired, and Major C. W. Wash, Sixteenth Infantry, acted as inspecting officers.

The galleries at the Regimental Armory were well filled with visitors to witness the inspection. "First call" was sounded at 8 o'clock, and for ten minutes there was a scramble of young men getting into uniforms, strapping on their belts and haversacks, and "warming themselves up" for the work to come.

When the "assembly" blew the young soldiers fell into long, straight lines and answered "hoosh" as their names were called by the first sergeants.

Then came the official business. Company C was the first to perform. In solid sets of fours the men trooped into the quadrangle of the drill hall, being greeted with cheers. They opened ranks and stood at "attention" during the mustering ceremony. The inspection which was without fault, showed that the militiamen being called to account by Colonel Jackson for trifling irregularities in dress, but no serious mistakes being discovered. The company was then put through its best paces in all kinds of drill and drill.

Company E came next upon the scene and was treated similarly to its predecessor.

There will be continuation of the inspection tonight.
