

# AFTER TRIP DOWN PUGET SOUND PRESIDENT IS SEATTLE'S GUEST

On Steamer Spokane Roosevelt Leaves  
Tacoma and Journeys Along the  
Great Inland Sea.

Tumultuous Cheers Greet the Nation's  
Executive at the City of Destiny  
and at Seattle.

## PRESIDENT HONORS MEN WHO WRITE

For the second time during President Roosevelt's present tour of the country, of which he is the honored Chief Executive, he has seen fit to pay especial compliment to a press club, and let it be known that no other club or organization of a social or business character has received recognition by the seal of his signature.

To the Portland Press Club has the President of the United States expressed his high appreciation of the club's action in electing him a member of that exclusive organization. Mr. Roosevelt goes further and pays tribute to the writers of Portland by acknowledging his intention of visiting them in their rooms in the Marquam Building, but was prevented by the ravages which Oregon's rainstorm created on the afternoon of his visit to this city.

The following, written in the President's own hand, on elegant embossed White House paper, was received by the president of the club this morning:

"TACOMA, Wash., May 22.—My Dear Mr. Shillock: Nothing but the fact that from the knees down I was as wet as if I had been wading in a trout brook could have prevented me from going around to see you at the Press Club. I am very sorry. I need hardly say, my dear sir, that I accept with great appreciation the honorary membership.

"With hearty regard, believe me, Sincerely yours,

"THEODORE ROOSEVELT."

The Portland Press Club has placed in the hands of a goldsmith a design of a membership card which will be made and then forwarded to President Roosevelt at Washington, D. C.

When finished the souvenir will be a double plate of pure gold fastened in book style by hinges. It will be about six inches long by three and a half wide. On the other cover will be an inscription designating the motive for the gift, and on the remaining three leaves will be engraved expressions from the club to the 26th President of the United States of America.

The letter received from Mr. Roosevelt this morning will be exquisitely framed and then hung on the walls of the club rooms.

SEATTLE, Wn., May 23.—The Presidential party arrived here on the Puget Sound Navy Yard at 1:15, promptly on schedule time. A great throng, estimated at 50,000, crowded the wharves and intersecting streets. The President lifted his hat in response to the cheers. The weather was perfect. The trip on the Sound was without unusual incident, but was enjoyed by the President and the members of the party. The stop at the Bremerton navy yard was necessarily short, as the schedule of time called for quick movement.

Excursions have been run from Fairhaven, Whatcom and other points and Seattle is filled with hundreds of visitors anxious to participate in the greeting to the Chief Executive of the nation. Business houses throughout the city are gay with flags and bunting, and in other respects the city presents a festive appearance. Upon his arrival the President was greeted by the Mayor and other city officials and by representatives of the city's commercial bodies. The formal part of the program will be crowded into this afternoon and evening in deference to the President's well-known desires for a quiet Sabbath. From the landing place to the hotel the Presidential party was escorted by state militia and other organizations. A public reception and banquet are features of the evening program. No arrangements have been made for tomorrow beyond the general expectation that the President will take a drive about the city. An effort will also be made to have him attend church services to be held under the auspices of the veterans' organizations in honor of the memory of departed comrades.

The arrival in Seattle marks the completion of the first half of the President's long and memorable trip. From this city the return trip will commence Monday morning, and though many stops are to be made, they will be very brief and little time will be lost in getting back to Washington. The journey is to be made by way of Nevada, Oregon and Washington, with a loop up through Montana and down back to Idaho and Utah. One week hence the party is scheduled to be in Laramie, Wyo., from which point the trip Eastward will be made across Nebraska, Iowa and Illinois, after which no unnecessary stops will be made. Unless something unforeseen occurs to upset present calculations the President will reach the national capital on the evening of June 5, just two weeks hence.

WALLA WALLA, Wash., May 23.—The first day of the President's return journey Eastward will end at Walla Walla, after a day's ride across the State of Washington and through the beautiful Cascade Mountain region. It has been so long since this city has entertained a Chief Executive of the nation that it will practically be a new experience for her citizens. The only other President who has visited Walla Walla

was President Hayes, and it is almost a quarter of a century since he stopped here in company with General Sherman, Secretary of War Ramsey and several other notables composing the party.

When President Roosevelt passes down Main street Monday afternoon he will pass under the most artistic and elaborate piece of decoration ever attempted in this section of Washington. It is a triumphal arch spanning Main street at the intersection of Second, and the finishing touches were put on it today. The real work of decorating is nearly finished. The arch is nearly 30 feet in height in the clear over the roadway, and the columns attain a height of over 40 feet. The structure is of heavy lumber and is the best piece of work ever attempted in this city for any public occasion.

The special train carrying the Presidential party will arrive at 4:30 o'clock Monday afternoon, and the stay will be four hours. During this time the President will address two gatherings, review the troops at Fort Walla Walla and dine with Senator and Mrs. Anderson. The party will be banqueted at Odd Fellows' Temple by the citizens of the town, while the President will be entertained privately. An escort of colored troops will be given the President, under command of Colonel Godfrey.

Nearly all the business houses, except hotels and restaurants, will close Monday, and the day will be given up to the celebration. The buildings along Main street and the other streets traversed in the march, will be handsomely decorated, and the city will be patrolled by a score of extra patrolmen. A number of excursion trains will arrive in the city early in the day.

At Bremerton.  
BREMERTON, Wash., May 23.—The revenue cutter McCulloch escorted President Roosevelt down the Sound to Bremerton, which was reached at 11:15 a. m. A visit was paid to the big dry dock where the big steamer Ohio, of the Empire Transportation Company, was undergoing repairs. One hundred and fifty citizens of Tacoma made the trip to Seattle with the President and turned him over to the committee from the latter city.

Thus far the bitter fight that has been going on between Tacoma and Seattle over the President's entertainment has not disturbed the atmosphere about him to any great extent. The squabble has been going on for months. The last gun was fired by Tacoma's Mayor yesterday when it is said he sent word to Seattle that if any committee came down to board the steamship Tacoma without invitations he would have them arrested as vagrants. Perhaps he meant to carry out the threat, or perhaps it was merely one of his jokes. At any rate, none of the Seattleites showed up at the wharf, and Tacoma was allowed to retain peaceful possession of the President until he landed on the dock at Seattle.

Sullivan locked himself into his private office, but the police battered down the door. A long line of patrol wagons was necessary to carry the prisoners to the station. The police then cut all the telegraph wires leading to the office and carted away a ton of literature used in the business.

Miss Ollie Henderson died this morning at 7:50 at her home on the East Side. The death came after an illness of four months. Miss Henderson was 24 years of age at the time of her death and was well and favorably known to a large circle of friends. She was a member of Brooklyn No. 4, United Artists and Bookbinders. The funeral will be held at the Mizpah Presbyterian Church, Thirtieth and Powell street, tomorrow afternoon at 2 p. m.

### WOODEN BUILDING CRUSHED.

### DR. M'BROOK VERY ILL.

J. M. McBrook, a prominent Portland physician, is dangerously ill at St. Vincent's Hospital where he was subjected to an operation last evening. Dr. McBrook has suffered from a complicated disease of the ear for some time and has grown steadily worse. It was finally determined that an operation was the only means of saving the patient's life. Report from the sick man this afternoon is that recovery seems doubtful.

### DEPUTY CORONER APPOINTED.

Arthur L. Finley, son of J. P. Finley, was today appointed deputy coroner, the appointment being made under the recent Legislative act. This is the first deputy coroner ever named in Multnomah County, as in the past there has been no provision in the laws for such an officer. All duties connected with the coroner's office have heretofore been performed by the coroner. Hereafter, when the occasion requires, Deputy Finley will attend to cases. There is no salary attached to the office.

### MATTHEW CRUNNICAN MISSING.

Matthew Crunnican, aged 32 years, is missing from the residence of Chas. Burns in Russellville, and it is feared

he has met with foul play. Mrs. Burns appeared at the police station this afternoon and reported the disappearance to Capt. Gritzmacher. She stated that Crunnican arrived in the city ten days ago from Nebraska, for the purpose of looking over some farm land. He has not been seen since last Thursday. It is understood he has a large sum of money in a local bank.

## HUNTING AFTER A MISSING GIRL

She Is Believed to Have Been Assaulted and Murdered by Negro.

LAWRENCEBURG, Ind., May 23.—An excited posse is scouring the country in search of Anna Kiser, aged 17, who was probably a victim of a foul assault and murder. Last night she accompanied her father to church. Her father was struck down by a club and laid unconscious on the road all night. The girl was evidently carried off by woods near by. Her hat and umbrella were found lying near the river bank, which leads to the theory that she was assaulted and then murdered and her body thrown into the river. A suspicious looking colored man of giant stature was seen loitering around Manchester Station yesterday and is suspected of the crime.

## A LONG LOCKOUT BROKEN AT LAST

Steam Laundries Will Resume Operations.

Start Up Monday With Non-Union Help  
...Failed to Agree on the Number of Hours.

Several of the nine steam laundries, controlled by the Portland Laundrymen's Association, will resume business Monday morning, according to Chairman Tate of the executive board. They will start up with non-union help, the association and the union having failed to come to any agreement. Just how many of the closed plants will be set in motion Mr. Tate was unable to say, explaining that that matter would depend altogether upon the number of employees that could be secured. In order to run the several affected laundries to their full capacity it will require about 500 workers, the Troy alone having employed almost 150 previous to the shutdown. The several managers anticipate considerable trouble before a full quota can be found, because skilled labor is required.

Failed to Carry.  
The union called a special meeting last night to take action in regard to a proposition which had been submitted to them by the association. The proposition consisted of an increase in the wage scale of about 10 per cent, with the number of hours to remain unchanged. There were 128 members present at the meeting, and the offer of the association was rejected by a vote of 112 to 16. The hour question was the main feature to which they were opposed. They insist that the working hours be reduced from ten to nine, and that nothing short of this concession will meet with their approval.

The Drivers.  
When the laundries start up Monday many are wondering just what action the Laundry Drivers' Union will take. During the lockout its members have been retained on the payroll of the association. They are affiliated with the Federated Trades Council. Both sides appear to think that the drivers will act with them. When asked if he thought they would walk out Monday in sympathy with the Laundry Workers' Union, Mr. Tate said:

"I have no reason for thinking so. No, I do not anticipate any trouble from this source."

Union men are emphatic in the assertion that the drivers cannot consistently continue in the employ of the association. The drivers' decision in the matter is being awaited with interest.

## GLAD PETITIONS FAILED.

SALEM, May 23.—The people of Marion County in general and those of Salem in particular, irrespective of political faith or social standing, are jubilant over the failure of the few enemies of the Fair who attempted to delay matters by petitioning for the referendum of the Fair bill, so that the Exposition would be seriously crippled. Especially pleased are the members of the labor unions of Salem, who in vigorous terms opposed the action of the Portland Federation of Labor in declaring against the Fair. The people of this city generally realize the enormous benefits that will accrue to all of Oregon, and, in fact, to the entire Northwest from a well conducted Exposition.

## THE VINEGAR IS RARE.

H. V. Tartar, Deputy State Dairy and Food Commissioner, stated to a Journal reporter this morning that all the cider vinegar now on sale in this city was the genuine article. Several days ago the manufacturers and retailers of discolored vinegar, colored with caramel, were warned that liquid of this kind was sold in violation of the law and that it would have to be withdrawn from the market at once. The hint had the proper effect, the dealers having stopped the sale of this brand of vinegar, at least, so far as known by the State Commissioners.

## DEATH OF MRS. GRUTZE.

Mrs. S. Grutze died at the Good Samaritan sanitarium yesterday. Her death was the result of a surgical operation. Mr. Grutze is chief assistant in the City Auditor's office and has the sympathy of all the city employees in his bereavement. Funeral arrangements will be made when arrangements have been completed.

## COLOSSAL SWINDLE IS UNEARTHED BY POLICE

Get-Rich-Quick Scheme in Chicago Takes in Over  
a Million Dollars From Credulous Victims  
... Proprietor Ready to Decamp.

(Journal Special Service.)

CHICAGO, May 23.—What is believed to be the biggest get-rich-quick scheme ever set in operation was nipped this morning by police raids on George E. Sullivan, proprietor and manager of the Red Letter Stock and Grain Company. Detectives had been investigating the concern for a week past.

Millions of circulars sent out broadcast induced credulous people, by alleged fraudulent representations, to invest in stocks, grain and cotton futures. When they wanted to withdraw they were informed their money had been lost. These alluring circulars were always printed in red, and hence were called the Red Letter reports. During the period of police surveillance \$50,000 was received by the con-

cern in less than two weeks. A few days ago Sullivan sent out two million circulars and telegrams to intended victims and an immense amount in drafts, checks and cash remittances commenced flowing in yesterday. This led the police to believe that Sullivan was preparing to make a big haul, anticipating flight from the city.

The police made a descent upon his luxurious offices this morning. Three of these are down town and they were crowded with richly-dressed women speculators of all ages. Many of the women burst into hysterics and a panic prevailed. More than a hundred persons were arrested, including Sullivan himself and twenty-five girl stenographers, and many telegraph operators and spec-
