

FATHER COMES FAR IN SEARCH OF SON

Travels from Illinois On Advice of a Medium and Locates the Missing.

In search of his son, William, from whom he had received no message since last March, J. T. Shepard arrived in Portland this morning from Mount Vernon, Ill., and without waiting to register at a hotel, walked rapidly to the police station where he made anxious inquiry of Capt. Gritzmacher. He was told that nothing was known of his son, but that if he would return in an hour, an officer would be detailed to go with him, and aid him in the search.

Hardly had the hour elapsed, when the aged father walked into the station, and told the captain that he had located his boy. "He is working in a cannery at Annetta, Wash," said the father. "I met a young fellow on the street, who told me where he is. Before I would believe him, I took him to the Sheriff's office, where they knew him. They say that my son is slightly mentally unbalanced, and that probably accounts for the fact that he has failed to write me."

SPENCER WILL RUN STEAMER ON RIVER

New Line Is Shortly to Operate Between The Dalles and Portland.

THE DALLES, July 11.—Capt. Spencer of Portland is in the city looking over the field to see what encouragement there is toward another line of boats on the Columbia. In an interview he said:

"I am seriously thinking of placing my steamer, the Charles W. Spencer, on the run between Portland and The Dalles, and have received encouragement enough from business men here to warrant me visiting The Dalles to ascertain the actual outlook. There is enough business at present for two lines, and when the portage railroad is completed a heavy increase of business will result causing immense traffic on the river."

The captain, in company with James Crichton, former agent in this city of the White Collar line, made a canvass of the city, and they report to have received such encouragement that within a few weeks the Spencer will be making three trips a week between here and Portland, laying over in The Dalles on Sunday. Mr. Spencer also secured an office, and appointed James Crichton his agent.

GOES GUNNING FOR BOTTLE OF WHISKY

SALEM, July 11.—Emil Byars, a farm laborer residing about seven miles north of Salem, was arrested at midnight last night by Constable J. H. Lewis and lodged in the county jail here at 3 o'clock this morning, on the charge of assault with a dangerous weapon. The warrant was issued at 11 o'clock last night on a complaint of J. H. Hammack, a farmer residing at Clear Lake, seven miles north of Salem. He charges defendant with coming to the Hammack home last night, armed with a revolver, and threatening to kill J. H. Hammack, a brother-in-law of the complaining witness, unless a bottle of whisky, believed by him to be hidden by the Hammacks, was produced. The fellow was pacified when the whisky was produced, and he went off happy, but his neighborhood had in the past suffered from Byars' actions when intoxicated, and Mr. Hammack decided to put a stop to it, hence the prosecution of the case. Byars frequently comes to Salem, when, it is stated by those who know him, he always becomes intoxicated, and while in that condition makes himself a general nuisance and frequently causes trouble. He was in Salem yesterday, became intoxicated, and armed with a bottle of whisky left for home, hiding the liquor in the Hammack barn, and when later he could not find it, started out "gunning."

He will have a preliminary hearing this afternoon or Monday next.

WOOLEN MILLS TO SHUT DOWN

Pendleton Blanket Manufactory Will Be Given Complete and General Overhauling in the Month of August.

Sales for Year Show Great Increase and Agency Has Been Established at Osaka, Japan—Schools.

(Journal Special Service.)

PENDLETON, July 11.—The Pendleton Woolen Mills will shut down on August 5 and will remain idle until September 1. This is done for the primary purpose of making some general repairs to the mills that could not be done were they in operation, and secondarily that the operators may have a vacation after the busy and successful run of the past year.

The sales of the mill have increased 100 per cent during the past 12 months and indications are that the increase will be as great during the year to come. During the year just closed the mills paid \$20,000 for repairs, \$15,000 for wool and \$3,000 for dyes and coloring matter. The mills here use far more dye than any other like institution on the Pacific Coast from the fact that they make a specialty of the highly colored Indian robes for which they are famous. The mills employ 40 people the year round and during the summer months and the wool season the list will run to twice that amount for there are 80 men used in the wool sorting department alone.

In the last few months the mills have secured an agency for their goods at Osaka, Japan through the work of H. E. Doach and they are rapidly building up a good trade with the islands for their blankets, shawls and other specialty goods.

are all of them now contracted for by the merchants of the town who carry perishable goods. Before the concern was running steadily half of the rooms were used, and in a short time their capacity will be taxed.

The ice room has a capacity of 800 tons, and the daily output of the ice vat is 15 tons. This daily product will about furnish the local demand, and during the cold months the storeroom will be filled for the out-of-town trade. Walla Walla attempted to close a contract with the company for all of the ice that the Washington city could use, but the people here declined, telling them that they could have all of the ice that Pendleton did not want if there was a surplus, but that the plant had been planned as a local institution in answer to the local demand, and that the local trade would be considered first. The plant is equipped with its own electric lights, and is up-to-date in all particulars.

Trout Shipment.

PENDLETON, Or., July 11.—Twenty thousand young trout are on their way to Pendleton from the Clackamas hatchery. When they reach here they will be taken charge of by the Sportsman's Club. Milton will get 4,000 of the number for the streams adjacent to that place, and the remaining 16,000 will be put in a pond at Bingham Springs until they are large enough to care for themselves and keep out of the clutches of the bull trout in the streams. The consignment is from the State Fish and Game Association.

Policeman Assailed.

The Heppner church was entirely destroyed by the flood, and is now to be rebuilt. The Rev. Dr. Warren is given the task of getting the diocese once more in order.
