

CHAUTAUQUANS MEET BY THE THOUSANDS

Willamette Valley Association Build City of Tents
and People from All Over Inhabit Them---
Senator Dolliver Will Speak Tonight.

(Journal Special Service.)
OREGON CITY, July 14.—The Willamette Valley Chautauqua Association met this morning for its tenth annual session. Hundreds of tents dot the enclosure, where a week ago the great fir trees held sole dominion. A small city of 1,500 souls, with canvas homes, now nestle beneath the trees. More campers and more tents still continue to arrive, and it is thought that 2,500 campers will be on the ground before the close of the first week. Besides numerous parties from Oregon City, Portland and surrounding towns, who are camping on the ground, many have come from long distances and will remain during the entire twelve days of the meeting. Managers of the association are very much pleased with the outlook and feel that the promise is for a much better attendance than last year.

The Opening Session.
This morning's session was opened by the address of welcome, delivered by the president, C. W. Hawley, of Salem, followed by the response, after which the organization of classes and the announcement of instructors consumed the time until the noon hour. The feature of today's program will be Senator Jonathan P. Dolliver's address or lecture this evening. His subject is, "A Poor Man's Government and a Poor Boy's Country." The Chemawa Indians are on the ground in full force. This afternoon there will be a game of ball between the Indians and the Sunnyside Women. The auditorium has a seating capacity of 5,000. It has been beautifully decorated. Firs and evergreens have been

used profusely, giving the great building the appearance of a mammoth summer garden. The stage is profusely decorated with flowers, evergreens and the national colors, and, taken all in all, the auditorium is a very attractive place. Arrangements have not been made for any sports save baseball this year. There is a good bicycle track a quarter of a mile in length, but no arrangements have been made for any races. There is a dancing pavilion that will accommodate 200 couples, but dancing is forbidden. In former years dancing was allowed, but in later years the ultra puritanical set has been in charge, and dancing is tabooed.

The weather bids fair to be all that could be desired, and, altogether, the meeting this year promises well.

ANARCHISTS ACTIVE IN DIABOLICAL WORK

First Attempt Made to Blow Up the Agram
Cathedral and Second One to Wreck a
Newspaper Office—Both Failed.

VIENNA, July 14.—Two dynamite explosions, evidently planned by anarchists, occurred at Agram this morning. The first bomb was exploded outside of the residence of Dean Mantner of the

Agram Cathedral. Considerable damage was done, but the dean, who is 49 years of age, was unhurt. Shortly afterwards a second bomb was exploded in the cellar of the newspaper *Journalne Novine*, doing very small damage.

The fact of Colonel Mitchell having positively declined to accept the offer of the appointment and the further fact of Governor Chamberlain's non-committal attitude leaves the question open to conjecture and a further fact of every indication pointing to the carrying through of the alleged slate, which places General Gantenbein in the colonelcy, makes it imperative according to those who have watched the affairs of the national guard of Oregon that the Governor make his appointment of adjutant-general prior to the holding of the election on July 25.

HAVE TO BEAR OWN EXPENSES

Legislature Made No Provision
for Defraying Expenses of
Child Labor Commission
When Making Visits.

As a Consequence Members Labor
Under Difficulties—Federated
Trades Council May
Come to Rescue.

Although likely to be called to the most remote portion of the state to investigate alleged violations of the law the members of the Oregon Child Labor Commission are allowed neither salary nor expenses. They must work for love or not at all.

When the bill passed the Oregon State Legislature creating the child labor law, a commission or board composed of five members was appointed for the enforcement of the new statute. There was no appropriation made and no money set aside, however, that the members of the commission might draw upon, either for salary or in order to

defray their expense accounts in going from one part of the state to another to enforce the law.

It is stated that the Federated Trades Council may make some sort of provision to remedy this apparent negligence on the part of the State Legislature, but unless it does many are inclined to believe that the law will not be given the attention which its supporters are of the opinion that it deserves.

Members of the Child Labor Commission are expected to be kept on the move during the next few months investigating complaints about children, under the statutory age of 14 years, working at different places in Portland and the State of Oregon. Yesterday an alleged case was brought to the attention of Chairman Kundert. A boy, 13 years of age, was said to be working at the Standard Box Factory. Mr. Kundert made a visit to the factory, and was informed that the youth only lacked two weeks of being 14 years old. He gave a copy of the law to the management of the concern, with the request that it be complied with, and after receiving a promise that it would be, he returned home.

Frequent calls of this character are expected by those composing the commission, and as there are no emoluments attached to the office, to say nothing of honor or glory, they are beginning to realize that they have been elected to perform a most exacting and thankless task. If called upon, they are supposed to visit the most remote parts of the state to investigate alleged violations of the law, and they will even be obliged to bear the expenses of the trip.

DEADLY WORK OF THE TOY PISTOL

Lockjaw, caused by the explosion of a blank cartridge in a toy pistol on July 4, resulted in the death yesterday of Charles George Christian West, aged 13 years.

The youthful victim of his own patriotism was the son of George West, a milkman residing at 91 East Ninth street, north. The remains were taken to Holman's undertaking establishment. The interment will be at Holdridge, Neb.

In common with hundreds of other boys, young West bought a toy pistol to celebrate the nation's birthday. He used a blank cartridge with which to make a noise. One of the cartridges refused to explode and the lad began to investigate. He placed his left thumb over the end of the muzzle, when the cartridge went off unexpectedly. A small wound was inflicted in the flesh of the finger, either by a piece of cartridge or by wadding.

The injury appeared so trifling that it was considered of no account, although, as a matter of precaution, the boy went to a doctor's office to have it attended to. The physician dressed the finger and the boy returned to his celebrating.

After the first visit to the doctor the injury gave the lad no trouble and the little accident had been forgotten. Four or five days ago symptoms of tetanus, or lockjaw, set in and although two skilled physicians did everything for the suffering little patient, their efforts were in vain, and he died a victim of a terrible malady.
