BANDITS ARE YET AT LARGE

Desperadoes Who Held Up Sellwood Car Tuesday Night Still Enjoy Their Liberty While Police Search.

Despairing of Help from Detectives Oregon Water Power & Railway Company Sends Out Corps of Sleuths.

Fred Day, Who Was Shot in Holdup, Rapidly Recovering at Hospital—talks Interestingly of Experience.

The daring holdup of the Sellwood car and its 49 passengers Tuesday night is still the main topic of conversation in Portland. On the streets, in business offices, in the stores and shops and about the places where men congregate the brutality of the thugs has aroused popular indignation to such a pitch that there are the guilty men caught, there are many men in the city who would be willing to deal out summary justice to them.

With the slight clues at hand, there is practically little chance of capturing the desperadoes. Chief Hunt stated this morning that all his men were working, but it is well known that none of the officers has any hope of being successful in the search.

The Police Department is somewhat chagrined at the lack of interest shown in the matter by the victims of the holdup. Thus far only three or four of these, who were on the car, have reported their losses at police headquarters. Capt. Simmons said this morning that if he had a complete list of the passengers who were robbed with a description of the valuables lost, it would be a great aid to the officers. The detectives also desire to interview every person who saw the highwaymen, for in this way, they hope to get a description which will assist them in running the bandits to earth.

Chief Hunt has detailed 20 officers in plain clothes to clean the city of every character who cannot give a good account of himself. This crusade, he announced this morning, will not be confined only to any particular locality, but to everywhere toughs are likely to loiter about the saloons and dives. Officers are in the suburbs taking to account tramps and hoboes who may be found loitering or begging.

During the morning Patrolman Kay

took four young fellows to the station. They claimed they were looking for work. In a general way they answered the description of the holdups, and their case is being carefully looked into. The detectives have been furnished with any number of clues. Suspicious characters are being reported in almost every building and block of the city. While most of these reports are groundless the officers are running each one out in the hope that something tangible will result.

Arrested at Oregon City.
Officers in the near by towns are all on the lookout, the offer of a reward of \$500 being a special inducement to vigilance. At 1 o'clock this morning Night Officer Shaw at Oregon City arrested two suspects who were trying to secure lodging for the night. The marshal furnished them a room in the lockup and telephoned the Portland police. Detectives Kerigan and Snow were sent to investigate.

The pair of prisoners had in their possession a lady's gold watch and lady's opal ring and about \$40 in cash. One man is described as five feet, seven inches tall, of slim build and with a long nose. In a general way he answers the description of one of the highwaymen who was said to have a Roman nose. The other man is about five feet, 10 inches in height but no further description of his was given. One of the men had a blue-barreled revolver in his possession, while both carried cartridges.

Patrolman O. F. Isackson, who walks the beat on which the holdup occurred, has a theory that some of the gay young men who live not a great distance from the scene of the crime, the episode were responsible for the affair. He was on duty until an hour before the robbery but yesterday he was busy in running down every possible clue which presented itself. It is reported that there are several young men who have no visible means of support who congregated nightly in the neighborhood, and some of them may be compelled to account for themselves.

Following Clues.
The patrolman reported to headquarters that five or six young men were seen in Brooklyn selling soap at a suspiciously low figure yesterday. Two young men, both strangers and apparently very much excited, called at a saloon at Milwaukee avenue and Rhine street and changed a \$5 gold piece. Detectives are following each of these clues.

Chief Hunt's instructions to round up suspicious characters resulted in several arrests today. Edward Fallon, who was selling pens on the street, fell under the ban and went to the station under the charge of peddling without a license. Will Schmidt, a lad of 16, who claims he came from Albany this morning, was locked up for vagrancy. Others who landed in the lockup under charges of vagrancy were James Dean, aged 26; Sam Beshaw, 24 years old; W. C. Udell, James Demit, Peter Mitchell and Ferd Olinghouse.

Acel Clark and Harry Ollenbeck, both aged 17, were locked up by officers for the robbery was the work of a gang of "yegg men." Crooks thus designated are clever in their line of work, but to divert suspicion they travel in the guise of tramps. All of the victims agree in stating that the thugs were very rough clothes and one man had overalls and a jumper which looked well worn. While he refused to give The Journal

the least information regarding the holdup, Superintendent Tiffany of the Oregon Water Power & Railway Company admitted that his corporation was not looking for the least assistance from the Police Department.
"No, sir, we are not working with the police," said Mr. Tiffany. "We are conducting our own investigation, but I refuse to say anything about it. We have all the assistance and information we need, and are not looking for any help from any one. The men we have at work for us are perfectly capable of handling this matter."
"Why have you no faith in the detectives?" was inquired.
"Because the last time there was a holdup on our lines officers came here to see us. One detective I know of came right into my office here and said point blank that if we did not pay so much money the Police Department would not turn a hand in the matter. We are going it alone this time."

Charge Is Denied.
Upon being informed of the serious charge, Chief Hunt called Detectives Simmons, Kerigan and Snow into his private office, where the accusation was repeated. Each officer expressed his surprise that Mr. Tiffany had made such a charge, as they stated their relations with the company had always been the most cordial. Each detective in unqualified terms denied that he had been guilty of soliciting a bribe.
Captain Simmons said that upon the report of the robbery in question he had investigated and that other officers had done likewise. It had been reported that two young men of suspicious appearance might have been implicated, but they were able to prove themselves entirely innocent. Nothing about money had ever been suggested.

"I am glad that the company is conducting an investigation," said Detective Simmons. "For we want everybody to help. In this way the chances will be better for capturing the thugs."
"Now I want you," continued the senior detective, "to tell Mr. Tiffany that we would like to have him come to headquarters here and pick out the man who asked him for money. We want to know who it is."

Detectives Kerigan and Snow told The Journal that in their investigation of the robbery, Assistant Superintendent Hoynton, of the Oregon Water Power & Railway Company, had rendered them every assistance.
Fred Day Improving.
Lying on a bed of pain and filled with a natural desire for revenge upon the cowardly thugs who had shot him in cold blood, B. F. Day, better known to his friends, of whom he has many, as Fred Day, chatted pleasantly at North Pacific Sanitarium this morning.

Day was the victim of the Sellwood holdup Tuesday night. Following the operation yesterday he rallied rapidly, and he is on the road to recovery now. The bullet wound on the right side of his back gives him considerable pain, but he is able to turn himself over in bed and is in no danger.

The young man, who is an employee of the Oregon Water Power & Railway Company, lives with his uncle at Sellwood. He had a narrow escape with his life, but it is not the first time he has almost been killed. Two years ago he was caught under the pilot of a locomotive and seriously injured. He recovered after having a long siege in the hospital.

"I would like to get a shot at those fellows," he said this morning. "They seemed to think that I carried a gun or

was a desperate character, for after shooting me wantonly my assailant followed me through the car to where I fell before turning his attention to any of the other passengers.

"I remember that when I heard 'hands up,' mine shot into the air instinctively. I was standing on the rear platform in such a position that two men could not have passed by me. Instinctively I stepped to one side and then turned my head as the mark of the fellow who shot me dropped from his eyes. Almost immediately I was shot, the muzzle of the gun being so close to me that it burned the flesh of my back and carried pieces of cloth into the wound.
"I ran up the aisle to near the front, where I dropped. The man who shot me followed with gun in hand and commanded me to keep my hands up. I replied that I could not, as I was done for."

"Hold up that young guy there," commanded the fellow to the passengers. "He's the guy who tried his funny work."

"Following instructions, a nurse, her brother and a telephone girl, who were near me, braced me and one of them held my hands. The thief took my watch and a few dollars in currency."

Day's View of the Act.
After thinking over the affair, Day believes that he made his mistake when he took a step to the side and looked around. He is of the opinion that from what the brutal thug said inside the car that he believed Day was about to resist and possibly had a revolver.

The victim of the bandit's cruelty has also reached the conclusion that the tough clothes worn by the highwaymen were used simply for the occasion. He recalls that all of the men appeared very heavily built and their clothes appeared loose. This leads to the impression that the overalls and old clothes covered possibly tailor-made suits of the latest pattern.

Day remembers seeing another thug standing outside the car, with two guns pointed at the windows and guarding the platform. The fellow who fired the shot and the other Dick Turpin who entered by the front vestibule were the ones who collected the booty. The latter talked all the time in a facetious mood, while occasionally wearing a blue streak to frighten the women.

"I hate to give you this watch," said one woman in a faint voice as the thugs snatched it from her neck.
"Well, you ain't givin' it to me, but I'm takin' it. The next time you see me you can have it back."

Addressing a number of passengers, he explained:
"You see I don't want these watches, but I need them for a short time. If any of you people see me again you can have them back."

NO TRACE OF THE ESCAPED PRISONERS
No trace of the three prisoners who escaped from the county jail Tuesday night was obtained by Sheriff Storey or any of his deputies today. Mr. Storey issued circulars describing the fugitives and had them sent to the police authorities of all the cities in the Northwest, but up to this afternoon no reports of arrests of suspicious characters was received from any city. The Sheriff himself has been busy at work on the case, but if he has discovered any clues to the whereabouts of his lost boarders he has kept them to himself, for no one about his office has heard anything of them.

ANOTHER CASE FOR QUICK RELIEF

Facts Which Show the Absolute Necessity for an Emergency Hospital.

No better illustration of the necessity of an emergency hospital could be given than one which occurred yesterday afternoon.

On her way home to lunch, Mrs. Ida Thompson, a stenographer employed by Kelly, Clark & Co., was seized with a fainting spell at Clay and Thirteenth streets. The woman fell to the walk with great force, bruising her face in several places and receiving a severe shock.

The patrol wagon was hastily summoned by neighbors, who went to Mrs. Thompson's assistance, and she was conveyed to the Police Station. The city physician was called, and once there was necessarily a few minutes delay before he could respond. When he examined the woman he found her complaint but temporary and advised that she be kept quiet for a time.

Accordingly Mrs. Thompson was carried into the apartments of Police Matron Simmons, where she rested for several hours. After a time she recovered consciousness and strength and was able to go in a carriage to her home at Market and Twelfth streets.

However, Mrs. Thompson was greatly shocked, upon regaining her senses, to find herself in a police station. This knowledge was almost as great a shock to her as the injuries which she sustained.

Had there been an emergency hospital the patient would have received immediate medical attention, which, in many cases, would undoubtedly have saved her. Instead of awakening to find herself in the woman's quarters of the jail, Mrs. Thompson would have been in a hospital where she would have received every needed care.

San Francisco's Case.

There are five emergency hospitals in San Francisco which are located in widely separate districts, thus providing for short trips in the ambulances of the suddenly taken ill and injured. The Central Hospital is situated in the City Hall ground floor, as is also the hospital for the alleged insane; the Harbor Hospital is centrally situated on the waterfront; the Park Hospital is in a new building recently finished near the principal entrance from Haight street to Golden Gate Park, and the Potrero Hospital is in the neighborhood of the Union Iron Works. These five emergency hospitals are under the charge of the Board of Health and are maintained by funds every year by the Board of Supervisors in the annual appropriation. The charter under which the city is now being governed provides in the section devoted to health and sanitation that the Board of Health shall have charge of the fund appropriated to their use in, among other things, maintaining such "emergency hospitals as they may deem necessary for the proper care of the injured, etc."

There is a surgeon in charge of all the emergency hospitals, at present Dr. Bunnell, who has a staff of assistants under his direction, together with nurses, ambulance drivers and helpers. The surgeon in charge issues to his assistants such instructions as he deems necessary for the conduct of the different hospitals, though there is no fixed set of rules, it being considered that a
