

NOT PROPER USE OF COUNTY FUNDS

A Deputy Sheriff Cannot Legally Be Assigned to Perform the Duties of a Constable in the Justice Court.

Protests Against the Removal of Deputy Adkins Will Therefore Probably Be Unavailing, and His Head Will Fall.

It is generally understood about the courthouse that the contemplated reorganization in the force of deputies in the sheriff's office will involve the removal of Deputy Adkins, who has been assigned to duty at the Justice Court. While the sheriff has not yet made public announcement of the men slated for removal, it is thought probable that Adkins will lose his job for the reason that there is no warrant in law for assigning a deputy sheriff to do the work of a constable.

Three years ago the question was raised by the Taxpayers' League whether this practice was legal. The matter was finally referred to the District Attorney, George E. Chamberlain, who gave an opinion that it was clearly illegal to expend county funds in paying the salary of a deputy sheriff employed in performing the duties of a constable. This opinion, which was in writing, was as follows:

PORTLAND, Or., July 6, 1900.
HON. W. H. POPE, County Auditor, City—Dear Sir: I beg to own the receipt of your favor in which you state that the Board of County Commissioners desire my written opinion in reference to the matters hereinafter set forth.

It appears that an extra deputy sheriff has been appointed to serve in the Justice Court in Portland District. The act of 1895 entitled "An act to fix the compensation of justices of the peace and constables in the State of Oregon in cities having over 50,000 inhabitants," provides: "Section 4. The constables in all cities within the State of Oregon having 50,000 or more inhabitants shall receive an annual salary of \$1,500, to be paid in like manner as the salaries of other county officers are now paid, which said salaries shall be in full compensation for all services or duties performed by said constables, and no other fees, commissions or compensation whatever shall be allowed or received by them." Under this statute it is the duty of the constable-elect to perform the duties enjoined upon such officer by law, and to serve such process as may issue out of the court of which he is the ministerial officer, and for such service he is only entitled to the compensation fixed by law.

The act of 1895 prescribing the fees of the sheriff of the several counties provides that "the Sheriff of Multnomah County may appoint as many deputies as the County Court of said county shall by order authorize, one of which deputies shall be paid at the rate of \$1,500 per year, and the others at such rate as the County Court may by order direct, not exceeding \$1,200 per year." Under this provision, the Legislature evidently contemplated the appointment of a sufficient number of deputies to properly dispose of the business in the office of the Sheriff of Multnomah County and did not have in view the appointment of deputies to relieve the constables of duties enjoined upon them by law.

I am advised that it has been the practice in the Justice Court for Portland district to have in waiting upon the court a deputy sheriff who performs the duties of the constable at a salary of \$75 per month, fixed and ordered paid by the Board of County Commissioners. Whilst it might be convenient at times for some one about the Justice Court to hold a commission as deputy sheriff, there is in my opinion, no warrant or authority for the payment of the salary of such deputy out of the treasury of Multnomah County. It was intended that the salary of the constable should be in full compensation for all services performed by him as such officer. Yours respectfully,

The law upon this subject is the same now as it was when the foregoing letter was written. It would therefore seem to be clearly improper to continue to allow Deputy Adkins to draw salary from the county for such services as he has been performing at the Justice Court.

TO COMMEMORATE BATTLE

LONDON, July 18.—Many American tourists are preparing to visit the ancient town of Shrewsbury during the coming week on the occasion of the celebration of the 500th anniversary of its great battle, which occurred on July 21, 1403. The celebration will begin tomorrow with appropriate services in the old Abbey Church. The next few days there will be performances of "Richard II," "Henry IV," "Henry V," and "The Merry Wives of Windsor," by Benson's Shakespearean Company. The battle which the celebration is to commemorate is famous as one of the fiercest and most decisive contests ever fought on British soil, as well as by reason of being mentioned frequently by Shakespeare. The struggle was between the forces of Henry IV and those of Hotspur, the warlike son of the Earl of Northumberland, and its effect was to "make the former's position on the English throne, which he had usurped, stronger than it had been up to that time."

Charles A. Eastman, whose admirable book on "Indian Boyhood" has met with such success, has been appointed a special agent to revise the allotment rolls of the Sioux and see that they are given permanent family names. This is in pursuance of the general plan of merging the Indians into American citizenship. It is a task requiring great patience and delicacy. Preferably the original native name will be preserved, but all vulgar nicknames and incorrect traditions and anything which might mortify or make the civilized Indian appear ridiculous are to be rejected. Each Indian must be personally consulted when any change appears necessary.

No Abatement of Interest Shown Toward Windup of Big Detroit Meet.

DETROIT, Mich., July 18.—The proceedings of the Epworth League international conference are nearing a close, but no abatement of interest is apparent on that account. The morning watch services in the Central M. E. Church at 8:30 o'clock this morning were conducted by Thomas S. Marshall of Salem, Ill., and were well attended. At 9 a. m. the gathering divided into three general conferences, composed respectively of the delegates and visitors representing the Methodist, Episcopal Church, the M. E. Church, South, and the Methodist Episcopal Church of Canada. Bishop Isaac W. Joyce presided over the conference of the M. E. Church held in Auditorium Epworth. Rev. N. A. Swickard of Aberdeen, S. D., discoursed on "The Literary Work of the Chapter." Bishop E. E. Hoss was the presiding officer at the conference of the M. E. Church, South, and among the speakers were Rev. T. F. Sessions, Seguin, Tex.; Rev. E. H. Rawlins, Portmouth, Va.; Rev. J. M. Nichols, Gainesville, Tex.; and Rev. E. O. Watson, Charleston, S. C. Rev. John McDougall, D. D. of Calgary, N. W. T., was one of the principal speakers at the Canadian conference, his subject being "Our Work in the Northwest."

John G. Woolley of Chicago, and Samuel Dickie of Michigan, both temperance leaders of national prominence, are to speak tonight and among other prominent persons to be heard are Bishop Galloway, Henry D. Lloyd, representing the American Federation of Labor; Hon. D. D. Woodmansee of Cincinnati, and Rev. E. A. Benson, D. D., Columbus, O. Representing the American Anti-Saloon League, tomorrow the pulpits of the leading churches of Detroit will be occupied by distinguished divines who are among the visitors.

JAUREZ' NAME IS HONORED

CITY OF MEXICO, July 18.—This was the birthday anniversary of the Liberal party president, Benito Juarez, and in honor of his memory appropriate memorial exercises were held in the cemetery of San Fernando. A long procession marched to the cemetery wherein lie the remains of the illustrious soldier, who led the successful struggles against Maximilian emperor. The procession included workingmen's societies, members of the federal, district and city governments, scientific societies, officers of the garrison, members of Congress and members of the Liberal patriotic committees. Orations were delivered by prominent public men and at the conclusion of the exercises the tomb was almost buried beneath the floral offerings of the different societies and Masonic lodges.

TRI-STATE TENNIS TOURNAMENT

CINCINNATI, July 18.—The fifth Cincinnati open tennis tournament for the tri-state championship of Ohio, Indiana, and Kentucky, was formally opened here today and will continue through the greater part of next week. The winner of the men's singles will be entitled upon to play the tri-state champion, Raymond D. Little, who has won two "legs" on the present tour. The winner will become permanently possessed of the trophy in the event of a victory in the approaching contest.

HARRISON FOR STATE NEXT PRESIDENT

Boom of Chicago Mayor Is Expected to Be Launched Before Democratic Picnic There This Afternoon.

Sullivan, Bryan, Hearst, Trimble and Other Important Party Leaders Are Present at the Gathering.

CHICAGO, July 18.—The boom of Mayor Carter Harrison for Democratic Presidential candidacy for the campaign of 1904 is expected to be launched this afternoon at Brand's Park, where prominent Democrats from all over the United States are making merry today. Among those in attendance are Sullivan, the Democratic nominee for Governor of Iowa; William Jennings Bryan, and Congressmen Trimble, Hurst and Williams.

Secretary Walsh of the Democratic National committee, who was to have brought Harrison's name before the party in an address at the picnic today, was unable, through illness, to be present at the gathering. He forwarded, however, a copy of the address he intended to make and this will be read before the assembled multitude some time this afternoon.

Enthusiasm runs high. Fifty trolley cars had been chartered to carry the guests to the park and at 1 o'clock this afternoon a mammoth procession passed through the downtown district and out to the grounds. This is the most notable gathering of Democratic politicians in the West for months and great results are expected.

TREE CHOPPERS TO HOLD SWAY TONIGHT

Woodmen of the World Will Take Possession—Big Shows Are Largely Attended.

Tonight is Woodmen's Night at the Carnival now on in Portland and the managers of the big show expect to break the record of all carnival attendance this evening.

A parade of the various camps will start from the corner of Fourteenth and Washington streets about 7:30 tonight, proceeding down Washington street to Third, to Morrison, to Sixth, to Washington, to West Park and on to the carnival grounds last night during the festival of the Women of Woodcraft was, although not so large as for the opening night, quite heavy, and confetti throwers vied with each other to see who could throw the most pieces of the little paper. It was a merry war of many colored discs.

The slideshows were liberally patronized and all were at their best. The various attractions went off without a hitch.

Among the Slideshows.

The dog and pony show continues to attract the attention of not only the children but a majority of those who enter the grounds. The work of the counting pony is especially good. The Ferris wheel, one of the "higher attractions," is constantly crowded with visitors who can obtain beautiful birdseye views of the carnival grounds with its thousands of electric lights while on its upward and downward journey. The electric theatre, with its varied program of moving pictures, is well worth seeing, a majority of the scenes shown being entirely new to Portland audiences.

Every day will be a "special" at the carnival during the coming week. Monday being designated as "Oregon Day," when special features concerning the state at large will be shown. The various fraternal organizations have consented to take charge of the carnival on Tuesday night and a program of excellent merit has been prepared for the home and visiting brothers.

On Wednesday the babies will hold full sway and a number of prizes will be offered for those who excel in fairness of features and good behavior. Of course, every mother thinks that her child is the prettiest to be found and a lively competition is sure to result. Thursday has been set aside for the exclusive use of the Multnomah Club; Friday is given to the Elks, and Saturday, the closing night, will be devoted to a general program.

STATE MAY HOLD A MILITARY CAMP

Although Joint Encampment at American Lake Is Abandoned, Oregon Guardsmen Are Not Discouraged.

Military Board Will Meet in Portland Next Tuesday to Discuss Peace Campaign for the Troops.

Although the officers of the Oregon National Guard are greatly disappointed at the announcement made through the War Department late yesterday afternoon that no joint encampment of the Regular Army and the militia of Oregon, Washington and Idaho could be held this year, they are still hopeful that the volunteer soldiers of Oregon may be accorded a military outing and two weeks' training at a mobilizing point within the boundaries of this state. This latter question will be discussed and determined upon at a special meeting of the Oregon Military Board which has been called for next Tuesday afternoon at the office of Adjutant-General C. U. Gantenbein, Chamber of Commerce Building. If a state encampment is held Regular Army troops may participate.

There is known to be a sufficient amount of money in the Oregon military fund to defray the expenses of the guard for transportation to and from such a gathering, but whether the limited sum remaining after these bills had been discharged would warrant such expenditure is the matter to be decided upon.

Should the military board determine to recommend to Governor Chamberlain the holding of a state encampment the time and place will be named in such recommendation. While it is desirable that the journey of the troops be confined to the least possible distance in order that the cost of travel may be reduced to the minimum it is held by members of the board that no suitable site for a military camp exists in the immediate vicinity of Portland and that some other part of the state would have to be selected.

Board to Determine.

The members of the State Military Board, who will determine upon the matter of a state encampment, are: Adjutant-General C. U. Gantenbein, Col. James Jackson, Inspector-General; Col. D. M. Dunne, Commissary-General; Col. A. B. Gillis, Surgeon-General, and Col. S. C. Spencer, Judge Advocate-General.

While admitting that a state encampment would be of undoubted benefit to the Oregon guard, Adjutant-General Gantenbein was not prepared today to express himself as entirely favorable to a mobilization of the militia of this state during the present year.

"It is a grave question," the General said, "and one that an officer cannot be ventured upon without many things being taken into consideration. The amount of money in the state military fund is not the least of these. The board will meet on Tuesday afternoon and some conclusion will be decided upon at that time. I could not even hazard an opinion at the present time regarding the decision that will be reached."

While General Gantenbein is reticent on this point, the members of the rank and file of the guard are of the opinion that before the board he will favor an encampment and it is looked upon as a certainty that if the funds at hand can be in any manner made to cover the expense of a military outing exceeding eight days the state camp will be held. A shorter stay than eight days at the place of encampment, it is urged, would be without practical good result.

Disappointment is Keen.

"It is a great disappointment to members of the Oregon guard to be deprived of the actual service experienced that would have resulted from a joint encampment of the military forces of Oregon, Washington and Idaho, in connection with the Regular Army," said General Gantenbein today. "Such a military gathering would have the utmost benefit to the National Guardsmen and would have promoted the feeling of good fellowship between the Regular Army men and the volunteers."

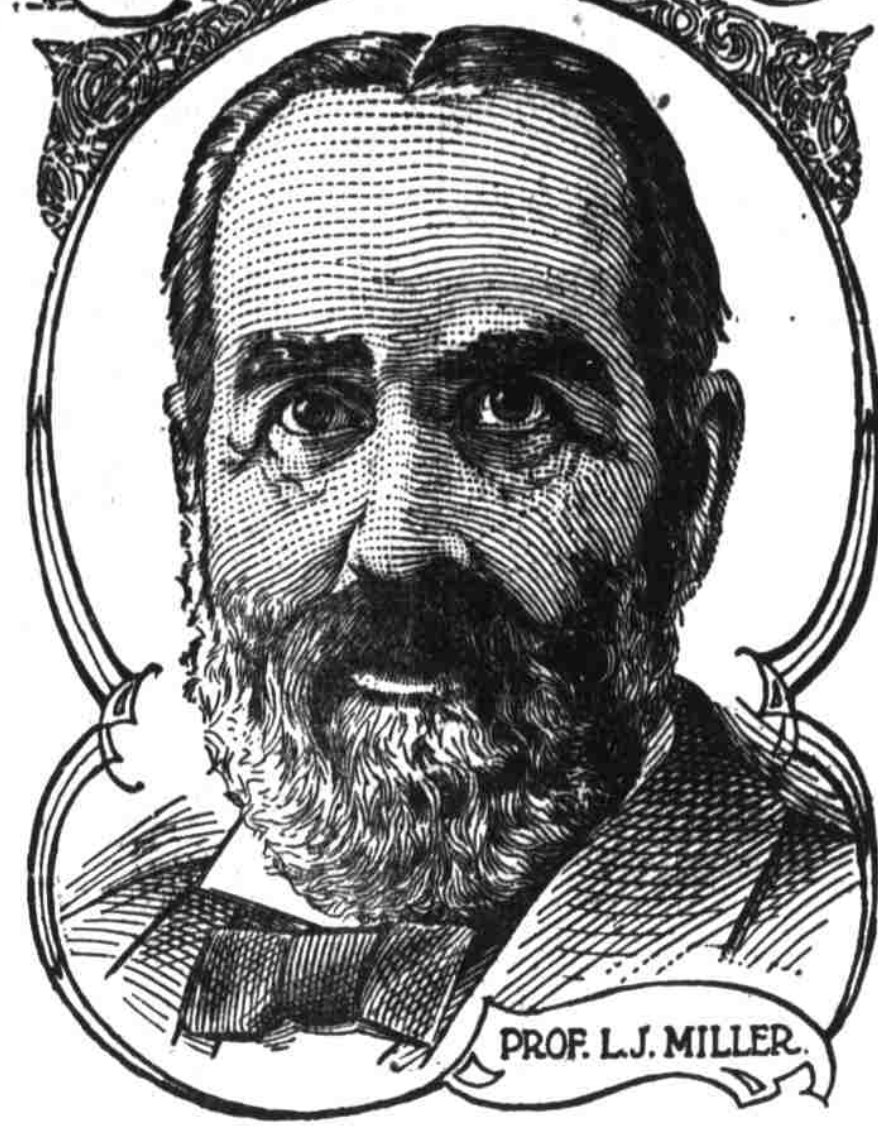
On Tuesday the board will decide whether the joint encampment be held at American Lake, near Tacoma, in the State of Washington, and the National Government, in the interest of promoting the efficiency of the volunteer forces, was to have delayed the training of the militia. The announcement which I received late yesterday afternoon through Major Evans, Adjutant-General of the Department of the Columbia, that the War Department had found it necessary to abandon this plan, has made a joint encampment impossible, as the states themselves cannot afford the cost of such a military maneuver.

"I feel certain, however, that within the year some provision will be made for matters of this kind and that my hope is to have the militia of the National Guardsmen and regulars meet in a Northwest camp and drill and march."
