

A DEEP MURDER MYSTERY

Prominent Railroad Man Found Hacked Almost to Death with an Ax, and Girl with Him Treated in Like Manner.

Scandal Connected with the Case that May Never Be Fully Told—Brother of Young Girl Accused.

Another Man Also Charged with the Crime, but Both, After Being Arrested, Deny Any Connection.

CHREVEPORT, La., Aug. 15.—A terrible crime was committed here sometime during last night which is exciting the country for miles around. Master Mechanic Elliott of the Cotton Belt Railway and May Smith were found at daylight this morning in bed in the latter's cottage, their bodies mangled and hacked with an ax. The woman is living and the man is unconscious and cannot live. The brother of the young woman, who slept in an adjoining room, heard a noise and discovered the tragedy. The brother and William McKeevan, another occupant of the cottage, were arrested and charged with the crime. A bloody ax was found in the kitchen. Robbery was not the motive, as the money of the murdered man was found in the bed.

May Smith was a handsome young girl scarcely 20 years old, and until a few days ago it was not known that she had an intimate acquaintance with Elliott. It is not believed that the brother knew that Elliott was in his sister's room, but suddenly learning it, killed the man for his actions. Smith denies all knowledge of the murder. Elliott was a married man with a family.

SOLDIER MONUMENT DESIGN ACCEPTED

The Second Oregon Volunteer Infantry Monument Committee this afternoon decided unanimously to accept the design submitted by Tilden and Corhead and work on the erection of the memorial to the brave citizen soldiers of the state who fought in the Philippines will commence at once. It was further decided at the meeting this afternoon in the office of Adjutant-General C. U. Gantenbein of the State Guard, to pay over to the designers the \$1,000 specified in the contract, when bids for designs were submitted, as soon as the working drawings are completed and furnished the general committee, motion by Colonel James Jackson, to let contracts for the monument.

Chairman H. W. Scott appointed a committee, consisting of Colonel Jackson, General Gantenbein and Major C. E. McDonnell, to take charge of the work.

The monument will be erected in the Plaza between Third and Fourth streets, in front of the County Court House and will occupy the neighborhood of \$14,000, the money for which has already been subscribed. The granite base will be 22 feet in height and will be surmounted by a bronze figure of a soldier, seven feet in height. The soldier stands in a life-like pose, in campaign uniform, his sleeves rolled up and his gun in the position of a skirmisher.

Those present at the meeting were H. W. Scott, H. C. Campbell, Colonel Jackson, General Gantenbein and C. E. McDonnell.

BIRDIE GOERTZ NEW SECRETARY

The Portland Federated Trades Council Elected Her to Position of Statistical Secretary Last Night.

Miss Birdie Goertz has the honor of being the first woman to hold an official position in the Federated Trades Council of Portland. At a meeting of that organization last night she was elected statistical secretary, to fill a vacancy caused by the resignation of John G. Hoffman. Miss Goertz is a member of the Cooks and Waiters' Union, and has been a delegate to the council for the past six months, taking an active part in the various questions that came up for consideration before that body.

P. H. Scullin, the Seattle labor leader, was in attendance and delivered an address upon the subject of arbitration. His remarks were confined almost wholly to the discussion of a recently proposed plan, last night, and he requested the council to endorse it. No official action was taken in the matter, but it is said that it will be acted upon favorably at the next meeting of the organization. Mr. Scullin has visited nearly all the employers' associations in Portland, and secured their written approval of his plan.

The committee appointed for the purpose of making all necessary arrangements for the Labor Day celebration reported that the program of the several events would soon be prepared. It is the intention, the committee states, to have one of the most routing celebrations held in recent years. There is to be no parade, but the day will be devoted exclusively to games, sports and picnicking.

NOTED TIP SMITH IS NOW IN JAIL

W. Smith, better known as "Tip" Smith, who is said to have posed as Detective Day and under this pretense to have robbed Myrtle Collins of a gold ring, was held to the grand jury in \$1,000 bail, after he had been arraigned in the Police Court today.

As exclusively published in The Journal of yesterday, Miss Collins was waylaid by a man Wednesday night, who said he was Detective Joe Day. He threatened to arrest her, and assisted another man in a room, robbed her of a finger ring, after searching her for money.

The real Detective Day started out to find his clumsy imitator, and soon Smith was in custody. Miss Collins identified him as one of the men who had robbed her, and she swore to a complaint charging larceny.

The complainant was also held as a witness.

LIVESTOCK MEN WANT \$100,000

Breeders' Association of North Pacific in Conference with the Lewis and Clark Fair Directors.

The Livestock Breeders' Association of the North Pacific desires an appropriation of \$100,000 for the purpose of making an exhibit at the Lewis and Clark Centennial Exposition. Delegates are in session today at the offices of the Fair Commission, and at a meeting this morning a resolution was passed asking that the association be given that sum with which to make its display.

Mahoe to Help Fair.

C. B. Hurtt, Executive Commissioner for the State of Idaho at the two great World's Fairs, believes that the Western States should stand together, and in his energetic work in behalf of his own state he is willing to assist his neighbors. He is in Portland today, and made the following statement:

"Idaho feels very kindly toward Oregon, and, as I told the local Fair Commission, I am willing to fold in Lewis and Clark advertising matter with every bit of literature I send out."

"Our state has unlimited resources that have never been developed. There is no need for rivalry between Oregon and Idaho. The Panhandle State has 180,000 population scattered over 84,000 square miles of territory, while Oregon has in the neighborhood of 500,000 people. Why, we haven't enough residents in Idaho to consume the spring chickens we raise."

As Executive Commissioner for Idaho Mr. Hurtt is in direct charge of the Fair, and he is working for the erection of the state buildings. From Portland he will go to Northern Idaho to look after the work there. His family is at Long Beach, and he will join them tonight. While in Portland he is the guest of R. M. Hall, advertising agent of the O. R. & N., an old college friend.

"Every exhibit at the St. Louis Fair," said Mr. Hurtt, "will be prepared with the idea of its being later transferred to Portland. In this way I believe both fairs will be benefited."

WOULD PREVENT SIDEWALK SIGNS

Special officers from the City Engineer's Department yesterday arrested August Erickson, who keeps a saloon at Front and Burnside street on a charge of violating the sidewalk ordinance. It is alleged that he had a sign or advertisement cut into the sidewalk in front of his saloon.

This will be a test case upon which the construction of the ordinance will depend. Heretofore there has been no attempt to get around the provision where the placing of advertisements in the sidewalks is actually prohibited.

After Erickson's arrest he was taken to police headquarters and released upon depositing cash bail in the sum of \$50. He apparently intends to fight the suit in the courts.

"This is the first arrest upon such a charge," said an employee in the City Engineer's Department today, "and we intend to fight the case. The law specifically provides that the firm name can be placed on the sidewalk in front of any place of business, but in an equally strong terms prohibits the similar placing of any advertising matter. The ordinance was passed because it was thought to be to the best interests of the municipality and it must be obeyed."

Besides the presence of advertising matter on the sidewalk where people are constantly passing would be a source of annoyance."

A great deal of interest is being manifested in the suit, for in its nature the outcome will be of great importance to many local business houses. There is no question that if some loophole is found wherein the particular feature of the ordinance can be violated sidewalk advertisements will become highly popular as a means of advertising the wares of many merchants.

DOCTOR'S SUIT DROPPED

The suit of Capt. Marsh of the National Guard against Major G. C. Von Egloffstein was dismissed in the West Side Justice Court this morning, as Von Egloffstein filed a petition in bankruptcy, as related in yesterday's Journal. The Major's uniform, etc., are, under the state law, exempt from attachment, and as they were personal property, could not be held after he had decided to become a bankrupt.

PORTLAND WANTS THE EDUCATORS

All Oregon Has Been Asked to Assist in the Effort to Bring the 1904 Convention to This City.

Portland wants the next annual convention of the National Educational Association to be held in this city. This is the first time the city has been asked to assist in the campaign. Seattle is also an aspirant for the honor, and, like Portland, has been quietly working for some time to secure the meeting.

At a meeting held yesterday afternoon at the headquarters of the Board of Trade, it was decided to take action at once and to work toward securing the convention for Portland in 1904. A means of advertising the Lewis and Clark Fair is the foremost thought in the minds of those who attended the meeting, and it is confidently expected that this city will land the prize.

Committee Has Done Much

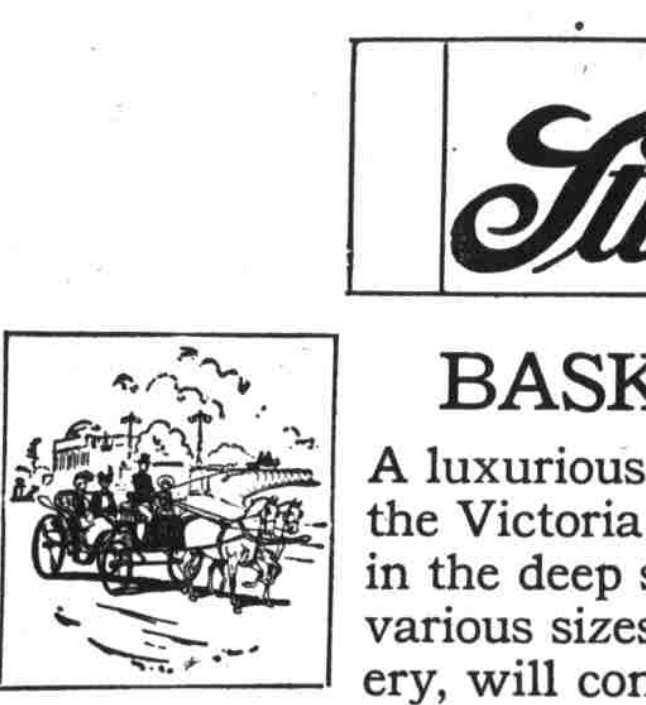
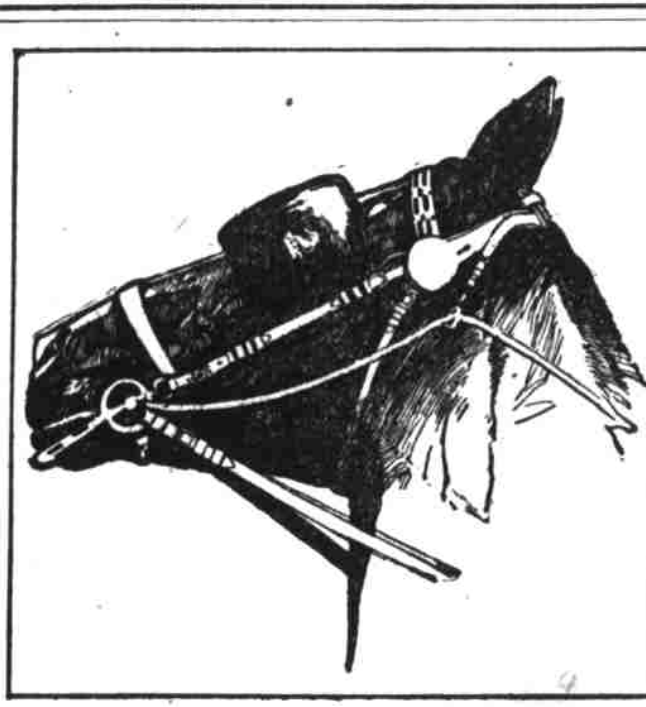
The preliminary committee, appointed at a meeting held on August 5, reported that it had been in correspondence with Secretary Irwin Shepherd of the National Association, at Winona, Minn., and had received from him the following list of what was required of the city that would entertain the convention:

"A hall capable of holding 5,000 people and at least eight churches or smaller halls, having a capacity of from 500 to 1,000, for the different divisions; quarters for the Executive Board and head officials, 16 in number; a guaranteed attendance of the teachers of the state and accommodations for about 10,000 delegates. All these, Max M. Shillcock, secretary of the Board of Trade, said he believed could be easily provided."

Messrs. A. L. Craig of the Oregon Railroad & Navigation Company, Chas. S. Fee of the Northern Pacific, W. E. Coman of the Southern Pacific, Director-General H. W. Goode of the Fair Commission, representatives from the commercial and educational bodies of the city, and others were in attendance at the meeting, and all expressed themselves as heartily in favor of bringing the convention to Portland. A meeting will be called in the course of the next two weeks to further outline a plan of action.

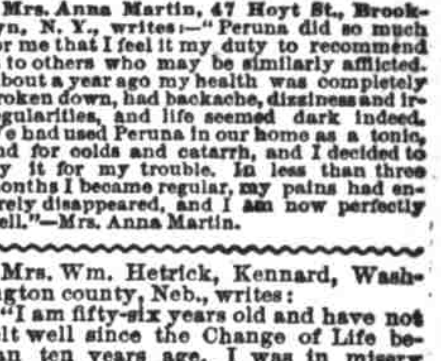

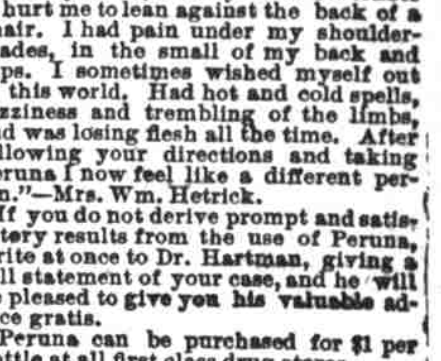
