The Police Department is trying to stop the practice of teamsters of driving across the corner of the sidewalk in the neighborhood of Twenty-third and Russell streets. Willie Conannon, a lad of 16, was arrested by Patrolman Hammers for this offense and when he appeared before Judge Hogue pleaded guilty. The court reprimanded him, but suspended sentence as long as he kept his promise not to break the ordinance again.

After examination, Dr. A. E. Mackay concluded that W. B. Dyer was not seriously injured as at first believed. Dyer, who is an employee of Contractor C. J. Brett offered to make a settlement with the defendants, but they refused to accept his offer or to surrender the certificate.

NEW "TELEPHONE" NEARLY COMPLETED

Owners Say She Will Be the Swiftest Sternwheeler Afloat.

It is the ambition of her builder to make the steamer Telephone, now nearing completion at the dock on the Willamette from Works, the swiftest sternwheeler in the world. The steamer's engines have a 26-foot bore, and an 8-foot stroke. Her boiler will carry 200 pounds of steam. The machinery is all new, and patterned after the most successful models. It is now being installed and will be in place as soon as good mechanics can complete the task.

The boat is modeled on trim lines that insure speed. She does not have the broad, bulky keel that time-killers of so many river boats, but has a long narrow hull.

From stem to stern the measures 200 feet, and has a 35-foot beam. Her cabins are being fitted up with a view to accommodating 500 passengers. With the exception of the Arrow, which was removed from the old Telephone, the boat is new throughout. They have been thoroughly overhauled.

The Telephone belongs to the Arrow Navigation Company, which recently built the steamer Arrow, and the Arrow is now operating on Puget Sound between Seattle and Tacoma. It is said that the new steamer will be placed in commission between Seattle and Whatcom. When completed she will be given a trial run on the Columbia.

The owners expect that she can outdistance any stern wheel vessel afloat between Astoria and Salem. If she can do this she can beat the world, they say, because the fastest stern wheelers in the world are on the Columbia.

"NO TRUSTEES." "AN 8-HOUR DAY."

Two Mandates Put in Force by Some Mysterious Power—Judge Webster Says the Thing Is Spontaneous.

Janitors Sweep the Lawn and Prisoners Who Have Done the Work Heretofore Break Rock for Exercise.

From all indications it appears that the County Court intends to make not only the county prisoners but also all the employees of the county earn the wages paid them by taxpayers. The morning the janitors were engaged in sweeping the leaves from the courthouse lawn, a duty which has in the past been performed by the trustees of the jail. It is said that the entire trusty system, with the exception of a few that are absolutely needed as janitors of the jail, will be abolished by the court, and even Sheriff Storey, who is now at Astoria as commodore at the regatta, will be compelled to spend more of his time in his office.

When asked about the reported rule that the janitors were engaged in sweeping the leaves from the courthouse lawn, Judge Webster said no formal order of the court had been made.

"Why are the janitors at work on the lawn?" was asked.

"They perform that work of their own volition," smilingly remarked the judge. "Like other employees of the county they feel that they should work as hard for the money they get as does the taxpayer for the money that pays their salaries. All do the work voluntarily."

Asked about the absence of the trustees, he said he supposed the Sheriff had sent them to the rockpile.

"A great many of them wish to get exercise in the open air," said the judge, "and I suppose the trustees were among those in the list. No, I do not know of any petition by the prisoners for shoes and clothes while they are working for the county. I have heard rumors that such a petition would be filed, but I have not seen it yet. Of course, we shall furnish the men with working clothes, overalls, jumpers, heavy shoes, etc., while they are out on the rockpile so that they may save their good clothes and when they get out of jail they will not look like a lot of tramps. But they will get no fine apparel."
