HUNDREDS ATTEND ZIONIST RALLY

Hebrews in Portland interested in the Zionist movement to people Palestine with Jewish colonists gathered last night at Talmud Torah synagogue and listened to addresses delivered by prominent members of their own race. The principal speaker of the evening was Rabbi Isaac M. Wise of San Francisco, who spoke on Zionism and the persecution of Jews in Russia.

Rabbi Stephen B. Wise of this city spoke to some length on the persecution of the Russian Jews and urged his congregation to stir themselves in the cause of humanity. Dr. Simeon M. Ostrow, Ben Selling and Rabbi R. Abrahamson also took part in the meeting.

Zionism as explained by Dr. Myers is the love of the Jew for his fatherland, and the one star of hope to which he has turned for the last 1,800 years. "It makes his suffering less severe," he said, "and at all times has a prayer been ready for Zion, the love for which the Jew has never lost."

The speaker spoke of George Eliot's "Daniel Deronda" as an example of Zionist love. His first suggestion of the Zionist movement, said Dr. Myers, came through a visit to Palestine, at which time, as a sort of vision, the assistance the sufferers needed should come from the free, was brought to his mind. This "Genius of Palestine," as he termed it, suggested the buying of land on which the less favored of the race might reside. Palestine was the place.

Dr. Myers closed his lengthy but interesting address with a high praise of the action of President Roosevelt in attempting to forward the Kishineff petition to the czar.

"Russia would not dare treat Catholic or Protestant as he has the Jew," continued the speaker, "for there are governments controlled by these orders that would prevent it. But there is no Hebrew government, but there shall be one little corner of the world that shall yet be called the Jews' corner."

Rabbi Wise answered the attacks of several critics of Zionism in the course of his address. Ben Selling announced that the \$100 remaining of the local Kishineff relief fund had been donated to the fund of the orphans of the massacre.

CHILD ELOPERS CAUGHT AT ASHLAND

A runaway couple from Olympia, Wash., for whom the police in this part of the country have been seeking since last Wednesday, were arrested at Ashland, Ore., yesterday.

Frank Barnett, a bootblack aged 18, is now under arrest charged with kidnapping, while his youthful companion, Tracy Eads, a tiny miss of 13, is sorrowfully weeping because of her wardens.

Charles Eads, the girl's brother, felt sure that the couple would try to reach San Francisco instead of going to Seattle. He arrived in Portland yesterday on the trail of the runaways. He communicated with Superintendent Gardner of the Boys' and Girls' Aid Society, and it was learned that the missing couple had spent Thursday night in Portland at a Third street lodging house. Friday night they had left for the Bay City.

The boy was sent to Ashland and it arrived in time to put Constable M. M. Long on the watch when the noon train pulled into his town. He found the elopers and put them under arrest. An officer will go from Olympia at once to take the runaways back.

LAW AGAINST RIGHT OF COP TO SHOOT

According to the decisions of Southern and Eastern courts, Policeman Hemsworth had no legal right to shoot Tommy Ryan, fleeing from arrest. Suit for damages against Hemsworth was filed by Attorney W. T. Hume, representing Ryan, last Saturday morning, and there was some doubt expressed as to whether such damages could be obtained from a peace officer in the performance of his duty. Decisions cited by Mr. Hume show that Hemsworth acted wrongfully; that Ryan, an escaped convict, had been guilty of only a misdemeanor (optimum eating), and that undue force in causing his arrest was neither justifiable or necessary. The principal decisions cited are as follows:

"A peace officer acting without warrant cannot kill a fleeing person who refuses to stop when commanded to do so, on suspicion that he has been guilty of a felony where the offense was only in fact a misdemeanor." (Marie Petry vs. S. H. Cartwright, Kentucky court of appeals, Nov. 12, 1932).

"No greater force or violence can be used to prevent the escape of a person from arrest than might rightfully be employed to effect his arrest. An officer cannot rightfully kill one charged with a misdemeanor to prevent his escaping from arrest unless it is necessary to save his own life." (Martha Thomas et al. vs. Ewing Kinkaid, Arkansas supreme court, March 28, 1898).

"An officer has no right to shoot at a person who is merely running away from him, without committing any violence, when under arrest for a misdemeanor. The wrongful shooting by a deputy sheriff of a prisoner attempting to escape from arrest for a misdemeanor is an official act that creates a liability on the sheriff's bond. An amendment so as to bring suit in the name of the state for the use of the real party in interest, when it was brought in the name of the latter, may be made in action on a sheriff's bond." (T. J. Brown vs. E. B. Weaver et al., Mississippi supreme court, March 28, 1898).

In the Mississippi case the court held in part:

"In making the arrest or preventing the escape the officer may exert such physical force as is necessary, on the one hand, to effect the arrest, by overcoming the resistance he encounters, or on the other, to subdue the efforts of the prisoner to escape; but he cannot in either case take the life of the accused, or even to inflict upon him a great bodily harm, except to save his own life or to prevent a like harm to himself. It is considered the duty of a peace officer to prevent a prisoner to escape altogether than to take his life."

NELS WALLGREN FOUND DROWNED

The funeral of Nels Wallgren, a longshoreman, who lived at 371 Nineteenth street, took place from Finley's chapel today. The interment was at Lone Fir cemetery.

Wallgren's body was found in the Willamette last night at the dock of the American Can Company by L. C. Batchelder and W. Mason. Coroner Finley decided to hold no inquest.

The drowned man was a brother of J. Wallgren, a grocer at 381 Seventeenth street. Nels Wallgren was last seen alive Tuesday, when he left his lodging house. He had been drinking heavily. The body remained unidentified until the man's name was found scribbled in an old notebook.
