

CRITTEEN HOME TROUBLES AIRD

BOARD OF MANAGERS AND COMMISSIONERS IN JOINT CONFERENCE THIS AFTERNOON AT HOME OF MRS. A. H. BREYMAN—GOVERNOR'S LETTER READ.

The refusal of State Board to Allow Bills for Nurse Mrs. Riggs' Salary, Gov. Food, etc., Subjects of Discussion—What Becomes of Money Put Up by Inmates is Answered in Various Ways.

Several bills presented by Superintendent Anna R. Riggs of the Florence Crittenden home, that the state commissioners have refused to allow, and a letter from Governor Chamberlain in which he counsels strict economy, were before the joint meeting at Mrs. A. H. Breyman's home, of the managers and the commissioners of the Refuge this afternoon.

Mrs. Riggs maintains a down town office for which the rental is \$12.50 a month. In addition to this there is a telephone bill of \$2.00 and her own salary of \$60. All this and more the commissioners have refused to pay. Mrs. Riggs' salary, section 5, which reads as follows, was amended so as to include a superintendent and "what other assistants are deemed necessary."

"The local board shall employ a matron, who shall have the general superintendence of the home under the direction of the board."

The matter of keeping babies and girls of unsound mind at the Refuge was also a matter for discussion and difference of opinion at today's meeting. It is said by the commissioners and some of the board of managers that the home is merely a refuge for women and should not be turned into an insane asylum of an infant's home.

"No such places are maintained by the state and county," declared one of the conclaves.

The old story of one of Capt. Riggs' cows being fed at the home was also mentioned in a casual way. It appears that one of the bills the commission refused to allow was \$54 for the feeding of the home's cows for a period of three months. Investigation was made and it is alleged that the cows were discovered in the paddock instead of two.

The governor's letter is the same that was written at the conference of the commission and his excellency a week ago. It states that the \$2,000 fund is to be held in sacred trust by the board and to be disbursed only as it sees fit.

At the joint meeting this afternoon the board of managers stated it was preparing a report of its side of the case, which it will present in a day or two.

Some Concluding Statements. Except in cases where there is contagion at the home or the condition of the women is such that they cannot be removed the expectant mothers are taken to the Good Samaritan hospital during their confinement. Dr. S. E. Joseph, in charge of the maternity ward at the hospital and dean of the medical school of the state university, said this morning that all Refuge Home cases were attended free of charge.

"Not a single penny do we receive from either the patients or the home," he said.

It has been charged that the women were exposed to clinics at the hospital, but this was denied by both Dr. Joseph and Matron Wakeman.

"An understanding from the medical school sometimes assists the regular physician," remarked the doctor, "but never is there more than one." Mrs. Wakeman made a similar statement. She also declared that the hospital received no money from the home.

Mrs. Riggs stated that the girls upon entering the refuge were expected to pay \$20.

"However," she continued, "if they haven't the means they are received just the same."

PAWNSHOPS FAIL TO OBSERVE ORDER

Sunday Closing Mandate of Chief Hunt is Observed in Its Breach, and No Arrests Follow—Mr. Hunt is Silent.

It is evident to the most casual observer that the recent orders of Chief Hunt to close all second-hand stores and pawn shops on Sunday have either been privately countenanced or the merchants in these lines of business have little fear of the police.

Yesterday several of the stores which were placed under the ban were open for business as usual. Some of the dealers in second-hand goods observed the Sabbath, but the majority of the North End places were transacting business.

Whether the orders have been rescinded is not known, but it is understood that the officers were told not to molest any who wished to keep open.

The order was issued about three weeks ago, and Chief Hunt has been emphatically enforcing the orders of the police department were never changed, and that the regulation in question was not temporary. The day following but one North End second-hand dealer kept his doors open. He was dusting off his stock when a policeman told him to lock the doors or suffer arrest. He immediately complied with the order.

A week ago yesterday the order was disregarded, as it was yesterday. What has caused the change of front on the part of Chief Hunt has not been ascertained. When the order was first issued the merchants threatened if they were compelled to close, that they would close every other line of business. They asserted that clothing stores were not molested.

When an attempt was made to secure explanation of his change of front on the question Saturday, Chief Hunt refused to talk.

MILITIA WILL BRING THE MEN INTO COURT

Cripple Creek, Colo., Sept. 21.—The habeas corpus proceedings were resumed in the district court this morning. The judge gave the military authorities until 2 o'clock this afternoon to bring the petitioners from the bull pen to court. General Chase announced that he would bring the prisoners, but under a heavy detachment of soldiers, who would be instructed to resist any attempt of the civil authorities to take charge of the men.

NATIONAL TREASURY WAS NEVER SO FULL

Washington, Sept. 21.—Never in the history of the country has the national treasury had such a large cash balance. Current receipts today furnished \$1,000,000 week in excess of the expenditures. The available balance shows an unprecedented amount, \$269,000,000 odd, and if the amounts in the hands of disbursing officers and the gold reserve of \$150,000,000 were added, the grand total would show \$419,000,000.

LOSSES SUIT FOR DAMAGES.

The jury in the case of M. L. Duff, administrator of the estate of his son, James Duff, against the Willamette Iron & Steel Works today brought in a verdict for the defendant as it had been out three and a half hours. Duff sued for \$3,000 damages for the death of his son who was killed by the explosion of a cylinder head in the shop of the Willamette Iron & Steel company on September 22, 1902.

DELAYED BY GALE

INDRAPURA HAD SIX DAYS OF STRONG WIND TO COUNTER WITH ON THIS TRIP IN CROSSING THE PACIFIC—VOYAGE IS OTHERWISE UNUSUAL.

Waves rolled over the decks, but no damage was done—Few Passengers Brought Over on Account of Difficulty Experienced in Landing Them—Large Cargo of Various Kinds of Goods, Among Which Are 17,415 Cases of Tea.

An unusually strong gale of wind encountered on September 9 and continuing several days was the cause of the Indrapura's long passage from the Orient. The gale was a nor'wester, but on the second day it shifted to the south and southeast, and blew practically until the 15th before spending its force. Heavy seas swept over the decks of the big liner, but no damage was done further than causing a delay. She ploughed through the waves laboriously, but never deviated her course.

The Indrapura, Captain Hollingsworth, sailing from Hong Kong on August 22 and forays later arrived at Moji, where she took on 500 tons of cement. From there she went to Kobe and Yokohama and after receiving additional cargo sailed from the latter port on September 1 for Portland.

The fine weather was experienced until September 9. Two days previous to this date the American whaling bark Wanderer was spoken in latitude 43 degrees 37 minutes north and longitude 168 degrees east. The bark reported all well and on the 11th later the American ship Costello Mare was also spoken.

The Indrapura reached Portland Saturday night at 10:30 o'clock. On this trip she only brought three Chinese and nine Japanese passengers, one of the smallest lists since the line was established. The reason is said to be on account of the seventh day's service and that she has recently been subjected by United States government inspectors, and the transportation company does not care to run any risks of being obliged to carry them back free of charge.

It is told, the cargo consists of 2,220 tons, one of the principal items on the steamer's manifest being tea. An itemized list of the cargo is as follows: Gunnies, 175 tons; coffee, 13 tons; preserves, 50 tons; pineapples, 70 tons; tapioca, 10 tons; Chinese merchandise, 61 tons; cement, 2,500 barrels; tea, 15,415 cases; matting, 4,627 rolls; straw braid, 25 tons; hilly bulbs, 1,073 cases; curios, 134 cases; sulphur, 563 bags. The tea is among one of the largest shipments ever brought to Portland. About 3,000 cases are consigned to local merchants, the balance to go inland cities and other coast points.

RADIUM POWER WILL VASTLY INCREASE

New York, Sept. 21.—Dr. George Kunz of the Museum of Natural History, together with Dr. Charles Baekervill, of the University of North Carolina, who have been experimenting with radium, discovered that by mixing it with willardite the power of the former is increased a hundred fold and when an instrument is devised for measuring power it will probably greatly exceed that. Dr. Kunz said: "Radium has been only known three years, yet great results have been accomplished. In one branch I predict great accomplishments for even the near future."

DISAGREEMENT IN NICOLAI CASE.

After a deliberation of two and one half hours, the jury in the Davis-Nicolai case reported to the court Saturday that it was unable to reach an agreement. Three stood for the plaintiff, Dr. John H. Davis and nine for the defendant, Mrs. Hannah B. Nicolai. It was expected this morning that the case would be re-set for trial at once, but no motion in that direction was made by the attorneys for either of the parties.

LOCK OUT UNION MEN.

Berlin, Sept. 21.—The German metal manufacturers today decided to crush the strike of 3,000 workers which has been in progress for several days, by locking out the remaining 7,000 employees until all others are ready to resume work. One hundred and seventy factories are idle.

FLEET RACERS WILL BECOME POLICEMEN

Applicants for Fire and Police Jobs Successfully Performed Hair Trials—ing Climbs and Jumps Yesterday.

The applicants for police and fire positions were given a physical examination on Multnomah field yesterday, and to the uninitiated it was like nothing more than a lot of performers practicing for the circus ring.

Forty-three men went through the various requirements perspiring but triumphant, and when the final results were known it was understood that they had not had a single failure. All were up to the required average and a number gave remarkably good performances. It would take a feet-footed thief to outrun the majority of the policemen-elect. The average for the 50-yard sprint was about 11 seconds and on one man, A. Smith, went the distance in 9.2-5 seconds. This is about the world's record for professionals in the 100-yard dash. All of the applicants were exceedingly fast on their feet.

When it came to climbing the 75-foot ladder, swaying fearfully when a man reached the top, there were several who looked a little shaky. It was one of the requirements, however, and by clinching their teeth and calling into use all of their reserve nerve the more timid managed to perform the task successfully.

It was another one of those nerve-racking ordeals to jump from a high level into a life-net, and several men were shaken up considerably in performing the feat, but they all went through it. PRISONER HOLDS UP ARRESTING OFFICER

Bown was held up by an arrested man, caught as a suspect of being the thief who got away with two sets of furs and other valuables in Eugene, in Cottage Grove, Friday evening. The man, who was a prisoner, held up the deputy to stand back while he escaped with his plunder. The daring of the man surprised the officer and aroused suspicion that he was a more dangerous character than was first supposed. Bown put in a call for help and the fugitive was traced by Sheriff Fisk to the home of a woman in the town of Douglas county until he was rounded up near Oakland, Sunday morning. He saw that there was no chance of escape and gave up without resistance. He was brought to Eugene this morning and will stand trial before the fall term of court on a charge of kidnaping.

LANE COUNTY MOPS

The sunshine of the past week has saved the hop crop of Lane county. During the long hours of good weather the pickers and growers made the most of the good conditions and worked with might and main to garner the best crops of the county. Their efforts are shown in the huge loads of hops which are daily now being stored in the city warehouses. As was said in these columns, the first lots were slightly affected with mold but the later additions to the valuable stores are up to the Lane standard, the best there is. Growers now feel that the loss on account of the rain is but slight to what they expected it would be at the beginning of the harvest. They have been enabled to do their work without the slightest hindrance this last week.

EUREKA HERALD MUST DEFEND LIBEL SUIT

Thompson, the receiver of the local land office, and Powell, his son-in-law, have filed an action of criminal libel against the Evening Herald for matters published relative to Thompson's conduct in office. It is charged by the paper that Powell failed to comply with the homestead laws. Many claims were held up by a recent ruling aggregating nearly \$400,000, and causing consternation among many people who were waiting to prove up.

GREAT SUFFERING.

(Journal Special Service.) St. Petersburg, Sept. 21.—Great suffering is reported on account of drought in the province of Ostrog. In a recent fire five hundred families were made homeless. The villages of Serghats and Kokeksharog were nearly destroyed by fire. Four hundred houses were destroyed and 80 houses with immense stores of grain were burned. In Transcaspia locusts entirely destroyed the cotton crop, amounting to nearly a 100,000 bales, as well as immense crops of growing wheat and rye. Nearly all fruit was destroyed.
