

VANCOUVER BOARD OF PORT DISTRICT

COUNTY COMMISSIONERS ACT ON
PETITION OF MAYOR EASTHAM
AND OTHERS AND DESIGNATE
BOUNDARIES OF PORT OF VAN-
COUVER—ELECTION ARRANGED.

Citizens of District Will Vote on October
31 on the Question of Making the
Port District Permanent and Fixing
the Levy—Need of Funds for Harbor
Improvement is Great and Question
Will Carry.

(Journal Special Service.)
Vancouver, Wash., Oct. 6.—The Port
of Vancouver assessment district seems
at last to be a possibility. Indeed, ac-
cording to leading citizens, the port is
a certainty after the action of the
county commissioners yesterday.

Acting on the petition of Mayor A.
B. Eastham and other prominent citi-
zens, the board determined the bound-
aries of the port district and fixed the
time of the election for October 31. At
this special election the citizens resid-
ing in the district named by the board
will vote on the question of
adopting the district as fixed by the
board and of assessing the same for
the improvement of the waterfront and
the deepening of the river channel. The
election will also determine the person-
nel of a Port of Vancouver board to
consist of five members.

There has been a continued agitation
among some of the more enterprising
citizens of this action, but the matter
has not been successful enough, adher-
ents to assure its success, and it was
decided to wait until there was a gen-
eral sentiment in favor of the district.
When recently the ship Two Brothers
stalled in the harbor before the Colum-
bia mills, and other vessels were pre-
vented visiting this port because of the
low stage of the Columbia the need of
improvement was generally conceded,
and the petition for the Port of Van-
couver began to attract the attention of
those who could insure its success. The
election will probably result in favor of
the project, and though but a small levy
will be assessed, still the property value
in the district is sufficient to insure a
good sum of money from even a low
assessment.

The district as determined by the
board includes the city proper, the gov-
ernment reservation and a mile and a
half east of the reservation along the
Columbia and about a mile back along
this line to the north boundary of the
reservation. The entire waterfront in-
cluded in the district includes more
than three miles and takes in all the
present and proposed milling sites and
railway tracks and yards.

ENGINE IS WRECKED BY FALLING TREE

While Train Is Passing Through Forest
Near Yacolt Heavy Wind Uproots
Giant Tree that Falls Around
the Engine.

Vancouver, Wash., Oct. 6.—P. V. & Y.
engine No. 7, under control of Engineer
Weisse, had an experience yesterday
near Yacolt which was very
amusing. While the engine
was puffing along with a freight train
near Yacolt about noon the high wind
began to topple trees across the track,
one slender pine cut across back of the
engine and got in the way of the tender.
While the crew was trying to get this
out of the way a monster tree was
blown on top of the engine and the
train suddenly stopped. The tree was
afterwards found to be 40 feet long,
and in falling it broke in three places,
though it was green and sound.

The falling giant wiped the smoke-
stack out of existence and left some-
thing that resembled a battered tin can
in its place, the smokebox went with
the stack, and the front end of the boiler
was badly smashed. Out in the woods
the crew worked all afternoon repairing
the damage, and in the evening the dis-
mantled engine pulled into the depot
where with an oil barrel and a sawstack.
Some time ago this engine lost a
cab while on a night run and the first
question asked by the foreman when he
heard of the accident was: "Is the cab
injured?" The engineer said it was
not, and is now wondering if the com-
pany has more regard for its engine
cabs than it has for its engineers. It
is believed that No. 7 on the P. V. & Y.
is not a lucky number.

Child Drinks Lye and Dies.
Arthur Rhorer, the 15-month-old
child of F. K. and Mollie Rhorer, died
this morning from drinking lye. The
child secured the poison yester-
day afternoon and swallowed a large
dose before discovered. The funeral
will be held this afternoon, the funeral
being held from the family home, Dunning
& Co. took charge of the body.

elected W. W. Sparks justice of the
peace to take the place vacated by the
death of Judge Steward.

DIVORCEE WANTS CUSTODY OF CHILD

Mrs. Sarah Code Files a Petition in the
Circuit Court at Oregon
City—Heavy Rain and
Wind Storm.

Oregon City, Oct. 6.—Mayor G. B.
Dimick, as attorney for Sarah Code,
filed an affidavit with the circuit court
yesterday in support of a petition to set
aside a decree of divorce under which
Charles Wilkins secured a divorce from
her. Mrs. Code seeks to gain the cus-
tody of her minor children. The affi-
davit says that she was married to Wil-
kins in August of 1892, and that last
year Wilkins brought suit for divorce
and represented and agreed with her
that in case she did not appear and an-
swer the complaint, thus allowing the
divorce to be granted, she would be al-
lowed the custody of the child, aged five
years. Mrs. Wilkins claims that she sub-
scribed to this agreement and fulfilled
her part of the contract, but says that
Wilkins took the child from her home at
Salem and placed it in a family of stran-
gers residing near Dallas; that Wilkins
violated his agreement made with her.
Wilkins, she says, is a deck hand on a
river steamer.

Taxpayers Pay Up.
Oregon City, Oct. 6.—Clackamas coun-
ty taxes for 1902 which have not been
paid became delinquent last evening at
6 o'clock. The delinquent list is unusu-
ally small, being considerably less than
\$10,000. The total taxes collected last
year were \$168,000. The shaver states
that the delinquent list will probably
not amount to more than \$5,000 by the
time all the late payments are made, as
several parties paid in at the very last
moment.

Heavy Rain and Strong Wind.
Oregon City, Oct. 6.—One of the most
severe wind and rain storms that has
visited this section for years prevailed
here yesterday. Rain fell unceasingly
almost all day while the wind at times
attained a velocity of 35 miles an hour.
Clackamas county tributaries to the
Willamette were flushed and it is
thought the Willamette will rise suffi-
ciently to allow the resumption of work
in the mills here. No damage has
been reported from the storm.

COMMEMORATING THE ENTRY INTO CANAAN

The feast of the Tabernacles was ob-
served at the synagogues throughout
the city last evening. This feast com-
memorates the coming of the Hebrews
into the promised land after their 40
year wandering in the wilderness. It is
also a time of thanksgiving.

At Temple Beth Israel, services are
held only during two days of the nine
days of the feast—the first and the
eighth.

Dr. David Levine conducted the ser-
vices at Temple Beth Israel last evening
in the absence of Rabbi Wise. A
musical service was sung, in which
solo recitations were sung by the
members of the congregation, which
the congregation partook of the feast
prepared in a special booth. This morn-
ing at 10 o'clock Dr. Levine preached on
"The Brotherhood of Man," or the
significance of the festival of the Taber-
nacles.

The music for today's service was
according to a beautiful ritual of joyous
responses. In addition the choir ren-
dered an anthem by Schneek. "O, Be
Joyful," and Mr. Belcher and Mrs. Rose
Blach-Bauer sang a duet by Gounod,
"The Lord is My Life." Mrs. W. E.
Thomas was the organist.

SCORES GOVERNMENT ON FOREST RESERVES

CHIEF OF THE BUREAU OF FOR-
ESTRY TAKEN TO TASK BY LUM-
BERMEN OF THE STATE OF
WASHINGTON AND TRIED TO EX-
PLAIN MATTERS.

New Forest Reserve Is to Be Opened
in the Cascade Range—Much Discon-
tention Manifested Over the Restric-
tions Placed Upon the Forest Re-
serves in Our Adjacent State—State-
ment by Head of Bureau.

(Journal Special Service.)
Tacoma, Oct. 6.—Gifford Pinchot,
chief of the bureau of forestry of the
department of agriculture, was taken to
task by 30 prominent lumbermen and
others interested in the preservation of
timber in the Pacific Northwest at the
Tacoma chamber of commerce rooms
yesterday.

United States Senator Foster presided
at the meeting and a general discussion
was indulged in, during which the gov-
ernment was roundly roasted by the
representatives of Skamania, Cowlitz,
Jefferson, Skagit and Whatcom coun-
ties, who were present. A great deal of
dissatisfaction exists in the state over
the management and restrictions of the
forest reserves. Already one fifth of the
timber of the state is included in the
forest reserves and a large section of
land has been withdrawn from entry
in order to allow the government to ex-
amine it with the intention of creating
another forest reserve, which will prac-
tically cover the entire region on the
Cascade range. The addition proposed
is nearly equal to half the total of the
present reserves.

Mr. Pinchot, who was graduated from
Harvard, is a wealthy man, and a warm
personal friend of President Roosevelt.
He is known as the father of the forest
reserve movement and has had his
hands full answering the criticisms and
objections hurled at him during the
meeting here. The sentiment of the
meeting was not so much against the
principle of forest reservation, but
against the alleged bad tactics of the
government as regards sheep grazing
on the reserves, and the restrictions
imposed upon lumbermen in taking tim-
ber off reserve lands.

Mr. Pinchot, in addressing the meet-
ing, admitted that the management of
the reserves has been poor, that men in
office in Washington, who had no prac-
tical knowledge of affairs in this state
and the Northwest generally, had so
bungled things and that there is not
now a man in the Washington office who
had ever been on a forest reserve.

Mr. Pinchot is making a tour of the
forest reserves of the West.
He asked for the support of the state
in remedying the evils which now exist
in the system and met with a cordial
response. He stated the two objects of
the forest reserve policy to be the bene-
fit of the settler and the permanent use
of all the resources of the reserve, min-
eral, grass, timber and water.

SUPREME COURT MAY SAVE LIFE OF THIS MAN

Appeal Case of Pleasant Armstrong
Submitted to the High Court—Other
Cases on Appeal in Which
Orders Are Asked.

(Journal Special Service.)
Salem, Oct. 6.—In the supreme court
the appeal case of Pleasant Armstrong
from the judgment of the circuit court
of Baker county, sentencing him to
death by hanging, was argued yesterday
afternoon, by Attorney General A. M.
Crawford and District Attorney Samuel
White for the state, and M. M. Godman
and George J. Bentley for the defendant
and appellant.

The case of Samuel A. McCall and
wife, appellants, against Marion county,
was also argued. This case originated
in the county over a road petition.
The new road, as laid out by the county
court, passed through the farm of Mc-
Call and he asked for damages, failing
which he appealed to the circuit court.
Here he secured a verdict at the hands
of the jury, but the court remanded the
case without giving him judgment, and
he appealed.

THEATRE MANAGER ON THE WAR PATH

Manager of Vogt Opera House at The
Dallies Is Threatened with Dam-
age Suit for Cancelling
a Contract.

The Dallies, Or., Oct. 6.—A. E. Crosby,
a local druggist and manager of the Vogt
opera-house here, is threatened with an
action for damages as the result of an
alleged cancellation of a contract with
Leslie Moroso, whose company was to
have appeared at the opera-house last
Saturday night.

Mr. Moroso, with a company of 18 per-
sons, arrived at first about 10 o'clock af-
ternoon from the eastern part of the state
where they have been filling one, two and
three-night stands with some success,
to judge of the complimentary things said
of them in the local papers. Mr. Moroso
was surprised at not seeing any of his
sister actresses, and he inquired of the
manager, who told him that the company
which had been forwarded to the bill-
poster in care of Mr. Crosby. When
reaching the hotel, he found that no one
knew anything about his company being
booked for that evening.

Mr. Moroso hunted up the local man-
ager, who at first refused to offer any ex-
planation, but upon taking notice of Mr.
Moroso's firm attitude in demanding to
know the reason why he had been treat-
ed in such a manner, Mr. Crosby tried
to excuse himself by saying that the city
authorities had increased the license for
theatrical performances during the week,
owing to the holding of the fair and car-
nival, in which the majority of the mer-
chants were interested, and in conse-
quence had concluded not to bill the com-
pany.

He had sent no word to that effect to
the manager and the company was forced
to remain here over Saturday to con-
tinue to Tacoma Sunday morning, where
they will play a three nights' engage-
ment.

Mr. Moroso does not propose to bear
this loss of one night's receipts.

The booking for the opera-house here
is done by John Cort of the theatrical
trust in the Northwest and of late of
Portland.

Mr. Crosby's action has aroused some
adverse criticism for the part of which the
men interested in the carnival just closed
come in, because of their action in hav-
ing the license raised for the occasion,
with a view of "hogging" everything in
sight by shutting out competition.

FIGHTS WIDENING OF RIVERSIDE DRIVE

The demurrer to the complaint in the
case of Rena Rohse against the Mult-
nomah county court to restrain the
court from completing the widening of
the Riverside drive was argued before
Judge Cleland yesterday afternoon and
was taken under advisement. The wid-
ening of the road would cut off a strip
of Mrs. Rohse's property 20 feet in
width and 300 feet in length. Mrs.
Rohse alleged that act of the court is
in violation of the constitution, and
objections were not given, while the
county court alleges that proper notice
was given and she has no remedy in
equity.

ond ward were re-elected. Mr. Mar-
sters defeated Attorney John T. Long
for recorder. W. A. Burr defeated W.
H. Fisher in the race for councilman in
the first ward, and Attorney Frank G.
A. C. Masters defeated J. W. Kruse in the
third ward and Joseph J. Sykes, council-
man ahead of Councilman J. C. Aiken in the
fourth ward.

Not more than two thirds of the total
vote of the city was cast. Lack of
interest was due to the fact that no is-
sue of any kind was raised and no po-
litical partisanship displayed.

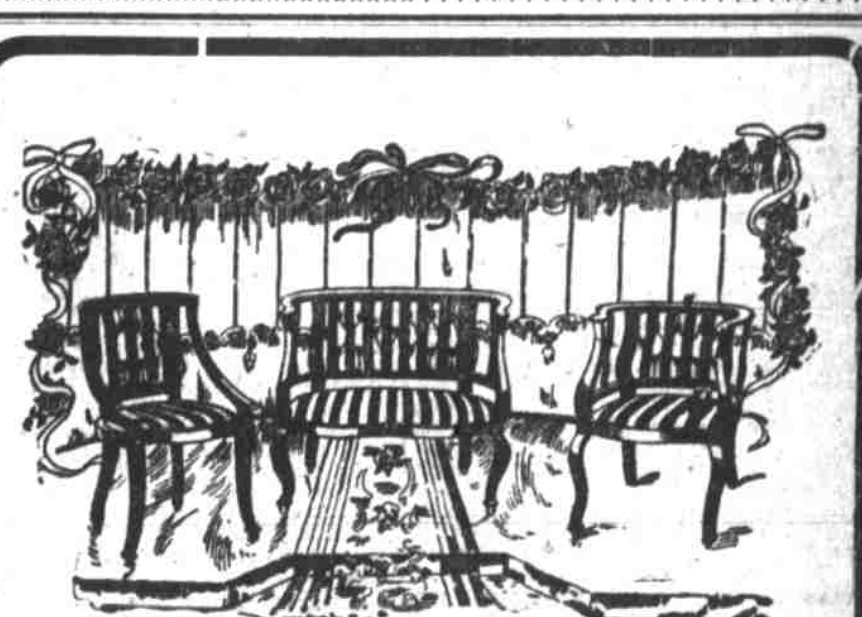
