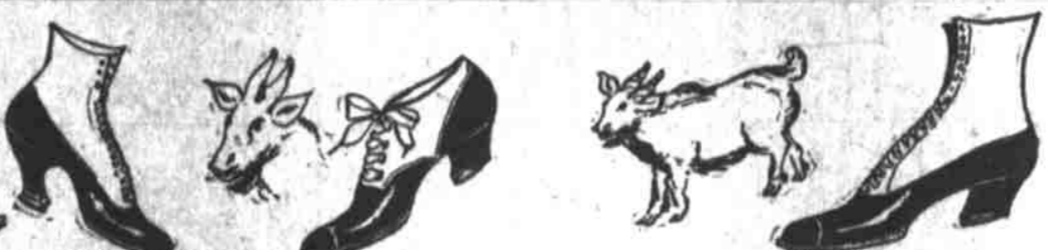

CRAWFORD SENDS REPLY TO WILLIS

GRIEVANCE COMMITTEE OF THE BAR ASSOCIATION WILL DECIDE AFTER EXAMINING IT WHETHER THE EVIDENCE WARRANTS DISBARMENT PROCEEDINGS. Attorney-General A. M. Crawford has forwarded to the grievance committee of the State Bar association his reply to the charges of perjury, made against him by Judge Willis. The document was received this morning, but has not yet been considered by the committee. Judge Northrup, the chairman of the committee, says that it will meet as soon as convenient and will review the matter. "If the committee finds that there is ground for further proceedings," said Judge Northrup, "they will be instituted, and the bar association will then be the prosecutor." Judge E. B. Watson is acting as Mr. Crawford's counsel, but he declined to give any information as to the line of defense that will be adopted. A. C. Emmons, the secretary of the grievance committee, is absent from the city and will not return until next Monday, so that there will probably be no meeting of the committee before that time.

WIFE FROM DEATH SEARCH TO LEARN WHETHER THE BLAZE WAS INCENDIARY.

Perilous rumors have been doing since Saturday night's disastrous fire on East Washington street in which Mrs. Helen Patterson lost her life, to the effect that the fire was of incendiary origin. While there are no definite clues, the report will not down and it is likely that the matter will be turned over to the police within a day or two. District Chief Holden has been quietly investigating, but is not prepared to tell what he has learned. Last Monday Chief Holden saw a man digging in the ruins of the Patterson house. A story was afloat that "Patsy" Patterson, who was once wealthy, had \$500 in money under his pillow, but this was lost. When taken to task the man in question told Chief Holden that he had found nothing. Later he admitted that he had unearthed one dollar, but said that Patterson had sent him to look for the coin. That the fire was started underneath Dolson's basket factory there seems little doubt. A quantity of shavings was piled here, although Chief Holden some time ago had ordered this cleaned up. There is a gang of boys on the East Side who will probably have to show where they were at the time the fire started. Charles Patterson, who was seriously burned in the fire, which consumed his home and resulted in the death of his wife, is gradually growing weaker and his condition is regarded as hopeless. The death of his wife has weighed heavily upon him and the physicians now fear that he will not survive. "If any person set that fire, he ought to be hanged," said Chief Campbell. "It is simply murder if the fire was incendiary," said District Chief Holden.

SUICIDE'S BODY IS NOT YET IDENTIFIED

In the hope of establishing the identity of the unknown man who committed suicide on Willamette Heights, Monday night, by shooting himself, Coroner Finley has telegraphed to San Francisco, where the stranger purchased a ticket, October 4, calling for passage to Vancouver, B. C., on the steamer Umatilla. This was the only clue found on the man's person. While it is a very slight bit of evidence, the coroner desires to take advantage of it and has asked for news from the steamer. The body is still lying at Finley's undertakings rooms, and although many people have viewed it, none has been able to tell the man's name. The police and the coroner are both of the opinion that it was a deliberate case of suicide.

WIFE STILL MISSING.
