BEST RECRUITS FAIL TO ENLIST

VANCOUVER RECRUITING OFFICERS FAIL TO GAIN "BOOKIES" IN OREGON AND WASHINGTON RURAL DISTRICTS—LACK OF PAY THE CHIEF CAUSE GIVEN.

Vancouver, Wash., Oct. 28.—The men of the West are neither as hard-up nor as patriotic as the men of the East. This is the opinion of three recruiting officers who left here 10 days ago for a trip through Oregon to recruit for the companies here.

After more than a week's hard work the results were nil, and, indeed, the returning soldiers report that there is not only apathy, but antipathy, to their calling manifested by the rural young men. Old soldiers, who have been on recruiting service often, say that until spring there will be many enlistments made, but that most of these will come from the far East.

"When snow flies," said one soldier, "the fellows who have been loafing all the summer will hunt a warm bunk, and the army will get hundreds and thousands of these. This happens every winter, but this class comes from the big cities, not from the country nor from the West."

Gen. Funston has expressed his opinion of the recruits that come from the large Eastern cities, and it was not a favorable one. The general in his report advised that more pay be offered and that the boys from the country be especially sought out by enlisting officers. Every attempt made recently to secure this class of recruits, especially in the West, is said to have failed, and chiefly because of the high wages paid all classes of laborers.

Love Their Profession.
Vancouver teachers are not in their work because they need the money. This is the opinion of the school clerk who has been at it since last payday. Generally school clerks face on payday a throng of teachers who are clamoring for their money, and who have it all expended in their mental eye before they draw it, but at Vancouver none of the teachers were in a hurry and two of them waited a week after payday before they casually inquired if their warrants had been drawn up. What especially impresses the clerk is the fact that the month was the first after a long vacation, during which time the teachers have been on a constant expense with no income.

Condemn Missoula Officers.
"They are cheap officers," was the way a non-com. put it when he read the story from Missoula about the frost Marksman Hawkins met on his return. "The officers were not asked to attend," said another, "and why they should refuse to let Hawkins' comrades entertain him, after making the most remarkable rifle record ever made in the country, is past me."
"It isn't past me," growled another. "I know what some men they usually have over negro regiments, and it's always the same. I don't blame an officer for not mixing with his men when they are different in blood, but they might be decent."
The position of the officers at Missoula is not understood by the men or officers here, and though there may be some hidden reason for their action that has not been mentioned on the face of the report, the soldiers' unadvised travel blame the action of the white officers in closing down the negro welcome.

STATE LAND BOARD DISCUSSES MATTERS

(Journal Special Service.)
Salem, Or., Oct. 28.—The state land board was in session yesterday afternoon, disposing of a quantity of routine matter. During the session the board discussed the matter of outstanding certificates of sale for state school lands, and it was decided to call in the older of these certificates, so as to clean up many of the old loans held by the board. Several months ago the board notified all those holding certificates of sale on which \$50 or less was due and unpaid, to pay the balances due, or the certificates of sale would be canceled and the lands involved resold.

At yesterday's meeting of the board Charles G. G. Brown was instructed to notify all those holding certificates of sale to state school lands of date prior to April 1, 1902, to turn in the certificates and pay the balances due, or the certificates of sale would be canceled and the lands would revert to the state to be again sold.

This directly is in line with the extension of all debts that have matured, to clean up all debts that have matured, so as to dispose of the old paper and the issue of certificates of sale for state school lands. There is a two-fold object in this. One is to dispose of all matured paper, and the other is to make the lands thus sold pay its just proportion of the taxes. Under present conditions on which the state purchases land, it is not possible to make the lands pay its proportion of the taxes, and the state is forced to pay interest on the bonds which would have to be placed of record and would immediately subject the land to taxation. Under the new ruling of the board a great deal of this abuse will be disposed of to the satisfaction of all concerned.

Yesterday's order affects a large number of tracts of land, on the most of which balances for one-third the purchase price remains unpaid, and as the certificates of sale have to be made by April 1, 1904, it is believed that large sums of money will reach the office of the state land board during the next few months.

Cases in Supreme Court.
In the supreme court the case of Phil Metschan, petitioner, appellant, vs. Ladd & Bush, respondents, a case growing out of the case of J. A. Baker, plaintiff, vs. The Williams & England Banking company, defendants, has been settled, and on motion of Mr. Metschan's attorneys the case was dismissed with costs to the other party, upon stipulation of the parties to the case. This suit grew out of the failure of the Williams & England bank about nine years ago, when Mr. Metschan was state treasurer. He was one of the bank's heavy creditors, carrying large deposits in that institution. During the winding up of the affairs of the bank, Mr. Metschan received in dividends sufficient to pay his deposits in full, as did all other depositors, and when the receiver began to pay interest on other depositors, Mr. Metschan petitioned for interest payments on his deposits, and this was resisted by Ladd & Bush, also heavy creditors of the bank, on the ground that Metschan's deposit was in reality state funds, and he could not draw interest on the money. Upon the showing Secretary of State Dunbar petitioned the court that the interest money claimed by Metschan be paid into the state treasury, as he asserted that the principal—the state—this suit grew out of by the state, Judge Boise denying the petition of the state.

Now the controversy between Mr. Metschan and Ladd & Bush has also been adjusted, and there is very little, if anything, in the way of the winding up of the affairs of the bank.

Of the original promoters of the bank, one of the leading spirits, Major George Williams, is now a resident of Portland. William England, another one of the men heavily interested, is dead, while several others reside in this city.

Work on Dome Almost Done.
Secretary of State Dunbar recently let the contract for redecorating the interior of the dome at the statehouse, and the work has now been about completed, with results that are extremely gratifying, adding, as the new decorations do, greatly to the appearance of

the dome and the interior of the building. The background of the great vaulted dome is in Naples yellow, the stucco ornaments in dark cream, while the relief work is touched with gold leaf, making a most beautiful effect. There are 16 panels of stucco work, and at the base of each panel there is a stucco wreath enclosing a circular panel in the center of which is to be placed an independent light. On the ledge base of the dome incandescents will be placed on reflectors, so as to distribute the light in the interior of the third floor lobby, making that portion of the building one of the best lighted in the entire structure.

The walls of the third floor lobby, under the dome, are toned off in lighter cream than that employed on the stucco work, so as not to make the contrast too strong between this and the other work when seen through the light well. The wood work is in pure white, giving a clean, airy effect to the whole color scheme.

The gold work laid on the stucco ornamentation is distributed in such a way as to throw an even light over the panels. The beads that divide the panels end in a circular bead surrounding the art glass in the top, and a half-circle of beads at the base of each panel, all laid in gold leaf, gives character to the whole making this one of the most beautifully ornamented places in the capital city, if not in the state.

The work will be completed in a few days, nothing being now left unfinished except the ceiling over the stairway, leading up to the third floor and into the lobby under the great dome. Frank Willman, a local painter and decorator, had the contract for the work, and it was carried out under the personal oversight of Secretary of State Dunbar.

The operators say this reduction is a commercial necessity, as the supply of coal is still largely in excess of the demand.

Mr. Dimick does not think he will have any serious opposition and is confident that he will win no matter how much opposition he may have. He has undoubtedly ruffled the feathers of the ultra religious set by his recent stay in a saloon, and his street fair holding open Sunday but it is not probable that the ultras will put out a ticket. The mayor is a Republican, is 35 years old and is very popular.

Tells Story of Brutality.
Last night between 7 and 8 o'clock a young man was picked up on the Seventh street steps in an unconscious condition and it was at first believed that he was dead. He was carried to the home of Night Watchman Edward L. Shaw and medical attendance summoned and it was discovered that he was suffering from epilepsy. Dimick, who for the past two years has presided over the destinies of Oregon City as mayor, made the announcement last night to the Journal that he would again enter the political arena and ask the people of Oregon City to elect him for that office for a third time. The mayor's decision was brought about by a petition signed by a great number of the voters of the town, asking him to make the race. Mr. Dimick says that he would rather the people would have selected some other man as he is not anxious to hold down the mayor's chair for another year, but that the voice of duty calls and he must answer to them. Mr. Dimick does not think he will have any serious opposition and is confident that he will win no matter how much opposition he may have. He has undoubtedly ruffled the feathers of the ultra religious set by his recent stay in a saloon, and his street fair holding open Sunday but it is not probable that the ultras will put out a ticket. The mayor is a Republican, is 35 years old and is very popular.

Tells Story of Brutality.
Last night between 7 and 8 o'clock a young man was picked up on the Seventh street steps in an unconscious condition and it was at first believed that he was dead. He was carried to the home of Night Watchman Edward L. Shaw and medical attendance summoned and it was discovered that he was suffering from epilepsy. He was shortly brought around, when he told a harrowing tale of brutality. He said that he was a deserter from an English vessel now lying in the Portland harbor. He shipped about five months ago from Calcutta. While the ship was anchored in a South American port he fell from a yard arm and sustained a fractured skull which superinduced epilepsy.

The officers of the ship were brutal and he was subjected to repeated floggings and the whole crew was treated like so many cattle. When the ship arrived in Portland he at once concluded to desert. He got away from the ship yesterday morning and walked to this city, arriving last evening and was shortly afterward attacked with the fit. He was entirely without money and without friends.

He declares that he is the son of a prominent American in Ceylon, and that his father is manager of large tea plantations belonging to Sir Thomas Lipton. He is 24 years of age. He contends that he is not liable to the ship
