Until yesterday, when the information against him was formally dismissed, Harry Tracey, the notorious bandit and murderer, who met a tragic death in Washington two years ago, stood charged with assault on the books of the Multnomah circuit court. The information was dismissed by Judge Cleland, with a number of others, which had accumulated for several months.

Tracey's information charges assault with a deadly weapon on Ned Dougherty, March 21, 1929. Dougherty was a jailer at the time and Tracey made a daring attempt to escape from the jail.

Two informations against A. L. Bellinger, who was hanged last year for the murder of his mother-in-law, were also dismissed. One charged him with killing a man named "Gyle" and the other killing his wife, Sylvia Maude Belding.

The county health board is experiencing a serious difficulty in establishing a strict quarantine of scarlet fever patients in Montavilla. Quarantine officers Evans said today in a summary of instances quarantine flags, posted by the authorities, have been torn down, and children in families where the disease exists have persisted in going to school.

The first cases were reported from Montavilla last week ago, but quarantine was promptly established," said Dr. Evans. "The disease has been spreading, however, and yesterday the board decided to make an investigation. It was found that a number of families afflicted had not even called in doctors, and in such cases the quarantine flags were torn down."

The quarantine will be rigidly enforced by the board from now on, and offenders will be promptly punished. All school children who have been exposed to the disease have been excluded from school, and will not be allowed to return until the danger is past.
