

DEATH OF DISGRACE

weeks was at the far end of the second story cell row.

A death march along the corridor took great precaution to prevent him from committing suicide by casting himself over the railing to death on the cement floor beneath. The procession continued across the chapel through the door leading to the yard and around the rear of the kitchen, past the fire room and into the death chamber. At noon the prisoners were marched from the workshop and locked in their cells, where they remained an hour. There was no excitement among the inmates and all passed off quietly. Seventy invitations were issued, and the spectators filled the space in front of the gallows. Who released the lever sending Egbert into eternity was kept a secret, the idea of the officials being to rob the scene of all sensational features.

Elmer L. Parsley, a Vancouver soldier, has the distinction of beginning prison life on Egbert's fatal day, being received from Portland for larceny of a Burnside street hotel and has 18 months to serve. Work about the institution proceeded as usual, the convicts being in touch with practically none of the gruesome features. The spectators all agree in declaring the new law governing executions a splendid provision, and the new death chamber is admirably fitted for the purpose. Under Superintendent James' direction no untoward circumstances marred the affair. All was quiet and orderly and the details were perfected with neatness and dispatch, in marked contrast to hangings sometimes carried out by sheriffs.

HISTORY OF THE CRIME.

Educated in Iowa High School, he began as saloon keeper.

Harry Egbert was a native of Exira, Audubon county, Iowa, where he was born, raised and educated, and where he began his career as the operator of a "blind pig" or unlicensed saloon, after graduating from the high school. From that point he strayed west and in 1900 he came to Oregon, and soon thereafter, in March, 1901, he was arrested and convicted for the crime of larceny from a building in

a half-breed woman known as Mabel Rhodes, and with her he was living at the ranch of Charles Fields in Wild Horse valley, the woman passing as his wife. When the two officers approached the house, the fugitive opened fire on them from behind the corner of the ranch house, killing West. He then went into the house through a window, while the woman made her escape, and Saxton entered the house through the door. A thin partition separated the two men, and a terrible hand to hand battle ensued, the fugitive firing with a rifle and the officer with a revolver. It seems that Saxton, running out of cartridges, went to West for a fresh supply, when Frost, as he was called there, shot the officer from the second story of the building, inflicting a mortal wound.

Fled to Nevada.

After the flight the fugitive and twice murderer went to a nearby ranch, where he secured a horse and fled to Nevada. Here a large posse started on his trail, and when near Elko, Nev., posse of Mormon settlers, headed by Deputy United States Marshal Sidney McCoy, ran him down, arrested him after a running fight of nearly four miles, and held him until Sheriff Allen of Harney county could come with a requisition and return him to Burns, where he was tried December 8, last, and on December 10 he was sentenced to be hanged on January 29, 1904, between the hours of 10 a. m. and 2 p. m. He was brought to the penitentiary a few days later, and on the way up he attempted to kill the deputy sheriff accompanying the sheriff as a guard, and was prevented by the latter officer from adding another crime to his already black record.

CITY COLLECTING GAMBLING GRAFT

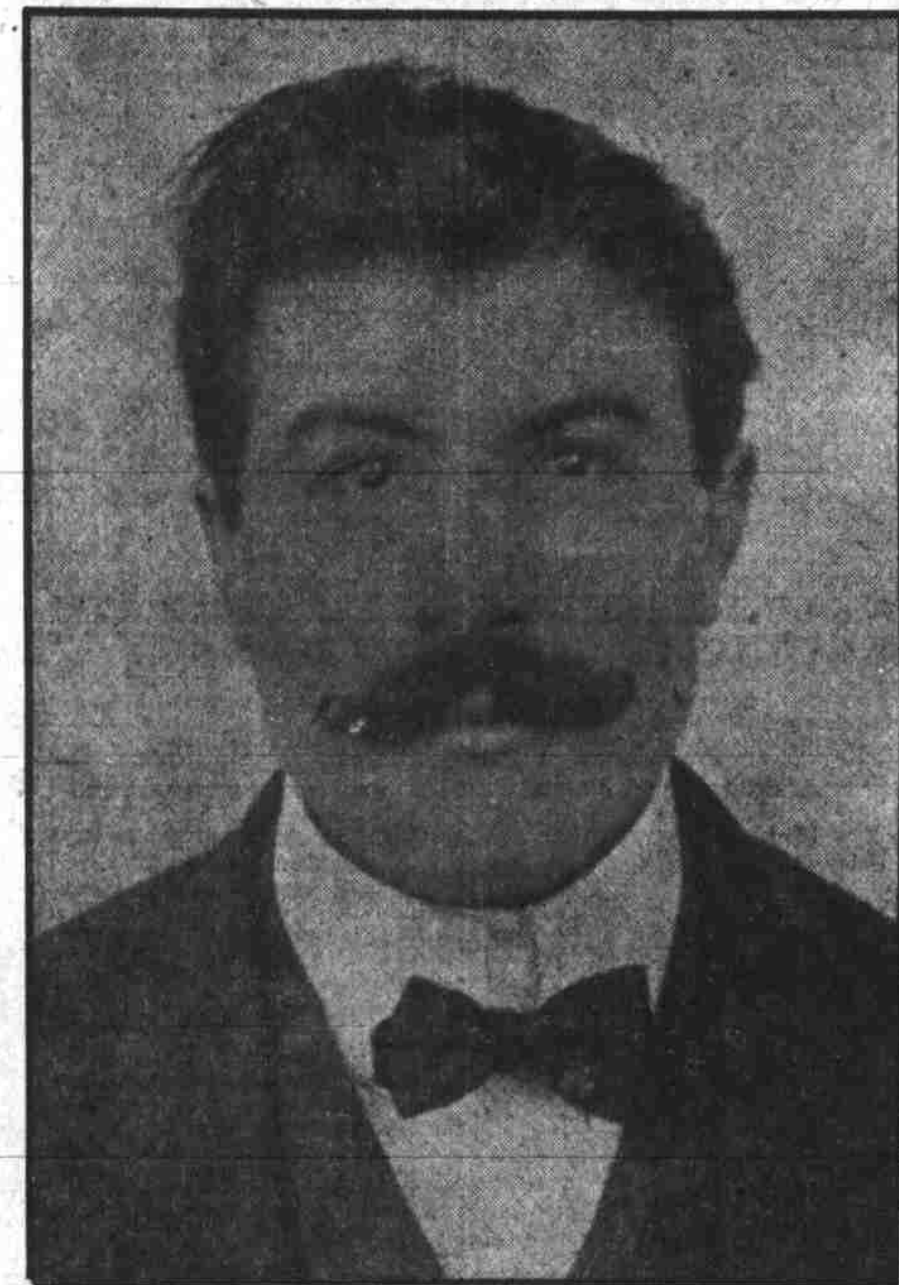

Lane county, and sent to the penitentiary for one year. He was received at the penitentiary March 22, 1901, and was released from that institution February 19, 1902. In 1903 he was wanted for burglary in Douglas county, but he escaped, and notice was sent to the sheriff of Harney county that he was believed to be in that county, and that a warrant had been issued for his arrest, and requesting the Harney county officer to arrest him if possible. Attorney John G. Saxton, a man of unquestioned nerve, was deputized to secure the man. He found and arrested him, but the criminal made his escape and left the state; but a few days later it was learned that he had again been seen in Wild Horse valley, 85 miles south of Burns, and only 20 miles from the Nevada line.

They Both Died.

Hearing of his whereabouts, Attorney Saxton, accompanied by another deputy sheriff, Jack West, started out after their quarry, with the result that neither man came back alive.

KICKED HER DYING HUSBAND IN FACE

(Journal Special Service.) Kansas City, Jan. 28.—Mrs. Lulu Kennedy Price was today acquitted of murdering her husband, the plea being emotional insanity. This was the second trial. The first resulted in her conviction and a sentence of 10 years in the penitentiary. Three years ago Mrs. Price shot six bullets into her husband and then kicked the dying man in the face, saying: "You'll never betray another girl." The cause of the killing was his suit for divorce, alleging that the marriage was unjustly forced upon him by his wife's father and brothers, with revolvers.

SHOT HIMSELF TO COVER A ROBBERY

Bolmen, treasurer of the labor council, was short in his accounts and shot himself in order to make it appear he was robbed. The chief says two chambers of the revolver found at Bolmen's side were freshly blackened by powder. Bolmen still insists on the robbery story.
