Eugene, Or., Jan. 30.-Eugene merchants are complaining that this city has had more than its share of auction sales of cheap, shoddy bankrupt stocks of goods, to the detriment of the legitimate merchants' business. With an idea to putting a stop to so many of these sales a number of merchants met at the store of Cockerline & Wetherbee last night for the purpose of formulating a plan of action and effect an organiza-

It was decided to petition the city council to place a prohibitive license on the auctioneers of these cheap stocks. Several weeks ago some of the leading merchants asked the council to take some action upon the matter, but no

A leading merchant today expressed the opinion that it was useless for a reliable merchant to try and offer his goods in competition with the cheap, shoddy and shelf-worn, bankrupt goods that are now being auctioned off by at least one concern here at ridiculously low prices at the present time.



# ARMORY FOR SALEM NOW THE QUESTION

(Journal Special Service.) Salem, Jan. 30 .- Adjutant-General Finzer was in the city yesterday afternoon and while here he discussed the matter of an armory for Salem, with the local militia officers and some of the citizens. He has taken up the proposal of the correspondent of The Journal, made last spring, that this county build a substantial armory in this city, the capital of the state, and make the local company stirring events during their service in an assured success for the future. The the islands. A large number of the proposal for an armory is for a substantial brick building to be located on a lot graphed by renowned artists and the to be provided with funds raised by pop-chaplain's stereopticon views are sebe paid for by the county. It is estimated that such a building could be constructed for from \$10,000 to \$12,000, and it is believed that for this purpose the material-brick-can be secured from the penitentiary brickyard for from 50 to 35 per cent less than the market price, as the building would in the very nature of things be for public use and for benefit of the state. An active canvass will be made among the people of this county with a view to ascertaining the sentiment in favor of such a venture, which would be of inestimable benefit to the multia company in this city. The department of the Columbia and the department of the Pacific will be merged into the Pacific division, according to the plans now under dicsussion, and Gen. Arthur Mac-Arthur will be in commanl and in charge of the maneuvers to be held on the coast some time next summer. The ground, it is said, is now practically selected at some point in California and the militia forces of Oregon, Washington, Idaho, Montana and California, together with the regular troops stationed in those states, will take part in the maneuvers at the time of the encampment, similar to the maneuvers held at Fort Riley,

Kan., last year, to the great benefit of the state troops. The adjutant-general stated it as his opinion that the clive drab uniforms, to take the place of the yellow khaki now in use, would be adopted for the militia, a change which he favors very much as he thinks the color better than the old

He also brought down Lillian Myrtle Gaker, 16 years old, an idlot from birth. Mrs Leonie Baker, mother of the girl, accompanied him. Lewis A. Segar, a blacksmith. 26 years old, was brought from Astoria by Sheriff Thomas Linville. He is violent and destructive without cause.

James D. Marley, aged 44, a soldier in the Eighteenth infantry, was brought from Pendleton by Sheriff T. D. Taylor. He is homicidal and suicidal, and was picked up while wandering about Pendleton. His insanity is the result of an injury received while in the line of duty in the army.

# **GAMBLING LAYOUTS** ARE ALL BOXED UP

Albany, Or., Jan. 30 .- In accordance with the orders issued by the city council Tuesday evening, all gambling games are closed and the layouts have been boxed awaiting the selection of a new field by the owners, as it is conceded that knights of the green cloth will not ply their calling in this city for some time. The members of the city council, while they favor a liquor license policy, are not under obligations to the gamblers and propose to rid the city of the "banking" games. The three mem-bers who were reefected last December, Ralston, Marshall and Stewart, were op-

posed by the saloons, but succeeded themselves in spite of this opposition. The movement is not so much against saloons as it is to compel the observance of ordinances that are for the best interests of the citizens. The majority of the saloonmen are not affected by the orders and approve the action of the council. New Captain for Company G.
