

MR. WAKEFIELD SEES HOPE AHEAD

FORMER HEAD OF HOME BUYERS SAYS THAT NO MEMBER WHO HAS DONE HIS PART WILL LOSE A DOLLAR - CONTRACT-HOLDERS WILL MEET TOMORROW.

The war between the two sets of officers of the Order of Fraternal Home Buyers continues. C. Guy Wakefield called at the order's office on the McKay block yesterday afternoon and demanded a desk and some furniture, which he said was his personal property. The demand resulted in a point blank refusal to give up the goods. Wakefield refused to register his name and the foreman Constable Jackson took possession of the furniture. He stored them in a warehouse until affairs are settled.

Wakefield has called a meeting of the contract holders in Auditorium hall for tonight, when he will try to formulate some plan of reorganization, with their co-operation. Wakefield says he will push quo warranto proceedings to oust Harbaugh and Altman, who now hold the fort.

MRS. TOBIN, SHOT BY HUSBAND, IS BETTER

The condition of Mrs. Tobin, wounded last Thursday night during an attempt made by her former husband, E. D. Tobin, to kill her, is not nearly as serious as it was at first thought to be. Mrs. Tobin is now at the Good Samaritan hospital. Dr. Stocum, who is attending the injured woman, said this morning that he was of the opinion that Mrs. Tobin would soon be strong enough to leave the hospital.

INDICTMENT FILED AGAINST GAMBLERS

District Attorney Manning filed information with the clerk of the circuit court this afternoon charging A. Erickson and George Fuller with gambling. Both men will plead guilty before Judge Sears, through their attorney, Wilson T. Hume. The proceeding is the finale of the Fishbeck case, when the defendants were obliged to pay \$165 to Mrs. Fishbeck, who claimed that her husband lost that amount gambling in their house. The first case came up before Justice Reed and Erickson and Fuller waived examination. Mr. Manning then prepared the indictment which was filed today.

ADDS \$100 TO GAMBLING FUND

The city of Portland is just \$100 richer today than it was before the arrest of A. Shapiro, proprietor of the Mass Cafe. Mr. Shapiro was arrested last evening on the charge of conducting a place where gambling is carried on. He forfeited \$100 bail in the municipal court this morning.

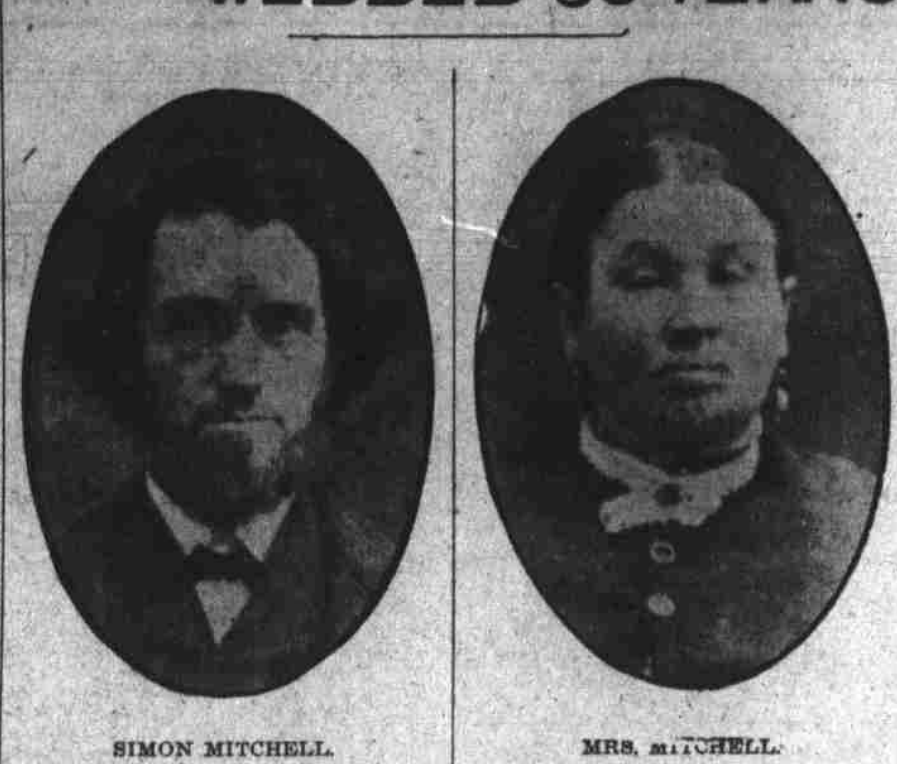
Nothing Too Good.

(Journal Special Service.) Albany, Or., Feb. 13.—The McKinley Republican club met last evening at the court house, pursuant to call. Dr. M. H. Ellis presided and stated the object of the meeting was to prepare for an active campaign. On motion Secretary C. E. Winn read the constitution and by-laws and the membership roll was signed by a large number. The following officers were elected: President, A. W. Bowersox; vice-president, S. S. Train; secretary, W. Lair Thompson; treasurer, J. C. Irvine. A committee to outline the plan of campaign was appointed as follows: J. A. Finch, Hon. S. A. Dawson, George E. Sanders, Gale S. Hill, J. N. Duncan, J. C. Irvine and George W. Wright. The name of the club was changed to the Roosevelt Republican club and the secretary was instructed to correspond with the state club in order to affiliate with that organization. The meeting was harmonious throughout and very enthusiastic.

Albany Notes.

The United Organ & Carriage company was incorporated yesterday, with capital stock of \$50,000. R. M. Cramer, J. A. Cramer and John McNeal are the incorporators. The machinery and buildings are on the ground and workmen are rapidly getting the plant in shape.

William Wyatt, one of the oldest, wealthiest and most highly respected pioneers of Benton county, died at the family home near Philomath, Wednesday afternoon. Deceased was aged 87 years, and the ailment that ended his career was inflammation of the bladder. The funeral occurred at 11 o'clock today from the Philomath M. E. church, the services being conducted by Bishop Barclay of Portland. Interment was in the Newton cemetery.

Mr. Wyatt came to Oregon in early days and had resided for 47 years in the house in which he died. At one time the Wyatt possessions included the ownership of 4,000 acres of land. Mr. Wyatt was the founder of the city of Philomath and of Philomath college, and was a citizen of whom the whole county spoke with the highest respect. He married Miss Mary T. End, a native of England, in April, 1838, the wedding taking place in New York. A large family as well as the widow, survives him.

SPRINGFIELD SPUR SOON TO BE BUILT

Eugene, Or., Feb. 13.—A report comes from a reliable source that the construction crew of the Southern Pacific company, which is now somewhere in California, will arrive here early next month and commence the construction of the Springfield-Henderson connecting link. It is understood that the crew will begin work at the Springfield end of the line, calculating to have the track on that side of the river completed by June in order that the big bridge may be built while the water is low. After getting through on the Springfield side, the construction gang will then begin operations on the Henderson side and finish up that portion of the track by the time the bridge crew is finished, thus completing the whole job by next fall. It is stated that after completing the connecting link, the crew will likely be sent down to Linn county and put to work on the proposed change of the tracks on the Woodburn-Natron line to a high elevation which will take in Lebanon and Scio, also run near the coal fields, which are now being opened up in that vicinity.

WATER COMPANY'S BLUFF DIDN'T WORK

(Journal Special Service.) Corvallis, Or., Feb. 13.—In spite of the threat recently made by the local water company to remove all hydrants unless the city council entered at once into a contract for supplying the city with water from the Willamette river, no action has yet been taken by the water company. Strained relations have existed for a number of months between these bodies, on account of the refusal of the city fathers to enter into a contract with the local company, with Willamette water as a source of supply; but the company finally served notice on the council that all water plugs and hydrants would be removed the first of February, leaving the city entirely without protection in case of fire, unless an agreement could be made immediately. The council has awaited the threatened action, but no steps have as yet been taken by the company.

The Latest Move.

The latest development in the case is the recent visit, and the talk before the council, of H. V. Gates, a hydraulic engineer of renown, who offers Corvallis a mountain water system at a price not to exceed \$50,000.

The supply would come from Rock creek, and would be water of the purest and best quality. A fall of 400 feet could be secured in 12 miles, and the supply would be abundant for all purposes. This is what citizens are clamoring for, and the general objection to Willamette river water is the principal reason why the council has refused to contract with the local water company.
