

CONFERENCE AT JEFFERSON CLOSES

Delegates Unanimously Endorse The Journal for Its Truthful Account of the Proceedings—
Gratifying Financial Report.

The following resolutions were passed by the Evangelical Association conference at Jefferson, Or., May 14, 10 p. m., 1904:

Whereas, The Oregon Journal, published at Portland, Or., has given us a fair and truthful report of the proceedings of our conference; therefore, be it

Resolved, That we, as a conference and church, do most heartily appreciate The Journal's efforts to do justice to the religious world; and, be it further

Resolved, That we, by vote, extend our hearty thanks to the publishers of The Journal.

The resolutions were presented to the assembly by Rev. P. J. Green, pastor of the Memorial church of Portland, and unanimously adopted by the conference.

Jefferson, Or., May 16.—The Evangelical conference at Jefferson has come to a close. The board of examiners for preachers was appointed as follows: English—Theology, J. E. Smith; history, G. W. Plummer; other studies, P. J. Green.

German—Theology, Theodore Schauer; history, H. E. Hornschuch; other studies, T. R. Hornschuch.

The Salem district has been changed so as to hereafter contain only the following fields: Salem, Liberty street, Salem, Chemeketa street, Fruitland, Jefferson, Albany, Monmouth, Kings Valley and Seaside and Sweet Home.

The missionary fund was increased \$447 by yesterday's offerings.

It is expected that the conference camp meeting will be held somewhere within the bounds of the Salem district. In connection with the campmeeting

there will be a three days' convention—one day to be devoted to Sunday school work, one day to the Young People's Alliance, one half day to ministerial work and one half day to the Woman's Missionary society. A conference branch Missionary society will probably be organized.

Highland was taken from Canby and joined to the Oregon City circuit.

Rev. W. E. Simpson was ordained deacon. Rev. T. R. Hornschuch was appointed postal secretary. Rev. G. W. Plummer was elected to represent the Evangelical association on the Anti-Saloon league board.

Next Annual Conference.
The time and place for the next annual conference was not definitely decided, but Bishop Bowman was requested to confer with the other coast conferences as to the advisability of changing the time from spring to fall. In this case a short session would be

held next fall without the presence of a synod, the work to be carried on as usual with the exception of change of appointments of ministers. The plan seems to meet with general approval.

Rev. G. W. Plummer and Rev. P. J. Green were elected to edit and publish the conference journal.

Rev. H. E. Hornschuch of Seattle; Rev. E. D. Hornschuch of Everett; Wash., and Rev. E. L. Jones, missionary to eastern Oregon, request that any one knowing of the arrival of Evangelists in their territory advise them at once of the fact, there having been considerable difficulty heretofore in finding the new arrivals from the eastern states and Europe. Letters addressed in care of Rev. N. Shupp, Portland, Or., will be forwarded to these ministers.

A plan, of which the memorial Y. P. A. is the author, is on foot for a Y. P. A. trip to Mount Hood the last of July. A number of ministers of the conference expect to accompany the party.

Conference Proceedings.
The financial report was one of the most gratifying which has been given since the organization of the Evangelical association in Oregon. Very few of the ministers have failed to receive their entire salaries and many have received a surplus. Besides this many parsonages and churches have been repaired, some new buildings have been erected and several large debts paid. This satisfactory state of affairs seems to be the result of the titling system, which was introduced last year. Rev. G. W. Plummer was elected financial secretary.

Presiding Elder Shupp was appointed to serve on the Portland district, which is the request of the new presiding elder, Rev. E. R. Mauer, has been enlarged to include all the fields in the conference with the exception of eight, which have been left to the Salem district, to be served by Presiding Elder Mauer, the salaries to be apportioned accordingly.

The report of the committee on Sabbath and temperance brought forth a warm discussion. The conference expressed itself as strenuously opposed to the opening of the gates of the Lewis and Clark exposition next year on the Sabbath day, and as decidedly in favor of the local option bill.

The subject of questionable amusements was brought up and the attending of theatres, horse races, Sunday excursion, card games and the playing of cards and all games of chance were heartily denounced as un-Christian.

The building of a parsonage at Jefferson

and the purchase of a parsonage for Memorial church, Portland, were favorably considered and referred to a committee for action.

BAND OF ROUGHS BATTLE WITH POLICE

PATROLMAN ADAMS BABY BEATEN BY FOREIGN TRUFS WHO PUT UP SUCH FIERCE FIGHT THAT ASSISTANCE IS BECOMING NECESSARY.

Patrolmen Adams and Croxford, the former in charge of the Lower Albina beat on the first night relief, and the latter on day patrol, last night had a terrific fight with several men in front of Sinnott's saloon on Falling between Sixth and Seventh streets. The officers were forced to use their clubs freely in order to win in the conflict. The fight was waged for nearly an hour, when the patrol wagon from headquarters arrived, and J. Peters and V. Yost were carried away to jail. One other belligerent made his escape, and has not been captured.

Peters and Yost were arraigned on charges of disorderly conduct in the municipal court this morning, and were fined \$20 each; the highest possible amount from which they cannot appeal. Judge Hogue told them that they deserved the limit, but in order to make them pay the fines he placed it so low they could not take recourse to a higher court.

The fight started in the saloon, and Patrolman Adams, who was alone at the time, went in and ordered the three men to be quiet. Instead, they attacked the officer, and a fierce scuffle ensued, in which Adams and the three men worked their way out on the sidewalk in front of the saloon. There the men got the better of Adams, and knocked him down. While he was prostrate, they jumped on him and tore off his star, which they threw into the street.

Adams fought the men single-handed as best he could, and had a bystander summon Officer Croxford, who lives near the scene of the fight. When he arrived, the fight was renewed with greater vigor, and a battle, such as has not been fought in Portland for many months, was waged.

The men who attacked the officers are Russians, and are a part of a gang that infests Lower Albina. It is said that the men had threatened to "get" Adams, who was detached from night duty Friday by Chief Hunt, because he spoke out in line against Special Officer Mallett, in charge of the Paris house dive. It is said the band had made the statement that if they beat Adams, nothing would be done about it, as the chief "had it in" for him.

In the fight, Patrolman Adams' trousers were torn nearly off him, his helmet was smashed, he received a bad cut in the face and a gash on the nose.

after some mining interests, but Mrs. Sebecki, who viewed the other side of the loss would reach \$1,500. "We did have some insurance," said Mrs. Sebecki, "but it ran out several weeks ago, and I do not think Mr. Sebecki took the time to go up and have it renewed."

Chase Lee, a Chinese tailor, was not able to "sabe" when asked regarding the fire. "Me lose \$3,000 worth and hab \$2,000 insurance," was the only comment that the tailor would make. It is said that Lee was sleeping in the rear of his shop, but he is said to deny that he had any sort of a fire in his apartments last night.

L. Goodman said that the burning of his store caused him a loss of \$350. He said that his stock was worth \$1,500, while the insurance was \$550.

N. Alsager's shoe shop was partly destroyed, the loss being estimated at \$500. F. Clief stated that his cigar store was a total loss; it was valued at \$400, with \$200 insurance.

Two Firemen Injured.
While driving to the fire, George Mitchell, driver of truck No. 3, had his back severely wrenched. Mitchell was making all possible speed to reach the scene of the blaze, knowing that it was located in a wooden building district, when the truck struck a bump, and the driver was almost thrown from his seat. But he drove to the fire, and pluckily attempted to help in the work of putting out the blaze, but his injury was so painful that Chief Campbell ordered him to go home. This Mitchell did not want to do, but at last did so. He expects to be at work again within a few days.

A falling timber struck Joe Stutt, captain of engine company No. 1, on the left shoulder, and as he was attempting to knock the board off a large piece of glass struck the back of his right hand, cutting a severe gash.

Praises the Firemen.
Although the fire was not discovered until the quarter-block then, the now charred ruins was all ablaze, the work of the firemen in limiting the flames to the area in which they started was widely praised by spectators. Charles W. Boost, of the wire company, gave the following signed statement to The Journal:

"I have only words of praise for Chief Campbell and his men. I think Portland has as good, if not better, fire department than can be found in any other city in the United States. Their work at this morning's blaze was fine. I am sure that if the fire had been discovered when it started the boys would have quickly had it under control."

LOS ANGELES CHAMBER OF COMMERCE TO GIVE A DINNER IN HONOR OF WILLAMETTE UNIVERSITY OF SALEM—EMINENT OREGON MEN WILL SPEAK.

Los Angeles, May 16.—A banquet will be given at the chamber of commerce in Los Angeles this evening to the delegates by President Coleman in honor of the Willamette university of Salem, Or. Bishop Cranston, Senator R. A. Booth and other eminent gentlemen will respond to toasts.

J. C. Hartzell, bishop of Africa, made his report of his travels and work in Africa, giving interesting items of present and prospective conditions as affected by the late Boer war and quoting a statement from the late Cecil Rhodes made to the bishop just previous to Mr. Rhodes' death: "My chief object in life is to do everything possible for the civilization of the barbarous peoples and the unification of all men who speak the English language."

Personal Items of Oregon People.
Rev. John Flinn, whom the Portland people sent with his wife to Los Angeles, was invited by resolution to occupy a seat on the platform of the conference.

Senator R. A. Booth of Eugene is a delegate doing persistent work for the church in Oregon. He is highly esteemed by the bishops and other members.

The Rev. John H. Coleman, D. D., president of Willamette university, was elected delegate by the Troy, N. Y. conference, he having not yet transferred his membership to Oregon. His election under the circumstances was a high tribute to his worth.

Rev. T. T. Fox, D. D., who was taken sick on arrival, is so far recovered as to make his appearance in conference again.

CARNIVAL CROWDS WILL BE HOUSED

CARNIVAL COMMITTEE ESTABLISHES HEADQUARTERS AND WILL PREPARE LIST OF ROOMING PLACES FOR VISITORS—SPECIAL MESSENGERS AS GUIDES.

There will probably be many visitors in the city at the time of the Federated Trades-Fraternal mardigras and carnival to be held in this city between June 28 and July 9, and the management is making extensive preparations to provide for their comfort. Many inquiries have come in from people in other cities asking what arrangements are to be made for providing suitable accommodations. The committee on entertainment and reception has now established its headquarters in room 612, Marquam building, and is ready to hear from all who can furnish rooms and board. These must call in person, stating location, price, convenience, and number of the rooms they have for rent. These will be registered, and during the carnival special messengers will be provided to take visitors to their boarding places.

The carnival will be well advertised throughout the state. The first of next week four press agents and advertising men start out to visit every town and hamlet within 200 miles of Portland to advertise the carnival.

A horse contest will be a feature. A letter has been received from the Astoria horse team, which has challenged the championship for the state, asking that it may be allowed to compete in a horse contest. Similar requests have come in from Willamette valley towns.

The Fourth of July committee will call on General Beebe today to secure his co-operation in regard to furthering arrangements for the Fourth of July parade.

ORPHEUM ADOPTS SUMMER PRICES

The Orpheum theatre has adopted summer prices and with the other amusement places of the city will offer special inducements for summer crowds. The prices now are 25 and 15 cents.

The new bill this week is a long one and is headed by the Robert four with their musical comedy, "The Dollmakers Dilemma"; Zara and Zara, change artists, make 20 complete changes in their act; "The Soldier and the Peasant," Addison and Livingston, sketch artists, are additions to the bill, which holds over the good turns of last week and adds enough new talent to make the program entirely novel and interesting. Many large parties have attended the last few nights and the attendance has been constantly increasing.

ORO ACCUSED OF BEATING HIS WIFE

W. Oro, an employee of the Arcade theatre, will have to stand trial in the municipal court Wednesday on a charge of assaulting his wife. He was arrested at an early hour this morning by Patrolman Carlson, whose attention was called to the fight by screams issuing from a room in the Vincennes house.

Oro told Patrolman Carlson that he would make the arrest cost him his job on the force, but Carlson took him to the station and ran the risk. Bail was furnished, with some difficulty, in the sum of \$50.

DRUNK, SETS FIRE TO HIS HOME

The timely arrival of Patrolman Dan Connors was all that averted a serious fire at the residence of George Rein, 124 Arthur street, South Portland, last night. The man of the house came home drunk, threw a lighted lamp across the room and the lamp exploded, throwing burning oil over the room. Connors, passing, and seeing the flames, burst in the door, and with some blankets, smothered the blaze after a hard fight. In the municipal court this morning Rein was arraigned on a charge of drunkenness and was fined \$10.

Judge Parker is said to be in a receptive frame of mind. Some of his backers, while apparently loyal, are suspected of being in a deceptive frame of mind.

MIRACULOUS ESCAPE OF MOTOR PARTY

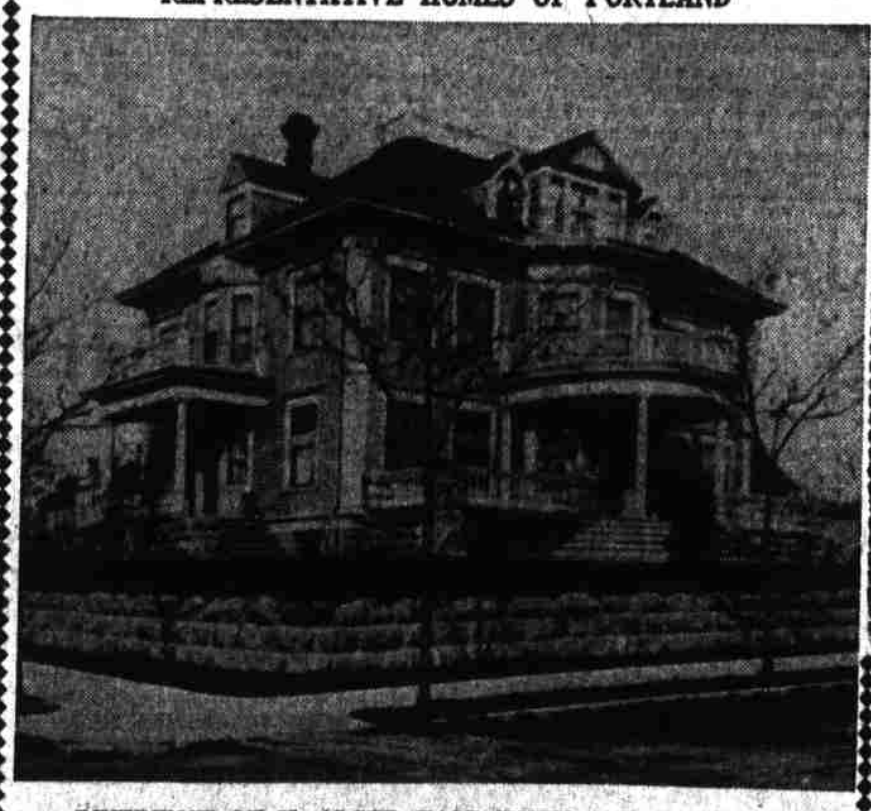
"That none of the party was seriously injured, and that the automobile merely suffered a bent handlebar, is the most remarkable accident ever brought to my attention," said George H. Andrews, land agent for the Southern Pacific railroad, regarding the double somersault flip-flop turned by a big Whiton touring machine, in which members of his family were riding last night.

In the car at the time of the accident were Mr. and Mrs. Ben Holladay and child, who are Mrs. Andrews' son-in-law, daughter and grandchild; his two daughters, Misses Alice and Louise Andrews, and William Patterson, all of Portland.

The machine was coming down a grade at a rapid clip, near Troutdale, at 7 o'clock in the evening, when two of the wheels struck a sand bed, suddenly veering the machine over the 20-foot clay embankment. With lightning speed the car had reversed, throwing all six of its inmates out. The machine promptly rebounded, doing another flip-flop, and landing on its wheels in the soft soil at the bottom of the bank.

Word of the accident was at once sent to Portland, and Dr. Holt C. Wilson went out on the train and Mr. and Mrs. Andrews in another automobile. Miss Louise Andrews sustained a slight fracture of the collar bone, the only injury sustained by any member of the party other than a severe shaking up. She came home last night. Mrs. Holladay and her mother remained over in Troutdale until this morning. The machine also made the run into town today.
