

UNDOING CUPID'S ILL-TIED KNOTS

VANCOUVER COURT HAS TWO INTERESTING CASES, IN ONE OF WHICH A PREACHER IS PROMINENT FOR HIS IDEAS ON WIFE'S SUBJECTION.

Vancouver, Wash., May 23.—While the county auditor is kept busy from time to time licensing people to marry, the superior court is called upon frequently to separate those who have already enjoyed their fill of matrimonial life.

The court was busy until 12 o'clock Saturday night in finishing up two cases of divorce, both of which were contested, and this leaves two more lately filed for adjudication.

The two cases disposed of Saturday and Sunday night were Eliza C. Gossett against W. J. Gossett, and Jessie Engleman against Christian Engleman.

In the latter case the court awarded an absolute divorce, and decreed that Christian should pay his estranged wife \$1,000; \$300 within two years, unless certain property owned by him shall be sold before that time, in which case the judgment is to be immediate, and the balance of the \$1,000 within five years, with interest at 8 per cent. The custody of the child, which was the great point of contest, was awarded to the husband, but will for the time being be left where it was before the trial—in the charge of a third person.

The trial of Eliza C. Gossett vs. W. J. Gossett was disposed of in shorter order than the Engleman case.

Gossett a Preacher.
W. J. Gossett is a preacher well known in Clarke county, who resides at Fourth Plain, and Eliza C. is his second wife. A recital of Gossett's treatment of his first wife was given in court, but the facts proved at the trial showed conclusively that it was no easy matter for him to subject his second spouse to the same treatment without some manifestation of rebellion and final separation.

Mrs. Gossett, in her complaint, alleged that she was married to him on August 22, 1900, and that shortly after he commenced the cruel and inhuman treatment toward her, and heaped personal indignities upon her until life was burdensome. She alleged specifically, and so proved to the satisfaction of the court, that on or about December 20, 1902, she requested him to get provisions for the family and wearing apparel for herself, and he assigned as a reason for his failure to do so that he did not feel like complying, and was very emphatic in giving his wife to understand that he did not intend to get her anything, and that he expected to treat her that way for five years, or so long as he wished, and by such means he expected to bring her to "subjection" as he did his first wife.

It was also shown in the trial that Preacher Gossett endeavored to show his domestic authority on January 1, 1904, by scattering food which his wife had prepared for the family over the floor, and even throwing part of it out of the house. His reasons were that he wanted to show his authority; and a couple of days after, when there was nothing in the house in the way of provisions, and his wife complained of being hungry, he advised her that she would be more so before she got through with him, and then likened her unto Esau of old—that she had sold her birthright and also had lost the affections of her husband.

The court thought the evidence of abuse sufficient, and granted the divorce.

Proceeds to Entertainment Fund.

DEDICATE NEW CHURCH.

The building, which cost \$2,000, was dedicated entirely free of debt.

It is beautifully finished, being papered and stained in brown and tan, besides the main auditorium, four Sunday-school rooms and a choir loft, with a seating capacity of 200.

MONSTER MEETING HELD AT CANBY

DEMOCRATS ARE CONDUCTING VIGOROUS CAMPAIGN AND OUTLOOK IS HOPEFUL—STREET WORK IN COMMENCED—TAILOR SHOP IS BURNED.

Oregon City, Or., May 23.—Democrats are conducting a vigorous campaign and are very hopeful over the outcome on June 6. On Saturday night they held a monster meeting at Canby, at which Colonel R. M. Washburn spoke to the voters. His speech was received with much applause, especially that part which alluded to the record that Binger Hermann had made as a public official. R. A. Miller spoke, and also J. E. Hodges. The candidates were present and made short talks.

Republicans held a rally in Barlow Saturday night, which was fairly attended. G. B. Dimick was the speaker of the evening, and his subject was confined to taxes. He explained the present system of assessing and the reason why people were paying more money than usual. Walter L. Toose also spoke in defense of the charges that are being made against Binger Hermann. The candidates were heard in short talks.

Street Work Commenced.
Work was commenced this morning on Center street, the contract for which was let to the firm of Jones & McKay. For the past week Engineer E. P. Rand has been busy over estimates and drawings, and Friday and Saturday he was running the grade lines and setting grade stakes. This morning workmen were taking up the sidewalk so that the grading could commence. The contract calls for considerable crushed rock, and when finished this street will be one of the best in Oregon City.

Costly Blaze.
Yesterday morning about 8 o'clock flames were discovered issuing from the rear of the building on South Main street that is occupied by the tailoring firm of Him Kee & Co., Chinese tailors. At the time of the fire four Chinamen were sleeping in the building and they were awakened by the firemen but did not know the cause of the blaze.

The fire was soon extinguished but not before considerable damage was done both to the building and stock. The stock was valued at \$2,000 and is fully insured. There is probably \$1,000 damage done to the stock, while \$100 will be the extent of the damage to the building. The latter belongs to the John Schram estate and will be repaired at once.

Courthouse Notes.

Saturday in the circuit court suit was commenced by Asaph P. Barton, through his attorneys C. D. and D. C. Latourette, against H. H. Johnson and C. O. T. Williams for recovery of \$941.25 with interest at 10 per cent from November 8, 1900. The note was issued by the two defendants on March 27, 1897, and the interest and a small payment on the principal was made up until November 8, 1900.

Marriage licenses were issued Saturday by County Clerk Sleight to Miss Ora Welsh and John Parrish and Miss Lena Kay and Louis Standiger.

Richard Melville Allen Dead.
Richard Melville Allen, a pioneer of 1850 and a Grand Army man, died after a lingering illness at the home of C. W. Ganong in Canemah. He was the son of Dr. William Allen and was born in Palmyra, Missouri, in 1844. When the war broke out he enlisted with the northern forces and was in many of the important engagements in the Civil war. He was unmarried and leaves three sisters, Mrs. C. W. Ganong of Canemah, Mrs. Thomas Miller of Oregon City and Mrs. W. M. Sheppard of Barlow. The funeral services will be held from St. Paul's church tomorrow at 1:30 p. m.

Oregon City News Notes.

The funeral of James Thorn occurred from the Congregational church in Ely yesterday afternoon at 2 o'clock. The interment was in the Masonic cemetery.

May of Mr. Thorne's old-time friends attended the funeral and accompanied the remains to the grave.

Fred Miles, who has been in the hospital in Portland for several weeks from an operation for appendicitis, was brought home yesterday and will soon be around again.

A demurrer to the complaint of A. O. Gittinger against S. Oldstein in the justice court was yesterday filed by C. D. Latourette, attorney for the defendant.

Registration in the county is a little less this year than two years ago. This year it is 4,304, while two years ago it was 4,347.

The infant son of H. A. Smith of Clackamas, who died last night, will be buried in Clackamas cemetery today at 2 o'clock. The Rev. Elliott will conduct the funeral services.

Surveyor H. A. Rands leaves today for Eagle Creek, where he will survey 18 acres for J. M. Lyons that will be platted off into lots for a townsite.

**WILL BE DECIDED
AT JUNE ELECTION**

**LA GRANDE AND UNION COUNTY
SEAT CONTEST BEING WAGED—
WORK ON JOSEPH AND BUREKA
TELEPHONE LINE IN WALLA
BEING RAPIDLY PUSHED.**

La Grande, Or., May 23.—The removal of the county seat from Union to La Grande, its former location, will soon be voted upon by the people of Union county. La Grande has made arrangements for a building to be used for the purpose, and it will now depend on whether or not she will be successful in gaining the vote of the people. Union must get over 40 per cent of the votes cast, and La Grande will have to have 60 per cent of the votes for removal.

This fight has long been on in Union county and each place claims its right for the county seat. The question will be placed on the official ballot for the regular June election.

Walla Walla Telephone Line.
Work on the Joseph & Eureka telephone line in Walla Walla county is rapidly being pushed to completion and the company has all the material on the ground as far as Imnaha bridge, and a force of men setting out poles.

The company has decided to establish four stations between Joseph and Imnaha bridge, and the line as far as the bridge is assured by the first of July.

ARMY OF TRAMPS IN WASHINGTON

CLOSING OF LUMBER MILLS AND CAMPS CAUSE MANY MEN TO SEEK EMPLOYMENT IN OTHER OCCUPATIONS—CITIES ARE APPARENTLY UNAFFECTED.

Seattle, May 23.—Not since the great Coxy movement of 10 years ago has there been such an army of tramps in Washington, crossing and recrossing the mountains and following the main lines of railroads through the agricultural sections and to the coast. Railroads are having more trouble with these wandering elements than they like to admit, particularly at the junction points.

Railway trainmen recognize two distinct classes of these tramps, the men with blankets on their backs going from place to place in search of employment, however light, and the real hoboes, caring not where their restless takes them, or on whose rights they infringe. It is this hobo class that is particularly annoying to the railways, and it also is the predominating element among the wayfarers. The number of workmen going to and fro is due partly to the closing of sawmills and lumber camps, while many are going to the fields in the eastern part of the state. But this falls far short of an explanation for the total increase in tramps, and the reason for that the railway people cannot give.

Though the closing of the lumber mills and camps has had an injurious effect on the labor market in the smaller towns of the state, William Blackman, state labor commissioner, believes that industrial conditions in the cities are entirely satisfactory and will continue so throughout the year. Building operations keep up their usual activity, in fact, seem always on the increase, and the labor commissioner sees no reason why there should be any slackening tendency, while with the coming of fall the lumber interests are expected to have a brighter outlook.

EASTERN OREGON MINING ACTIVITY

**E. & E. MILLS AGAIN START STAMPS—
BOURNE CAMP LIVELY—ROCK
CREEK POWER COMPANY NEARLY
READY TO START—GOLCONDA TO
RESUME.**

Baker City, Or., May 23.—The big mill at the E. & E. mine has just been renovated and partially rebuilt and 20 stamps will begin dropping again today on rich ore.

This news was received from D. R. McNamara, who has just arrived from Bourne, and who is connected with the E. & E. property. Thirteen true vanners, one Johnson vanner, and two Willy concentrating tables have been installed. The mine is working a full force of men and has for months been doing extensive development work. Enough ore is now on the dump and blocked out to run the mill for two years, whether any more development work is done or not.

Mr. McNamara states that the Bourne camp is quite lively and that the snow is now going off. It is expected that the Golconda will again be working in a short time, and that the tonnage output of ore from this camp will this season exceed that of any previous year.

Flume Nearly Completed.
Manager Al Welch of the Rock Creek Power & Transmission company, who has just been to the head works, reports that the pipe flume will be completed now in a few days and the big water-wheel started, which will send the electric current into Baker City and over the lines of the company's system.

This will mark an epoch of progress in eastern Oregon and enable manufacturers and mining companies to do business very much cheaper than heretofore. Not only this, but this cheap power has already induced capital to invest in this field which would not otherwise have come here.

LAND DIVISION ENDS IN KILLING

**ABRAHAM ELLIOTT OF CAMAS SWALE
SHOTS AND KILLS LOUIS FOITRA,
AN AGED AND SOCIETARY
FARMER—CLAIMS SELF-DEFENSE
FOR HIS ACT.**

Eugene, Or., May 23.—Archibald Elliott, aged about 23 years, shot and killed Louis Foitra, aged about 60 years, in the Camas Swale neighborhood, five miles west of Creswell, and about nine miles south of Eugene, Saturday afternoon.

A coroner's jury today exonerated Elliott, finding that he killed Foitra in self-defense.

There were no eye witnesses to the shooting, and further than Elliott's own story, there are no details of the tragedy.

After the shooting, young Elliott rode to Creswell and informed the constable there what he had done and was placed under arrest.

Elliott lives on a farm adjoining that which belonged to Foitra. For some time past there had been a dispute between the two men over the division line separating the two farms. They had also had trouble over the alleged killing of some of Elliott's cattle by Foitra. On Saturday the latter drove to Creswell to do some trading and when he returned some time later in the afternoon found Elliott slashing brush on what Foitra claimed was his land. According to Elliott's story, Foitra ordered him off the land, but he refused to go. The old man then advanced and told Elliott that he was going to give him a good whipping, at the same time reaching for his hip pocket as if to draw a gun. Elliott, in self-defense, then drew his revolver and shot the man dead. The bullet entered his abdomen and came out at his back, killing him almost instantly.

Sheriff Fred Fisk was telephoned for late Saturday night, and he and Deputy Sheriff Harry Bown left at once for the scene of the tragedy. Deputy Prosecuting Attorney L. T. Harris and Coroner C. B. King also drove to the place Sunday morning where the inquest was held today.

Foitra lived alone on his ranch and was an eccentric character. Many residents in the neighborhood think that he was a miser and had plenty of money hidden away somewhere, but since he took up his residence in that neighborhood he lived as if in abject poverty. His appearance was peculiar, as he wore long, bushy hair, reaching to his shoulders, was short in stature and always dressed shabbily. Very little is known of him or his relatives, if he had any, as he seldom talked much about himself and never told where he came from or anything about his past life.

Archibald Elliott lives with his mother on their homestead, is a hard-working young man and considered steady and honest.
