

REED TOO HEAVY A LOAD TO CARRY

Republican Strategists Asked Late Candidate to Withdraw From Ticket Two Weeks Before Election—Refused to Yield to Managers.

Realizing that Sanderson Reed's defeat was almost certain and would be a body blow at the machine, leading Republicans went to Judge Charles H. Carey and induced him to try to get Reed to withdraw from the fight for district attorney about two weeks prior to the election and two days before the sample ballots were issued. Judge Carey sent for Reed and had a long and earnest conference with him, but the machine candidate felt assured of success and would not allow his name to be withdrawn and a stronger candidate placed on the ticket.

Knowledge of this attempt to get Reed off the ticket has been in possession of several officials at the county court house for more than two weeks. They have guarded the secret well, fully appreciating that if Reed stood any chance at all such a confession of weakness as trying to pry him off the ticket would mean his sure defeat. Now that Reed has been decisively defeated and the "Matthews machine" so crushing rebuffed by the electors of the county, no reason exists for secrecy and publicity has come to be looked on as really desirable under the circumstances.

Disclaimers Deputyship.
Two days prior to the time the sample election ballots were issued John F. Logan, law librarian at the court house, who was to have been chief deputy in case Reed was elected, went to Judge Carey and advised him to persuade Reed to withdraw, if possible. In order to show his honesty in the matter Logan disclaimed deputyship, saying he would offer no opposition to Reed being selected for the position of chief deputy, provided the substitute candidate should be elected.

"I am thoroughly convinced that Reed cannot be elected," Logan said to Judge Carey. "The fact that he changed in political opinion so recently is militating strongly against him. The Multnomah club is opposed to him. He has many bitter personal enemies in the Republican ranks, and from the way I size it up now he is being knifed by men who are otherwise to be deemed loyal members of the Republican party."

Judge Carey was also approached by other leading Republicans and was so impressed with their arguments against Reed's candidacy that he sent for the candidate for district attorney. Reed was then informed by Judge Carey that his chances were looked on as slender by many leading members of the party. He went into the subject at length and

gave the reasons advanced showing Reed's weakness.

These arguments produced considerable effect on Reed and he was in a state of hesitation for some time. Finally he declared his belief that he would be elected by a safe majority and said he was convinced he would do himself an injustice by withdrawing from the ticket. He left Judge Carey's office while in this frame of mind.

A conference of Republican leaders was held and it was decided that further persuasion should be used on the candidate. While the methods to be employed were under consideration something materialized which the leaders had forgotten was to take place—the sample ballots of election were printed. This precluded further effort to secure Reed's withdrawal. It was agreed that the utmost secrecy should be observed as regards the vain attempt to have a stronger man substituted on the ticket for Reed.

From the day the sample ballots were printed until the day of the election Logan worked hard for Reed, though he was satisfied his labor would go unrewarded. His loyalty was largely due to the fact that in 1895 and 1896, during the period of financial depression in the country, Reed, as secretary of the law library commission, held him in his position as librarian.

MAYOR SCHMITZ CAN'T ORATE HERE

Portland people will not have the pleasure of hearing Mayor E. E. Schmitz of San Francisco on the Fourth of July, notwithstanding the fact that the Bay City popular official was urged to be here. Mayor George H. Williams twice telegraphed an invitation to Mayor Schmitz, asking him to deliver the Independence Day address in this city.

Owing to the fact that the federated trades of Portland have planned to make the coming Fourth one of the most memorable in the history of the municipality, they wished to secure as a speaker for the day a public man who has taken some interest in labor questions on the coast. Mayor Schmitz of San Francisco was the local trades union's first choice.

The following telegram from Mayor Schmitz was received this morning by Mayor Williams:

"Appreciating the high distinction

and honor conferred upon me by your invitation to deliver the Fourth of July oration in your city, and to participate in the celebration of American independence and liberty, I regret that I cannot accept, because of arrangements already made, and which cannot be changed, to be elsewhere on that day. With many thanks to yourself, the federated trades, and the citizens for whom you speak, and with best wishes for the success of your celebration."

SAYS SCHNEIDER'S LICENSE IS FAVORED

Whether or not Captain Herman Schneider will be granted a license to conduct a saloon business at Montavilla will be known tomorrow, when the county court will pass on the question. Schneider was recently indicted by the grand jury on two counts, his conviction by a jury following in one, and the other charge being dismissed.

The duke's was the third surviving life named in many of these leases, and all of these now revert to the Prince of Wales, as Duke of Cornwall.

REED INSTITUTE MUST WAIT AWHILE

INSTITUTION FOUNDED BY PORTLAND'S PHILANTHROPIST FUNDRAISERS WILL NO DOUBT BE BUILT ON PLOT KEPT VACANT FOR THAT PURPOSE.

Present indications are that the Reed institute, for which more than a million dollars worth of property was bequeathed by the late Mrs. S. G. Reed, will be located on the north side of Jefferson street between Twelfth and Thirteenth streets.

"This plot of ground was long in the mind of Mrs. Reed as a site for the school," said an intimate friend of the family this morning. "With this object in view the land in the block was always held vacant, although the estate owned both sides of Jefferson street from Eleventh to Thirteenth streets. The site is a beautiful one, within easy walking distance of the entire business part of the city; in fact, less than a mile from the heart of the city. For an institute or technical school building no location in Portland could be more desirable."

Settlement of Estate.
As to the settlement of the estate, nothing can be done until the return of Martin Winch, the administrator, who is now in California. He and his family are at Pasadena, and he may not return for three or four weeks. After he returns, however, the settlement will go steadily forward and an appraisal of the property left by Mr. and Mrs. Reed will speedily follow.

"Not until after the estate has been settled and the property divided will the trustees of the proposed school hold their first meeting. At that time they will know exactly how much money is at their disposal, and will at once start plans for the building of the school and the establishment of the work that is to be carried on."

It is the opinion of persons closely identified with the project that at least two, and maybe three, years will be required, even with no unnecessary delays, before the Reed institute will actually be in operation.

VOTED FOR SOCIALIST.

All the Democratic Representatives in Linn County Elected.

Albany, June 9.—Complete returns from the precincts in the county show the election of all the Democratic representatives to the legislature. Among them is I. A. Munkers, one of the best equipped men in the county for the duties of a law-maker, and he is expected to do good service when the legislature meets next winter. Mr. Munkers is a native of this county, and served Linn county as a deputy sheriff for many years. During his incumbency of that office he made a special study of the question of assessment and taxation and is a practical man whose assistance in shaping legislation on this question will be of great value to the legislature. His long service in the county as one of its peace officers and tax collector made him peculiarly acceptable to all classes of citizens and the people generally accepted his nomination as a well bestowed one. He was voted for by Republicans and Democrats alike. His majority was a large one and would have been much more but for the fact that the Socialists had a man of the same name on the ticket, and over 100 votes cast for that candidate were evidently intended for I. A. Munkers, the Democratic nominee. The Socialist Munkers ran over 100 votes ahead of his ticket, and all believe that he was voted for by mistake. Mr. Munkers is a close friend of Governor Chamberlain and will be one of the most loyal supporters of that officer during the coming session of the legislative assembly. His associates are also able men who will represent the county well in the legislature. A. B. Cavender is the editor of the Brownsville paper and is a man of sterling worth, standing high in his community. He will make an able and careful law-maker when the legislature convenes in Salem next winter.

UNION'S FINAL RETURNS.

Republicans Carry All the State and County Offices.

La Grande, Or., June 9.—The entire Republican state ticket in Union county and county ticket was elected as follows: Leroy Lomax, district attorney; representative, N. C. McLeod; sheriff, C. C. Pennington; clerk, J. G. Gilham; recorder, J. T. Bolles; commissioner, J. M. Selder; treasurer, John Frawley; assessor, J. H. Morton; county school superintendent, E. E. Bragg; surveyor, Arthur Curtis; coroner, J. C. Henry; justice of the peace, John E. Huff; James B. Gilham of La Grande, the newly elected county clerk is the first Republican elected to that office for 25 years.

C. C. Friedley, who is alleged to have fired the shot that killed McGee in the mass meeting riots Monday night, has been captured on Thompson ranch near Canon City.

Deportation of union miners continues under the direction of the citizens' committee, appointed by General Bell. The committee was in session all night considering the cases of individual miners, but the result of the report has not been made public.

Tyson S. Dynes, one of the foremost lawyers in Denver, arrived last night and is today preparing for the Citizens' Alliance a form to be submitted to all employers in the district, pledging them to refrain from employing any person charge of the camp.

The coroner's jury is sitting today in the independence outrag, but no verdict is possible for several days. Advice received here say that at an early hour this morning the office of the Victor Record was entered by a number of armed men, who destroyed the machinery and ordered the men employed in the office to get out of town.

The linotype machines, presses, telephones and typewriters were broken to connected with in again quieting the thousands men and women will be effected. It is also decreed that no idle persons will be allowed to remain in the district, which is a significant move.

CRIPPLE CREEK PEACEFUL.

Militia and 200 Deputies Effectively Control the Situation.

CLOSURE PORTLAND MINE.

Victor, Colo., June 9.—At 2 o'clock this afternoon General Bell issued a proclamation closing the great Portland mine on the ground that it is harboring a dangerous class of men. The Portland is the only union mine in the district and employs between 700 and 800 men.

George Naylor, proprietor of the Record, today said he would establish a new plant as soon as possible. He estimates his loss at \$5,000.

Joint funeral services were held today over the five independence depot victims.

WILL FREE VARLEY AND PERDICARIS

Washington, D. C., June 9.—Admiral Chadwick cables the following from Tangier this morning: "Minister of foreign affairs has received instructions from the president to all the demands of Raisuli. The two prisoners will be released as soon as a ransom of about \$55,000 is paid."

No further advices have been received regarding the condition of the captive, Perdicaris and Varley. The last communication from Perdicaris stated that he was ill, and considerable anxiety as to the outcome is felt among his friends, owing to his advanced age.
