

VICTIM'S FATHER SUES MURDERER

Freda Garacio's Father Brings Suit Against Her Murderer for \$5,000—First Local Case of the Kind on Record.

Gastano Garacio, the father of 18-year-old Freda Garacio, who was shot and killed last Tuesday by Frank Guglielmo, brought suit against her murderer in the circuit court yesterday afternoon to recover \$5,000, at which figure he assesses the damages he has received on account of forever being "deprived of his daughter and her assistance and services."

The suit was filed by Attorney A. C. Emmons on behalf of Garacio. It briefly recites the facts of the shooting, the whole action being disposed of in four clauses.

Garacio is unable to write and his mark is appended to the document. The complaint was sworn to before Attorney Emmons as notary. In the petition the damages defendant's name is spelled Guglielmo, although the charge of murder calls him Guglielmo.

So far as known to local attorneys this forms the first case in the history of the state where an action for damages has been brought against a person taking human life by the relatives of the victim. There have been two famous cases in Multnomah county in which damages have been obtained by men shot and were mortally wounded.

In 1884 P. C. Smith shot George W. Philbrick. While a criminal action was being prosecuted against Smith suit

was brought by Philbrick for damages. He transferred his property during the progress of the civil suit to Thomas J. O'Connor for a third its real value. The case was appealed to the supreme court after judgment for \$5,000 had been secured against O'Connor. The plea of the latter was that he was innocent of fraudulent intent. The supreme court asserted that he could not have been an innocent purchaser, because the damages suit was widely known.

Many Lawyers Employed.
Otto Morrell was shot by Joseph Miller in 1892, judgment being returned for \$10,000. Miller was represented by Pierce May, Charles F. Lord, Henry E. McGinn, Nate Simon and Alfred E. McGinn. The attorneys employed by Morrell were J. R. Stoddard, D. B. Watson and Ed. Mondenhall. Miller transferred his property to Lord, as it was claimed, to insure counsel their fees. The court held that the value of the property transferred was greater than the combined fees, and a part of the property had to be returned, but Morrell did not get the full amount of judgment.

Miller was assessed \$250 recently by a jury in Judge Fraser's department of the circuit court for shooting O. F. Strack in the foot. Miller was also found guilty and fined \$250 as the result of a criminal action.

RIVER BOATS ARE WELL GUARDED

**GENERAL SLOUGH DISASTER
WOULD NOT BE LIABLE TO HAP-
PEN HERE—GOVERNMENT IN-
SPECTION IS RIGID AND LOCAL
BOATMEN KEEP THE LAW.**

Portland excursionists need not fear a General Slocum disaster, that is, if careful guarding and carrying out of the government's laws to the letter insure the safety of river boat passengers.

Every year thousands upon thousands of Portland people go down to the river in boats, and only once in the marine history of Oregon has an excursion boat caught fire, and then no lives were lost. The local boats that carry excursionists are carefully inspected by government officials, not only once a year, as the law requires, but several times a season. By a recent order issued by Secretary of Commerce and Labor George B. Cortelyou, one of the forces of local steamboat inspection is gone over by marine engineers, the boilers are tested, all of the life saving equipment is inspected and everything possible is done to make life and property safe. In Portland the river steamers are inspected many times each year, and let a captain be found trying to evade the law in the least and he has trouble enough, and to spare. As custom officials are also steamboat inspectors, the ship owners are very careful to keep everything about their craft "in Bristol fashion," for they never know just what minute one of Uncle Sam's men may have in sight.

Portland's Excursion Fleet.
The excursion fleet of this city is one of the largest and finest on the coast. And the steamers that are allowed to carry excursion parties do not include nearly all of the river boats that are registered here. The largest of this fleet is the T. J. Potter, and during the many years that she has been proudly plying between the Rose City and the sea, not a serious mishap has marred the gladness of her voyages. The other boats of this merry-making fleet are:

Bailey Gatzert, Charles R. Spenser, Harvest Queen, Don Pomona, Leonia, Altona, Joseph Kellogg, Annie Corning, Hassalo, Lurline, Undine, Mascot, Gleasola, Dalles City, Regulator, Albany and Sarah Dixon.

Should all of these boats steam out of the harbor laden with all the passengers they are allowed to carry in the day time, it is said that at least 7,000 people would be afloat on them. But at night, the excursion boats are only allowed to carry about one-half the number that they may take during the time old King Sol rules. This order has been made because the dangers of the loss of life in case of an accident are far greater at night than they are during the day.

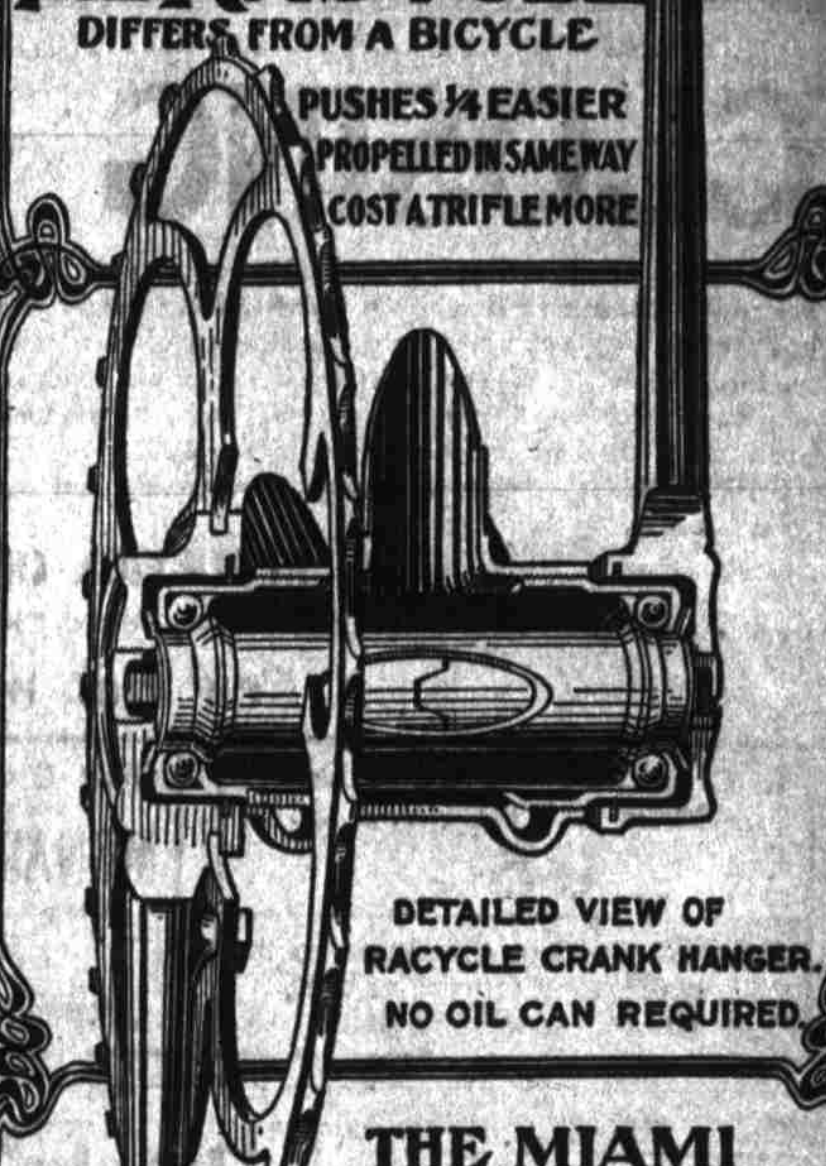
