

RYAN WILL FACE LARCENY CHARGE

TURFMAN AGREES TO RETURN TO ST. LOUIS WITHOUT FURTHER PROTEST—LAW PROHIBITS HIM GIVING BAIL IN NEW YORK ON WARRANT ISSUED IN MISSOURI

New York, July 25.—John J. Ryan, the turfman, will return to St. Louis without further protest. This agreement was reached after a conference between Ryan's attorneys and representatives of the St. Louis circuit court attorney's office.

Ryan was arrested at Brighton Beach Tuesday on a charge of grand larceny to the amount of \$800,000. His attorney immediately began preparation to resist his removal to St. Louis, advancing the plea that he had already been placed in jeopardy on the same charge and that if forced to leave New York at this time he would suffer heavy financial loss.

Owing to the law prohibiting Ryan from giving bail in New York on a warrant, it was found impracticable to allow him his liberty on parole, and he has now agreed, if given a little time, to return to St. Louis without further trouble.
