Nellie Gray, his sister, and Walter
Kamney and Donald Campbell, his
companions.

from shore. At that time the breeze
subsided and an attempt was made to
beat back to shore.

CRIMINAL SHOOTING
MAY END IN MOB LAW

Colfax, Wash., Oct. 10.—Be-

fatal shooting of Tom Brown, a

Frank Lewis, a billiard hall prop-
rietor, a lynching is threatened
and the jail here is guarded this
afternoon by extra deputies who
will protect the prisoners who are
held in case the multitudes of
excited citizens take a more
aggressive form.

DEPUTIES TALK
ON BREUER CASE

In giving their reasons for the arrest
of John Smith, the painter, on suspicion
of murdering Gus Breuer, Deputy Sheriffs
Grassi and Cordano criticized all po-
lice, and especially Detective Weiner, in
strong language. They declare that they
took no action until after the five Ital-
ians held on suspicion had been re-
leased, and did nothing in violation
of the law, but that the latter were
guilty of "most bungling" work, ar-
resting six men and having to witness
the release of every one because of lack
of evidence.

The published statement that Smith
first threatened Breuer's life on account
of the divorce obtained by his wife is
said to be an error. The boy died while
the two were separated, the deputies say,
whereupon Smith and the demes was
due to his son having no home and not
being properly cared for. The other
threats were made after the divorce was
obtained.
