### Federal Grand Juries in Many Parts of the Country Returning Indictments.

## RAILROAD OFFICIALS TO ANSWER FOR VIOLATIONS

### Packers and Railways Indicted at Kansas City and Chicago—Manufacturers at Philadelphia—Investigation on Coast.

Washington, Dec. 16.—The orders issued to United States district attorneys by Attorney-General Moody, to prosecute givers and takers of railway rebates and violators of the Elkins law have met with a prompt response in a dozen states and indictments are beginning to pour in against both railroad officials and shippers.
