

The college season closed on Thanksgiving day, when Multhoumah won the annual game from Oregon by a score of § to 0. The Oregon team had provide way the college charmlond the annual game from Oregon team had previously won the college champion-ship of the state, having defeated Cor-vallis, Williamette and Chemawa. The Oregon-Corvallis game will go down into history as the hardest gridiron battle ever seen in the state. The spirit and dogged determination of the Eugene men carried them through to victory, although they were fighting against tremendous odds. Idaho-won the championship of Idaho and Wash-ington and, on paper, is entitled to the college championship of the northwest. It is very doubtful, however, whether Idaho would have a look-in with Wil-lamette, Corvallis or Oregon. Three Oregon elevens-Eugene, Cor-vallis and Willamette — played Call-fornis at Berkeley early in the season. Willamette and Eugene played the Call-fornians to a standstill, but Corvallis was defeated 19 to 0. Oregon was de-

The annual Oregon-Washington game, which was played in Seattle, resulted in a score of 12 to 12. Among the coaches who worked in the northwest this year were Cutts of Harvard, who coached Washington, and Shorts, Michigan's famous tackle, who coached Oregon. 'Reddy' Griffith, Iowa's famous fullback, coached Idaho for the fourth consecutive season and Swelly, Michigan's greatest punter, trained the Pullman eleven. Chauncey Bishop, of Columbia fame, coached Wil-lamette university again. Bishop's team amette university again.
